HOTEL KEY CARDS

Ever wonder what is on your magnetic key card?

Answer:

- a. Customer's name
- b. Customer's partial home address
- c. Hotel room number
- d. Check-in date and out dates
- e. Customer's credit card number and expiration date!

When you turn them in to the front desk your personal information is there for any employee to access by simply scanning the card in the hotel scanner. An employee can take a hand full of cards home and using a scanning device, access the information onto a laptop computer and go shopping at your expense. Simply put, hotels do not erase the information on these cards until an employee reissues the card to the next hotel guest. At that time, the new guest's information is electronically 'overwritten' on the card and the previous guest's information is erased in the overwriting process. But until the card is rewritten for the next guest, it usually is kept in a drawer at the front desk with **YOUR INFORMATION ON IT**

The bottom line is: Keep the cards, take them home with you, or destroy them. NEVER leave them behind in the room or room wastebasket, and NEVER turn them into the front desk when you check out of a room. They will not charge you for the card (it's illegal) and you'll be sure you are not leaving a lot of valuable personal information on it that could be easily lifted off with any simple scanning device card reader. For the same reason, if you arrive at the airport and discover you still have the card key in your pocket, do not toss it in an airport trash basket. Take it home and destroy it by cutting it up, especially through the electronic information strip! If you have a small magnet, pass it across the magnetic strip several times. Then try it in the door, it will not work. It erases everything on the card. Always take a small fridge magnet on your holiday. It will come in handy at the end of it.

HOLLEY SENIOR NAMED TO 2014 ALL-WESTERN NEW YORK ACADEMIC TEAM

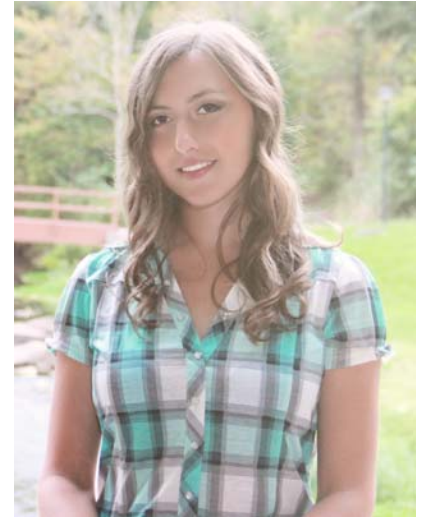
Holley High School senior Shelby Kunker received Special Mention on this year's *Business First* list of the 100 most outstanding high school seniors in the eight-county region.

Students were selected for this honor based on their records of academic excellence, school leadership and community involvement. The top 25 were named to the First Team, 25 runners-up to the Second Team, and another 50 to the Special Mention list.

"This is a highly competitive award," said Jack Connors, president and publisher of *Business First*. "Think of it this way: We have about 20,000 high school seniors in Western New York this year, and we've picked only 100 for the Academic Team. That puts them in the upper one-half of one percent. They're the best and brightest students anywhere in this region."

Schools throughout the eight-county area were asked to nominate their most accomplished students for consideration by an eight-member committee, which included six admissions directors at area colleges and two *Business First* editors. A total of 122 schools responded with 419 nominees. (Each school was limited to four candidates.)

The complete list of 100 honorees — along with their photos and profiles — will be published in the *Business First* 2014-2015 Guide to Western New York Schools, which will hit newsstands on June 13.



HOLLEY BOARD ADOPTS BUDGET AND ANNOUNCES 10.6 PERCENT TAX LEVY DECREASE

The Holley Board of Education will cut the school tax levy by \$800,000 or 10.6 percent according to the \$25 million budget that was approved at the Monday, March 17 Board of Education meeting. The tax cut would reduce the tax rate for residents from \$25.11 to a projected \$22.44 per \$1,000 of assessed property.

"At a time when state funding remains precarious, we are actually reducing taxes," said District Superintendent Robert D'Angelo. "This is attributed to the board and its long history of making strong, prudent and diligent decisions with a sharp eye on the future."

D'Angelo explained that, over the years, the Holley board has been able to effectively plan for uncertainties in state aid. "Most impressive of all is the fact that they did this while we were investing in our campus," said D'Angelo. "Now we find ourselves in the strongest financial and structural condition in district history."

The 2014-15 operating budget will be \$25,070,000, an increase over the 2013-14 budget of \$22,093,571. The budget figure represents the addition of all-day kindergarten, four instructional staff positions and the elimination of short term debt.

"With our finances and physical plant in top shape, we are ready to focus our undivided attention on building academic achievement," said D'Angelo.

When Holley residents go to the polls on Tuesday, May 20, the \$25 million budget will be put before them. They will also see three propositions: one is for a \$2.5 million capital reserve fund, the district received another proposal to decrease the size of the Board of Education from seven members to five; and a third proposition regarding the Community Free Library. Additional budget information will be available soon on the district website at www.holleycsd.org.

"More than ever, it is extremely important that Holley residents turn out to vote," said D'Angelo. "We have good news but we also have much to do and we need the community's continued support to be successful."

The vote will take place on Tuesday, May 20 from 6 a.m. to 9 p.m. in the Holley Middle School/High School foyer.

MARCH 2014

GREG SELKE

Climate Action Plan

Greg Selke, a graduate of SUNY Brockport and attending SUNY Syracuse for Environmental Science addressed the board regarding a proposed internship by preparing a Climate Action Plan for the Town of Clarendon. Mr. Selke provided a Climate Action Plan for the Town of DeWitt that he helped prepare as a sample of work he'd be doing for Clarendon. Extreme climate changes and the importance of reducing greenhouse gas emissions were presented. A Climate Action Plan will help identify possible reductions in emissions; research will be done on money and energy savings. Mr. Selke would work 15 hours/week for three to four months on this project. Irondequoit, Brighton, Oswego and DeWitt have Action Plans. The Town Board accepted Mr. Selke's proposal to prepare a Climate Action Plan for Clarendon.

HIGHWAY/WATER

DEPARTMENT REPORT

Larry Swanger, Superintendent

Superintendent Swanger reported plowing done and cutting back on salt used. Superintendent Swanger reported minor flood problems due to the culvert pipes freezing. The gear box on the sander is broken. The 2007 dump truck has been taken in for repair. The Highway crew is trying to patch pot holes and clear out the fire hydrants. It was reported that the frost is down in the ground around four feet. State Roads are breaking up as are the town/county roads.

PLANNING BOARD

David R. Griggs, Chairman

Chairman Griggs submitted the following written report:

02-25-2014 (regular Meeting)

- The Planning Board held a pre-conference SD 14-04 for a five (5) lot sub-division Holley Byron Road tax

id# 120.-1-66.2 . Chairman Griggs reviewed the application with the board. Four (4) individual lots are proposed and the remaining one (1) lot is proposed for merger with an existing lot. No issues were noted with the proposal. The applicants were advised of their right to waive the pre-conference and move to a formal application. They waived the pre-conference. A motion was made, seconded and approved to amend the agenda from a pre-conference to a formal application. A motion was made, seconded and approved to declare this a minor subdivision. A motion was made, seconded and approved to declare this a type II action and waive the SEQRA. A motion was made, seconded and approved to waive the need for a public hearing. A motion was made, seconded and approved to approve SD 14-04 contingent upon verification of the merger of lot number five (5) with the existing undersized lot of record tax id# 120.-1-65 and new deeds/maps for the remaining four (4) lots filed at the county.

- The Planning Board reviewed renewal of Special Use permit SP 96-005 Nancy Curtis- Caswell 4880 South Holley Road, Pet's Galore Grooming. The renewal fee has been paid, there are no complaints and the OIO has done an inspection. A motion was made, seconded and approved to approve renewal of SP 96-005 .

02-11-2014 (regular Meeting)

- The Planning Board held a pre-conference for a one (1) lot subdivision and building lot approval SD 14-05, Jan Maxim 16399 Glidden Road, tax id# 109.-1-49.11. Chairman Griggs reviewed the application with the board. No issues were noted with the subdivision portion of the application. Additional information was needed for the building lot portion. Applicant had requested in writing to waive the pre-conference. A motion was made, seconded and approved to amend the

agenda from a pre-conference to a formal application. A motion was made, seconded and approved to approve the one (1) lot subdivision. A motion was made, seconded and approved to table action on the building lot portion of this application pending further detail on house location, septic and water.

- The Planning Board held a pre-conference for a site plan review to construct a 40" x 50" pole barn, SD 14-06, Mark & Kathy Kelso. Chairman Griggs reviewed the application with the board. No issues were noted. Applicant had requested in writing to waive the pre-conference. A motion was made, seconded and approved to amend the agenda from a pre-conference to a formal application. A motion was made, seconded and approved to approve SD 14-06.

SUPERVISOR REPORT

Richard H. Moy, Supervisor

Supervisor Moy reported that he and Superintendent Swanger will attend broadband training to identify vertical assets on Friday, March 21st in Albion.

Supervisor Moy reported that the Town of Clarendon has been audited by the New York State Comptroller's Office in Albany and nothing was found to be wrong. Supervisor Moy thanked the department personnel for doing a fine job.

Supervisor Moy informed that over the last two weeks he has received many favorable comments from young residents; they love the town.

CORRESPONDENCE

The Orleans County Health Department has sent Notice of 2014 State Monitoring Requirements for the Clarendon Water System.

The Orleans Economic Development Agency/IDA has sent its 2013 year end report.

The Orleans County Youth Bureau is requesting nominations for multiple recognition awards. The deadline for

submission is March 26th; the Annual Youth Recognition Banquet will be May 8, 2014. Information is available upon request.

The New York Municipal Insurance Reciprocal (NYMIR) will contact the town to schedule site visits to appraise insured buildings.

Orleans County Legislature has sent notice of the broadband initiative training scheduled for March 21, 2014 from 12:30 – 3:30 in the Legislative Chambers in Albion. This training will be to identify and catalog unserved addresses and vertical assets in your town.

The Town has received its Build America Bonds rebate for Water District No. 9 in the amount of \$622.79.

OLD BUSINESS

The Town Board scheduled a public informational meeting with Dick Metzger of Monroe County Water Authority to be held May 20, 2014 at 6:00 PM at the Town Hall; the regular meeting to begin upon closing of the informational meeting.

Supervisor Moy referenced the Out-of-District-User form prepared for County Line Road, T/Sweden residents in WIBA 11. The form was submitted for Town Board review after approval from Superintendent Swanger and Attorney Schubel. Supervisor Moy, Town Clerk Colby and Superintendent Swanger will meet with Town of Sweden officials regarding billing Sweden residents the water debt service charge on their tax bills.

Water rates were increased for Water Districts 2, 3, 4, 5, 6, 7, 8, 9 and Water Improvement Benefit Area 10 excluding Bennetts Corners and Taylor Roads and Future districts to \$3.22 per thousand gallons. Bulk rate will increase to \$6.00 per thousand gallons with a 1000 gallon minimum charge.

NEW BUSINESS

Historian Melissa Ierlan referenced the estimate submitted by Laura

Schell of Lockport, NY to preserve and stabilize the town's 1852 map of Orleans County and described the techniques used to repair the cracking and ripping. The fennels on the top and bottom will come off as it does more harm to the map when hanging. Historian has spoken to Bob Barrett, Mill Road resident, about possibly building a frame/shadow box to house the map. It should not be hung on the wall but rather displayed in a slightly tipped frame/box on legs. The Board accepted the proposal for preservation work; at a cost of \$427.50.

Historian Ierlan reported that her grant application through the Pomeroy Foundation was successful. The Town has received a check for \$980 to have a sign made for the Hillside Cemetery Chapel stating that it is on the National Register.

General discussion was held regarding the sharing of offices at the Town Hall; that both the Assessor and Court Clerk should have privacy from the other offices when speaking to clients. Supervisor Moy intends to speak with the Senator about possible funding; drawings will be needed. The Town Board accepted a proposal from Architect David Strabel to prepare drawings to determine a revised layout of offices in the Town Hall at a cost of \$800.

Resolution accepting Affirmation of Justice Court Records audited March 5, 2014 by Supervisor Moy and Councilman Robinson;

Resolution in support of County-wide Broad Band Service;

Resolution to renew the Inter-municipal Agreement regarding County-wide Shared Services (use of Slashbuster); effective 3/1/2014 through 3/1/2015.

The Town Board authorized Supervisor Moy to sign a proposed three year Lease Agreement with Nicholas Penna to farm a portion of Hillside Cemetery land contingent upon receipt of Certificate of Insurance; for annual rent payable at \$850 with an increase of \$25/year for the remainder of the lease.

The Town Board amended the Town Fee Schedule and changed the Return Check Fee from \$25 to \$20; per General Municipal Law Section 5-328.
