INITIATIVE TO SAVE THE OLD STONE STORE UNDERWAY

On July 19th, the Town Board held an informational meeting regarding the future of the Old Stone Store building located at the corner of NYS Routes 237 & 31A in the Clarendon Hamlet. Many residents attended and spoke in support of saving the historical building. At the Town Board meeting which followed, the Board adopted a motion to allow a group of interested parties to work with the Landmark Society of Western New York for one year to find a buyer who will rehabilitate the building. The Medina Sandstone structure was built in 1836. It operated as a store until the mid 1970's. It is one of the oldest remaining structures in Clarendon as well as the most visible to travelers. If a buyer is not found, it will face demolition.

While many consider its current condition to be an eyesore, it is structurally sound and could be brought back to its previous appearance. It has been made eligible for listing on the National Register of Historic Places, which will make State and Federal tax credits available for it's rehabilitation.

Once rehabilitated, it will return to generating tax revenues for the Town as well as save the town tax payers the cost of demolition and future maintenance of the empty lot. It will also serve as proof of Clarendon's pride in our history.

The first step will be to commission a professional feasibility study to determine the overall condition and cost estimates for rehabilitation. Without this, it is unlikely a



buyer can be found. The Landmark Society has generously pledged \$500 toward this purpose but, additional funds will be needed. You can help by making a tax deductible donation.



LOCAL TOUR FOR EDUCATION

The Orleans County Town Clerk's Association spent a day on the road in July touring local businesses and places of interest in different towns within Orleans County. Karen Lake-Maynard, Orleans County Clerk and her Deputy Diane Shampine joined the Clerks for a portion of this Educational Day. Town of Clarendon Officials, Supervisor Dick Moy, and Councilman John DeFilipps chauffeured the Clerks around the county and accompanied them for the touring. Scheduled stops included:

WESTERN NEW YORK ENERGY LLC, 4141 BATES ROAD IN THE TOWN OF SHELBY.

The Plant Controller, Tim Winters gave a thorough guided tour of the entire plant, explaining the involved process of making ethanol from corn, and the great lengths taken to use every bit of corn by-product in oil, syrup and gas. This plant runs 24 hours/day all year, stopping production for approximately 3 days of maintenance. Clerks were impressed with the efficiency of product use, the flow of operations and the size and maintenance of the plant.

ORLEANS COUNTY ANIMAL CONTROL SHELTER, 13925 ROUTE 31A IN THE TOWN OF BARRE.

Kathy Smith, Orleans County Animal Control Officer walked the group through the County facility and explained the different rules of housing according to why and how long the animal is there. Officer Smith has volunteers that help exercise and groom the animals on a regular basis as well as handle the adoption of animals. One room at the shelter was dedicated to cats that are up for adoption. Clerks were glad to visit the facility as it ties into their job at the Town Hall.

OAK ORCHARD GALLERY, 2500 OAK ORCHARD ROAD IN THE TOWN OF GAINES.

Carol Culhane, proprietor of Oak Orchard Gallery welcomed the group and everyone browsed the shop. Wall paintings, tree bulbs and glassware, hand-painted by Carol were on display and for sale. Carol's newest project got the most attention ~ Her involvement in spearheading a committee to turn the old Swan Library building into an Orleans County Museum lead to the Mark Christopher donation of paper mache dolls approximately 3 feet high, from The Charlie Howard Santa Claus School at Christmas Park in Albion. These dolls, made in Germany, were animated characters originally on display at Macy's in New York City. Charlie Howard, who many times rode the Macy's Float for the NYC Thanksgiving Day Parade, obtained them around 1947. Carol intends to restore the dolls for the proposed museum. INTERGROW GREENHOUSES, INC., 2428 OAK ORCHARD ROAD IN THE TOWN OF GAINES.

All were impressed with the guided tour of the 33 acres of greenhouses and packaging plant. The group walked through isles of the vine tomato crop, being careful not to get in the way of the self-operating carts used to move tomatoes from one end of the plant to the other! Fifteen million pounds of tomatoes are produced here each year and upon completion of their 18 acre addition of greenhouses that will increase to 20 million pounds. Vine tomatoes are packaged here for both Wegmans and Aldie stores in the area. Two days each week, the plant offers tomatoes for sale to the public at a bulk rate.

LUNCH WAS ENJOYED IN THE TOWN OF MURRAY.

Clerk's opted for Subway lunches at the pavilion by the Holley Waterfall and afterward, walked the Canal Park path to the Gazebo.

LEONARD OAKES ESTATE WINERY, 10609 RIDGE ROAD IN THE TOWN OF YATES.

This was the last tour on the schedule. The group started out at the farm in the Town of Yates where we toured the vineyards and watched cherries being crushed while the juice extracted was put into large stainless steel vats for wine making. We learned of the 90 year Oakes Family history of ties to agriculture and their beginning venture in 2003 with the planting of their first wine grapes. At the farm, our group sampled brand new wines not yet on the market and learned first hand the difference between American Oak barrels and French Oak barrels! The group traveled back to Ridge Road for a formal tasting at the Winery where wine and glasses were purchased by some. Leonard Oakes wines are available at some local restaurants and liquor stores, so the next time your out to eat and would like a glass of wonderful wine, ask for Leonard Oakes!

The group ended the day at the Orleans County 4-H Fair, having dinner with the County Supervisors/Legislators Association at the pavilion. All agreed it was a very fun, informative day, learning about the different places within the county and plan to schedule another day of educational touring!

CLARENDON TOWN BOARD MEETING HIGHLIGHTS

July 2011

The Clarendon Town Board held an informational meeting about the future of the Old Stone Store building. The meeting was well attended and more residents spoke in favor of saving the structure than against it. The Landmark Society submitted a proposal to the Board and requested one year to obtain a feasibility study and try and find someone who will refurbish the building and possibly use it for a small office type business. Resident Erin Anheier will head up a committee of residents to work with the Society on the project and will send application to get the building put on the National Register. The Board agreed to give them one year and discussion was held regarding funding for the study; minimum cost estimated at \$1400. Community Renewal grant funding from \$5,000 to \$25,000 was mentioned. The Landmark Society has donated \$500 toward the study; the remaining monies needed will need to be raised. It was explained that the Town would deed the property over to the Landmark Society who in turn will deed the property over to a new owner. There will not be a purchase price on the property, but instead will find a buyer who will take the property and invest money into refurbishing the building. The Town sets the zoning and use of the building when renovated and can craft specific requirements; Zoning is Residential Agricultural; it has never been commercial.

Supervisor Moy acknowledged Eagle Scout Josh Hatfield of 16954 Taylor Road, Clarendon, and apologized for not attending his award ceremony. Scout Hatfield described his project; painted trim on the Hillside Cemetery garage and built and installed a display cabinet for the Hillside Cemetery maps and information. Board members thanked Josh for the great job done and presented him with a Certificate of Recognition

and a new American Flag. Historical Society President Jim Moore also shook his hand and offered "with men like you, we're in good hands."

HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Swanger reported that the highway department has been helping other towns with paving and sealing. The north end of Lake Road has been repaved and the second roadside mowing has been started. The Highway Department was closed for one week; all employees took vacation the week of July 4th. Water meter readings were completed yesterday; bills will go out next week. Superintendent Swanger reported fixing a water leak on Hindsburg Road.

A motion was made, seconded and approved to table action on a preconference for building lot approval, SD 11-07, Duane Feor, Bennetts Corners Road until applicant could be present.

Additional information previously request on setbacks from property line, driveway, septic and well locations was provided. Anchoring methods discussed. No significant issues were noted and applicant request waiver of pre-conference to formal application. A motion was made seconded and approved to amend the agenda accordingly. A motion was made, seconded approved to approve Special Use Permit SP 11-02 pending receipt of the OIO of a finalized anchoring design sketch.

SUPERVISOR REPORT

Supervisor Moy informed that Assemblyman Hawley came to the Town Hall last week about the 2% tax cap legislation. Legislator Bill Eick and some of the other town supervisors attended. Comptroller's Office will send information on the next tax levy cap for the towns; it is now at 1.64%, which is approximately \$12,000 for Clarendon. Supervisor reported that health care cost alone is increasing 19% next year. Supervisor explained State mandates and exampled the town hall roof job. One of the bids turned in did not include union labor and the town could not consider that

contractor. The Town had to pay prevailing wage to the contractor, costing taxpayers an additional \$5000 for the project.

OLD BUSINESS

Supervisor Moy confirmed that the Legal Notice has been in the paper, putting the WIBA#10 construction project out for bid; deadline for submission is 8/19/11. The board scheduled a special meeting to award the waterline construction project to be held August 23rd at 10:00 AM.

Attorney Schubel confirmed that application for approval has been sent to the NYS Comptroller's Office. After approval, the Town will go for BAN funding. The project was reviewed as being 5.6 miles at a \$1.6 million cost; expected

construction start is September, 2011.

The Town Board authorized the signing of an agreement with Orleans County to Control Snow & Ice at \$5375 per mile of County Road and to Mow at \$560 per mile of County Road within the Town of Clarendon from 10/1/2011 through 9/30/2016.

MEMORIES IN A GARDEN

A plaque under a 56 year old Silver Maple at my home says, "There is always music among the trees in the garden, but you must be quiet to hear it." What kind of music is the poet referring to – wind, birds singing or something else? Are these trees talking about all the memories in a garden? I am going to list a few of my memories of the garden. I live on original land that has been in my family since it was divided up by the Holland Land Purchase, many years ago. It was farm land and before that, it was the home of the Indians.

My Grandmother Brooks started my love for gardening. As a little girl, I would be at her farmhouse on Cole Road (now called Glidden Road). I lived across the road in a house my father (Leon Mark Robertson) had remodeled. My grandparents, Roy and Isabelle Brooks, lived across the road in a big white farmhouse. I would go over to my grandmother's house and help wash clothes in her wringer washer and then we would hang the laundry on the clothesline to dry. It was then that I saw her beautiful gardens. Gardens of pink and yellow Shrub Roses, Scarlet Quince bushes, single Hollyhocks, Golden Glow perennials, Trumpet Vines, Bridal Veil Spirea, Snowflake Spirea and the biggest Mulberry Tree that you ever saw!

I also have memories of my grandparents Jess and Minnie Robertson's sandstone house on Lynch Road, adjacent to the Erie Canal. This house is across the road from the Holley High School. As you entered the long driveway, you would see the most beautiful Hydrangeas against the east side of the house. There also were a lot of Gladiolus and Pansies on the property.

My own parents have given me many memories of gardening too. Outside of my mother's kitchen window was a beautiful Blaze Rose and beneath it, a garden of perennials consisting of Phlox Columbines and Daises. My father was an avid vegetable gardener. He is the inspiration for my big vegetable gardens. He would grow fruits such as Strawberries, Raspberries, Currants and sometimes Quince bushes and Crabapple trees. In his vegetable gardens he would grow all the common vegetables ~ corn, tomatoes, cucumbers, squash and all kinds of peas. Two of his favorite vegetables were potatoes and parsnips. My parents had a stand on Upper Holley Road where they sold vegetables. My father also sold vegetables to the IGA Store in Holley and Bells in Albion.

On my parents' property there also were a lot of Black Walnut trees. My father was not fond of the green shells that fell all over the lawn. He had to pick them all up. I have a Black Walnut tree on our property for this memory.

At our home on Upper Holley Road I have a lot of the same plants that my grandparents and parents had. I also have some Bicolor Iris that were given to my Grandma and Grandpa Brooks by their friends from Tonawanda. They were great race horse fans, as were my grandparents. They would go to Batavia Downs and watch Clarendon's own E.D. Beadle and Danny Gunter race their horses. One time they gave my grandmother these Iris as a gift and they have passed down to me.

Monica Beck the Town Hall gardener gave me a root of Trumpet Vine that had been planted in the gardens by the Clarendon Beautification Group many years ago. I had tried to grow this and it had failed. Now today, July 29, it is blooming against a barn that I have.

The Snowflake Spirea that my Grandmother Brooks had, was found on-line two years ago, after I found some blooming at Harrington's Nursery in Elba. They told me the name of it but didn't have any for sale.

The Golden Glow perennial flower was given to me after I wrote an article on Heritage Flowers for the Gazette while serving the Town as Historian.

My friend, Roberta Gluck, gave me an Endless Summer Hydrangea and I purchased an Annabelle variety in Vermont.

I am always ready to start memories in a garden for anyone. My own family has started many themselves. My daughters Melissa and Angela have vegetable gardens. My daughter Meredith loves Sunflowers and grows them. My daughter Anne Marie has a Patio Garden. Our daycare has a raised bed garden of vegetables with homemade vegetable markers. The children take home the vegetables that they grow.

The inspiration for this article came from vegetable garden that is about two years old. It is to the north of the hamlet of Clarendon on the right hand side. A young family has purchased this property and is creating its own memories.
