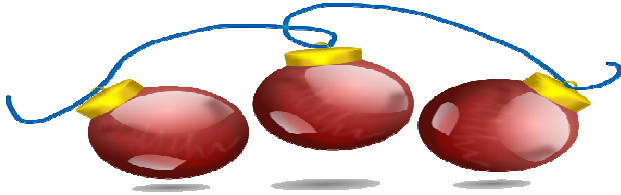

## DEC Invites Initial Feedback on Several Wildlife Regulations Being Considered

Continuing efforts to keep hunters and the public informed about possible wildlife regulation changes, DEC has posted several ideas that are under consideration for 2017.

Prior to initiating a formal rulemaking process, DEC routinely seeks public input regarding concerns or interest in potential changes to regulations. In many situations, DEC uses scientific surveys to gather public opinion about potential rule changes. In other cases, DEC communicates informally through e-mails, letters, or meetings in response to ideas and suggestions. In all situations, it is helpful to obtain informal feedback to gauge public interest and support, and to learn of any concerns that may exist, before the formal rulemaking process is initiated.

DEC invites informal feedback regarding several issues: (1) prohibiting feeding wild white-tailed deer, (2) issuing permits for 4-Poster Tickicide™ and 4-Poster™ deer treatment devices, (3) strengthening measures to protect New York deer from Chronic Wasting Disease, (4) eliminating the special permit for hunting and trapping bobcats in the Harvest Expansion Area, and (5) closing the season for take of diamondback terrapin.

These ideas are not formal proposals at this time, just options being considered as potential changes for 2017. ## CLARENDON TOWN BOARD—Meeting Highlights October 2016

**Sandy Shaw, Director of the Community Free Library in Holley** spoke at the November Town Board Meeting and informed of the \$20,000 funding received from Senator Rob Ort. Spending of this funding has restrictions. The Library will hire a part-time child librarian for 17 hours/week at \$14,250. The remainder of the money will go toward programming for adults on the first Wednesday of every month; i.e. digital photography, Tole painting, final wishes (for people and animals) and extra large medium fun were examples given. The Library is also now open on Saturdays for four hours in the morning. The annual report showed an attendance increase of approximately 400-500 per week during the summer. All were invited to the Annual Christmas Celebration on December 2<sup>nd</sup> from 6:00 – 8:00 PM, to include Christmas Carols, Adult Women's Choir, Mrs. Claus will read The Night Before Christmas and Santa will visit. Basket raffle winners will be picked that night.

**OPEN END** - Upper Holley Road resident Dave Brooks requested the yellow suggestive speed limit sign on Upper Holley Road coming into the Hamlet be changed to a white sign, reducing the speed to 35 mph between the quarry and the hamlet. Mr. Brooks related that cars fly by his house down the hill. Superintendent Swanger informed that the State has the final say. Brown Schoolhouse Road resident Tammy Brongo requested the dirt section of the road be paved and speed signs put up; that the road is supposed to be maintained until December 1st. Superintendent explained the road is too dry now to grade it; that it is in his schedule to pave next year. At Mrs. Bongo's request, it was clarified that a summary of town board minutes is included in the monthly Clarendon Gazette; that a complete set of minutes is available at the Clerk's Office.

**HIGHWAY/WATER DEPARTMENT** - Superintendent Larry Swanger reported that the Clarendon Highway crew helped the Town of Murray and Orleans County with paving project, repaired some blacktop roads on the edges and hauled stone for the Village of Holley. Equipment is being prepared for the winter and employees have been taking vacations this past month. Due to the last heavy rain, more top soil will be needed for Water District No. 9 extension where it was hydro-seeded. Paul Burley, seasonal worker in the cemetery is done working for this year. Ben Downey's Eagle Project – the new fence in Hillside Cemetery – looks great. The current cemetery mower has 700 hours on it for one year's time; the average for a homeowner is 50 hours. Three times the pulley has broken. The Board authorized purchase of John Deere Select Series Tractor with 42 Accel Deep Mower Deck. With trade in of current mower, cost will be \$1679.

**PLANNING BOARD REPORT** - Chairman Dave Griggs submitted a written report. **Regular Meeting, October 25, 2016** \* A Pre-Conference was held for site plan review to construct a 30' x 40' Pavilion, SD16-06 Richard Moy Jr. 16419 Glidden Road. Chairman Griggs reviews the application with the board, no issues were noted. The applicant has provided a letter waiving the pre-conference. A motion was made, seconded and approved to amend the agenda from a pre-conference to a formal application. A motion was made, seconded and approved to approve SD 16-06. \* A Pre-Conference was continued for site plan review for a one (1) lot subdivision, SD 16-05 division 4348 Hulberton Rd. Tax id# 87.-3-40. Chairman Griggs revisits this application and informs the board that it has changed from a one (1) lot to a two (2) lot sub division per the applicant's request. The applicant has provided a letter waiving the pre-conference. A motion was made, seconded and approved to amend the agenda to a two (2) lot sub division. A motion was made, seconded and approved to amend the agenda from a pre-conference to a formal application for a two (2) lot sub division. A motion was made, seconded and approved to declare this application a minor sub division for SEQR purposes. A motion was made, seconded and approved to approve SD 16-05 contingent upon the 3 remaining pins being set and shown on the map, receipt of revised maps and a deed filed for the new parent lot with the Orleans County Clerk's Office. **Regular Meeting November 8, 2016** \* Meeting cancelled due to general election conflict. Chairman Griggs showed appreciation for the Eagle Scout project coverage in the Clarendon Gazette.

**SUPERVISOR REPORT** - Supervisor Dick Moy informed that because the town borrowed federal funding for two water districts, Rural Development has another requirement; the town needs to have a plan on how to serve people that can't speak English well for the Limited English Proficiency Program.

**CORRESPONDENCE** - NYSDOT has responded to Mrs. Amatrano's request to extend the 35 mph speed limit eastward from the hamlet; they will investigate it. NYS Association of Counties has sent a listing of county sales tax cash distributions cash comparison for second quarter of 2016. Orleans County revenue is down 5.62% from last year for the same period. MVP has sent notice of health insurance benefits and renewal; Supervisor stated the 2017 premiums can increase up to 1.65%. Justice Thomas DiFante has completed the 2017 continuing judicial education program requirements. Notice of the 2017 Training School & annual Meeting of the New York State Association of Towns has been received; scheduled for February 19-22, 2017 in New York City. The District Attorney's Office has sent \$1733.33 in revenues of the Traffic Diversion program for the period of July through September, 2016. The American Public Works Association has sent their annual request for award nominations for outstanding public works projects and individuals. The awards banquet will be held in late January, 2017.

**OLD BUSINESS** - The Town Board adopted Local Law 3 of 2016 regarding outside storage of unlicensed vehicles. Regarding animal control, the county is looking to have one dog law for the entire county; using the Town of Barre dog law as the sample. The Board adopted the final budget for 2017; tax rate will be lowered to \$4.62 per thousand. *A copy of the complete budget can be found on the town website, Supervisor or Town Board pages, or at the Clerk's Office upon request.*

**NEW BUSINESS**-The Board adopted a Resolution approving renewal of the NYS Snow & Ice Agreement through June 20, 2019 and a Resolution accepting the Highway Audit of Equipment performed by Councilmen Robinson and Major on October 29, 2016.

### DEC's HUNTING SAFETY RULES

- Assume every gun is loaded.
- Control the muzzle. Point your gun in a safe direction.
- Keep your finger off the trigger until you are ready to shoot.
- Be sure of your target and beyond.
- DEC encourages hunters to wear blaze orange or pink. Wearing orange or pink prevents other hunters from mistaking a person for an animal, or shooting in your direction. Hunters who wear hunter orange are seven times less likely to be shot.
- When hunting in tree stands use a safety harness and a climbing belt, as most tree stand accidents occur when hunters are climbing in and out of the stand. Also, never climb in or out of a tree stand with a loaded rifle.
- Always be prepared for winter conditions when venturing in the woods, inform a friend or relative of your whereabouts, and pack emergency supplies.

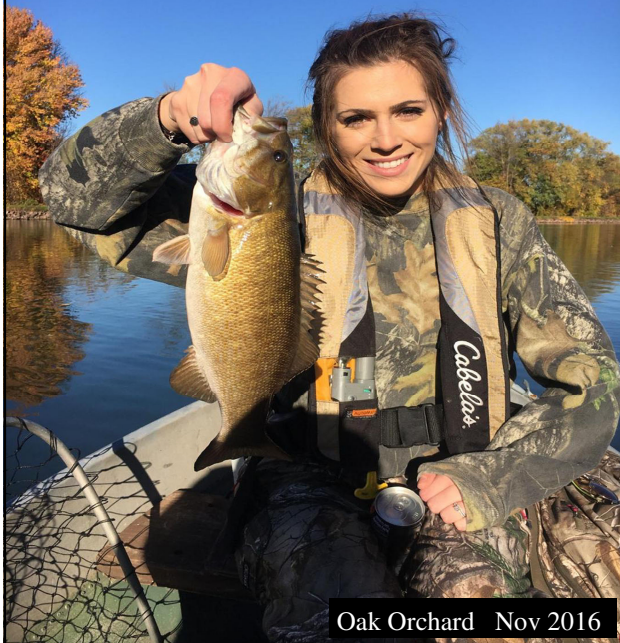

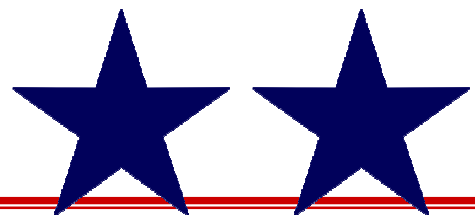

## Hillside Sketches

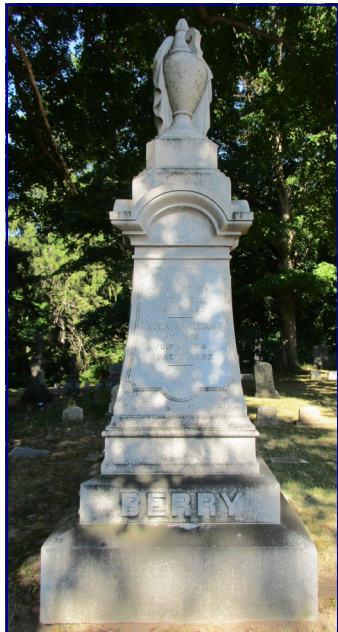
**John Berry** (1812-1892) was born in Berlin, NY on October 11, 1812. He was one of nine children. John was a

descendent of Rhode Island Quakers.

At the age of twenty-two, he moved to Albion to work for General Lee, a produce dealer. Within three years (1837) he had moved to Holley to begin his own produce business. His warehouse was located on the Erie Canal loop. He became one of the most successful produce dealers in Holley, possibly Orleans County.

In 1860, he formed a partnership with his son-in-law **David H. Partridge**. It was at this time that the firm was shipping thousands of barrels of apples to the large cities on the eastern seaboard.

On December 11, 1866, an association was organized and incorporated under the general act of the NY Legislature as "The Holley Cemetery Association." John Berry was instrumental in promoting Hillside Cemetery being an original stockholder and president for many years. Being elected for two terms in the NYS Assembly gave him the recognition of being called the Honorable John Berry.



His monument, a handsome obelisk, contains his and his wife (1814-1892) **Rhoda's** names; also the names of three daughters and their husbands.
