LEGAL NOTICE

TAKE NOTICE that the Clarendon Town Board will hold a Public Hearing on February 16, 2016 at 6PM at the Town Hall, 16385 Church Street to consider the following amendments to Town Zoning Ordinance Section 301: 1) A new Subsection B shall be added which reads as follows: "B. All buildings or structures 64 square feet or greater within the Town of Clarendon shall require a building permit." 2) Current Subsection B shall be designated as Subsection C and shall read as follows: "C. No building permit shall be issued for any buildings, structures, dwellings, their customary accessory structures and common farm related structures unless a Site Plan has been submitted to and approved by the Planning Board *cont. on page 9*

Councilman Major stated that Cemetery Administrator Melissa lerlan has asked that a portion of Hillside Cemetery be set aside for burials of military persons and their spouses, as is done in the Albion Cemetery; thinking a portion of land toward the water tower would be best.

County Legislator John DeFilipps informed that County Real Property has decided to do the pictometry flyover in March; when there are no leaves on the trees. High school students, Shayna Swisher and Sienna Steier were welcomed to the meeting.

HIGHWAY/WATER DEPARTMENT

Superintendent Larry Swanger reported being busy plowing snow the past couple of weeks. Connection to Water Improvement Benefit Area No. 11 has slowed down; over half the homes in the district are hooked in now.

PLANNING BOARD

Chairman Dave Griggs stated no meetings were held in January; nothing to report.

HISTORIAN/HISTORICAL SOCIETY

We are busy working on getting things in order for the grant as far as obtaining the paperwork needed to advertise and seek bids for the Roof and Windows of the chapel first. I have completed the paperwork and mailed in the application for the town to be set up in the Grants Gateway contracting system. I will be doing a program for the after-school friends at Holley Elementary on Wednesday. The topic is games played during colonial times and before video games! Judy Jensen has graciously provided me with a large variety of games and puzzles to present. I imagine it will be a surprise for the kids to see things that can be done without the use of technology! I assisted the Holley humanities class in photographing families for holiday portraits. They offered to email the photos to families or provide them with a free print. I was one of the two photographers and edited my photos. The students did not charge money rather they asked for non perishable donations or new toys to take to the community center. It was well attended for the first time and they hope to do it again next year. I still have a couple of Holley students helping me with some projects. I am planning two new exhibits for the Historical Society Museum next year. The CHS is finalizing our list of speakers for the upcoming year. We are still meeting every third Wednesday at 7pm. We have obtained permission to use the High School Auditorium on May 30th for a screening of movies made in the 70's and early 80's by Holley native Raymond Santoro. This features many locals who played parts and it will serve as a fund raiser for the Hillside Chapel as well. Our Akeley monument is at the engraver still being worked on at this time. The memorial bricks for the walkway have been purchased and are now at Brigden Memorials to be etched this winter with the names of the people who made donations of \$100 or more. I am currently working on re-painting three more historical markers and will be looking for more in a month or so. I have a meeting with a potential Eagle Scout to discuss the project he would like to do in the Veterans Section of the cemetery this spring. I am finalizing the application for a grant from the Pomeroy Foundation to place a Historical Marker at Hillside Cemetery to honor Charles Herbert Taylor, only resident of Orleans County to be killed at the battle of Gettysburg in 1863. This work was mostly coordinated and done by Tim Archer a Social Studies teacher for Albion Schools and his 7th grade class. The grant can be submitted in February and we will know by April if we have been chosen. Likely we will hold a ceremony on a Saturday to unveil it.

I took the opportunity to attend and join the Orleans County Genealogical Society at their meeting on January 10th. This group meets monthly to serve as assistants to those doing research. They now meet in the Hoag library and have access to computers and other materials. They are looking to make people aware of their existence should they wish to join or they need help.

CORRESPONDENCE

The Orleans County Dept. of Self Insurance sent notice of its quarterly meeting.

The Orleans County Legislature approved apportionments of 2016 sales tax to towns and villages; Clarendon at \$116,260.89.

The Orleans County Legislature sent its adopted resolutions; as follows: No. 435-1215 Supporting New York State's Constitutional Home Rule; No. 454-1215 Supporting New York State Legislation Concerning Fuel Zone Pricing; No. 457-1215 Opposing Legislation A8580 and A1548/S.782, Enacting the Safe Staffing for Quality Care Act; No. 458-1215 Orleans County Legislative Position on Commercial Wind Turbines in the Town of Yates. (copies of these resolutions are available at the Town Clerk's Office).

OLD BUSINESS

The Town Board adopted a Bond Resolution for Water District No. 9 ext.1 funding allowing a twenty day period for contesting such.

Monroe County Water Authority has sent notice of water rate increase; per 1000 gallons 2015 Rate: \$2.04; 2016 Rate: \$2.11. Clarendon's April water billing for the first quarter usage will include an increase. This will be handled at the February meeting. Discussion was held regarding a public informational meeting about a contract with Monroe County Water Authority; a meeting was not scheduled at this point.

The Board adopted a Resolution introducing Local Law No. 1 of 2016, 'A Local Law to Amend Local Law No. 1 of 2007' to change the size of structures requiring a building permit and scheduled a public hearing. A public hearing was also scheduled to consider amendments of the same to the Town Zoning Ordinance Section 301. (See Notice on Page 1 of this Gazette).

NEW BUSINESS

Nyla Gaylord, Glidden Road resident was appointed to fill the vacant seat on the Clarendon Board of Assessment Review; term to expire 9/30/2020.

Because the Presidential Primary election this year is scheduled for April 19th, the monthly Town Board meeting for April was moved to the 21st at 7:00 PM.

The Town Board adopted Resolutions approving refunds and corrections of water debt services charges on four properties.

Superintendent Swanger reported that the mower at Hillside Cemetery currently has 660 hours on it. The Board authorized the (annual) purchase of John Deere Select Series X304 tractor with 4 wheel steer and 42X edge xtra deck from Lakeland Equipment in North Chili.

Hillside Sketches

The Pratt family chose a burial lot on the Highest ground of Hillside for their final resting place. To further distinguish the Site there are granite corner markers

which support an iron railing. A tall columnar marker carries the family name.

Joseph Pratt (1802-1881) purchased the monument before his death for more than \$1000, a hefty sum in the late 1800's. He was born in Massachusetts. moved to Jefferson County, NY when a child and then to the Town of Sweden. Joseph purchased his land on what is now called Bennetts Corners Road in 1829. In time, he built two houses as well as some barns on his land. He had learned the trade



of surveying while in Sweden and continued that profession as well as being a farmer. He also was an assessor and served as justice of the peace from 1847-1856. His first wife was **Alinda Howard** but she died in 1849. In 1851 he married a widow, **Chloe Walker Hill**, whose husband, **Horace B. Hill**, had recently died. Chloe was one



one of Clarendon's prominent citimost zens. Chloe outlived Joseph, passing away in 1900. When Chloe died. newspapers called her one of Clarendon's oldest and most highly respected women. It was also reported that she was one of the wealthiest women in the county. There are grave stones for both the previous spouses, Alinda and Horace, even though

their deaths predate Hillside Cemetery. It is likely their bodies were moved from other places. Also on the lot is **Joseph C. Walk-er**, Chloe's brother, who died in 1898.



To improve public awareness about ideas being considered for future hunting rule changes, DEC has created a new webpage (Public Input on Hunting Regulations) (http://www.dec.ny.gov/outdoor/104785.html). To kick this off, we invite feedback on a couple of ideas related to deer and bear hunting in 2016: (1) allowing junior hunters to take bears during the Youth Firearms Deer Hunt, (2) reducing antlerless harvest in WMUs 6F and 6J, and (3) rescinding the antlerless-only requirement during portions of the bow and muzzleloader season in a handful of Southern Zone WMUs. These ideas are not formal proposals at this time, just options being considered as potential changes for the 2016-17 season. Please see Public Input on Hunting Regulations to read more about the ideas and to provide feedback. Also, many hunters are aware that DEC has been engaged in a process to determine the best path forward for reducing harvest of young bucks, including possible expansion of mandatory antler point restrictions. We will be meeting with leaders of NY hunting organizations and other interested groups in early February to discuss the outcome of this process and our intended next steps. We will provide the information broadly to hunters thereafter, and will invite feedback on this issue at that time. In the meantime, much information about the decision process considered is available at DEC's <u>Buck Harvest Management</u> (http://www.dec.ny.gov/outdoor/27663.html)webpage.





Jacob Oman Biography

Born on December 29th, 1784 in Onondaga, New York, Jacob Oman lived a full life. He was the sixth child to parents George Jurrije Oman and Maria Oman (neé Mack). Oman settled in Millard Place, Clarendon in 1814, when the region was still mostly wilderness. Prior to his settlement, Jacob Oman served in the War of 1812 and stood seven drafts. He was a man who not only served his country, but was also a great hunter. He was a deer hunter, bear hunter, and fisherman. In 1823. it is recorded that he shot one of the largest bears of the area. In fact, it was so big that the end board of his wagon had to be removed in order to fit the beast. In all of his great adventures, Oman also managed to have a family. He married Amelia Begole, who was from Maryland, on October 11th, 1806 and had 11 children spanning over the years of 1808 to 1826. Jacob Oman, Jr. was the eldest, and went on to make a name for himself in the history of Clarendon. In 1823, Jacob Oman, Sr. planted an orchard of apple trees for each member of his family at the time. Jacob Oman died on October 22nd, 1868, and is buried at the Pettingill Cemetery. He is beside his wife, who passed three years after he did in 1871.

Elisha Farwell Biography

Elisha Farwell was born on October 1st, 1814 to parents Judge Eldredge Farwell and Polly Farwell (neé Richardson). He was the seventh child, but the first to be born in Clarendon, which was not yet recognized as a town. His parents had arrived to the area in 1811 and set up a saw-mill. The town came to be known as Farwell's Mills. When Elisha became old enough, he followed in his older brothers', George W. and Eldredge, Jr., footsteps and began carrying mail on horseback to and from Byron Center. This was previous to the completion of the Erie Canal, which occurred in 1825. The stages of Elisha's route were between Rochester and Buffalo.

Elisha Farwell became a father in 1842. This was the year that his wife Sarah A. Farwell (neé Goddard) gave birth to their son, Eldridge L. Farwell. His next child, a daughter, was named Mary L. Farwell. She survived only a few days after her birth. However, Elisha and Sarah adopted a girl a year after their first was born. Interestingly enough, they also named her Mary L. Farwell. The couple's last child was another daughter in 1857. Her name was Clara Farwell. In both 1861 and 1864, Elisha Farwell was a Trustee of the Universalist Church. This church was erected in 1832, which was 18 years after Elisha was born. His father and many of his brothers had also been Trustees throughout the 1850's, 1860's, and 1870's. Elisha Farwell died on April 27th, 1896 in Clarendon. His wife, Sarah, had died five years earlier in 1891, and they are both buried in Pettingill Cemetery.

The purpose of this local law is to give the Town CEO broader authority in issuing building permits for detached structures. 2) Section 5 (A)(2)a of Local Law No. 1 of 2007 is hereby amended to read as follows: "2. No permit shall be required for: a. Construction or installation of one story detached structures associated with one or two family dwellings or multiple single family dwellings (townhouses) which are used for tool and storage sheds, playhouses or similar uses, provided that the gross floor area is less than 64 square feet." 3) All other provisions of Local Law No. 1 of 2007 shall remain unchanged. AND BE ADVISED that the regular monthly meeting will begin immediately following the 6:30 PM public hearing.

HOLLEY FIRST AND SECOND GRADERS LEARN ABOUT HEALTHY CHOICES

In December, Karen Blank, from The Whole Approach studio, led Holley Elementary Students in first and second grades through a workshop entitled "Healthy Snack Cooking & Games." She met with 24 students after school twice a week and taught them about nutrition, games to stay active, how to make their own healthy snacks and how to make healthy living choices. The students were joined by their parents for the final workshop on the evening of Dec. 17, where they set the table together and prepared a healthy dinner of homemade ravioli and salad.

Blank's workshops were offered free to Holley Central School District (HCSD) students as part of the three-year Carol M. White Physical Education Program (PEP) grant the district received last year. HCSD regularly offers before and after school programs to grades K-12 students as part of its FIT4U! program, made possible by the PEP grant. The FIT4U! program focuses on teaching students about fitness and nutrition through a variety of activities and educational programs.

Students took pre- and post-tests evaluating how much they knew about healthy choices at the start and conclusion of the workshop. Their knowledge of healthy behaviors increased from 61 percent to 99 percent.
