We need to help our Senator, George Maziarz, expand broadband in western New York. Senator Maziarz has mailed survey forms to residents of Niagara and Orleans Counties requesting time be taken to complete and return the information. It is important that these surveys be completed. They are needed to help determine the next steps in reaching the goal of expanding broadband services. Some already have access to service, but some do not. The Senator states that in the 21st century, access to broadband internet services is a vital part of our economy and also necessary to ensure that our children can compete with their counterparts across the globe. Senator Maziarz has been working with County Legislators and Town Supervisors in Niagara and Orleans Counties and Assemblymen Steve Hawley and John Ceretto and Assemblywoman Jane Corwin to develop a creative path to bring broadband internet services to un-served and under-served areas. RECYCLING

Place all recyclable materials inside the green recycling bins provided by the county. On the opposite side of this sheet you will find your recycling guide. All recyclables can be placed out weekly inside the recycling bin on the same day as trash pickup. Please place recycling bin away from garbage so driver can see it.

GARBAGE

The equivalent of 6 bags or cans of normal municipal solid waste including garden and yard waste, ashes (cold ashes only), plaster, stones, bricks and building materials.

- Place garbage in 20 or 30-gallon watertight cans with covers and handles, or (3 mil minimum) plastic bags. Do not use shopping bags. Limit of 60 pounds per container. Securely tie bundles of brush and building materials in lengths of no longer than 4 feet and within a 60-pound limit.
- DO NOT INCLUDE: tires, pesticides, oils, solvents, flammable liquids, explosives, animal carcasses, fecal matter, industrial waste, other regulated hazardous waste or building materials left by a contractor.
- **E-WASTE (MICROWAVES, TELEVISIONS, and COMPUTER equipment)** will no longer be picked up. Please take it to the nearest Electronic Recycling facility.

FOR COLLECTION

Place garbage and recyclables at your roadside, within 5 feet of the road, before 6:00 am on your pickup day. If you have a ditch in front of your property, place garbage and recyclables between the road and the ditch.

- Garbage and recyclables will be collected on the same day in separate trucks, at different times during the day.

LARGE ITEMS

A large item is any refuse that cannot be placed in cans or bags easily. ONLY ONE LARGE ITEM WILL BE PICKED UP EACH WEEK AT THE ROADSIDE. Refrigerator doors and shelves must be removed and the customer must call Modern Disposal (# below) on the **FRIDAY** prior to their scheduled pickup day. Large items will be collected on the same day as regular service and placed in the compactor truck. These items shall include, but are not limited to furniture, mattresses and box springs, carpets, appliances, Christmas trees, or carpeting (rolled and tied 4 foot lengths).

TIPS

Paint Cans- the lid must be off and the cans are to be set next to the trash can so the driver can see that the contents are dry. Clumpable cat litter can be used to dry up any contents prior to disposal.

Cold Ashes- must be cold and contained either in a bag or a cardboard box so the ashes do not go airborne as they are placed in the truck.

Medical Syringes- Medina Memorial Hospital takes them on Saturday mornings. Please do not dispose of these in the regular trash.

HOLIDAY SCHEDULE

New Year's Day – Memorial Day – Independence Day – Labor Day – Thanksgiving Day – Christmas Day. If your collection day is on or follows any of these holidays during the week, then your collection will be one day late.

HOW TO GET A RECYCLING BIN

A green recycling bin may be purchased for \$7.00 each from the County Real Property Office in Albion at Courthouse Square. Call (585) 589-5400. If you have built a new home, you are entitled to a free bin. Just present your property tax receipt, showing that the garbage collection fee has been paid, to the Real Property Service Office.

- The Planning Board held a pre-conference for a one (1) lot subdivision and building lot approval, SD 14-01, Mark Flint, 5414 South Holley Road, Tax id# 120.-1-70. No significant issues noted with either the subdivision proposal or the building lot proposal. Applicant had requested in writing to waive the Pre-conference if no issues were noted. A motion was made, seconded and approved to modify the agenda from a pre-conference to a formal application. A motion was made, seconded and approved to approve the one (1) lot subdivision and to approve the building lot contingent upon verification by the OIO that the building location remains the same as was presented.

The next regularly scheduled Planning Board meeting is 7:00 PM, January 28, 2014 at the Clarendon Town Hall, 16385 Church Street.

SUPERVISOR REPORT

Richard H. Moy, Supervisor

Supervisor Moy acknowledged receipt of a Broadband questionnaire from Senator Maziarz and stressed the importance of filling it out and returning it. Senator Maziarz is helping to get coverage all through Orleans County.

The Orleans County Legislature has approved apportionment of 2014 sales tax to towns and villages. Clarendon will receive \$116,260.89.

Supervisor Moy reported receipt of a letter from Monica Beck proposing to maintain the gazebo garden this year at \$600; in 2012 Monica was paid \$500. Discussion was held regarding the work needed to maintain the gardens. The gazebo needs to be stained this year; Supervisor Moy intends to do the job with a sprayer.

Monica Beck, Church Street resident was appointed to maintain the gardens at the Town Hall Gazebo and around the Town Hall building for the 2014 season for \$500.

CORRESPONDENCE

Orleans County Director of Personnel and Self Insurance has sent notice of the Self Insurance Quarterly Meeting on 1/27/14 at 10:30 at the Villages of Orleans in Albion.

The Town received its share of state aid reimbursement for the Joint Youth Recreation Program in the amount of \$525.63

Monroe County Water Authority has sent notice of increase in out-of-county water wholesale rates; the meter charge per day and per 1000 gallons. Supervisor informed this will be discussed at the water workshop meeting he's requesting the Town Board schedule at this meeting.

The Orleans County Emergency Management Office has sent a request that towns track expenses for response, cleanup and restoration work performed since Sat., 12/21/13 in coping with the ice storm. The threshold for consideration of a disaster for Orleans County is about \$155,000.00; costs for New York State is about \$26 million.

Partial restitution has been received for the court loss in the amount of \$95.24. Partial restitution has been received for the cemetery vandalism in the amount of \$152.38.

OLD BUSINESS

The Town Board adopted a resolution restricting development in Ag District No. 2 within Water Improvement Benefit Area #11 boundary.

Attorney Schubel reported ownership of Brown Schoolhouse Road property 108.-1-12.23 is still a work in progress.

Supervisor Moy reported that the Fire Company has discussed COVA's request for a letter in support to expand their Certificate of Need to include Orleans County. They are taking no action; the Town determined to take no action.

Supervisor and Planning Board Chairman discussed Mr. Kibler's solar energy power system at his home on Hall Road. It is free standing and both felt it wouldn't hurt anything if it fell over. Chairman Griggs has looked into how other towns deal with the same situation. It was reported that Mr. Kibler has paid for 2014 renewal of his special permit. The Planning Board was directed to investigate all Special Permit uses; to determine if they are still needed or should be revised. Planning Board will report findings to the Town Board. Chairman Griggs informed that there are other sections of the ordinance that the Planning Board feels need to be reviewed/changed. The Planning Board is currently reviewing Subdivision Regulations.

The Town Board adopted the proposed Animal Control Contract with Orleans County at an annual rate of \$2766.24; payable in two (2) equal payments, the first payment being due on or before July 1, 2014 and the second payment being due on or before December 21, 2014. This agreement shall terminate on 12/31/2014.

Supervisor Moy was referred to the Orleans County Treasurer if he wanted to comment that Clarendon was the only town to pay the dog court fees last year.

Supervisor presented items for discussion at the water workshop meeting scheduled by the Board to be held February 25, 2014 at 9:00 AM at the Town Hall;

Regarding WIBA 11, if Countyline Road residents (Monroe County residents) wish to hook into the new waterline, they would be in the district by signing an affidavit and no tap-in fee will be assessed. It residents wait to hook-in, there will be a tap in fee charged.

The water main is approximately 20 years old; discussion is needed regarding a plan for replacement in 20 or 30 years. Water rates need to be discussed.
