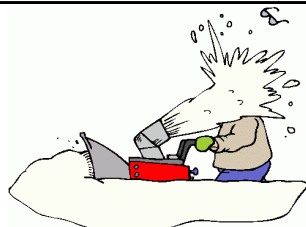

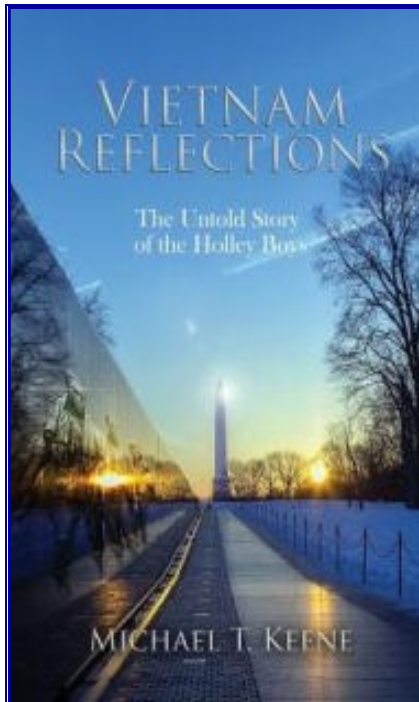

Eight boys from the rural community of Holley, New York, died fighting in Vietnam. All went to the same high school where the average graduating class consisted of just 30 students. This is believed to be one of the highest casualty rates per capita of any town and school in the United States.

CLARENDON TOWN BOARD—Meeting Highlights October 2016

HIGHWAY/WATER SUPERINTENDENT REPORT

Highway/Water Superintendent Larry Swanger reported the first snow on 11/20/16; the crew has been busy plowing. Clarendon used the county mower for a week and a few roads were graded prior to the snow. A fire hydrant was repaired on Route 31A & Fancher Road; a water tap has been installed for a new home on Glidden Road. The lawn mower for Hillside Cemetery has been delivered. There was one funeral service last month; the weather did not permit burial so the chapel is being used. Supervisor Moy commended the highway crew on the good job plowing during the storm.

PLANNING BOARD REPORT

Chairman David Griggs submitted the following written report:

Regular Meeting November 22, 2016 - A Pre-Conference was held for site plan review for a one (1) lot subdivision and property merger, (1.67 acres), SD 16-07, Robert Wilfeard, Holley Byron Road, Tax id#120.00-1-3. Chairman Griggs reviews the application with the board. The board determines that this application involved two (2) separate actions and requires two separate applications. A motion was made, seconded and approved to table action pending a second application.

Special Permit renewal, SP 10-03, Gary Westfall, 4533 Hulberton Road, Bull's Eye Deer Processing. Property has been inspected, fee has been paid, no complaints on file. A motion was made, seconded and approved to approve renewal of SP 10-03. **Regular Meeting, December 13, 2016** - A Pre-Conference was held for site plan review for a one (1) lot subdivision and property merger, (.150 acres), SD 16-08, Michael Wilfeard, Holley Byron Road, Tax id#120.00-1-4. Chairman Griggs reviews the application with the board, no issues were noted. The applicant has provided a letter waiving the pre-conference. A motion was made, seconded and approved to amend the agenda from a pre-conference to a formal application. A motion was made, seconded and approved to designate this application as a minor subdivision for SEQRA purposes. A motion was made, seconded and approved to approve SD 16-08 contingent upon filing of deed and merger with Tax id 120.00-1-3.

A Pre-Conference was held for site plan review for a one (1) lot subdivision and property merger, (1.67 acres), SD 16-07, Robert Wilfeard, Holley Byron Road, Tax id#120.00-1-3. Chairman Griggs reviews the application with the board, no issues were noted. The applicant has provided a letter waiving the pre-conference. A motion was made, seconded and approved to amend the agenda from a pre-conference to a formal application. A motion was made, seconded and approved to designate this application as a minor subdivision for SEQRA purposes. A motion was made, seconded and approved to approve SD 16-07 contingent upon pins being set, filing of deed and merger with Tax id 120.00-1-4.

Special Permit renewal, SP 12-12, Blue Top Management, 15549 East Lee Road. Property has been inspected, fee has been paid, no complaints on file. A motion was made, seconded and approved to approve renewal of SP 12-12.

SUPERVISOR REPORT

Supervisor Dick Moy asked Town Board members to consider hiring an attorney on an as-needed basis instead of paying to have an attorney on retainer. Many items that the town needs legal services for, are not included in the retainer services and the town pays an hourly rate anyway. Supervisor suggested using the Association of Towns for legal advice that would be covered by a retainer fee. It was reported that no towns in Genesee County have an attorney on retainer and just hire one when needed. Supervisor reported that the attorney retainer fee is in the budget for 2017 but would like to try the 'as needed' process for a couple months. Supervisor Moy informed that all accounts with Key Bank have been closed and in February, we will have a new rug/mat service at the Town Hall at a lower rate. In January, Supervisor Moy intends to look into forming another water district in the town. Lots are being surveyed on New Guinea Road west off of the Upper Holley Road. The Assessor and Supervisor are working on an energy program for grant funding; National Grid has a program to change street lights to LED lamps.

CORRESPONDENCE

The Town received \$58,206.34 from New York State inpayment for Snow & Ice Agreement with the town. Clarendon received \$13,225.63 in mortgage tax revenue from April 1 through September 30, 2016. The Orleans County Health Department sent results of its Clarendon Water System inspection. Chatfield Engineers has again requested appointment as town engineer; Supervisor reiterated that Clarendon hires engineering services on an as needed basis and does not appoint a town engineer.

OLD BUSINESS

The Board adopted a resolution requesting a lower speed limit on Upper Holley Road and Upper Holley Road Extension; this will go to the State DOT through the County Highway Department. The Board adopted a Resolution repealing Local Law 3 of 2016; Outside Storage of Unlicensed Vehicles; the State will continue to allow one unlicensed vehicle. The Planning Board will start looking into language for the town zoning in regard to the mobile manufactured/single family homes allowed by New York State; the town currently has a moratorium in place.

NEW BUSINESS

The Board authorized payment of year-end bills and authorized the selling of a cemetery urn by the Historical Society as a fundraiser. Eric Bradshaw was reappointed to the Planning Board for a five year term; to expire 12/31/2021.

The Town Board held its Organizational Meeting on Tuesday, January 3, 2017. Annual appointments and designations were made. The minutes are available at the Clerk's Office upon request.

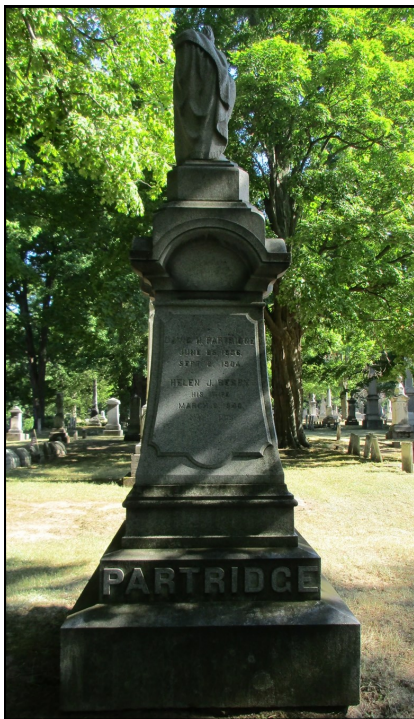




Hillside Sketches

One can't speak about **David Partridge** (1836-1904) without speaking about his wife **Helen** (1840-1916). Both were ar-

dent supporters of the Baptist Church; Helen being very active before David arrived in Holley in 1852. Four years later he joined the church. David and Helen, daughter of John and Rhoda Berry, dedicated many hours to their beloved church. Helen was recognized for her efforts when the Baptist Society presented her with a silver tea set, nicely engraved. David held every possible lay position, and was instrumental in the building of the new Baptist Church located on Geddes Street. Not only was David an original stockholder of the new Hillside Cemetery, but loaned it fifty dollars with interest at \$3.50 a year. The loan was paid in full by January 2, 1870. The agreement was signed by John Berry, President and Orange Eddy, Treasurer. David's love of music caused him to



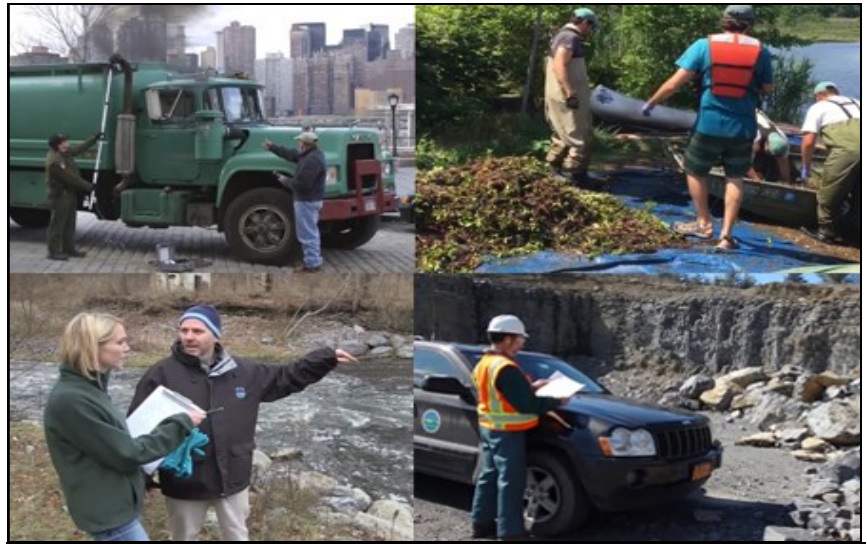
lead the church's choir, and to start the first band in Holley. To honor him, the band members named their group the David H. Partridge Band. He served as a trustee in the village and a member of the school board.

Helen

taught in the Academy before her marriage. She and her husband both attended the school. When the Academy's alumni association formed in 1901, Helen was president for several years.

David was born in Galway, NY; Helen was born in Holley. They are buried in the Berry plot with their names prominently engraved on the obelisk.

Roy Bubb's latest book, *The Family Scrapbook: An Era in Holley's History* will cover more detail. Anticipated publishing date is Spring 2017.

An Open Letter To The Residents Of Clarendon From Your Highway Superintendent

For your safety and well being during inclement weather, you should reduce your speed and drive according to the highway conditions. Winter driving conditions with icy and snow covered roads require more driving care.

If your vehicle becomes stranded, contact the Orleans County Sheriff's Department at 589-5527 and they will notify the appropriate Highway department.

SNOW REMOVAL

The law regarding the depositing of snow on highways, shoulders or ditches is as follows: "Section 1219 of the Vehicle and Traffic Law and Section 214 of the Highway Law of New York State specifically prohibit the placing or leaving of snow, ice or other substance upon any highway (which includes pavement, shoulders and ditches).

As a result, should these practices occur, Police Agencies will be notified of such occurrence(s) with the intent that summonses will be issued to the responsible person or persons.

MAILBOXES

Mailboxes damaged during snow removal: During and after significant snow storms, Highway Departments, in the course of plowing, receive phone calls regarding damage to mailboxes, either from snow plows: directly or from the force of snow being thrown by the plows. If such damage is indeed caused by snow removal, it is not done intentionally but is an unfortunate consequence of snow removal.

As far as the Highway Department replacing damaged mailboxes, it must be pointed out that there is no statutory or legal authority which grants a property owner or resident along a public highway any right to place a mailbox in a highway right-of-way.

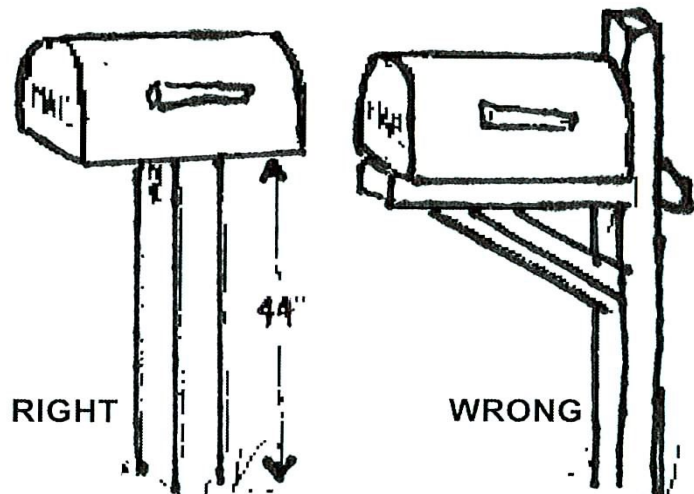
That the mailbox is on town or county right of way as a courtesy to the postal service.

Thus, when the necessity of keeping the highway open conflicts with the individuals reception of the mail the latter must stand aside. The owner might even be compelled to remove the box under Highway Law #319.

From past experience, we have found that plastic mail boxes do not withstand the abuse of snow from the plows hitting them and are not recommended.

As a courtesy, the Highway Department will place a temporary box so that a resident can receive mail if their box is damaged by the plow but we will not replace any, fancy mailbox or post.

Mailbox posts with fancy supports are not recommended as they stick down under the box and give the wing plow something to get hold of. A box mounted directly on top of a treated 4 x 4 is the best. Please note illustrations. For further information contact your Highway Superintendent at 638-8547.

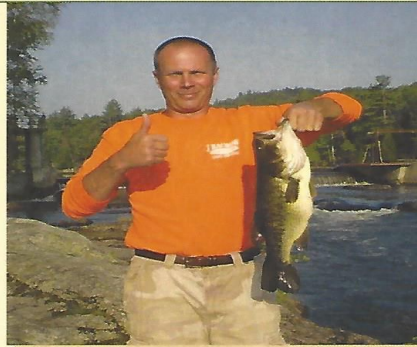
