## CLARENDON TOWN BOARD—Meeting Highlights December 2015

**HIGHWAY DEPARTMENT REPORT**—Superintendent Swanger reported that the highway crew has completed the new roof; their efforts have saved the Town \$20,000 as opposed to hiring the job done. The Town of Murray loaned their lift for the project. The Town helped the county put shoulders on Bennetts Corners and South Holley Roads. Two graves were dug and residents in Water Improvement Benefit Area have been hooking in. The unsafe barn structure on Church Street has been taken down.

**HISTORIAN/HISTORICAL SOCIETY REPORT**—Historian Ierlan reported that Russ Bosch and Jim Moore winterized and closed the Schoolhouse museum for the season and the Society is planning events for 2016. On the second application, we have received a matching grant of \$126,210 for the Hillside Cemetery Chapel Restoration Project from the NYS Office of Parks, Recreation & Historic Preservation. It will cover the chapel renovation but not the outdoor lights or stained glass windows. With monies in the Cemetery Association account, grants received and money from Historical Society fundraisers, less than \$10,000 is needed to complete the project. Supervisor Moy expressed appreciation for all the hard work Historian Melissa Ierlan and Erin Anheier have put into this restoration. Supervisor Moy suggested proposals for the windows be obtained so work can be done in the spring. Melissa reported the County Historian's big effort in getting all historians in Orleans County together. Brenda and Larry Swanger have lent baseball uniforms worn for St. Mary's by Brenda's father, former Highway Superintendent Gunter; they are on display in the Town Hall foyer.

**PLANNING BOARD REPORT**—*Regular Meeting Nov. 24, 2015* Per direction from the Town Board the Planning Board reviewed Article III, Section 301, Application Procedures for Building Permits and formulated possible revision language to re-enforce building permit requirements. Chairman Griggs to submit to the Town Board for their consideration.

*Regular Meeting Dec. 8, 2015* \* SD 15-10, Pre-conference for a two (2) lot subdivision, tax ID# 120.-1-56, Munger Road, L. Stebbins Farms LLC. No issues were noted with this proposal. A letter is on file from the applicant requesting move to a formal application. A motion was made, seconded and approved to amend the agenda from a pre-conference to a formal application. A motion was made, seconded, and approved to declare this application as a minor subdivision (Type II SEQRA action). A motion was made, seconded and approved to approve this application contingent upon the following; verification by the OIO that all pins have been set, revised drawings submitted for approval indicating 1- re-numbering of lot 1 (as 1 & 1A), 2- Notation of Z hook of parcels 1 & 1A, 3- verification by the OIO of the creation and filing of appropriate deeds with the County. \* A motion was made, seconded and approved to recommend to the Town Board for their consideration and approval the appointment of Kevin Johnson to a five year term on the Planning Board, term to expire 12/31/2020. \* A motion was made, seconded and approved to accept the Planning Board meeting calendar for 2016 as submitted.

**SUPERVISOR REPORT**—Supervisor Moy reported repeatedly sent resolutions to the State and Senate regarding the tax cap formula. Supervisor suggests towns do the same as the highway superintendents do every year and go to Albany and lobby for a change in the tax cap.

### CORRESPONDENCE

The town has received the NYSDEC's inspection report of the Holley Power Plant Dam; the first to have been done since the 1970's. The NYS Department of Public Service has sent information on its winter outreach and education campaign designed to provide energy efficient and financial assistance information to help consumers during the cold weather months. Informational publications have been ordered.

The Village of Holley has sent a report and \$410 in state aid reimbursement funding for the Joint Youth Program. Discussion was held regarding the Christmas decorations. Superintendent Swanger stated they need uplift.

**OLD BUSINESS**—Chatfield Engineers is obtaining agency permits needed for Water District 9 extension. Funding will be sought in the spring with Municipal Solutions and Attorney Essler's firm will handle the bond counsel work. Supervisor Moy reported having a lot of information regarding Monroe County Water Authority. Discussion was held as to whether or not this Board should deal with MCWA takeover of Clarendon water system or let the future Board handle it when the system gets older; WD#2 is 21 years old and the lines look as good as when put in but the bolts and valves are going. MCWA has done an assessment already. Superintendent feels it is a big drain on the highway department and that he should have one more employee if the town were to keep the water department. Supervisor Moy will put the data together to consider the options in January: 1. Go with Monroe County Water Authority. 2. Keep the water system and when the time comes to replace lines, raise the funding. 3. Build money into collections now for future use in replacing waterlines. The Board authorized Attorney Essler to prepare a zoning amendment to require a building permit for all structures 64 square feet or greater.

**NEW BUSINESS**—The Board was in favor of requesting the pictometry fly-over be done in the spring prior to the countywide town assessment updates. The Board authorized payment of year-end bills.

Kevin Johnson was reappointed to a five year seat on the Planning Board. A resolution was adopted extending the snow and ice agreement with the NYSDOT. Supervisor Moy reported writing and delivering a letter to Senator Rob Ort requesting funds through the Municipal Facilities Capital Funding Program to assist in repainting the water tower. Clarendon was the first town to submit a request. The Board directed Supervisor Moy to send a letter to Governor Cuomo requesting a change in the tax cap formula used at budget time and a Resolution was adopted affirming the Highway Equipment Inventory conducted by Councilmen Robinson and Major.

The 2016 ORGANIZATIONAL MEETING was held on January 4<sup>th</sup>. Annual designations and appointments were made. The board determined the ceiling for town contribution to employee health benefits. The board accepted the contract for Code Enforcement Services proposed by Ms. Ierlan and accepted Attorney Essler's agreement for legal services. A Faithful Performance of Government Officials Resolution was adopted resolving blanket and surety bond coverage for fraudulent or dishonest acts of employees and officials. Supervisor Richard Moy was re-appointed to a two year term as Marriage Officer for the Town of Clarendon.

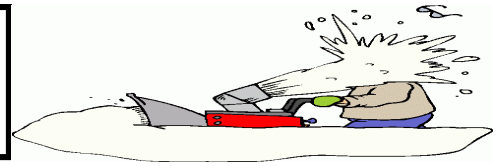

# Holley Central School District

*Soaring to Success*

During December, Holley High School's Current Events class held a series of mock presidential debates before determining a final winner. Students were assigned the roles of presidential candidates, presidential advisors or moderators. The candidates worked with their advisors to prepare for each debate. The Republicans endured three rounds of debates, while the Democrats had one, due to the number of candidates running. Debate times were restricted to one class period each day when the Middle School/High School Auditorium was available; students from other classes made up the audience. Students voted on their cell phones to determine the winner of each debate. The moderators played an important role in breaking any ties in voting.

Current Events Teacher Nick D'Amuro invited the Holley faculty and staff to watch the series of debates. He was pleased with the support from them as well as the students. "I am so happy to hear students, who aren't even in my class, talking politics around me," said D'Amuro. "I am so excited that our students are going above and beyond to discuss the current political climate." District Superintendent Robert D'Angelo agrees. "Nick and his students did an outstanding job with each and every debate," said D'Angelo. "I was very proud to attend them and was impressed with the number of students and staff in the audience each time. This activity was a perfect example of authentic instruction and learning. I am confident that our students' knowledge of both the political issues surrounding this presidential election as well as our political process have been greatly enhanced by these debates."

Sophomore Matt DeSimone portrayed Republican Senator Ted Cruz and went up against senior Ross Pinson as Democratic Governor Martin O'Malley in the final round. They discussed issues such as immigration, gay rights, terrorism, national debt, gun laws, health care, the middle class, jobs and religion. Moderator Mikala Smith, a senior, kept the candidates on task while D'Amuro kept track of time. DeSimone was determined the winner with 67 votes against Pinson's 37 votes. "The students in our district tend to lean towards the ideals of Cruz on several subjects," said D'Amuro. "I expected Ross to have a hard time convincing them, but he wanted to meet the challenge head-on. I am so pleased with both of their performances and their rebuttals to each other. I think both of them could end up serving in public office if they wanted to go that route."

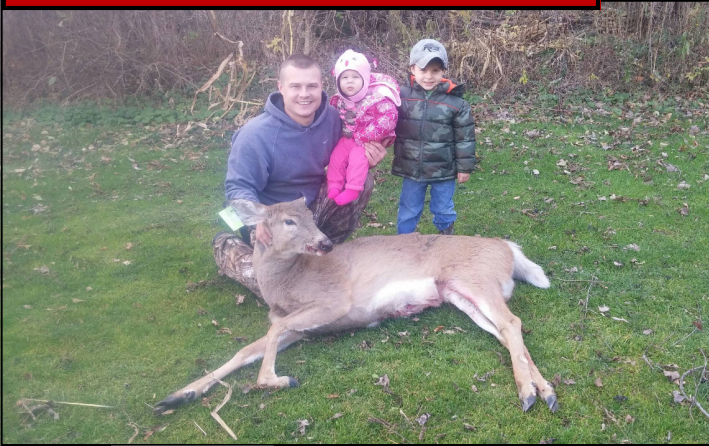
## Hillside Sketches

Near the back of one of the terraces in Hillside is a handsome stone memorializing the Eddy family. It reminds me of a Greek temple with Corinthian columns supporting an entablature. On small gables on the front and back of the stone are lovely relief carvings of an oak branch and acorns. The oak tree and leaves have been used to symbolize strength, endurance, eternity, honor, hospitality, faith and virtue.



The head of the family was **Orange A. Eddy** (1832-1884). He was a lawyer who bought an interest in the Holley Exchange Bank in 1882. He served on the Village of Holley Board and was the chairman in 1867. He was a member of the Holley Lodge # 100 A.O.U.W. (Ancient Order of United Workman, which evolved into Pioneer Mutual Life Insurance Company) and the Holley I.O.O.F. (Independent Order of Odd Fellows) and served as Justice of the Peace for several years, being elected in 1865. Significant to Hillside, he was Secretary of the Holley Cemetery Association when it created our cemetery. He was described in his time as "a gentleman of the strictest integrity, a good lawyer, and he has the entire confidence of the community where he resides, and is entitled to the confidence of all." Also listed on the stone is his wife, **Harriet M. Hendrick** (1834-1903) whom he married September 13, 1866. Two daughters are also included. Their daughter, **Grace Augusta Eddy**, died in 1875 at just four years old. Their daughter, **Mary Eddy Cady**, who had married dentist Frank W. Cady, survived into her forties and died in 1913.

**An Open Letter To The Residents Of Clarendon From Your Highway Superintendent**

For your safety and well being during inclement weather, you should reduce your speed and drive according to the highway conditions. Winter driving conditions with icy and snow covered roads require more driving care.

If your vehicle becomes stranded, contact the Orleans County Sheriff's Department at 589-5527 and they will notify the appropriate Highway department.

**SNOW REMOVAL**

The law regarding the depositing of snow on highways, shoulders or ditches is as follows: "Section 1219 of the Vehicle and Traffic Law and Section 214 of the Highway Law of New York State specifically prohibit the placing or leaving of snow, ice or other substance upon any highway (which includes pavement, shoulders and ditches).

As a result, should these practices occur, Police Agencies will be notified of such occurrence(s) with the intent that summonses will be issued to the responsible person or persons.

**MAILBOXES**

Mailboxes damaged during snow removal: During and after significant snow storms, Highway Departments, in the course of plowing, receive phone calls regarding damage to mailboxes, either from snow plows: directly or from the force of snow being thrown by the plows. If such damage is indeed caused by snow removal, it is not done intentionally but is an unfortunate consequence of snow removal.

As far as the Highway Department replacing damaged mailboxes, it must be pointed out that there is no statutory or legal authority which grants a property owner or resident along a public highway any right to place a mailbox in a highway right-of-way.

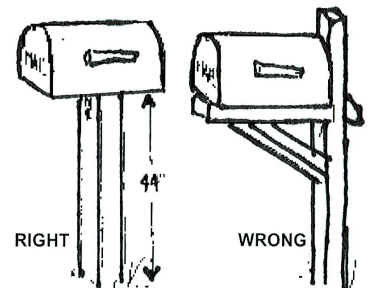
That the mailbox is on town or county right of way as a courtesy to the postal service.

Thus, when the necessity of keeping the highway open conflicts with the individuals reception of the mail the latter must stand aside. The owner might even be compelled to remove the box under Highway Law #319.

From past experience, we have found that plastic mail boxes do not withstand the abuse of snow from the plows hitting them and are not recommended.

As a courtesy, the Highway Department will place a temporary box so that a resident can receive mail if their box is damaged by the plow but we will not replace any, fancy mailbox or post.

Mailbox posts with fancy supports are not recommended as they stick down under the box and give the wing plow something to get hold of. A box mounted directly on top of a treated 4 x 4 is the best. Please note illustrations. For further information contact your Highway Superintendent at 638-8547.

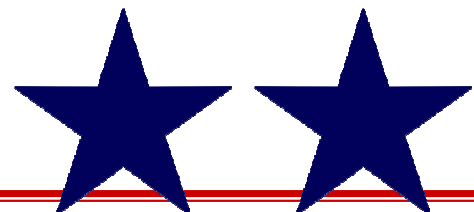

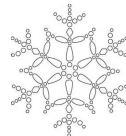
