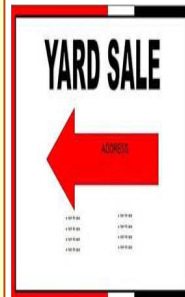

CLARENDON TOWN BOARD—Meeting Highlights June 2016

The Town Board held a public hearing for proposed Local Law No. 2 of 2016 entitled a Local Law to Establish a Moratorium on the Installation of Mobile/Manufactured Homes Outside Mobile/Manufactured Home Parks. No comments were given. The Board adopted said local law at the regular meeting following the hearing. It will be in effect for one year from the date of filing with the State.

HIGHWAY DEPARTMENT REPORT

Superintendent Larry Swanger reported completing four new waterline hook-ups in different districts. WD9 extension is in and passed the pressure testing at 150 pounds for two hours. Samples have tested good and we're waiting for Health Department approval so residents can hook in. The first roadside mowing is complete and portions of Powerline Road have been paved with help from the county and other towns. Crusher run has been added to Transit Road; it's been too dry to grate the roads. Councilman concern was discussed about the condition of the roadway in front of Thomas Estates on NYS Rte 31A. Superintendent will call NYSDOT to see if there are any plans to fix it. Supervisor Dick Moy informed that Village of Holley Mayor John Kenny is retired; the new Mayor being Brian Sorochty. Supervisor intends to go to a Village Board meeting and thank the Village for their help and 'cooperation' with the construction of Water District No. 9 extension; Highway/Water Superintendent Swanger will attend also.

PLANNING BOARD REPORT

Chairman Dave Griggs submitted the following written report:

Regular Meeting May 24, 2016 - Meeting cancelled due to lack of sufficient agenda items

Regular Meeting June 14, 2016 - The Planning Board held a pre-conference for a Two (2) lot subdivision SD 16-03, Duane Feor, 4763 Bennetts Corners Road, tax id 99.-1-50.11. After review of survey map the Board found no significant issues with this proposal. The applicant had requested to waive the pre-conference and move to a formal review. A motion was made, seconded and approved to declare this as a Minor Subdivision. A motion was made, seconded and approved to amend the agenda from a pre-conference to a formal application. A motion was made, seconded and approved to approve application contingent upon receipt of new survey maps indicating that all pins had been set, copy of new deeds.

The Planning Board held a pre-conference for a site plan review for the construction of a 24' x 30' pole barn, SD16-02. Robert Thompson, 4789 S. Holley Road, tax id 99.-1-37. After review the Board found no significant issues with this proposal. The applicant's representative (D.

Feor) requested to waive the pre-conference and move to a formal review. A motion was made, seconded and approved to amend the agenda from a pre-conference to a formal application. A motion was made, seconded and approved to approve application.

Special Permit renewal, SP05-01, Chris Neff, 5360 Upper Holley Road, auto repair shop. Fee paid, no complaints, inspected by the OIO. A motion was made seconded and approved for renewal.

HISTORIAN/HISTORICAL SOCIETY REPORT

Melissa Ierlan, Town Historian and President of the CHS submitted a written report: I am thrilled at the news received today that we have been awarded a marker for Hillside Cemetery. This would not have been possible without the hard work and dedication of Mr. Tim Archer and his 7th grade class from Albion Middle School. He was looking for a project and our County Historian Matt Ballard suggested he contact me. I visited his classes one day and spoke about history and its importance and then we worked on the wording for the marker to submit an application for grant funding. The CHS was the submitting group as we are a 501-C3 organization and were able to sponsor the kids. This has been a difficult process and one we thought may not happen due to some facts that could not be verified with enough primary source documents. The Pomeroy Foundation is very thorough and also very helpful. When it came down to whether or not we would give up, simply dropping one word made the difference and Susan Hughes then changed a few things around to make the statement work. We are very grateful to everyone who worked on this and I hope to work with Tim again in the future!

PRESS RELEASE**DEC Prepares Students for Hunter and Trapper Education Courses
New Homework Program Will Help Provide a Solid Footprint for Becoming a Safe and Ethical Hunter and Trapper**

Beginning in 2016, all Sportsman Education courses will require students to review course materials and complete a homework sheet prior to attending the classroom and field sessions. The new homework portion of the course is designed to present an introduction to the subject and enhance the students' understanding of the course material. Proof of the completed homework is required in order to enroll in the classroom and field portions of the course. Students should register for the course well in advance in order to allow time to complete the homework requirement, which takes about 3 hours. All courses also require successful completion of an in-person field day to earn certification. You can download the free manual and worksheet at <https://www.hunter-ed.com/newyork/manual>. With more than 300 courses completed so far this year, the homework requirement is proving to be popular with many instructors. "With the homework now being completed prior to the class, the students are far better prepared for the classroom session," said Saratoga County instructor Bill Schwerd. "This is an improvement over the previous delivery of the course, where students got their training manual at the first class session and didn't have a chance to read it prior to the class." Master Instructor Eric Minton from Niagara County said, "I coordinated a Hunter Education course in February of this year with the homework requirement for all students. Every student had their homework worksheet completed when they arrived at the first class. The students were better prepared and more readily engaged in classroom presentations, and the course was reduced from three sessions to two. With more time for field exercises, we were able to offer students more hands-on training." We simultaneously ran our election for Chancellor of the Chapel all month and the winner was announced at Flag Day in June. The Holley Elementary Student Council took the Chapel on as their civic project for the year and it was a huge success. They decorated small donation boxes as stained glass windows and local businesses had them on their counter for people to donate. They had a read-a-thon and raised money and then we did the election. Sally Martin, Larry Dabney as well as support from school Principal Karri Schiavone made all the difference. CHS member Denise Bedard came up with the idea of the election and we worked with the kids to make signs and ballot boxes. Local businesses again participated as well as the faculty from both schools. We had a meet the candidates night and it was a great success. The kids raised over \$2600 for the chapel restoration and even better than the money was the fact that the kids got involved, got excited and really were invested in the goal. They understood the difficulty of trying to make a difference but they also saw that no matter what, everyone CAN make a difference. We are shaping future generations to appreciate and preserve what we have. Our June program was well attended, around 50 people for our speaker Richard Riesem who did a presentation about Myron Holley. It was quite interesting and he did a book signing at the end. I was asked to participate at the Holley Library and do a class about genealogy. They received a grant and scheduled programs through the summer. They will be able to offer Ancestry.com in the library for people who want to do research on their family tree. The class was well attended and I was able to explain to them the difference between the duties of a government appointed historian and a person who does genealogy. The Town/Village Clerks are responsible for inquiries on genealogy. When the clerk finishes giving out the request information, often times she will ask me if I have any other information on the family name. We work very well together to try and provide people with good information. I have several students who have volunteered to help out doing projects over the summer with my historian files and at the Historical Society setting up some new displays. We have some needs at the meeting building in terms of plumbing. There are some maintenance things that we need to have done and are looking for volunteers to help out if they can.

The next month speaker for the Historical Society is Danny Mawn, talking about the Holley Water Works.

CORRESPONDENCE

Invitation to the Orleans County Veteran Service Agency Open House on June 27, 2016 from 5-7 pm was received. Resident Pat Giglio commented that the new Director, Earl Schmidt, is very, very good. The Town’s share of Mortgage Tax Receipts from the County, for the period October 1 through March 31, 2016 is \$9223.75. The Town has received payment for first mowing and 2016-2017 sanding/plowing from the County in the amount of \$88,349.47. Notice was received that the Orleans County Planning Board cancelled its regular June meeting. NYS Taxation and Finance Office of Real Property has sent notice of 100% Tentative Equalization Rate for Clarendon. New York Municipal Insurance Reciprocal (NYMIR) has sent an accounting statement covering the fiscal year of 2015.

OLD BUSINESS

The Town Board approved the engineering service proposal from Chatfield Engineers for the Water District #9 ext. project; they are under budget. Proposed Local Law No. 2 of 2016 was adopted.

NEW BUSINESS

Les Mandracchia requested that the Town return to him the flagpole that his father put up in the Hillside Cemetery in 1970 to honor his brother’s service in Vietnam that took his life. The flagpole is no longer used as Jacob Crandall constructed the Veterans’ Memorial for his Eagle Project. Mr. Mandracchia would like to use the pole at his home; Town Board in agreement to let Mr. Mandracchia have the pole. Superintendent Swanger will remove it from the ground. The Board approved a three year renewal with Nick Penna to lease/farm property at Hillside Cemetery. The Board authorized an alternative rate for VSP eye insurance coverage renewal; the premiums are lower, the copay increased by \$5/visit. Employees with the coverage had discussed the options and requested this change.

REBATE CHECKS MIGHT BE DELAYED UNTIL FALL

ALBANY-New York wants to give homeowners still waiting for a tax rebate an IOU; You will get your check in the fall. As New Yorkers complain about not receiving the checks that were all supposed to be sent out by February, the state tax department offered a new option for homeowners: You can wait until the fall when the next round of checks go out. On its website, the state Department of Taxation and Finance quietly announced plans to combine all rebate checks under \$50 with the new round of checks expected to ship out later this year. The checks for 2015 were the second year of a 3-year, \$1.5 billion program to provide rebates to homeowners for their growth in property taxes. But some checks have languished. So now the state is saying you can simply wait and have the outstanding checks folded into the new ones. The new checks will cover the third year of the program, plus a new incentive in which homeowners receive a rebate based on their household income. "To obtain processing efficiencies, the department will be combining all remaining 2015 property tax freeze credits under \$50 with the 2016 property tax freeze credits and the 2016 property tax relief credits to produce combined checks that will be mailed to eligible taxpayers in the fall of 2016" the department said. They offered people an option though. If you really want the check that's under \$50 you can call and ask for it. "Taxpayers who wish to receive their 2015 property tax freeze credits as stand-alone checks before the fall of 2016 should call the Tax Department at (518) 453-8146" the agency said. Some homeowners still waiting for their checks were miffed by the latest change by the state. They have reported calling the state's hotline repeatedly in recent months to demand their checks, but said they have gotten nowhere. "If we owed it to the state, they would be hounding us and applying all kinds of penalties. But since it's the other way around, we're supposed to be patient?" said Anne DeVico of Greece.

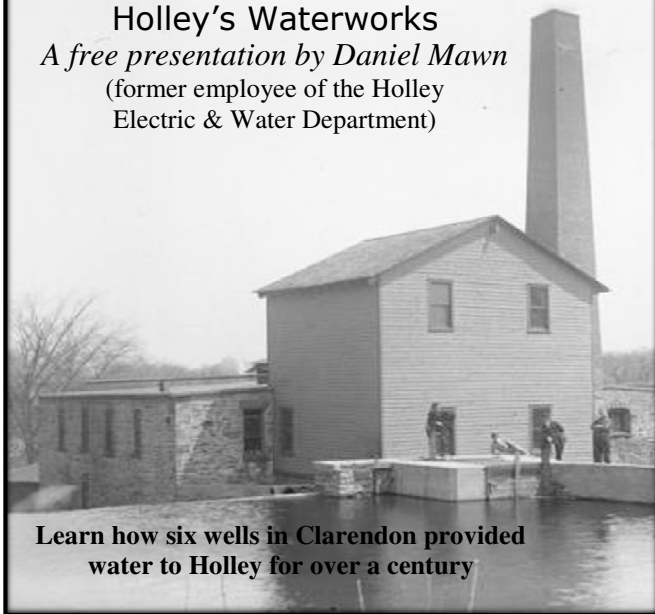

ONE OF THE LAST OF “THE GREATEST GENERATION”

If you happen to stop for morning coffee at Crosby’s or frequent Sam’s Diner in the morning, you are likely to see Joe Andreano chatting with the guys and playing the numbers. Joe likes to meet new people and will quickly tell you that he is 97 years old (as of May 16th) and still driving. Joe is one of the last of “the greatest generation.”

Joseph Angelo Andreano was born on May 16, 1919 in Rochester, NY, the number five of seven sons to Cosmo and Michalina Andreano. Joe has been a Clarendon resident since 1969 and he now lives with his wonderful wife Grace on the South Manning Road. They were married in August 1944, and will celebrate their 72nd Anniversary this year. Clearly they are both still in love. Grace is still a very beautiful woman and still looks like the beautiful bride in the photo hanging on the living room wall. When I asked Grace the secret to their obviously successful marriage, she said “Marriage is *all* give and take. You need to discuss things and work them out together. It takes work and nothing worth it is easy.” Grace is an amazing, vital woman who clearly enjoys keeping her home lovely and is very proud of her husband Joe’s accomplishments. Joe left high school in tenth grade and went to work as a mason contractor. He worked for the City of Rochester Urban Renewal as a rehabilitation specialist, the Building Bureau in property maintenance and then in Water Works until he retired. After retiring from the City of Rochester, Joe became New York State certified and served as Clarendon’s Building Inspector for a salary of \$25/month. He instituted the change of building permit fees from a flat \$25 each to a charge per square footage and certificate of occupancy.

In 1938 Joe enlisted in the U.S. Army. He met Grace in 1943 and they married August 10th in 1944 when Joe was home on a ten-day furlough. Joe served overseas for 1 ½ years. He was already in the Army when Pearl Harbor was bombed. In fact, he had been stationed at Pearl Harbor and just missed being there for the attack by two weeks. Joe fought in the Battle of the Bulge and served in the Army Infantry 75th Division. He’s been awarded both a bronze and silver star for his service in the U.S. Military. Joe and Grace moved to Clarendon from Rochester with their daughters Grace Lizabeth and Vinessa Jo, to escape the riots that had begun in the city. They purchased a seven room farmhouse with two barns and 65 acres of land on the Mansfield and Manning Roads, and raised their family. Residents that know him say “Joe is quite a guy!” Joe has always been an active senior citizen. At age 78, he took the high school equivalence test and earned his General Education Degree with one of the highest scores in his group. He then attended Genesee Community College, where he earned his Associates Degree in Liberal Arts & Science General Education. Joe continued his schooling and at age 82, he received his Graduate Degree in Criminal Justice from Brockport State University. Hillary Clinton was the graduation speaker and Joe has a picture of her giving him a hug. Channel 12 News out of Rochester, NY interviewed Joe about his accomplishments. When asked why he decided to go back to school at his age, Joe said it was for his own self esteem. Brockport College has claimed Joe Andreano to be the oldest person to ever graduate from their facility with a degree. Joe became an artist while attending GCC and he still loves to paint using mostly water color and some acrylic paints. A tour of his art work starts in his garage. On the walls are a variety of scenes, all skillfully painted. There are even some on the ceiling! “Just like Michelangelo.” Joe jokes. Throughout the home the walls are covered with his framed paintings. Joe’s work brings to mind the work of Grandma Moses, a renowned American folk artist who started painting at the age of 78. Joe too is an example of an individual successfully beginning a career in the arts at an advanced age. For Joe, 65 is the speed limit, not the age limit!

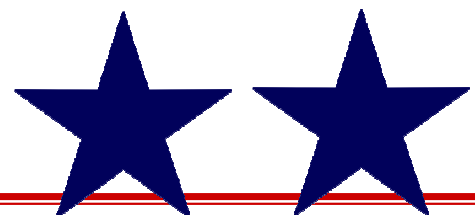

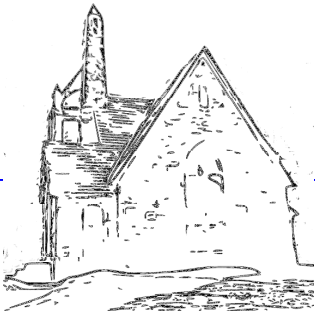

Hillside Sketches

Carl Ethan Akeley was born on Hinds Road in Clarendon on May 19, 1864 to Daniel Webster and Julia Glidden Akeley. He died on a trip to Africa on November 17, 1926. He was buried on the slopes of Mount Mikeno, in the place that he loved. Akeley is best known as an accomplished taxidermist, sculptor and inventor. He pioneered many new methods of taxidermy and museum dioramas still in use today. For Akeley, taxidermy was a tool for conservation. This meant dangerous expeditions into the African wild to study the species, document their habitats, and bring down most majestic specimens he could find for display in museum dioramas. His work for the American Museum of Natural History led to the creation of his masterpiece, the Akeley Hall of African Mammals. Among his contributions to the taxidermy world are the use of lightweight mannequins rather than sawdust to mount the skins, and the study of anatomy to achieve more life-like work. Akeley was obsessive about his methods and would not rest until the desired effect was achieved.

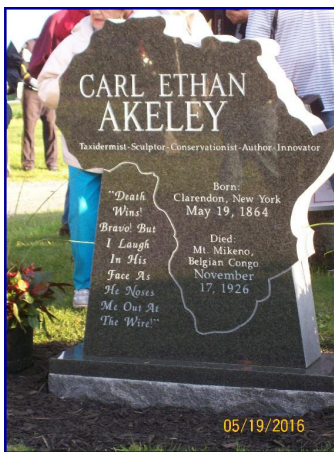
The year of the 150th anniversary of Carl Akeley's birth, an important connection was made. That connection was between the Clarendon Historical Society and Mr. John Janelli of New Jersey. An idea turned into a project with a goal. That goal was to pay tribute to Carl Akeley in the town where he was born. The town that still recognizes his name and his work. Fast forward to May 19, 2016 and a grand unveiling of a fitting monument to honor the life and legacy of this brilliant man. With a total cost of more than \$12,000 and countless hours of fundraising, planning and a bit of good luck this monument stands as a testament to the life and impact of one man on the world.
