


Clarendon Cub Scouts helped beautify the Community this year by planting the flower pots at the Town Hall. Thanks guys ~ they look wonderful!

Nick Winkley presented his Eagle Scout project at the Maplewood Pioneer Cemetery, Holley Byron Road, to the Clarendon Town Board as complete. Photos of different phases of the project were shown. Nick informed that headstones have been cleaned, small trees that had taken root and over-grown brush had been cut and cleaned out and a shadow-box display case has been built and installed. The case houses a map of the



cemetery, showing headstones and a list of persons buried there. Nick thanked Town Historian Melissa lerlan for the idea, Scott Smith Landscaping for help with the map and Stockham Lumber for donating the wood to build the case. Approximately 130 hours of work went into this project. The Scout Council has approved the project and Nick now only needs the Town's signature for completion. She holds certification as a School Library Media Specialist K-12 and is also an English Language learner, Italian being her natural language. Theresa lives in Orleans County with her husband and two young children. As a child, she was affected by adult literacy with a parent who is severely dyslexic and didn't complete any school past 7th grade. Theresa is presently taking the ProLiteracy America on-line tutor training course and in October of this year, will become an AmeriCorps member, possibly focusing on the programming needs of tutoring.

HOLLEY SCHOOL DISTRICT RESIDENTS APPROVE 2011-2012 SCHOOL BUDGET

District residents approved the 2011-2012 School Budget in Holley by a vote of 470 in favor to 413 opposed. The \$19,750,599 plan represents a 1.76 percent increase in total spending.

Proposition #1 for the purchase of school buses was defeated 375 to 503. Proposition #2 to provide funding in support of the Holley Community Free Library passed with 490 in favor and 363 opposed. Proposition #3 to authorize the establishment of a bus purchase reserve fund failed 328 to 490.

Elected to the Board of Education for threeyear terms of office beginning July 1 were Salvatore DeLuca, Jr. with 558 votes, and incumbents Robin Silvis with 533 votes, and Norman Knight with 484 votes.

HOLLEY ELEMENTARY RAISES \$1,500 FOR LEUKEMIA & LYMPHOMA RESEARCH

Holley Elementary School students and staff raised \$1,500 for the Leukemia & Lymphoma Society through the fundraiser Pennies for Patients. The Student Council organizes a penny drive every year, and every year the response in greater.

Amie Callen's kindergarten class collected the most coins - 68 pounds! So Student Council members decided to do a special flash mob dance for them as a surprise. The kindergartners cheered as Matt DeSimone, Luca Fahmer, Ryley O'Mara, and Sierra Verhagen showed them their dance moves then gave the students squishy star toys.

According to the Leukemia & Lymphoma Society, an estimated 894,543 Americans are living with leukemia, lymphoma and myeloma. Leukemia causes more deaths than any other cancer among children and young adults under 20. The money Holley Elementary raised will help fund blood cancer research, patient aid and services.

EMERGENCY CREWS ENACT REALISTIC CRASH FOR HOLLEY SENIORS

Holley seniors weren't thinking of getting their hair done or picking up their tuxedos the morning of their senior prom – they were thinking about the serious consequences of drinking and driving. Assembled in the Holley Middle School/High School parking lot, they sat and watched as a deluge of emergency vehicles arrived at a staged car crash. First, the Holley Police Department and State Police arrived on the scene. Then the Clarendon, Holley and Hulberton Fire Departments, Holley Ambulance, and Monroe Ambulance Advanced Life Support arrived – sirens blaring and lights flashing.

Inside the car were seniors Sean Brooks, Brandon Comden, Danielle Oliver, and Nick Troup, who volunteered to play the occupants of the car that caused the crash. "I never want anything like this to happen," said Sean, who played the driver of the car. "It's a weird feeling being pulled out of a crushed car." Wearing fatal vision goggles, which give the illusion of being intoxicated, Sean took a breathalyzer test, was handcuffed, and then put in the back of a police car.

After rescue crews used the Jaws of Life to pry open the mangled car, Brandon and Nick were removed, placed on stretchers, and put in the ambulances. When the fourth passenger, Danielle, was taken from the car, a hearse from Christopher Mitchell Funeral Home arrived to transport her body. "It was very scary," she said.

Holley Police Chief Rick Cary said rescue crews responded to the staged scene with \$3.5 million in equipment. "In the 10 years we've been doing this in Holley, we've never had an alcohol related incident on prom night," he said.



CLARENDON HISTORICAL SOCIETY REPORT

James Moore, President

President Moore reported that Historian Ierlan has again arranged for the Society to host a field trip to the Museum Site for the Holley School fourth graders on June 6th and 7th. This year, the PTSA is funding the trip as there is no money in the school budget for it, this year or last year. Supervisor Moy teaches the students what "old time school" was like.

The Town Board accepted a proposal from Clarendon resident, Gary Germeo, to tear down the burned structure at 4513 Hulberton Road and haul it away in dumpsters at a total cost of \$4125.20. Mr. Germeo stated the job could be done in one day: that once the burned house is down, he'll push the foundation in. As the Fire Company has training on the ladder truck at that site on the 25th of May, work will not begin until at least the 26th. Mr. Germeo will have a Certificate of Insurance faxed to the Town Hall.

HIGHWAY/WATER DEPARTMENT REPORT

Larry Swanger, Superintendent

Superintendent Swanger reported that the highway crew has patched roads and beavers have been flooding Wood Road; that problem is being taken care of. Most of the roads have been grated again and crusher run has been added. Because of the rain, the highway department is behind about a week; Superintendent intends to re-grate the roads. Most of a week was spent cleaning up after the wind storm. A few trees and three large limbs came down in the town, but most damage was found in Hillside where four big limbs came down. One huge limb was split: the highway crew will

need to get help with the Village of Holley bucket truck to get it down. Tires picked up this year were not as many as in the past. They are piled behind the garage. The highway department dug three graves at Hillside last month. The old roller was junked at \$252/ton, bringing in \$2600 revenue for the town.

Superintendent Swanger reported turning on the water at Hillside and having to go into the Chapel basement to shut the faucet off to drain the lines. Superintendent reported urns in the basement that are rusted, cast iron: that at one time must have been in the cemetery but look like they were just thrown down there in a pile. Supervisor Moy felt they were salvageable and that the Town may be able to sell them.

Superintendent Swanger provided board members with photos of the urns. Councilman DeFilipps suggested the Town be careful with the urns and not clean them up; that they're worth hundreds of dollars. They're cast iron and probably have lead paint on them: let whoever buys them. do the cleaning. Supervisor Moy and Councilman DeFilipps will go to the Chapel and look. It was suggested Historian Ierlan put photos of urns on Craia's List to sell.

Superintendent Swanger reported trying to fix the fence at the Hibbard Road Cemetery but the bottoms broke off, so he took it down. The cast iron pieces are at the site in a pile. Superintendent reported that the Munger Road Cemetery fence is also falling down and suggested they all be removed.

Councilman DeFilipps complimented T.J. Foster on the nice job of cleaning the wood out of the cemetery. Discussion was held and town board members in

agreement that when the highway department cuts a tree down in front of someone's house or property, the wood will be given to the property owner. If they don't want it, the highway crew will haul the wood back to the garage. When it has accumulated to a large pile, the town can bid it out.

expects a great program this year with the three new individuals that have been hired to operate the programs; Lora Bower, Jessica Bower and Carm Miller.

Supervisor reported census population results for Clarendon from 2000 to 2010 to be up 7.5%; T/Yates is up 2%; V/Albion is up 1.1%; T/Carlton is up 1.1%; T/ Albion is down 10% and T/Gaines is down 9.7%. (Remaining info is available from Supervisor Moy.)

CORRESPONDENCE

Independent Oil & gas Association of NY has sent correspondence regarding the prospects of natural gas development in New York State, promoting their trade.

New York State Real Property has sent notice of STAR exemption values for 2011-2012 school taxes; Basic STAR \$30,000; Enhanced STAR \$60,100.

The Orleans County Planning Department will host training workshops on June 29th at the Albion Middle School Auditorium. Supervisor Moy will attend the workshop entitled <u>Locally</u> Unwanted Land Uses.

A partial restitution payment of \$190 has been received for the Munger Road Cemetery vandalism. Original amount due was \$15,000; this person's balance due after this payment is \$5,169.25. Supervisor acknowledged that the other person's restitution has been paid in full.

National Grid has sent an electronic copy of the proposed environmental management and construction for its transmission line reconstruction. If anyone is interested in viewing the plan, it is available at the Town Hall. Councilman Robinson reported seeing the three-legged towers being taken out; that they were originally purchased from Sears & Roebuck Co.

OLD BUSINESS

Supervisor Moy reported that all permits and approvals had been obtained for Water Improvement Benefit Area #10 when New York State determined that Upper Holley Road needs an archeological study. Supervisor explained that if any portion of the proposed project is determined to need the study, the entire waterline project (5.4 miles) needs to be done. Bids for the study obtained from Chatfield Engineers range from \$7100 to \$7800. This study can hold up progress of the project for an additional four weeks.

Historical Society President Jim Moore confirmed that the Society Board will review and rule on the proposed agreement with the town regarding historical property ownership, at tomorrow's meeting. President Moore sees no problem with the agreement and will report the CHS Board's decision at the next Town Board meeting.

Supervisor Moy informed Town Hall Roof Bids have been received and reported high-low bids as follows: For Asphalt Roof; low \$11,150; high \$27,500.

For Metal Roof; low \$12,750; high \$30,550. Discussion was held and Supervisor asked board members for individual preference of roof material. Supervisor Moy and

Councilman Nicosia were in favor of the metal roof reasoning it would last longer. Councilmen Campbell, DeFilipps and Robinson in favor of the asphalt roof reasoning it looks better. Supervisor Moy will contact the low bidder and arrange for color samples to be left at the Town Hall prior to the June meeting.

NEW BUSINESS

The Town Board amended the Fee Schedule to include the following under Planning Board Fees: Reclamation (fill) Application: \$200 fee; This will include your site Plan review and necessary inspections by the Town of Clarendon Code Enforcement Officer. Reclamation (fill) Permit (for 180 days): \$100 fee. Reclamation (fill) Permit (for period in addition to 180 days up to 365 days): \$200 fee.

The Board adopted a Resolution declaring surplus equipment and designating disposition. See front page of this Gazette for Notice.

Discussion was held regarding the Stone Store Property and Town Board intent in July 2010 to demolish the building was reviewed. Supervisor Moy informed that some residents have approached him about the historical building. A public informational meeting was scheduled for July 19, 2011. See front page of this Gazette for Notice.

It was confirmed that the Town has not yet received a check from Hanson for the 10% due from 2010.
