

Tickets go on sale April 1, 2016, for the annual **"Raise a Glass for Reading"** Wine Tasting and Farmers' Market at the Community Free Library in Holley, NY, scheduled for Friday, April 28, 2017, from 7-9 p.m. Community members will have the opportunity to taste wines, meads and beers, shop with local farmers and entrepreneurs, listen to music, have fun with friends and support the Summer Reading Program.

This sell-out annual event, held on the last Friday in April, provides funding for the library's summer reading program for children. Because of the success of previous wine tastings, the Library has been able to double the number of programs offered to children throughout the summer, going from six to twelve. Each child who attends five or more programs and documents his/her summer reading will receive a free book. Special programs are being planned to attract area teens. The theme for the summer reading program is "Build a Better World."

The 2017 event welcomes the two new stops on the Niagara Wine Trail- Black Willow Winery and Meadery (Burt), and Vizcarra Vineyards and Becker Brewing Company (Gasport). Returning are favorites Leonard Oakes Estate Winery (Medina) and Schwenk Wine Cellars (Kent). All four of this year's vineyards have won awards at State or Nation wine competitions!

As a Farmers' Market, this event will provide attendees with the opportunity to find out about alpacas as well as purchase alpaca products from Stoney Meadows Alpacas. They will also be able to visit with Lora Partyka from Partyka Farms, find out about this year's plans, purchase hanging baskets and bedding plants, jams, jellies and other products.

The event also provides a showcase for local entrepreneurs. Aromantium is an apothecary spa with a natural skin care line. Sue Sew-It-All specializes in tailoring as well as making memory bears from nostalgic fabrics.

While sampling the wines and talking to the vendors (and buying wine, mead, beer, farm products, farm products, and other gifts), guests will be able to listen to jazz, and Broadway music by Sound Foundations, featuring Wendy and Sean Williams

This highly anticipated evening has something for everyone, promoting local businesses and the Niagara and Ontario Wine trails, and highlighting community support for children's reading. # **CLARENDON TOWN BOARD—Meeting Highlights February 2017**

Attorney Jeff Martin represented Adam Johnson at the February board meeting. Mr. Johnson's special permit to operate a service business at 15549 East Lee Road was under review for renewal by the Planning Board but ended up being revoked by the Ordinance Inspection Officer for non-compliance of the permit. The Planning Board will not entertain renewal any longer as is revoked; a new application will need to be filed. Attorney Martin requested Town Board consideration for reversal of the situation so Mr. Johnson may go before the Planning Board for renewal of the permit; the zoning for the property has changed since the special permit had initially been authorized. Board members agreed that Mr. Johnson should return for the March board meeting to discuss the matter; after his court appearance and disposition.

#### **OPEN END**

Councilman Al Robinson questioned the cable box maintenance by Verizon; the boxes are broken and doors hanging off; lines in Clarendon are so old they're getting brittle. It was said the lines won't be replaced as everyone is using cell phones.

#### HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Swanger reported plowing and sanding last month; with the windy, blowing snow, freezing rain and rain, the department used a lot of salt. Two burials took place at Hillside Cemetery this month. The highway crew has been patching roads with the nice weather. The fallen barn on Church Street has been cleaned up. Superintendent will go to Albany with other superintendents on March 7 and 8 to request additional CHIPS money. The second furnace has been installed at the highway building.

- A pre-conference SD 17-02, Don Harrington, New Guinea Road, tax id# 119.-2-62.11 and tax id# 119.-2-63 for a three (3) lot subdivision. Action tabled pending further information.
- Special Permit renewal SP 96-005, Nancy Curtis-Caswell, Pet's Galore Grooming, 4880 South Holley Road. Fee paid, inspected, no complaints. A motion was made, seconded and approved to renew Special Permit.
- Blasting permit renewal, BP 02-001, Hanson. Fee paid, inspected, no complaints, blasting licenses on file with OIO. A motion was made, seconded and approved to renew Blasting Permit for a period of three (#) years.

#### Special Meeting, February20, 2017

Continued review, pre-conference SD 17-02, Don Harrington, New Guinea Road, tax id# 119.-2-62.11 and tax id# 119.-2-63 for a three (3) lot subdivision. A motion was made, seconded and approved to change agenda from a preconference to a formal hearing. A motion was made, seconded and approved to declare this a minor subdivision. A motion was made, seconded and approved to approve application contingent upon verification by the OIO of survey pins being set & filing of deeds with the county.

#### SUPERVISOR REPORT

Supervisor Richard Moy reported that the toilet in the bathroom off the kitchen at the town hall had a leak. The water seeped through the back offices; Supervisor and Court Offices. SERVPRO was contacted to do the clean-up/restoration; walls and rugs. Friday a Tripi Foods truck came through the Town Hall parking lot and ripped the electric wires down off the outside of the building. The driver called the incident in; DeFrank Electric is going to give a quote to repair the damages.

#### CORRESPONDENCE

The Orleans County Planning Board has sent a letter regarding zoning applications and its 2017 meeting schedule. New York State Ag & Markets has sent correspondence regarding the state surcharge on dog licenses; \$1 for altered dogs and \$3 for unaltered dogs is sent to the state every month. Residents Ron and Diane Whalin sent a letter regarding cable service; Legislator Eick will see if he can get a map showing the plan for cable in the county and send it to Supervisor Moy. NYSDEC has grant funding available for urban and community forestry projects and parks. The Town received \$2000 in Traffic Diversion Program revenue for the period of October through December 2016. Orleans County has sent the town share of stumpage value in the amount of \$95.26. Real Property Tax Law Section 480a Sub 5A provides whenever any cutting of the merchantable forest crop on any certified eligible tract is proposed, a property owner is to pay a 6% tax on the certified stumpage value of merchantable forest crop to the county treasurer, who allocates percentages of said value to the town, school and county.

#### OLD BUSINESS

NYS DOT has sent confirmation of receiving the town's request and will investigate traffic conditions on Upper Holley Road and Upper Holley Road Extension relative to a lower speed limit. The Board adopted a Town Animal Contract for 2017 that reads the same as the one effective for 2016 at \$2766.24.

#### **NEW BUSINESS**

Proposals for 2017 season mowing were accepted: A & K Lawn & Garden to mow seven pioneer cemeteries at a flat rate of \$2450.00; Kingdollar Lawn Care to mow the Town Park at \$40/mow, Town Hall at \$40/mow, Triangle lot on Upper Holley Rd at \$15/mow, Water Tower lot at \$20/mow; Dan Jones to mow the Glidden Road pioneer cemetery at a flat rate of \$400.00. Beth Skehan's proposal to maintain the gardens at the Town Hall for \$550 was also approved.



One of the interesting people buried in Hillside is Miss Sara Shaw (1871-1948), an

educated woman who felt herself drawn to a career of nursing, often in dangerous places. The following excerpt from Delia Robinson's book *Historical Amnesia* describes some of Sara's career:

"Sara Shaw, born about 1872, the daughter of Dennis and Ellen Shaw of Holley, was a graduate of Brockport Normal School. On May 5, 1898 in the Holley Standard it was reported that Sara Shaw, a graduate of the Bellevue Hospital training school for nurses in New York, had joined the Red Cross Hospital Service and would be going to Cuba with the army. By August 24, 1898 the Orleans Republic stated that she had been doing Red Cross nursing at Santiago and Puerto Rico but had returned home to recover from Malaria and "nervous exhaustion." On January 18, 1899 the paper mentioned that she had gone to New York City to do hospital work there. The next month she sailed from New York City on the transport Sherman bound for Manilla to nurse the soldiers in the Philippines. The final mention of her on December 6 relates that a public reception was held for her at the home of F. D. Stearns in Holley.

But Miss Shaw's service was far from finished. During World War I she set up a Red Cross Center in Milan, Italy and received a decoration from the Italian government for her efforts. She also served at Bellevue hospital in New York directing its tuberculosis division. While in New York she was active in helping orphans and boys in gangs in the city slums near the hospital, in addition to helping local families in need."



Sara Shaw was certainly a person who cared deeply about people, even to the point of putting her own health and life at risk to help the less fortunate. She is remembered by a modest granite marker in Hillside Cemetery.



#### RECYCLING

Place all recyclable materials inside the green recycling bins provided by the county. All recyclables can be placed out weekly inside the recycling bin on the same day as trash pickup. Please place recycling bin away from garbage so driver can see it.

#### <u>GARBAGE</u>

The equivalent of 6 bags or cans of normal municipal solid waste including garden and yard waste, ashes (cold ashes only), plaster, stones, bricks and building materials.

- Place garbage in 20 or 30-gallon watertight cans with covers and handles, or (3 mil minimum) plastic bags. Do not use shopping bags. Limit of 60 pounds per container. Securely tie bundles of brush and building materials in lengths of no longer than 4 feet and within a 60-pound limit.
- DO NOT INCLUDE: tires, pesticides, oils, solvents, flammable liquids, explosives, animal carcasses, fecal matter, industrial waste, other regulated hazardous waste or building materials left by a contractor.
- E-WASTE (MICROWAVES, TELEVISIONS, and COMPUTER equipment) will no longer be picked up. Please take it to the nearest Electronic Recycling facility... Open 9am-2pm Monday Friday

<u>Albion</u>- Orleans County Highway Garage- 225 West Academy Street, Albion. <u>Holley</u>- Town of Murray Highway Garage- 3840 Fancher Road, Holley <u>Medina</u>-Town of Shelby Highway Garage- 4062 Salt Works Road, Medina.

#### FOR COLLECTION

Place garbage and recyclables at your roadside, within 5 feet of the road, before 6:00 am on your pickup day. If you have a ditch in front of your property, place garbage and recyclables between the road and the ditch.

• Garbage and recyclables will be collected on the same day in separate trucks, at different times during the day.

#### LARGE ITEMS

A large item is any refuse that cannot be placed in cans or bags easily. ONLY ONE LARGE ITEM WILL BE PICKED UP EACH WEEK AT THE ROADSIDE. **Refrigerator** doors and shelves must be removed and the customer must call Modern Disposal (# below) on the **FRIDAY** prior to their scheduled pickup day. Large items will be collected on the same day as regular service and placed in the compactor truck. These items shall include, but are not limited to furniture, mattresses and box springs, carpets, appliances, Christmas trees, or carpeting (rolled and tied 4 foot lengths).

#### TIPS

Paint Cans- the lid must be off and the cans are to be set next to the trash can so the driver can see that the contents are dry. Clumpable cat litter can be used to dry up any contents prior to disposal.

Cold Ashes- must be cold and contained either in a bag or a cardboard box so the ashes do not go airborne as they are placed in the truck.

Medical Syringes- Medina Memorial Hospital takes them on Saturday mornings. Please do not dispose of these in the regular trash.

#### HOLIDAY SCHEDULE

New Year's Day – Memorial Day – Independence Day – Labor Day – Thanksgiving Day – Christmas Day. If your collection day is on or follows any of these holidays during the week, then your collection will be one day late.

#### HOW TO GET A RECYCLING BIN

A green recycling bin may be purchased for \$7.00 each from the County Real Property Office in Albion at Courthouse Square. Call (585) 589-5400. If you have built a new home, you are entitled to a free bin. Just present your property tax receipt, showing that the garbage collection fee has been paid, to the Real Property Service Office.
