HILL TALK

I no longer used cigarettes in the house or in front of the kids. The "why are you killing yourself" looks were enough to make smoking a very private matter indeed! A serious health problem along with a hospital stay finally did the trick!

Some of my aborted attempts to quit bordered on the comical. One time while we lived next to a lake I tried to wean myself gradually by placing the cigarettes on the other side of the lake under a stone. At least the half an hour trek to get to them was good for my weight and it really seemed to

work until I started to worry about whether it might rain the next day and gradually brought back emergency supplies! When I would announce that I was giving up the cigarettes I felt great for a couple of days. The proud "I've taken control of my life" euphoria carried me through the rough times but only for a couple of days. Then my Marine training would take hold (I was a line crosser in Korea for a while) and I would use all of my scouting skills to smoke without getting caught! I still had the illusion that a breath mint would hide any evidence of my transgression!

It was dangerous to our health to continue smoking back then but not a danger to stop! Now though, I have seen an ad for a medication to ease the desire to smoke but the disclaimers make you wonder if one should give it up at all!

This medication cautions that mental health problems might accompany the use and the final disuse of this product including depression, sleeping difficulties, mood changes, hostility, agitation, along with suicidal thoughts and actions! Serious heart problems could develop including some that could be life threatening! Also, you must watch out for swelling in the mouth and throat along with a rash. If any of these symptoms develop you are told to see a doctor immediately!

I'm sure glad that I stopped smoking when I did! Back then it was all for the good but now a days, smoking can kill you but stopping could also!

From the desk of the Orleans County Clerk

On January 15, 2013, New York State passed new legislation known as the (NY SAFE ACT)

NEW YORK SECURE AMMUNITION AND FIREARMS ENFORCEMENT ACT

The NY SAFE ACT includes the ability for pistol permit holders to "Opt-Out". This means a pistol permit holder can request that their information be kept private and confidential. The NY SAFE ACT protects the privacy of pistol permit license holders by permitting them to notify the County Clerk that they do not wish for their information to be released publicly. Current licensees and new applicants may make this notification to their licensing officer using the NYS Firearms License Request for Public Records Exemption form which was approved by the Superintendent of the New York State Police. The form is available on the Orleans County website at www.orleans.ny.com (click on County Clerk link), at the County Clerk's Office, Pistol Permit Clerk Office and at participating Town Clerk Offices. You may also obtain the form at the New York State Police website at www.nysafeact.com. They have also provided a Hotline number 1-855-law-guns.

In order for the pistol permit holder to "Opt-Out" and have their information kept private, the form needs to be completed in its entirety and the original needs to be mailed or dropped off to the County Clerk's Office in the County where your pistol permit is on file before April 15, 2013. If in Orleans County, the address is: Orleans County Clerk's Office, 3 South Main Street, Suite One, Albion, NY 14411. No information pertaining to licensees or applicants for a license shall be disclosed to the public from now until April 15, 2013. After April 15, the information relating to licensee and sought through a FOIL request may be disclosed unless the licensee has submitted the Opt-Out form.

The Orleans County Legislature unanimously adopted the following Resolution on the 13th day of February, 2013.



ORLEANS COUNTY LEGISLATURE Resolution No. 82-213

Opposing the Process of Enactment and Certain Provisions Contained within the New York Secure Ammunition & Firearms Enforcement Act (NY SAFE ACT)



WHEREAS the right of the people to keep and bear arms is guaranteed as an individual right under the Second Amendment to the United States Constitution; and

WHEREAS the right of the people to keep and bear arms for defense of life, liberty and property is regarded as an inalienable right by the people of Orleans County; and

WHEREAS the lawful ownership of firearms is and has been, a valued tradition in Orleans County and the rights protected by the Second Amendment to the United States Constitution are exercised by many of our residents; and

WHEREAS the people of Orleans County derive economic and environmental benefits from all safe forms of recreation involving firearms, including but not limited to, hunting and target shooting while utilizing all types of firearms available under the Constitution of the United States; and

WHEREAS, members of the Orleans County Legislature, being elected to represent the people of Orleans County, are duly sworn by their oath of office to uphold the Constitution of the united States; and

WHEREAS members of the New York State Assembly and the New York State Senate, being elected by the people of New York State, are duly sworn by their oath of office to uphold the Constitution of the united States; and

WHEREAS the enactment of the NY SAFED Act (Chapter 1 of the Laws of 2013) has engendered significant controversy over both the process by which it was enacted and certain provisions contained within it; and

WHEREAS it is our understanding that many State Legislators had less than an hour to read the legislation which contained approximately twenty-five thousand words, before being forced to vote on it; and

WHEREAS having reviewed the legislation and time constraints, it is our conclusion that there is no possible way any individual could have read the entire bill and understood its full implications prior to voting on it; and

WHEREAS our State Legislators most certainly could not have had the time to request and receive the input of their constituents regarding this matter; and

WHEREAS seeking and considering such public input is a standard to which we hold ourselves in the Orleans County Legislature; and

WHEREAS this legislation has 60 section of which only three take effect immediately; and

WHEREAS in our opinion, there was no reason for the Governor to use a message of necessity to bring this bill to vote immediately and bypass the three day maturing process for all legislation; and

WHEREAS the mishandling of the process in crafting the NY SAFE Act resulted in complex policy changes, many of which have been left up to interpretation and are confusing even to the State Legislators who voted on them and the law enforcement officials who are required to enforce and explain them; and

WHEREAS requiring law-abiding gun owners to verify ownership of certain types of firearms every five years, in addition to registering them on their permits, which now also must be renewed every five years does not increase the safety of the public and is unnecessarily burdensome to the residents of New York State; and

WHEREAS there will be a significant financial impact due to the approximately 5300 Orleans County permits that will have to be renewed requiring additional manpower and computer systems; and

WHEREAS this legislation prohibits the sale of firearm magazines with a capacity larger than seven rounds; and WHEREAS those firearm magazines with a capacity larger than seven rounds which are authorized to be retained by existing owners, may only be loaded with seven rounds and eventually must be permanently altered to only accept seven rounds or be disposed of, thus constituting a seizure of legally owned personal property with no provision for compensation; and

WHEREAS few or no low capacity (seven rounds or less) magazines currently exist for many of the firearms commonly possessed by law-abiding residents of New York State; and

WEHREAS limiting the number of rounds to seven versus ten is arbitrary and capricious, has no correlation to public safety, unfairly burdens law-abiding gun owners and puts an undue burden on gun manufacturers to retool their manufacturing plants; and

WHEREAS the only persons who will comply with the new high-capacity magazine ban are law-abiding citizens, leaving the same high-capacity magazines in the hands of those who choose not to obey the law; and

WHEREAS requiring documentation of all ammunition sales in New York State as provided for in this legislation, is a significant unfunded mandate on business; and

WHEREAS the New York State Combined Ballistic Identification System which wasted \$44 million in taxpayer money and resulted in zero convictions, illustrates the propensity of government to waste taxpayer resources when legislation is not properly reviewed, and

WHEREAS Governor Cuomo has proposed spending \$36 million dollars in his 2013-2014 Executive Budget for the implementation of the NY SAFE Act at a time when New York State residents are crying out for tax relief; and

WHEREAS this legislation severely impacts the possession and use of firearms now employed for safe forms of recreation including but not limited to, hunting and target shooting; and

WHEREAS while there are some areas of the legislation that the Orleans County Legislature finds encouraging such as addressing glaring shortcomings in the mental health system, the strengthening of Kendra's Law and Mark's Law, as well as privacy protections for certain pistol permit holders, by-and-large, we find the legislation does little more than negatively impact lawful gun ownership; and

WHEREAS this legislation fails to offer any meaningful solutions to gun violence and places increased burdens where they do not belong, squarely on the backs of law-abiding citizens; and

WHEREAS this legislation effectively turns countless New York State law-abiding gun owners into criminals; and WHEREAS the manner in which this legislation was brought forward for vote in the State Legislature is deeply disturbing to the Orleans County Legislature; now, therefore be it

RESOLVED that the Orleans County Legislature does hereby oppose and request the repeal of any legislation including the sections within the NYS AFE Act (Chapter 1 of the Laws of 2013) which infringe upon the right of the people to keep and bear arms; and be it

FURTHER RESOLVED that the Orleans County Legislature considers such laws to be unnecessary and beyond lawful legislative authority granted to our State representatives; and be it

FURTHER RESOLVED that the Orleans County Legislature strongly encourages members of the New York State Legislature to hold public hearings to address the issue of gun violence in a way that will produce meaningful results; and be it

FURTHER RESOLVED that the Orleans County Legislature requests the members of the New York State Senate and Assembly who represent all or part of Or leans County, to reply in writing with their views on and actions taken in support of or in opposition to the NY SAFE Act; and be it

FURTHER RESOLVED that a copy of this Resolution be sent to President Barack Obama, Vice President Joseph Biden, Governor Andrew Cuomo, Senator Charles Schumer, Senator Kirsten Gillibrand, Congressman Chris Collins, New York State Senator George Maziarz, Assembly Speaker Sheldon Silver, New York State Assembly members Steve Hawley and Jane Corwin, NYSAC, InterCounty of Western New York and all other deemed necessary and proper.



CLARENDON TOWN BOARD MEETING HIGHLIGHTS

February 2013

Resident Pat Gigleo complimented Superintendent and his crew on the good job done keeping the roads open with all the snow. Mrs. Gigleo requested additional Town Board meetings be scheduled during the day.

HIGHWAY DEPARTMENT REPORT

Larry P. Swanger, Superintendent

Superintendent Swanger reported plowing and sanding 24 days last month and that minor equipment repairs have been down. The first week in March will be the annual trip to Albany by the NYS Highway Superintendents Association to lobby for CHIPS money. The Town Board reviewed information supplied bγ Superintendent Swanger regarding a CAT Loader; CAT will buy back the 2-year old one for price of \$130,000. The Town paid \$131,000 for it initially. Town Board authorized exchange of the old loader and purchase of the new one. The Town will gain 2 years and a one-year warranty. Discussion was held regarding the 2013 list for pick-ups on state bid. Highway equipment was initially to be on a three year schedule but the truck has been pushed to 5 years. Truck details were discussed as was other equipment that will be needed to be replaced. The Board authorized that a new red, 1/2 ton Ford pick-up be purchased off State Bid listing for \$26,742 and the old pickup be sold.

SUPERVISOR REPORT

Richard H. Moy, Supervisor

Supervisor Moy informed that the Orleans County Chamber of Commerce will host a Home & Garden Show at the 4-H Fairgrounds in Knowlesville on April 13 and 14.

Supervisor acknowledged a very nice letter sent to the Town regarding Nick Quaranto from his wife Karen. The Steve Hawley Conference in Albany has been

scheduled for June 2-4, 2013. Supervisor and Councilman DeFilipps intend to go.

CORRESPONDENCE

NYSDEC has sent the 2012 Haight Farm Operations. Maintenance and Monitoring Report in CD format. It is available for review upon request. The Orleans County Youth Bureau is calling for annual nominations for its Youth Recognition Banquet; it will be on May 9 this year. The Orleans County Health Department has sent notice of engineering plan review fee of \$250 payable to the Health Department at the time plans are submitted, for major water system improvements. extensions or installation of new water districts. The District Attorney's Office has sent Traffic Diversion Program revenues in the amount of \$1200 for October through December, 2012. The Orleans County Health Department has sent notice of provisions and changes to the New York State Sanitary Code in regard to purchased water supplier responsibilities.

OLD BUSINESS

Attorney Schubel informed that Joe & Susan Fertitta have accepted the Town's counter offer on the Stone Store Building. The Town Board adopted a Resolution, resolving to sell the Old Stone Store property for \$1.00 in accordance with the terms and conditions of the counter offer, subject to a permissive referendum.

Supervisor reported that the Town received an A Bond Rating; that it will see a 14% (\$633,000) in savings with the bond refunding of Water Districts 2,3,4,5,6,&8. The average percentage of savings is usually 2-4%.

Supervisor Moy reviewed the cost estimates provided by Chatfield Engineers for the areas in proposed Water Improvement Benefit Area No. 11. New

estimates need to be figured, as the ones provided were estimated with an interest rate of 2.5%; current rate is 3.125%. Areas included Hinds Road from WD#5 to WD#7: South Holley Road from WD#2 to Sandy Creek; Glidden Road from Holley Byron Road to South Holley Road and 1500 feet on Merrill Road: Brown Schoolhouse Road from South Manning Road to Barre town line; Holley Byron Road from Boots Road to New Guniea Road: Howard Road and Countyline Road from Howard Road to Taylor Road and Upper Holley Road from New Guinea Road to Private Road near town line. No parcels in the Town of Sweden are included in the new estimates. Supervisor Moy will speak with the town's financial advisor then hold an informational meeting.

At a resident's request, the Town Board adopted a Resolution Opposing the Process of **Enactment and Certain Provisions** Contained within the New York Secure Ammunition & Firearms Enforcement Act (NY SAFE ACT), requesting the repeal of any legislation including the sections within the NY SAFE Act (Chapter 1 of the Laws of 2013) which infringe upon the right of the people to keep and bear arms. The County Legislature has also adopted a resolution in opposition of the same. Clarendon representatives Assemblyman Steve Hawley and Senator George Maziarz were commended for voting against the law.

The Board reviewed the farming lease for use of Hillside Cemetery land that is due for renewal in April and agreed it should stay the same for this renewal. The Board adopted a Resolution in support of Senate Bill S2026-2013 to amend the lien law in relation to filing of false liens against public officials. Supervisor Moy will form a committee and draft a technology policy for the town.
