DEC Accepting Applications for Pheasant Release Program

The application period is now open for the New York State Department of Environmental Conservation's (DEC) cooperative Day-Old Pheasant Chick Program, the DEC announced today. As part of Governor Cuomo's NY is Open for Fishing and Hunting Initiative, the program enhances opportunities for pheasant hunting in New York State through a partnership between DEC and the sporting community, 4-H youths and landowners interested in rearing and releasing pheasants. In 2013, DEC distributed 41,500 day-old pheasant chicks to qualified 4-H and sportsmen applicants.

The Day-Old Pheasant Chick Program began in the early 1900s. In the early days, pheasant eggs and chicks were distributed to farmers and rural youth. Today, day-old chicks are available at no cost to participants who are able to provide a brooding facility, a covered outdoor rearing pen, and an adequate release site. Approved applicants will receive the day-old chicks in April, May or June. No chicks obtained through the Day-Old Pheasant Chick Program can be released on private shooting preserves. All release sites must be approved in advance by DEC and must be open for public pheasant hunting opportunities. The program is funded through the state Conservation Fund from license fees paid by hunters, trappers and anglers.

Daily care is necessary to monitor the health of the birds and to ensure that there is adequate feed and water for the rapidly growing chicks. The pheasants may be released beginning when they are eight weeks old and no later than December 1. Individuals interested in these programs should contact their nearest DEC regional office for applications and additional information.

Applications for the Pheasant Release Program must be filed with a DEC regional wildlife manager by March 15, 2014 (see contact information below). A "Pheasant Rearing Guide" and additional information on the Day-Old Chick Program is available on the DEC website.



Incidents Continue to Decline

Reports on the number of hunting-related shooting incidents indicate that 2013 had the lowest number on record in New York. There were 19 incidents in 2013, including two fatalities. The tragic fact that two of these incidents were fatal reminds us that the difference between a minor injury and a fatal gunshot wound can be a matter of inches.


A further evaluation of the incidents showed that 14 (74%) were self-inflicted, 3 (16%) involved members of the same hunting party (friend/family), and 2 (11%) where the victim and shooter did not know each other. Ten incidents (53%) occurred while deer hunting. The largest contributing factor was unsafe handling of the firearm, occurring in 13 (68%) of the incidents.

The number of hunters is declining, but the hunting incident rate (incidents per 100,000 hunters) is falling much faster. Since the 1960s, the number of hunters has declined about 20%, while the incident rate has declined over 75%. The current 5-year-average is 4.3 incidents per 100,000 hunters, compared to 19 per 100,000 hunters in the 1960s.

NY has an extremely safety-conscious generation of hunters, thanks largely to over 60 years of Sportsman Education and the dedicated efforts of thousands of volunteer Instructors.

Hunting remains safer than ever, but we cannot become complacent, as every hunting-related shooting incident is preventable.

This report includes only incidents involving firearms. It does not include all incidents and fatalities related to hunting. On occasion there may be incidents involving tree stand use or other hunter health-related mishaps.



The Stories behind the Statistics: Hunting-Related Shooting Incidents 2013

Draft descriptions of incidents as of 1/7/14. Many of the incidents reported here are still under investigation by NYS DEC Division of Law Enforcement. **Please note that in some of the incidents reported the shooter was participating in an illegal and/or unlawful act.** More details may appear in final reports after hearings are completed late in 2014.

The most common story: Remember that 99.9% of the people who hunt have safe and enjoyable experiences. Over half a million people hunted in New York this year, and for every incident listed, there are thousands of other hunting stories of people who safely and responsibly took game. Just as important, even more passed up shots for the sake of safety, conservation, and respect for wildlife.

Many, if not all of these incidents could have been prevented, if only the shooter and/or victim had followed the primary rules of Hunter Safety:

- -Treat every firearm as if it were loaded
- -Keep your muzzle pointed in a safe direction
- -Identify your target and what lies beyond
- -Keep finger off the trigger until ready to fire
- -Wear hunter orange

Thanks to our Environmental Conservation Officers for thorough investigations of each incident.

FORMAT FOR 2013 DESCRIPTIONS: Date (mm/dd) - followed by County and a brief description based on initial report.

SMALL GAME & NONGAME

- 3/2 Madison. Self-inflicted While hunting squirrel, the victim discharged one round from inside his residence. At the time of discharge he had his hand over the muzzle of the rifle causing injury to left index finger.
- 3/10 Clinton. Self-inflicted While attempting to take a grouse the victim shot himself in the right foot.
- 3/12 Washington. Self-inflicted The subject slipped on a patch of ice while attempting to shoot an opossum at his bird feeder. The victim died from an apparent self-inflicted gunshot wound to the chest. **FATAL**

3/15 - Genesee. The shooter discharged one round from his shotgun at a fox on a roadway. Some of the pellets ricocheted off the roadway, striking the victim in the calf.

5/7 - Tioga. Self-inflicted – The victim was hunting frogs from his ATV. He discharged one round from his pistol at a frog, striking himself in the left hand.

10/21 - Cayuga. The victim and shooter were hunting squirrel together. The shooter discharged one round, striking the victim with approximately 60 pellets from his neck to his legs.

12/5 - Broome. Self-inflicted - The victim discharged his handgun into his left hand while attempting to take a raccoon he had trapped.

TURKEY HUNTING

5/11 - Greene. The victim was calling turkey and using a hen decoy. The shooter discharged one round at the decoy, striking victim in head, face, leg and torso.

10/15 – Sullivan. The shooter and victim were hunting turkey and became separated. The shooter discharged one round at what he thought was a turkey striking the victim in face and upper torso.

DEER HUNTING

10/7 - Delaware. Self-inflicted – While stalking deer with an arrow knocked and trigger release connected, the victim discharged an arrow into his leg.

10/12 - Delaware. Self-inflicted - The 15-year-old victim was hunting deer during youth hunting season with his father. The victim stated the rifle slipped off of his shoulder and when he tried to grab it the rifle discharged one round into his left hand removing thumb.

11/5 - Oneida. Self-inflicted - The victim was tying a rope to his rifle preparing to hoist it up into his stand. The rifle discharged with the projectile striking him in the upper left leg.

11/16 - Delaware. Self-inflicted - The victim was climbing down from his deer stand when he discharged one round into his right leg.

11/16 - Sullivan. Self-inflicted - The victim was preparing to climb up into his tree stand when he discharged one round into his left foot.

11/16 - Ontario. Self-inflicted – The victim was carrying a .44 magnum handgun in a holster. While walking, the handgun discharged striking the victim in the lower leg and exiting through his right foot.

11/16 - Otsego. The shooter discharged one round at what he thought was a deer. The projectile struck the victim in the chest killing him. **FATAL**

11/17 - Cayuga. Self-inflicted - The 15year-old victim was hunting unsupervised when he reportedly discharged the shotgun he was carrying into his foot.

11/18 - Greene. Self-inflicted - The victim discharged his firearm, striking himself in the head causing a minor injury.

11/18 - Greene. Self-inflicted - While attempting to unload his muzzleloading rifle the victim discharged one round into his foot.

HOLLEY STUDENTS RAISED \$232,836 FOR AMERICAN HEART ASSOCIATION THROUGH JUMP ROPE FOR HEART

For the last 29 years, Holley Elementary School students have been participating in Jump Rope for the Heart, a national fundraising event typically held in February. In that time, students have raised \$232,826 for AHA research and education programs on heart disease and stroke. Jump rope for the heart recognizes the work of the American Heart Association (AHA) and encourages heart-healthy activity. Highlights included a special guest appearance by Dick "The Destroyer" Beyer. He and his wife, Wilma, traveled from Wisconsin to be a part of the event. Beyer is a former physical education teacher in Akron, NY.

SENATOR MAZIARZ VISITS HOLLEY ELEMENTARY SCHOOL

State Senator George D. Maziarz (R-62nd District) visited Holley Central on Thursday, Feb. 13 to see how a new infusion of technology is enhancing instruction in both the Elementary School and the Middle School/High School.

Last December, the district received and installed 30 SMART Boards® thanks to a \$67,800 Legislative Education Grant that Sen. Maziarz secured for Holley in 2013. As a result of the grant, 92% of all Holley classrooms now have the new SMART Board technology and that number is expected increase to 100% by end of the school year.

SMART Board technology blends internet connectivity with intuitive tools and projection capabilities. Combined, these capabilities create a powerful instructional tool that gives teachers and students a level of interactivity with information that was never possible before.

"The SMART Board engages students' interests and prepares them for the digital world," explained Holley Elementary School Teacher Lynn Vendetti. "It has changed the way I present information to students. Now, I can tailor daily lessons to fit the needs of the students. I can also add pictures to math lessons that students can manipulate. The added visuals make learning new math concepts more comprehendible for the class."

Teachers throughout the district are working together to learn how to use the technology and are maximizing the use of special SMART Board features to significantly enhance instructional presentations.

"The level of student engagement in class dramatically increases when SMART Boards are used," said District Superintendent Robert D'Angelo. "It is amazing to watch just how quickly students turn their full attention to learning when lessons become interactive and that's what this technology does – it makes learning a hands-on experience that lasts."

Among the many special features of SMART Board technology is a sophisticated mouse function which enables teachers and students to use their fingers to write and erase digital ink. Other capabilities include a gesture capability which provides a natural and flexible way to interact with content. There is also a multi-touch technology for multiple users and more.

This is the second time that Sen. Maziarz has secured grant money for Holley schools. In 2012, the district received a \$50,000 grant which was used to fund staff development training.

"We are extremely grateful to Sen. Maziarz," added Superintendent D'Angelo. "His passion for education is evident by the support he provides to schools in Orleans County."
