#### HILL TALK

#### When is a vacation not a vacation?

I decided one year that our family's camping trip would be up near James Bay in Canada. What was I thinking? We had always enjoyed the times we had spent at Missassaugagon, a lake much further to the south. Of course the desire to go up there was all mine since I have always gone for "over the top" adventures so I must take the blame for the consequences. My wife gamily went along with these irrational quests of mine.

As we traveled farther north than we had ever been before, the terrain became very swampy with small hummocks covered with evergreens scattered here and there. It looked a lot less inviting than my imagination had been predicting. We stopped at a rural gas station where the attendant appeared to be Native American. Swarms of black flies immediately attacked me when I stepped out of the car but didn't bother the attendant although he was wearing a short-sleeved T-shirt. Something on him was repelling the flies and I wondered if the strong smell of garlic emanating from his body had anything to do with it.

Back on the road again, we continued north while the landscape continued to look more alien and less inviting. Our young daughter had been complaining about an earache for a while but there came a point where it became worse. We stopped at a little town and visited the local GP. It was before socialized medicine in Canada and we were able to get right in.

The doctor informed us that our daughter had a severe ear infection. He prescribed eardrops from the local pharmacy and told us that we could not move her for a few days. We hadn't seen any campgrounds advertised as we approached the town and asked if he knew of any in the area. He told us about a new campground that had opened ten miles further on. We had planned on taking the northern route out of town and although this was to the west we had no choice.

At exactly ten miles we came upon a crudely lettered sign announcing that we had arrived at the "Happy Holidays Campground". A freshly bulldozed trail led through the woods to the site. We noticed a large heap of dung in the middle of the trail and wondered if it could be moose droppings. We were very wrong.

A little shack came into view with the word "Office" painted on its side. A young boy was in attendance. He took our money and said we could camp anywhere on the grounds. As we drove around we began to realize that there was only one other camper in the whole place and they were in an RV. The only plus thing was the large stream that ran along one edge of the camp. I couldn't wait to drop a line into that promising looking water.

The sites were nothing more than freshly bulldozed areas surrounded by trees and since we had two large tents, a sleeping one and a twelve by twelve screened canopy, we had difficulty finding a spot that would accommodate us. One was finally located if the tent were backed up next to a tree.

It was getting late so we ate as soon as we were set up, the food acting as a consoling agent because the strangeness of our situation had begun to unnerve my wife Jan, and myself. We were deep in the forest alone (The RV had pulled out). The trees, low sun, and heavy brush seemed to close in on us, precluding any view.

When it was time for Jan to take a trip to the outhouse our little dog wouldn't accompany her as she usually did. On her return my wife remarked about the loud racket the raccoons were making with the garbage cans at the site where the RV had been. We then settled down and spent an uneventful night.

In the morning we were greeted by swarms of mosquitoes. They finally left as soon as the sun rose but were soon replaced by black flies that cut little circles in our skin causing blood to ooze out. Swimming or fishing was totally out of the question. We were destined to spend the day in the screened-in canopy with the temperature hitting into the 90's along with four children who quickly became bored with checkers or cards. The eardrops that were prescribed to my daughter caused her pain and her screams added to the turmoil of the day. As the sun set, the mosquitoes took over from the black flies making us a prisoner in the canopy until bedtime.

Later in the evening the tent became cool enough to inhabit so we settled into our bags until sleep finally came. At some time late at night our oldest son awakened us. He stated that there were bears outside. I told him that he was dreaming, very confident that our lack of having bacon or any other bear attractants in our foodstuffs would keep us safe from them. He insisted that a bear had squeezed between the tent and the tree we had backed up into, causing his cot to almost tip over.

After hearing a noise outside, I grabbed the flashlight, unzipped the door flap, and Jan and I looked out. We couldn't believe our eyes! There were at least five or six bears at the site. An unthinking reaction to all of this was my yelling at them as if they were dogs in my garbage, "Get out of here!" They immediately took off running. Feeling pleased with myself for quickly handling the situation I said, with no small amount of manly pride, "Don't worry kids, I scared them away".

My conviction lulled the children enough that they were soon asleep but my wife and I lay there awake. Soon some more very loud noises came from outside. Our son woke up complaining that a bear had again passed between him and the tree bumping into his cot again. I was full of confidence as I assured him that I would take care of the bear problem again.

I unzipped the flap and opened it. We couldn't believe what we saw. Standing about ten feet from our tent was a big brownish bear. Another giant bear was standing next to the canopy and was able to reach all the way up to the center pole and was shaking it. Another one had our cooler by the corner and was running away with it. Several other bears were ripping into foodstuffs here and there.

I don't know if my confidence level (It was very low) affected my yells but that brown bear's reaction to them was much different this time. He stared back at me, stamped his front feet and loudly grunted while showing his teeth, which, by the way, were quite impressive. The tent flap was quickly zipped up. My only weapon was a can of raid that I held at the ready, hoping to get him in the nostril if he entered.

We huddled in that tent for what seemed like hours while they trashed everything outside. In retrospect, we were very thankful that we didn't have candy or any other foodstuffs in the tent with us because that brown bear didn't act like he would be afraid to bust right in.

When morning finally came we viewed the damages. The screened-in canopy was ripped to shreds, cupboard boxes were smashed, and any edible food was gone. We were left with a parting gift. A large heap of manure similar to what we had seen on the trail was deposited about five feet from the tent entrance. We now knew that it wasn't from a moose.

With no bug protection we packed up what we could and headed south. I've never again felt an urge to visit James Bay. So, When is a vacation not a vacation?

#### ARE YOU BLIND TO OUR TREASURE?

In February, three staff members from the Landmark Society of Western New York came to our Town Hall and met with several community leaders and members to discuss the non-denominational chapel in Hillside chapel. As you will recall, the Landmark Society recognized the importance of preserving our cemetery and chapel by naming them to the 2014 "Five to Revive" campaign. This meeting was to discuss ideas on how to raise awareness of this unique community asset and the need for preservation efforts.

Many great ideas surfaced for events to take place at the chapel so that the community can see what a great resource it can be. But, perhaps the most surprising thing that surfaced is that many of our local people just don't appreciate what a gem we have. The cemetery and chapel have been named to the State and National Registers of Historic Places in recognition of the special design concepts involved in their development. The chapel is particularly significant for its architectural expression of the Gothic Revival style on a smaller scale than normally seen. And it is even more unique in that it is in our rural area where such high style buildings are not the norm.

Have *YOU* taken a moment to reflect on how lucky we are that our forefathers created this beautiful place for memory and contemplation? The landscape design of the cemetery grounds and the beautiful chapel are truly treasures in our midst. But with such treasures come responsibilities we are responsible to assure that future generations will have the same opportunity to enjoy this place as well as honoring the memory of those who have Hillside as their final resting place. And, let's face it, many of us will be joining them. Hillside should be a place where families can cherish and share memories with pride in their surroundings. We need to make sure that occurs.

The last day of the course consisted of the Trophy Shoot, where each of the ten participants had the opportunity to shoot two targets and their average determined the placement: First place, Jacob Baron; second place, Koryn Neale; third place, Cole London; with an honorable mention to Kayla Neale, Joshua Henhawk, Emma Shay, Harleigh Andrews, Chuck MacPhee, Juliana Allis and Luminara Virgilio. Followed by a pizza party, and a big thank you to all who lent a hand to make this opportunity for the children to learn about gun safety and marksmanship.

## DEC Region 9 Environmental Conservation Police 2014 Hunting Season Report

Since the start of the regular deer season through the end of the late special muzzleloading season (Nov. 15 through Dec 16, 2014), Environmental Conservation Officers (ECOs) in Region 9 report a total of 294 hunting-related enforcement actions, in addition to responding to approximately 430 calls for service.

"Enforcing hunting and trapping laws helps to ensure suitable populations of deer, bear and other wildlife in the region and throughout the state," said Regional Environmental Conservation Police Captain Frank Lauricella. "It also ensures that the large majority of law-abiding hunters are provided with fair opportunity to pursue game that these poachers are taking. We appreciate the thousands of hunters who consistently adhere to hunting regulations and guidelines, and who pass on the traditions of safety, responsibility and conservation to the next generation."

Of the 294 charges issued, 89 were classified as misdemeanors and included the illegal taking of deer, discharging firearms within 500 feet of dwellings, shooting across roadways, possessing loaded firearms in vehicles, using spotlights at night to hunt deer, hunting after closed hours and others. These charges carry potential fines of up to \$2,000 and up to one year in jail.

Officers also issued tickets for 205 violations including trespassing, hunting over bait, improper tagging, hunting without a license, transport of untagged deer, hunting in the wrong Wildlife Management Unit or in a closed area, and others.

Officers investigated one hunting-related shooting incident (HRSI) involving property damage within Region 9 during this year's big game season; consistent with last year, zero incidents occurred involving personal injury. In addition to responding to a high volume of calls for service throughout the hunting season, ECOs in Region 9 also served a significant role in emergency response efforts during the severe November snowstorm.

Anyone with information about potential illegal hunting practices or other environmental crimes is encouraged to contact DEC's 24-hour dispatch hotline at 1-844-DEC-ECOS (1-844-332-3267). Region 9 covers Erie, Niagara, Wyoming, Chautauqua, Cattaraugus and Allegany counties.

The Town Clerk's Office will be closed April 27, 28 & 29, 2015 due to NYS Town Clerk's educational conference attendance. Taxes will not be received in person at the Town Hall on those days. The last day to pay Town/ County property taxes at the Town Clerk's Office is April 30, 2015. Payments made by mail will be accepted according to the postmark date on the envelope. Thank you.

#### **Clarendon Historical Society-**

Have received donations for the chapel from individuals. The chapel account is just over 11 thousand dollars. We have also reached the half way point for the Akeley Monument and the deposit/down payment was made last week.

A list of speakers lined up for the 2015 meetings is elsewhere in this Gazette.

Erin Anheier and I are going to assist Al Capurso in writing an application for a cobblestone school in Albion for placement on the national register.

We are also attempting to get some new historic markers through the Pomeroy foundation again this year. A notice came in the mail last week announcing new applications to be accepted in a few weeks.

## SUPERVISOR REPORT –

Richard H Moy, Supervisor

Supervisor Moy acknowledged Historian Melissa Ierlan as receiving the Orleans Hub 2014 Outstanding Citizens Award. All the Fire Companies in Orleans County were presented with Person of the Year Award. Ceremony was held at the Hoag Library in Albion.

The Town has received written authorization from the NYS Comptroller, approving Water Improvement Benefit Area No. 11. The Town Board authorized Chatfield Engineers to bid out the water project.

Supervisor Moy reported the annual Farmer to Neighbor Night 2015 will be held March 14, 2015 at White Birch Golf Course; Celebrating Agriculture in Orleans County.

Supervisor Moy reported that Assemblyman Steve Hawley will hold his educational conference in Albany this year; May 3-5, 2015. This conference has been cancelled the past couple years as there hasn't been enough people signed up to attend.

#### **CORRESPONDENCE**

The Orleans County Supervisors & Legislators Association Meeting Schedule for 2015 has been received; Clarendon will host September. The County Treasurer has sent the town's share of proceeds through the District Attorney's Traffic Diversion program; \$933.33. Correspondence from the NYS Association of Towns; Supervisor explained that the Association always holds its annual meetings in New York City; that officers are nominated through a 'closed process'. The ISO (Insurance Services Office, Inc.) rates towns for its code enforcement effectiveness: Clarendon was rated #4 at the last survey done; A field representative will re-evaluate Clarendon soon.

The Orleans County Health Department sent correspondence regarding the 2015 monitoring requirements from the Superintendent for the Clarendon water system. The County Planning Board has sent a letter reminding of requirements when submitting a zoning referral for county review. Orleans County Self Insurance has sent the Self Insurance Plan Reporting requirements. The NYS Department of Public Service is requesting assistance in informing residents of an energy modernization initiative that will transform the way

electricity is distributed and used in New York. Information Sessions have already been held.

#### **OLD BUSINESS**

The Town Board increased water rates last month; it was recognized that the approved rate did not encompass the increase from MCWA. The Town Board authorized the new water rate to be \$3.25 per 1000 gallons of water. The Board approved renewing/extending the Emergency Water Agreement with the Town of Barre for one year from

the meeting date, unless the town enters into a lease agreement with MCWA prior to that date which would end the agreement with Barre.

An Employee Handbook Committee meeting was scheduled for March 11, 2015 following a conference call with Attorney Essler regarding the MCWA lease agreement draft at 6:00 PM.

Highway Superintendent Swanger will go to Albany March 3<sup>rd</sup> and 4<sup>th</sup> for Advocacy Day with the other Superintendents.

Supervisor Moy suggested a Resident Energy Sustainability Committee; that anyone interested should contact Supervisor Moy to set up a date and time for first meeting. Chris White was appointed to the Board of Assessment Review for the remaining year of a five year seat; term to expire 9/30/2015. The Board authorized expenditure of Highway Moneys for 2015 and extended the Snow & Ice Agreement with the State. The Town Board accepted a verbal resignation from Nick Bianchi, Alternate Planning Board Member.
