Effective May 1, 2013, the Clarendon Post Office will provide four hours of window service each weekday. The facility retail hours will be from 1:00 PM to 5:00 PM on Monday through Friday and from 10:00 AM to 12:00 PM on Saturday. We did have Jitterbugging dances and the music to go along with them but they weren't the sing-a-long type of songs. The Andrew Sisters were the Jitterbug stagrs as they sang songs like the "Bugle Boy from Company C:"

Even my final repository of well-known music, the church, has been changing from familiar hymns such as "On A Hill Far Away" to repetitious chants without a discernible melody!

Now when we want music at home we turn to "Easy Listening" or horror of all horrors, to the music that we used to call "catawallering", country music! Even that has to be the older "She'll do you Wrong" type of songs as the new country music is also getting more and more chant-like.

What's to say? Am I joining that class of people that I remember as a child? Those old timers who shook their heads in dismay as they heard the music that was popular back then.

The giant rooster basket was quite a unique item for the Ronson Spring Auction and both donor and auction house staff were pleased with the bidding. Once the announcement was made to the bidders that the proceeds would benefit Hospice of Orleans, the bidding started and went on until it ended at an astonishing \$375! The Board and Staff of Hospice extend sincere gratitude to the donor and the winner for this very generous gift.

The 2012 deer harvest results are now available.

Hunters took approximately 243,000 deer (124,000 antlerless deer and 119,000 adult bucks) during the 2012-13 hunting seasons, about 6 percent more than were taken the previous year. Increases were most pronounced in the Northern Zone where total take (30,840) increased 15 percent from 2011. In the Southern Zone, the adult buck take (about 98,570) increased 6 percent and the antlerless take (110,900) increased 5 percent from 2011. The 2012 harvest reflects deer populations that are greater than desired levels in many parts of New York. Increased take of antlerless deer will be necessary in 2013.

TAPS

We in the United States have all heard the haunting song, 'Taps.' It's the song that gives us the lump in our throats and usually tears in our eyes. But, do you know the story behind the song? If not, I think you will be interested to find out about its humble beginnings.


Reportedly, it all began in 1862 during the Civil War, when Union Army Captain Robert Ellicombe was with his men near Harrison's Landing in Virginia. The Confederate Army was on the other side of the narrow strip of land. During the night, Captain Ellicombe heard the moans of a soldier who lay severely wounded on the field. Not knowing if it was a Union or Confederate soldier, the Captain decided to risk his life and bring the stricken man back for medical attention. Crawling on his stomach through the gunfire, the Captain reached the stricken soldier and began pulling him toward his encampment. When the Captain finally reached his own lines, he discovered it was actually a Confederate soldier, but the soldier was dead. The Captain lit a lantern and suddenly caught his breath and went numb with shock. In the dim light, he saw the face of the soldier. It was his own son. The boy had been studying music in the South when the war broke out. Without telling his father, the boy enlisted in the Confederate Army. The following morning, heartbroken, the father asked permission of his superiors to give his son a full military burial, despite his enemy status. His request was only partially granted. The Captain had asked if he could have a group of Army band members play a funeral dirge for his son at the funeral. The request was turned down since the soldier was a Confederate. But, out of respect for the father, they did say they could give him only one musician. The Captain chose a bugler. He asked the bugler to play a series of musical notes he had found on a piece of paper in the pocket of the dead youth's uniform. This wish was granted. The haunting melody, we now know as 'Taps' used at military funerals was born. The words are: Day is done. Gone the sun. From the lakes From the hills. From the sky. All is well. Safely rest. God is nigh. Fading light. Dims the sight. And a star. Gleaming bright. From afar. Gems the sky. Drawing nigh. Falls the night. Thanks and praise. For our days. Neath the sun Neath the stars. Neath the sky As we go. This we know. God is nigh.

All funeral services were held at the Clarendon Firemen's Recreation Hall on Sat., 1/24/2009. The 400 maximum capacity building was full of people there to pay respects to Bob. At the end of the service, a last call for Rotten Robert Woodworth was heard and tones went off leaving the rec hall in a state of emotional silence while bag pipes were heard playing Amazing Grace.

REGARDING GRIEVANCE PROCESS

The Grievance Board and Assessor have no control over taxes. Although the Grievance Board and Assessor sympathize with complaints about taxes and are taxpayers as well, the purpose of the Grievance Process is to determine whether your property is assessed at Market Value. The Most important Question to ask yourself before you Grieve:

Would you sell your property for less than the Assessed Value?

If your answer is YES, then you may want to get a Market Analysis of your property by a Certified NYS Appraiser showing properties within the Town of Clarendon only of like size, quality and age and submit that appraisal with your application to the Grievance Board. (Bank appraisals don't necessarily reflect market value, only the bank's interest). You can also do a market study on your own by finding like properties within the Town of Clarendon, similar to what the appraiser would prepare. If you do a study on your own and discover that your property is out of line with like properties in the Town of Clarendon, submit that information with your Grievance forms to be presented at the hearing. The Assessor will submit all applications and supporting documents to the Grievance Board for the hearing. The Assessor also does market studies and will submit those findings for the hearing as well. The Assessor will assign a time slot for your Hearing with the Grievance Board. Hearings are generally 15 minutes in length. All market studies must be done within the Town of Clarendon as each Town has its own unique market. Clarendon has a very active market and provides enough sales to prepare a fair study.

If your answer is NO to the question of whether or not you would sell your property for less than assessed value, then there is no Grievance. Again, taxes are not addressed at Grievance, the Grievance Board and the Assessor have no control over the taxes and that is not the purpose of Grievance. Grievance Day is May 28 from 10am – 2pm and from 4pm – 8pm. Grievance packets are available from the Assessor beginning May 1. Forms should be returned to the Assessor prior the hearing date to insure that the process is not held up for preparation of the applications. The Assessor will prepare packets for the Grievance Board and assign time slots.

Time slots will be assigned when the forms are returned in the interest of fairness to all wishing to participate. See page 1 of this Gazette for Assessor hours.

HOLLEY BOARD OF EDUCATION ADOPTS 2013-2014 BUDGET

During its April 23 board meeting, the Holley Board of Education adopted a \$22,976,429 budget for the 2013-2014 school year. If approved, the plan will result in a two percent tax levy increase.

The district received an additional \$702,000 in state aid and did not have to make any cuts to staffing or programs. Items that were added to the budget include two teaching positions, an athletic trainer, a golf team, and upgrades to the Middle School/High School music room.

"The Board of Education has worked hard with our administrators to build a budget that meets students' needs while also staying at the two percent cap. We have accomplished this task," said John Heise, board president. "We are happy to have been able to include a number of items in the budget that will improve opportunities for our students."

When Holley residents go to the polls on May 21, they also will be asked to vote on three additional propositions. The first is for the purchase of two full-size school buses, two 22-passenger buses, and one nine-passenger vehicle at a cost not to exceed \$372,136. The second allows the district to maintain a seven-member Board of Education rather than reducing to five members as authorized by voters on May 15, 2012. The third authorizes the district to raise \$102,652 to be used in support of maintenance and operations of the Community Free Library.

In addition, residents will be voting on one Board of Education seat. The three-year terms of office of current board members John Heise, Dorothy Morgan and Brenda Swanger expire on June 30, 2013. In accordance with a proposition adopted by voters on May 15, 2012, the board is being reduced from nine to seven members effective July 1, 2013. As a result of this reduction in membership, two positions on the board are being eliminated as of July 1, 2013, leaving only one vacancy to be filled at this year's election. The candidate receiving the highest number of votes will be elected to a three-year term of office expiring June 30, 2016.

In March, Supervisor Moy and Deputy Supervisor Robinson attended a municipal project meeting in Batavia presented by LaBella Associates regarding possible funding for the next water project. LaBella will send someone to look over the project.

Deputy Supervisor Robinson requested volunteers from the Town Board who will review the Town Emergency Plan/Procedures and the Employee Handbook; Please submit your intention by next week.

All were reminded that Tire Pick-

up will be May 6, 2013.

The Town is in receipt of the first quarterly sales tax payment in the amount of \$27,536.47.

CHIPS funding has increased by \$23,000. Superintendent Swanger commented that the trip to Albany was a very worthwhile effort.

Resolutions have been received from the Towns of Carlton, Shelby and Ridgeway and Orleans County Legislature amending the lien law. Assembly Hawley has sent a thank you letter to Clarendon for its support of the same.

The Village of Holley has sent a copy of its adopted resolution, requesting assistance of financial stability of Lakeside Hospital.

Notice of the Spring 2013 Regional Local Government Training in Burgundy Basin has been received; several Planning Board members will attend.

Deputy Supervisor Robinson informed those present that Lakeside Hospital is still open; that it is requesting State approval to keep its Emergency Room Open.

CORRESPONDENCE

The assessor has submitted 2013 Assessment Notification for Town Properties. The Town has received its share of State Aid for the Joint Youth Recreation Program in the amount of \$506.76. NYS Agriculture & Markets have submitted satisfactory inspection reports for the County Dog Control Officer and the County Municipal Shelter.

OLD BUSINESS

It was reported that the Fertittas are still working with different engineers to design a septic solution for the Stone Store Property that the Orleans Health Department will agree to.

This item will be handled when Supervisor Moy returns; on the May agenda.
