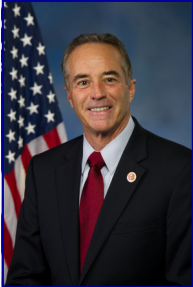

## CLARENDON TOWN BOARD—Meeting Highlights April 2015

Engineer John Schepp of Chatfield Engineers gave a short presentation on solar photovoltaic electric systems that his firm has provided design and construction phase services for, including the Town of Clarkson Court House, Clarkson Highway Garage and the Town of Victor Fire Hall. For the Clarkson projects four years ago, application to NYSERDA provided tax credits and incentives of 80% grant and 20% town. NYSERDA required production monitoring and the Court House project has paid for itself in savings already; system life being 25 to 30 years. Mr. Schepp explained the possible different options between programs and grants where the town would own and construct the system or agreements to purchase the power, leaving ownership and construction to another company.

### HIGHWAY DEPARTMENT REPORT

Superintendent Larry Swanger reported getting the equipment ready for summer work; the plows are off the road. Four trees have been taken down, roads are being patched and most lawns have been fixed from the plowing season. Gravel roads have been graded. Water readings are complete; due to a glitch in the software, meters had to be read twice. There was a water leak on Hall Road in a service line to a house. It's been fixed. NYSDEC has inspected the fuel tanks. A small crack in the concrete retaining wall around the tanks was found and fixed. Many roads have heaved up from the winter; there is a lot of roadwork to be done. Discussion was held regarding a new loader. Town Board will receive specs for review; on May agenda.

### PLANNING BOARD REPORT

Chairman David Griggs submitted a written report.

#### Regular Meeting March 24, 2015

The Planning Board held a pre-conference for a one (1) lot Subdivision/building lot approval, SD 15-02, Jim Rusin, S. Manning Road, Tax id# 108.-1-12.111. The board reviewed the subdivision portion of the application. No issues were noted with the proposal. Applicant was informed that they could waive the pre-conference and proceed to the formal application if they desired. Applicant indicated they so desired. A motion was made, seconded and approved to waive the pre-conference. A motion was made, seconded and approved to approve the one (1) lot Subdivision contingent on verification by the OIO that the pins had been set, creation of a new deed for the subdivided lot and filing with the County. The Board reviewed the building lot portion of the application. There was a question regarding whether or not the lot was in an agricultural district, and there was a question regarding the property being in a water district, no other issues were noted. Applicant was informed that they could waive the pre-conference and proceed to the formal application if they desired. Applicant indicated they so desired. A motion was made, seconded and approved to waive the pre-conference. A motion was made, seconded and approved to approve the building lot contingent upon verification that the parcel was not part of an agricultural district and that the parcel had the availability of public water via water district #3 or #6. OIO to confirm.

The Planning Board held a pre-conference for a one (1) lot Subdivision, SD 15-01, Joe McFarland, S. Holley Road, Tax id# 99.-1-3.11, parent lot. No issues noted with proposal. Applicant submitted a letter requesting to waive the pre-conference and proceed to the formal application. A motion was made, seconded and approved to waive the pre-conference. A motion was made to approve the one (1) lot Subdivision

contingent on verification by the OIO that the pins had been set, creation of a new deed for the subdivided lot and filing with the County.

Renewal, SP 96-002, Thomas Estates West, Mobile Manufactured Home Park. Chairman Griggs informs the board that the fee has been paid, inspection is done and there are no complaints received. A motion was made, seconded and approved to approve renewal of Special Use Permit.

#### Regular Meeting April 14, 2015

The Planning Board held a pre-conference for a one (1) lot Subdivision, SD 15-04, Don Harrington, 5612 Keck Road, Lockport, NY Tax id# 119.-2-74.1, parent lot. No issues noted with proposal. Applicant submitted a letter requesting to waive the pre-conference and proceed to the formal application. A motion was made, seconded and approved to waive the pre-conference. A motion was made to approve the one (1) lot Subdivision contingent on verification by the OIO that the pins had been set, creation of a new deed for the subdivided lot and filing with the County.

Renewal, SP 03-14, Urban League of Rochester, Akeley Manor. Chairman Griggs informs the board that the fee has been paid, inspection is done and there are no complaints received. A motion was made, seconded and approved to approve renewal of Special Use Permit.

Chairman Griggs reviewed with the Planning Board members the written response he received from TOC Attorney K. Essler regarding a Zoning interpretation request of Article IV, Section 601, Permitted uses, Accessory uses. Attorney Essler concurs with the Planning Boards interpretation that Section 601-A only allows for one (1) principle use and one (1) accessory use per any individual lot.

### HISTORIAN/HISTORICAL SOCIETY REPORT

Historian and CHS President Melissa Ierlan reported that Collin Nothnagle, Powerline Road resident will mulch and upgrade the trail behind the Historical Society Museum as an Eagle Scout Project. A new sign has been placed at the museum site. The Dee Robinson presentation went well. On May 20<sup>th</sup> the CHS will host an event at the Holley High School about Carl Akeley; it is his 151 birthday. Orleans County Historian Matt Ballard is preparing a 'traveling' World War I display. Clarendon's Mr. Warren's items will be part of the display.

### SUPERVISOR REPORT

Deputy Supervisor Allen Robinson read aloud the summary of bids on the WIBA 11/Equipment BAN; four were received. The Town accepted a 0.9639% interest rate from Oppenheimer & Co. in Philadelphia, PA. The Village of Holley is working with the residents of the private waterline on Route 237; to have them petition the Town of Clarendon for a waterline extension or go to private wells.

### CORRESPONDENCE

The Town has received a draft update of the T/Sweden and V/Brockport Comprehensive Plan. An abstract of revenues from Orleans County for the year 2014 has been received. NYS Real Property has sent notice of tentative and final special franchise full value and tentative telecommunications ceiling. NYS Real Property has also sent certification of STAR; Enhanced exempt assessed value at \$65,300 and Basic STAR at \$30,000. Orleans County Dept of Personnel and Self Insurance has sent a schedule of safety training sessions. The highway crew will attend. Assemblyman Steve Hawley has sent notice informing 2015 CHIPS allocation to be \$105,911.63; Extreme winter recovery grant \$15,553.33. NYS Office of Parks, Recreation and Historic Preservation has recommended the Stevens-Sommerfeldt House at 5482 Holley Byron Road be placed on the National Register of Historic Places. Inspection reports have been received from NYS Agriculture & Markets on the County Animal Shelter and Dog Control Officer.

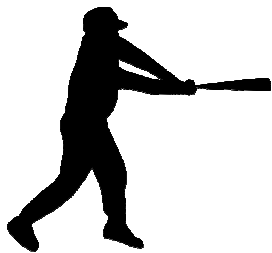
## OLD BUSINESS

Paperwork to close funding for Water Improvement Benefit Area 11 will be signed shortly. Amendments to the employee handbook have been put on hold.

Upon review of the attorney, the Town Board declined the request for the transfer station as such use would not be permitted under the code..

## NEW BUSINESS

The Board authorized \$10,000 be available from the Clarendon Cemetery monies for restoration of the Hillside Cemetery Chapel. This is to match an anonymous donation that the Historical Society has received for the project. Discussion was held regarding the two bids received for re-pointing of the stone on the chapel. The Board decided to put the project back out for bid; sealed bids to be opened May 18<sup>th</sup> at 10:00 AM at the Town Hall. This will be on the May agenda. Engineer Russ Bosch will oversee the project, volunteering on behalf of the Historical Society. The Board adopted the following resolutions: Supporting need for NYS to immediately fund highway and bridge funding; Opposing NYS plan to close skill development and work center; Supporting delay to proposed legislation moving STAR exemption from real property tax exemption to a personal income tax credit and Opposing part W of Governor's 2015 budget regarding local industrial development agencies. The Town Board did approve an application for out-of-district user in WD#6 pending close of property purchase on South Manning Road.

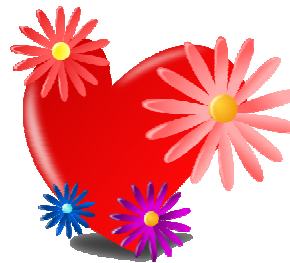

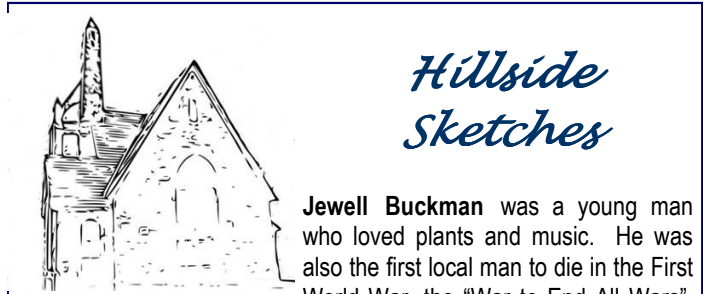

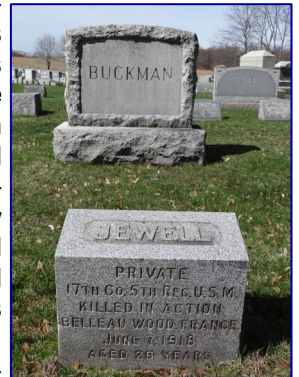




## Hillside Sketches

**Jewell Buckman** was a young man who loved plants and music. He was also the first local man to die in the First World War, the "War to End All Wars". He graduated from Holley High School, the only child of Albert and Myra Buckman. He attended the University at Baton Rouge for two years in military training. He then studied landscaping, which he hoped to make his career, in Flint, Michigan. He was the organist at the Baptist church for three years. He landscaped his parents' yard which was known as one of the most beautiful in the village. And, he enlisted in the Marine Corps in August 1917. He was stationed at Parris Island, SC and Quantico, VA before shipping out to France on December 31, 1917. It is known that he served in the front line trenches from at least late April 1918. He died at Chateau-Thierry-Belleau Woods in France on June 6, 1918 in one of the most important and bloodiest battles against the Germans.

In his last letter to his parents, less than two weeks before his death, he discussed several of his further plans for their yard. He said he had seen Laburnum, the golden chain tree, in bloom in France and planned to plant three of them when he returned home. He asked that they have their pictures taken and send them to him. And then they received the telegram telling them he was killed in action. He was 26 years old.




His death rocked the community; the distant war had come home. An impressive memorial service was held at the Presbyterian Church with honor guards, a memorial proclamation from the Village Board and the reading of a telegram from George Barnett, Major General Commandant of the Marine Corps.

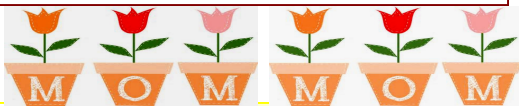

**HOLLEY ADOPTS PROPOSED BUDGET WITH ZERO TAX LEVY INCREASE**

During its April 13 board meeting, the Holley Board of Education adopted a \$23,300,000 budget for the 2015-16 school year. If approved, the plan will result in zero tax levy increase to taxpayers.

When Holley residents go to the polls on May 19, they will be asked to vote on two additional propositions. The first is for the purchase of two full-size school buses, one wheelchair bus and one 30-passenger school bus at a cost not to exceed \$355,000. The second authorizes the district to raise \$108,072 to be used in support of maintenance and operations of the Community Free Library. A public hearing on the budget and propositions is scheduled for May 5 at 6 p.m. in the Board Room located in the District Office.

In addition, residents will be voting on three Board of Education seats. The three-year terms of office of current board members Mark Porter, John C. (Jack) Welch and Anne Winkley expire on June 30, 2015. Additional budget information will be available soon and will be communicated on the district website at [www.holleycsd.org/budget](http://www.holleycsd.org/budget), through Facebook, Twitter and in the budget newsletter mailed to residents in May. Holley residents can vote on the school budget and Board of Education election on Tuesday, May 19 from 6 a.m. to 9 p.m. in the Holley Middle School/High School Foyer.

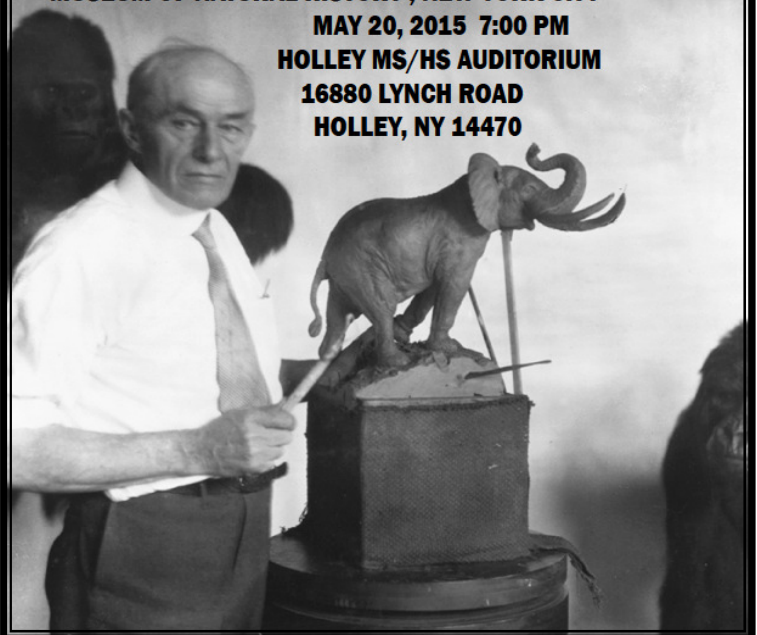

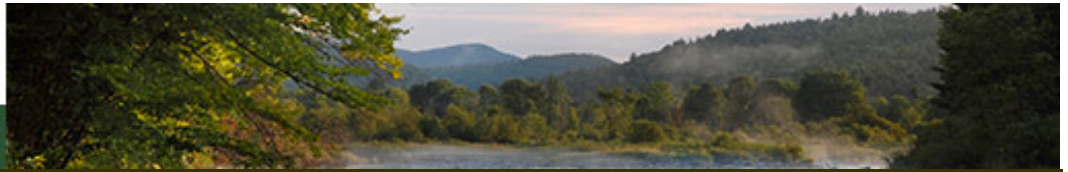

## A Number of Western New York Ponds Experience "Winterkill" Late Ice Contributes to Natural Phenomenon

The extended period of ice, blanketed by deep snow, is likely to result in fish die-offs in numerous area ponds, according to New York State Department of Environmental Conservation (DEC) Region 9 fisheries biologists. "As winter ice has started to melt away, we are receiving calls from concerned pond owners reporting large numbers of dead fish in their ponds," said DEC Regional Fisheries Manager Michael Clancy. "In most cases, fish kills that become evident when the ice melts can be attributed to a natural phenomenon known as winterkill." Winter die-off of fish, or "winterkill," is caused by oxygen depletion in the water through the winter. Ice that accumulates on ponds or lakes prevents wind action from adding oxygen to the water. If there is significant winter snow accumulation on top of the ice, sunlight is prevented from reaching plant life in the pond. Without adequate sunlight, the oxygen-creating process of photosynthesis cannot occur.

Shallower ponds are particularly susceptible to winterkill, due to their low storage capacity for oxygen. With the exception of extreme situations, it is rare that all fish in a pond will die as a result of winterkill. Typically, larger fish are more susceptible than smaller fish.

"Sensitivity to low oxygen levels varies by fish species," Clancy said. "For instance, catfish and carp are more tolerant of low oxygen levels than species such as sunfish, bass or trout." If desirable fish species are completely eliminated from the pond due to winterkill, replenishment by stocking may be necessary. Please remember to obtain applicable stocking permits from DEC.

A long-term approach to avoiding winterkills is to deepen the pond. Pond depths exceeding 12 feet are recommended since ponds will gradually fill in over time. Removing some of the organic substrate (decaying plant material) that accumulates within the pond can also help combat oxygen depletion. As a pond ages, organic materials are deposited on the pond bottom; these decaying materials have a high metabolic demand for oxygen.
