That belief allowed us to pretty much accomplish it all and we even helped out the rest of the world with programs like the Marshall Plan to rebuild Europe while we did it, and that was after spending trillions fighting World War 2!

## HOLLEY SCHOOL DISTRICT RESIDENTS DON'T FORGET TO VOTE!

**Tuesday, May 15, 2012**  
**6AM-9PM in the High School Foyer**  
**Lynch Road, Holley, NY**

To vote, you must be a legal resident of the district at least 30 days prior to the vote, 18 years of age and a United States Citizen. You do not need to own property or have children in the school system. No advance registration is required, but proof of residency by photo identification (driver's license) or a signed affidavit will be requested at the polls.

### 2012-2013 SCHOOL BUDGET:

During a special board meeting on April 11, the Holley Board of Education adopted a \$19,967,841 budget for the 2012-2013 school year. The Board reduced the tax levy increase by applying additional fund balance, and making cuts to staff positions and non-mandated programs. Staff cuts include an administrative reorganization, and a net of three instructional and four support staff positions for a savings of \$421,600. Program cuts include equipment and supplies district wide for a savings of \$155,479.

### 3 PROPOSITIONS:

Purchase three full-size school buses and four 30-passenger buses at a cost not to exceed \$517,995; Reduce Board of Education Members from nine to seven, effective July 1, 2013 and a further reduction from seven to five members, effective July 1, 2015; Authorize the district, to raise \$100,639 to be used in support of maintenance and operations of the Community Free Library.

### BOARD OF EDUCATION:

Vote to fill three board of education seats; expired terms are Elaine Berg, Kellie Spychalski, and John C. "Jack" Welch. The three candidates receiving the highest number of votes will serve three-year terms commencing July 1, 2012.

## HOLLEY INDUCTS 25 INTO NATIONAL JUNIOR HONOR SOCIETY

Holley Middle School/High School held its 24th Annual Induction Ceremony on March 27 to welcome 25 seventh and eighth graders into the Holley Chapter of the National Junior Honor Society. During the ceremony, current members went into the audience and brought new members up on stage. NJHS officers then described the qualities required for membership – character, scholarship, leadership, service and citizenship – and lit a candle symbolizing each of the qualities.

Superintendent Robert D'Angelo and Middle School/High School Principal Susan Cory welcomed the new members with certificates, and the new inductees recited the NJHS oath. In order to be eligible for the National Junior Honor Society, students must have an academic average of at least 90 percent; they must apply for the honor, and be selected by a faculty council based on the five qualities of membership.

The new inductees are: eighth graders Amber Becker, Danielle Bevins, Dana Frisbee, Sienna Steier, and Brady Smith; and seventh graders Lisa Alemu, Christopher Balys, Hannah Beidlingmaier, Anna Brasted, Andrew Cary, Claudia Drechsel, Makenzie Ferranti, Isaiah Flow, Megan Fribance, William Harrington, Megan Hatfield, Dylan Hillabush, Taylor Kimmerly, Jessica Mandigo, Alice McAllister, Veronica Mendoza, Cassandra Mohny, Garrett Moy, James Skehan, and Diana Yaroshchuk. Their advisor is Kelly Evans.

The highlight of the ceremony was guest speaker Ricky Palermo, who was paralyzed from the neck down in a car accident in 1981, and has since raised \$720,000 for spinal cord injury research and rehabilitation through the Ricky Palermo Foundation. National Junior Honor Society members presented Palermo, the brother of Jim Palermo, Holley physical education teacher, with a check for \$350 for his foundation. They raised the money by selling carnations and cookies. "I'm glad to be chosen to accept this wonderful donation," he said. "You are young honor students, but already there are younger eyes looking up to you. You can thank the person that you looked up to for that."

Palermo also told the students that their donation will have far-reaching benefits. Money from his foundation goes to the United Memorial Medical Center's Emergency Room to stabilize patients with spinal cord injuries; the University of Rochester Medical Center's Spinal Unit to help patients recuperate from surgery; Genesee County YMCA's Bike Program to help patients rebuild muscles and stay in shape; and The Miami Project for research to cure paralysis. Palermo showed the audience a video about the great strides being made by The Miami Project in strategies for the repair of damaged spinal tissue.

## HOLLEY CLASS HAS A WHALE OF A TIME WITH LOCAL AUTHOR

Students in Kristen Wagner's and Carla Rodrigues' classes at Holley Middle School/High School not only had the opportunity to crack open a brand new book, but to meet its author, Ron Mazzarella. The Spencerport resident and his mom, Chris Mazzarella, read aloud *There's a Whale in the Canal*, then answered the students' questions. "I was playing a rhyming word game with my three-year-old daughter, Samantha, one night and she said, 'There's a whale in the canal.' I thought it sounded like a kids' book and that's how the story came about," Mazzarella told the students.

It took him about three months to write the book while traveling for his job in sales, then nearly two years to find an illustrator and get it published. The illustrator is Tom Paul Fox, also a Western New York native. "The most fun part of all of this is reading the book to my daughter," said Mazzarella. "I wrote it for her because reading is an important part of our relationship."

The book begins when Humphrey, a young whale, learns about Niagara Falls in fish school and decides he must see this natural wonder for himself. He learns about persistence, resourcefulness, and friendship as he travels down the Erie Canal toward his destination. "I think this was a great opportunity for our students to experience a reading from a local author," said Teacher Kristen Wagner. "These experiences don't happen every day, so I'm grateful my students were able to be a part of it!"

# CLARENDON TOWN BOARD MEETING HIGHLIGHTS

April 2012

## HIGHWAY/WATER DEPARTMENT REPORT

Larry P. Swanger, Superintendent

Superintendent Swanger reported the 2012 first quarter water meter readings complete; bills will be sent this week. The driveway/road is complete in Hillside Cemetery; grass seed has been planted. The County ground stumps down in the Hillside Cemetery and two graves were dug this past month. Plows have been painted and put up for the summer.

Superintendent Swanger reported repairing a water service line to the curb box under the middle of Glidden Road; quarter inch hole over a period of 3 months will lose 1.2 million gallons of water.

Superintendent attended safety training at the County today and work was done on patching roads. The damaged railing has been removed from the park and the lawn has been fixed; Superintendent may replace the display cabinet there; a new one was estimated at \$270.

South Holley Road resident Pat Giglio reported that her neighbor saw a pick up truck go down behind the cemetery and heard a chain saw running; she told her neighbor to call the Town Hall next time that happened. Superintendent Swanger confirmed that no one should be cutting back there now.

Deputy Supervisor Al Robinson thanked Superintendent Swanger for the work done at Hillside Cemetery over the weekend – on his own time; electrical work done at the Town Park and the graves that were dug at Hillside.

SEQRA assigned. Item tabled pending further information. \*The Planning Board held a pre-conference for a Special Use Permit, Adam Johnson (The CATT Group), 15549 East Lee Road, tax id# 97.-1-44.2, multi-use (rental apartment, office, storage) Confirmation letter requested from OC Health Department, Public hearing date set for April 24<sup>th</sup>, 7:00 pm preceding the regularly scheduled Planning Board meeting. \* The Planning Board held a pre-conference for a Special Use Permit, Micah Eldridge/Edgar Storm, Mini Storage facility, location to be determined. Applicant was informed that the tentative parcel they were looking at was located within the Rural/Residential District (RR) and that a mini storage facility was not an allowable use even with a Special Use Permit. No issues noted, motion made, seconded and approved to grant renewal. The next regularly scheduled Planning Board meeting is 7:00 PM, April 24, 2012 at the Clarendon Historical Society building, Church Street.

## SUPERVISOR REPORT

Allen W. Robinson, Deputy Supervisor

Deputy Supervisor Robinson asked for volunteers to help run the Electronic Recycling Event Site at the Highway Garage scheduled for May 12<sup>th</sup> from 10am to 2pm. Deputy Supervisor Robinson read a list of items that will be accepted.

May 7, 2012 the Highway Department will pick up tires; roadside.

Deputy Supervisor Robinson reported his attending a Hydraulic Fracturing informational meeting. Mr. Robinson felt it

was well worth attending as very informative. DEC has said that there is currently no plan for hydro-fracturing in this area as it is too shallow; by the Pennsylvania border is felt to be a good area for this.

On April 4<sup>th</sup> Melissa Ierlan and Erin Anheier gave a great presentation on Clarendon History at the Clarkson Historical Society by invitation. Deputy Supervisor Robinson attended and commended them for their presentation; it was suggested they give the same in Clarendon.

June 2<sup>nd</sup> is the Holley June Fest; starting with the Jim Ferris 5K Race at 9 am, Parade at 10:30 am and yard sales, arts & craft booths, food vendors, antique car show and Drum Corp show throughout the day. There will be fireworks at night.

The Town of Kendall will hold their Opening Ceremony for the 2012 Bicentennial Celebration on April 28<sup>th</sup> at 7 pm at the Junior/Senior High School. There will be a fundraiser on April 28, 2012 at the Clarendon Fire Co. Recreation Hall for the Jenks Family as they lost their home to a devastating fire. Also, the 28<sup>th</sup> is National Prescription Drug Take-Back Day. Between 10 am and 2 pm unwanted and/or expired medications will be collected and properly disposed of at the following collection sites: Orleans County Public Safety Bldg, 13925 State Route 31, Albion; Holley Fire Department, 7 Thomas St., Holley and the Medina Fire Dept., 600 Main St., Medina.

The 7<sup>th</sup> Annual Senior Citizen Appreciation Breakfast will be on May third from 9 to 10:30 am in the Holley Elementary School Cafeteria.

Hamlin Beach State Park will host "Earth Day" on April 21 from 9 am to 3 pm in Area 3; very interesting is the CCC POW Camp Tour.

## CORRESPONDENCE

The New York State Review Board has recommended to the Commissioner of Parks, Recreation and Historic Preservation that the Old Stone Store property be listed on the National Register in Washington, D.C.

The Clarendon Fire Co., Inc. has sent notice of their expiring/renewing two year liquor license.

The NYS Department of Agriculture & Markets has completed mandated reports; satisfactory reports have been filed on the County Dog Control Officer and the Municipal Shelter.

The NYS Assembly is requesting mandated reporting information and recommendations of eliminating or

modifying such reports.

The Town has received a partial payment for the Munger Road Cemetery vandalism.

Orleans County Job Development Agency has sent information regarding the Youth Summer Work Program.

### OLD BUSINESS

Historian Ierlan introduced Ben Paratore, Merrill Road resident, who is very interested in the potential of the Old Stone Store Property. Mr. Paratore walked through the building and was very impressed with the volunteer efforts that have gone into it. Mr. Paratore felt it may be difficult with the property constrictions; water issues and parking. Mr. Paratore will meet with the neighbors to the property; the Thornes and maybe with Twins. Mr. Paratore's plan would be to lease office space in the building; the upper floor has 1000' office space and it was suggested the first floor maybe host a cupcake & coffee shop for commuters. Growth from Batavia and Rochester was recognized. Mr. Paratore thanked all the volunteers for their work to date and told the board he would move forward and come back with a concrete business plan.

Congresswoman Hochul visited Clarendon and viewed the stone store and Hillside cemetery chapel; she was very impressed. Scott Galliford was thanked for his work on the store gutters; he's patched and fixed the west side. Erin Anheier reviewed that if the property is listed on the National Registry, it will make it eligible

for tax credits; that it is an honorary status and will not restrict the property.

Tom Martin has prepared a new map of Hillside Cemetery consisting of the existing lots on the east side of South Holley Road and a new layout on South Holley and Route 237. The drive-way is in now also.

Regarding the cemetery chapel, Historian Ierlan reviewed waiting on the architect for the drawings; he did measure already; it will be a couple more weeks. Process was explained: The Town pays the money out and receives the service or product; the Town then submits a voucher to New York State and they will reimburse the Town with the committee money promised. Historian felt that when the as-built drawings are complete, we can submit and receive a portion of the money. Erin Anheier has been working on a rough draft of an application to the National Register on behalf of the entire Hillside Cemetery. If listed, it may help with grant funding for the cemetery too.

The Board adopted the lease agreement with Nick Penna to farm Hillside Cemetery property for \$825 in 2012.

### NEW BUSINESS

Superintendent Swanger requested the Board delay action on the NYS Roadside Mowing Contract. Many Superintendents are not happy with the language. The State is requiring 8 signs on the roadsides when mowing and special lights on the mower. Superintendent felt that for the \$2600/year paid the Town, it will not be worth the contract; the signs will cost

\$150 each. The Town would need to have a man moving signs while another one mowed. Superintendent reported that other towns feel the same way. Last year, the job was done in 8 hours; 2 mows, one pass. Now the State is requiring roadsides be mowed back to the right of way, that towns list the state as additional insured and provide a certificate of insurance, and get a work permit. Item tabled to May agenda.

Edgar Storm of Ogden addressed the board on behalf of himself and his partner, Micah Eldridge of Clarendon, regarding their proposed personal storage facility on Fourth Section Road in a Rural Residential (RR) zoned area of town. Mr. Storm reviewed the benefits of their project for Thomas Estates residents, Akeley Manor residents and Brockport College students. Mr. Storm reviewed that a storage facility is not a permitted use in RR zoning, but is allowed in Residential Agricultural (RA). Mr. Storm informed the board that he and Mr. Eldridge have put in a purchase offer on the property, contingent to a change in zoning or a use variance issued. Mr. Storm read off the conditions of such a variance and gave responses to each. The Board was informed that the plan was to build the mini storage in multiple phases, leaving woods, tree line, retention ponds, neat fenced in landscaping and keypad security for access. It was stated that Mr. Storm & Mr. Eldridge were scheduled for a public hearing with the Zoning Board for a use variance on May 1<sup>st</sup>. Board members felt the project should go through that process prior to Town Board discussion of the issue.
