



CLARENDON PERSONALITIES Everett Albert Campbell

Everett Albert Campbell was born on July 18, 1927 in Luisville, New York to Alfred and Irene (White) Campbell. When Everett was one, his family moved to a farm in Ogdensburg, New York on the St. Lawrence River. Everett being the oldest of nine children (six boys and three girls), remembers fishing a lot in a big creek when he was young. At age seven, Everett began school and walked one and a quarter miles to attend a one-room schoolhouse in Flaightville Corners. Due to the depression, Alfred lost the farm and the family moved to Corbin's Corners at Routes 20 & 36 on April 1, 1939. There the family rented a 600 acre dairy farm and managed 100 head of cattle. A year later they moved to Caledonia/Avon area and rented a 250 acre farm from Pete Macey. Mr. Macey being a millionaire, had a mansion with a water wheel on the property that is still there today. Everett remembers playing on the water



In 1948, Everett began working part-time for Birdseye/Snyder Foods and by 1949, was a full-time employee on the company farm on the Lakeshore in Kendall. That is where he met his future bride, Letha Smith, who worked at setting broccoli and tomatoes in the field. Everett managed the farm for two years before working in the Field Department on the road, contracting crops with growers all over Western, NY all the way to the Pennsylvania line. After 39 years of service to the company, Everett retired from what had become General Foods.

Letha and Everett were married in 1950 and lived in a one-room schoolhouse on the County line & Lakeshore Roads north of Morton which Everett had remodeled. Eleven years and three children later, they moved to Clarendon and purchased the 70 acre George Barber Farm at 15942 East Lee Road, where Everett lives today. Everett remembers his winning the bid for the farm over a total of four bids. The farm was rented to an area farmer when purchased, and Everett continued to lease the land. Maxon Farms has worked Everett's fields for close to 40 years, Homer, Glenn and now Chuck Maxon. While Everett continued to work for Birdseye, Letha stayed at home and raised their children. When they had graduated, Letha went to work part-time at the Holley School. Everett planted grapevines and fruit trees on his land and still shares his harvest every year with many of his neighbors. Everett remembers when he planted the 75 tree Cedar Hedge west of his house. It was a year after his friend George Novak passed away. George's wife Shirley decided to plant trees then too, but hers didn't survive like Everett's did. When Shirley asked Everett why, he simply told her that he watered and 'prayed over them' every day!

Both Everett and Letha were active in the Fire Company. Everett helped in negotiations with the Town for a fire protection contract and was instrumental in the start of the ambulance service. Everett served as Captain of the Emergency



Squad for eleven years and both he and Letha took their medical training from 'Rotten Robert' Woodworth! They then spent weekends at their EMT training in the emergency room at Rochester General Hospital for an entire year. Becoming unhappy with some of the Board's decisions and especially the Road Commissioner at that time, Everett decided to serve on the Town Board. In 1967 Everett was elected as Councilman for the Town of Clarendon, where he served the Community for 35 years. In January of 2000, the Batavia Daily News published an article about Everett and his many years on the Town Board. One of Everett's biggest concerns was the care of the Town's Pioneer Cemeteries.

Everett and Letha enjoyed hunting and fishing together. Everett remembers that Letha had gone deer hunting days prior to her scheduled heart surgery in 1990.

Letha went into the hospital for heart surgery and two days later on December 3rd, passed away.

Today, Everett enjoys retirement, his family and friends, and continues to attend St. Mary's Church in Holley. Two of his children, Danny and Judy, live in Clarendon and Jeanne lives in Henrietta. Everett has seven grandchildren and one great grandchild who, Everett was glad, came to visit this year from Pennsylvania. Everett is still active with his hunting, fishing, gardening and chopping wood.

Everett shared a couple of major life experiences that he'll never forget. In the 1950's after work, Everett checked his trap line along the lakeshore. The ice was just starting to break up and waves were hard. He found a dead woman on the shore of the lake and upon the arrival of Jack Williams, Sheriff at the time, he tied a rope around his waste and went down the bank to retrieve the body to land. The woman was identifiable, but estimated to be between 16-25years of age. Everett remembers over 100 phone calls from families of those who had young girls missing, in an attempt to connect evidence or identifying marks; mostly from Canadian families. The woman was never identified and is buried in Mt. Albion Cemetery in an 'unknown' plot. Everett says that one thing that will never leave him is his training as an EMT. He believes it saved his brother's life on a 1970 hunting trip in the Southern Tier. His brother, Gerald, got shot through the leg and it took off 2" of his artery in the thigh. When Everett reached him from a ½ mile away, he sent the other hunter for an ambulance while he dressed the leg with a traction splint and bandage. An area farmer led the ambulance on his tractor through a very snowy field and the medics carried Everett's brother out of the woods on a stretcher. They took him to Warsaw Hospital where the doctors sent him to Strong for treatment, but left Everett's professional dressing on the leg!

If you've ever been to Everett's house, you'll be greeted on the front porch by a standing, three-legged bear that Everett got while hunting in northern Quebec, Canada. Everett's walls are covered with hunting and fishing trophies, heads, horns and photos. Everett's family have all had a hand in hunting and he says that his daughter Jeanne takes after her mother, as he sports an eight-point buck head of hers on his wall! Everyone would hang their deer in Everett's barn and it was an all day project with his saws and hoists, to cut up and double-wrap package the meat. Everett still cuts his own deer! Everett's 'toys' include a 22' Starcraft cabin boat, two Articat four-wheelers, a Honda three-wheeler and a four-wheel-drive Mulley for riding his lands to hunt and haul wood.

"Everett is like our Community Grandpa" says Susan Colby, Town Clerk. "It's really enjoyable to 'tour' Everett's place, as he's so full of knowledge and fun tales! Every year, he brings us buckets of fruit to the Town Hall and invites me back to help myself to his grapevines!"

Everett passed away on October 23, 2013. He was 86 years old. Everett will be missed by all that knew him.

HILL TALK

ARE WE STILL ABLE TO ENJOY THANKSGIVING?

Thanksgiving was, next to Christmas, the most important holiday that we celebrated when I was young. Our family fortunes did climb very high and fall very low during my childhood, but surprisingly, the most memorable Thanksgivings happened when it would seem that we had the least to celebrate. We didn't always have turkey; a couple of chickens would do in a pinch, but how very much we looked forward to it! Those weeks of preparing sure paid off at that big table as we enjoyed the food and the conversations with loved ones, especially with those from far-off because telephone calls, especially those long distant ones, were very expensive back then.

The moment of the Thanksgiving prayer was a serious and profound time for us and usually focused on the harvest time. We were truly thankful for what we had and we all knew how much that harvest would impact us for the rest of the year. In those days before antibiotics and polio vaccine we were also thankful that we were still able to be together.

Our own harvest consisted of clearing the garden and preparing the pit for the root vegetables; we didn't have room enough in the cellar after the canned goods were stored and the onions were laid out on screens. The pit was a large square hole on a slope about two feet deep with a drain at the lower end. We would clean it out for the new crop and then place all of the root vegetables inside on a bed of straw before covering them with more straw and then tarps. I don't know if this method would work up here or not as the snowfall can be pretty significant.

One of the ways we prepared involved gathering, drying, and then cracking some of the hickory nuts and butternuts for the stuffing. The rest would become special snacks in the winter.

If a turkey wasn't available, we would be eying the roosters to figure out which ones would have the honor of gracing our table. I remember

that one year I was opting for an especially mean Plymouth Rock rooster we called Rasputin. He would attack us when we gathered eggs, but my father liked his aggressiveness when protecting the hens. He did grace our table that year, but only because he went after my sister causing my mother to shoot him.

Sweets weren't a daily part of our diet back then, so the brandied peaches and spiced pears were unbelievably delicious to us. Pies and cakes would follow later in the day when we had more room under our belts. They would be remembered in our young daydreams for months, especially when we impatiently waited for supper hours.

With these wonderful memories in mind it is somewhat mind-boggling to walk into a store around this time of year. As I write this, Halloween is THE HOLIDAY! THE BIG ONE! And the IMPORTANT ONE! I know that coming soon there will be Thanksgiving decorations along with turkey sales and pies displayed in these same stores, but Christmas motifs will overshadow them.

Is Thanksgiving's present downsizing due to a lack of commercial opportunities or is it simply a lack of excitement for younger generations who have been raised with these new wildly stimulating, electronic games, movies and TV shows?

Thanksgiving can and should be a wonderful time. It is so much more than turkey, stuffing, and that yearly prayer. Put aside electronics, wild movies, and games. Talk and share about the blessings of food, health, and fellowship that we can thank our maker for. Learn to really know one another in a profound way as you perpetuate the happenings of today along with the memories of yesterday. I'm sure that your own memories of past Thanksgivings have more to do with the gathering of loved ones than even the most spectacular turkey!

So, are we still able to enjoy Thanksgiving?

"OLD STONE STORE" BEGINS A NEW CHAPTER IN ITS HISTORY

On October 25th, the Town of Clarendon turned the Old Stone Store over to its new owners, Joe and Sue Fertitta. The 177 year old building is listed on the State and National Registers of Historic Places but has been vacant since 2007. Plans had been made for its demolition. But community members told the Town Board that they didn't want to lose the iconic building that holds many memories. The Board listened and sanctioned a volunteer organization known as the Old Stone Store Preservation Committee.



The committee raised funds through donations, removed debris from the property, made necessary structural repairs, pub-

debris from the property, made necessary structural repairs, publicized that the property was available and documented the building and its history, which led to the listing on the Registers of Historic Places. They worked with the Landmark Society of Western New York to raise awareness of the potential of the site. They conducted many tours for prospective buyers and kept the building in the public eye through various media outlets. None of this required any financial support from the Town.

The committee identified the Fertittas as the best potential new owners to bring the building back to life. They have a strong reputation as rehabbers of distressed properties. The Town Board agreed with their plans to make a large two bedroom apartment on the second floor and have commercial or office space on the first floor. They also plan



to restore the front porch based on historic photos.

The Town had taken ownership of the property and planned to demolish it to avoid the cost of repair and upkeep. By selling it to the Fertittas for \$1.00, the cost of demolition will be avoided, the property will contribute to the tax base and Clarendon retains a historic building that will once again be an attractive part of the hamlet. The committee thanks everyone who showed their support for saving this building. We can be proud that our community can work together so effectively.
