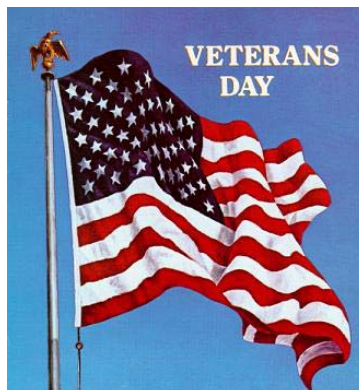

## HISTORICAL HAPPENINGS IN CLARENDON

CLARENDON HISTORICAL SOCIETY

In 2014, the Clarendon Historical Society has provided six free programs, open to the public, centered on historic subjects important to Clarendon. Over 465 people have attended these events. The titles of these programs were Carl Akeley's 150<sup>th</sup> Birthday, Anatomy of a Barn, History of the Universalist Church in Orleans County, Making of the Muck Lands, Historic Medina Sandstone and Memories of Manning Corners. We held six scheduled open days at the museum, in addition to opening it upon request for individual tours. Our buildings and grounds were used by the Town, as needed, for meetings and the annual hot dog and music celebration in the summer.

This year our society has also spearheaded a fund raising campaign to assist in financing the restoration of the chapel in Hillside Cemetery. To date, we have gathered \$6971.25 towards this important project. In addition to collecting donations from supporting individuals, our members have prepared and submitted grant applications for a total of over \$135,000. We also took on responsibility for planning and running the Town's event to celebrate Hillside Cemetery being placed on the National Register of Historic Places. This honor was obtained through the work of our members. The event centered on the unveiling of a roadside historical marker which was obtained with a grant, as a result of the efforts of Society members. Also, through the advocacy of our members, Hillside Cemetery and Chapel have been named to the Landmark Society of Western New York's 2014 "Five to Revive" list. The programs and the fund raising campaign have received favorable press coverage in Orleans, Genesee and Monroe Counties. We feel this benefits Clarendon by creating favorable public opinion of our community, as well as increasing interest in local history.

We have also work begun to work collaboratively with other historical groups. The Elba Historical Society helped us with the presentation on the Making of the Muck, The Medina Sandstone Society assisted us with our Medina Sandstone Presentation and our County Historian Bill Lattin has been available and a speaker during several meetings. We have assisted the Cobblestone Society in investigating the repair of a Carl Akeley fox. And I gave a presentation on their behalf regarding the fox at the Daughters of the American Revolution site during the Inaugural Museum Crawl Event held October 4th. All in all, it has been a busy and successful year for the Clarendon Historical Society and we are already planning exciting programs for next year.

At the Board meeting, Historian Ierlan acknowledged the 'Buffalo Paint' sign recreated and donated by Carol Culhane, Gaines Supervisor, for display on the old stone store building. It is a replica of the original that hung there when Copeland's Store was in the building. Councilman Robinson gave praise for the recent Historical Society presentations; they've been very good and interesting. Thank you.



The After School Friends Group' visited Hillside Cemetery this month. The adults who run the program are Jean Smith of Clarendon and Pastor Tom of the Holley Presbyterian Church. The Clarendon Town Historian joined up with them to walk around the cemetery and the group wanted to find the oldest head stone. We walked to the area where the first burials were done at the bottom of the terrace in the center division. These graves were removed from another cemetery and re-buried in Hillside and they pre-date the cemetery which opened in 1866. The group then had a tour of the Hillside Chapel and other than the big scary spider on the door, they enjoyed seeing the building.

### WHEN GOD WINKS

They are everywhere! You will find them at food cupboards, free kitchens, churches, schools, hospitals, volunteer fire departments and ambulances, just to name a few.

I know of a 96-year-old social worker who still works every day because it is her mission in life, and a woman, who after spending years running a food cupboard day and night, spends her days delivering flowers to those sick, in need, or just to celebrate a birthday. Through my late health problems, I sat in a recliner and was comforted by the prayer quilt draped over it; freely made by some local ladies.

At one time or another most of us are used, temporarily at least, as an "Earth Angel" whenever we help with one of those winks. One of the big "perks" about delivering a "God Wink" is seeing the wonderful effects on the recipient. It goes without saying that it also has a similar if not an even stronger effect on us. It almost feels like it's what we should be doing all of the time!

So be a helper the next time God winks!

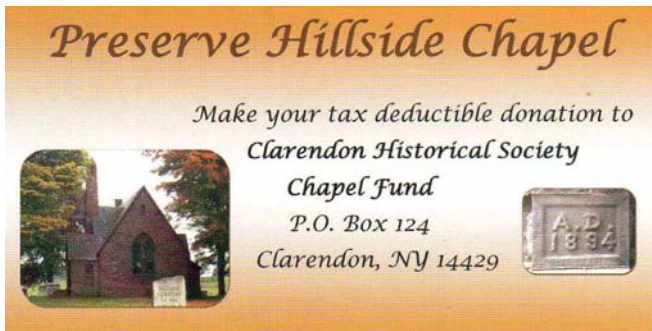

**HILLSIDE CEMETERY AND CHAPEL HONORED BY LSWNY**

On October 7, 2014, the Landmark Society of Western New York announced its 2014 Five to Revive – a list of historic sites it has determined to be in need of targeted revitalization. The list includes the Auditorium Theater in Rochester, NY, the Designated Buildings of Historic Value List of Rochester, NY, the Erie Canal Warehouse in the Village of Brockport, Hillside Cemetery and Chapel in the Town of Clarendon and the Former Trinity Episcopal Church, Town of Seneca Falls, Seneca County

“The preservation efforts of The Landmark Society of Western New York continue to be focused on community revitalization,” said Wayne Goodman Executive Director. “This is the second year we are announcing a Five to Revive list to call attention to key properties in western New York that are in need of investment. We can’t stress enough that these are significant historic properties whose rehabilitations can become catalytic projects for the neighborhoods and communities that surround them. “

The Five to Revive initiative, chaired by Tom Castelein, Vice-President of Preservation on The Landmark Society Board, continues to enhance the organization’s ongoing efforts to support revitalization in western New York. “Our inaugural 2013 list of properties are moving closer to the goal of contributing to economic revitalization in their communities,” said Castelein.

“Preservation is revitalization,” said Goodman. “Preservation creates local jobs, stimulates investment, increases tax revenues and builds sustainable communities. When residents, communities and those in local and state governments work together the possibilities are limitless.”

Here is what Mr. Castelein had to say about our cemetery: “Located just outside the village of Holley, Hillside Cemetery is an active town cemetery established in 1866 and developed between 1866 and 1938. Encompassing approximately 30 acres, the Cemetery is a significant example of two periods of cemetery design. Built in 1894, the elegant Gothic Revival Chapel is prominently located near the entrance to the cemetery on the west side of South Holley Road and is a primary feature of the cemetery. The Chapel has been vacant and largely unused since the 1960s. Both the designed landscape of the Cemetery and the Chapel suffer from deferred maintenance and lack of funds. The Hillside Cemetery and Chapel are important examples of historic landscape architecture and building architecture in Orleans County. They are highly visible resources at the southern gateway into the village of Holley. With such historic and architectural significance, the Hillside Cemetery and Chapel could, with proper funding and maintenance, serve as attractive assets in the Clarendon and Holley communities.”

The Landmark Society of Western New York, Inc. is one of the oldest and most active preservation organizations in America, serving nine Western New York counties. Formed in 1937, The Landmark Society continues to protect the unique architectural heritage of our region and promote preservation and planning principles that foster healthy and sustainable communities. The Planning Board meeting was cancelled due to insufficient agenda items.

## SUPERVISOR REPORT

Richard H. Moy, Supervisor

Supervisor Moy reported that the town tax levy for next year is less than this year, but the town will need to adopt a resolution to over-ride the tax cap because of the Water Improvement Benefit Area No. 11 construction project. The tax rate for 2015 is proposed to be the same as this year.

## CORRESPONDENCE

NYSDEC has sent an acknowledgement of Clarendon's adoption of the Climate Smart Communities Pledge. Partial court loss payment in the amount of \$114.29 has been received. NYSDOT has paid \$26,717.15 for Snow & Ice Agreement

of 13/14. \$314.62 has been refunded to Water District No. 9 from the Build America Bonds funding. The Town has received \$32.47 from the Orleans Economic Development Agency for its share of the PILOT program – Falls Rail Road. John Kemp has submitted his resignation from the Board of Assessment Review. Orleans County Board of Elections has sent information regarding elections on November 4<sup>th</sup>. NYS Association of Towns has sent results of its energy survey.

## OLD BUSINESS

The NYS Comptroller has acknowledged receipt of Clarendon's application for Water Improvement Area No. 11; the Town is waiting for approval.

Board members accepted the proposal for legal services in 2015 from Attorney Karl Essler and proposed zoning ordinance amendments were approved. The Town Board denied funding requested for the IDA. The Tentative budget was introduced, amended by adding \$3000 into medical and dental insurance accounts for general and highway funds and \$15,000 (1/2 of the money received from NYS Snow & Ice for adjustment in payment from severity of weather) into highway unfunded balance and accepted, becoming the preliminary budget; A public hearing was scheduled for November 6 at 7pm at the Town Hall.

Local Law No. 3 of 2014 regulating outside storage of junk materials and Local Law No. 4 of 2014 over-riding the state tax cap, were introduced and public hearings were scheduled for November 6 following the budget hearing.
