Town of Clarendon

PLEASE TAKE NOTICE that on September 18, 2015 the Town Board of the Town of Clarendon adopted a Resolution creating Extension No. 1 to Town of Clarendon Water District No. 9, such District located on Holley Byron Road (NYS Route 237) between Powerline Road and 600 feet southwest of McAllister Drive. The District will involve the installation of approximately 1,700 linear feet of 8 inch DR-19 PVC water main, valves, hydrants and appurtenances within the District Area and will also provide fire protection to the District area. The total estimated cost of construction is \$82,665.00. A copy of the entire Resolution is on file in the Office of the Clarendon Town Clerk. This Resolution is subject to permissive referendum pursuant to Town Law Section 209-q(11), a petition for which must be filed with the Town Clerk within thirty (30) days after the adoption of the resolution.

CLARENDON TOWN BOARD—Meeting Highlights September 2015

Supervisor Moy asked the students present to introduce themselves; Melissa Gates, Meghan Clark and Colton Major.

HIGHWAY/WATER DEPARTMENT REPORT –

Superintendent Larry Swanger reported working with a short crew due to vacations scheduled. Clarendon has helped other towns with paving, reciprocating help from other towns with shoulder work on Taylor Road; work will be done on Bennetts Corners Road next week. The third roadside mowing has been started. The highway crew has been clearing the scrub at the south end of the Hillside Cemetery. A new garage door has been installed at the Hillside Cemetery garage. Superintendent Swanger reported no bids received for the highway garage roof project. Superintendent will let the highway guys do it; employee Pete Surowy has experience in putting on a metal roof. It was stated that the town will need to go out to bid for the materials. Dead-end hydrants are flushed and hydrants working on Hinds, Merrill and Glidden Roads in WI-BA #11; people are able to hook-up to the new waterline there.

PLANNING BOARD REPORT –

Chairman Dave Griggs submitted the following written report:

Regular Meeting August 25, 2015

SD 15-08 Pre Conference for building lot approval, tax id#97.-1-14.212, Ken Trowbridge 15798 East Lee Road. The applicant provided a sketch of the property with the house location. Existing holding tank for wood shop will be filled in and abandoned in place. Existing perc data OK'd by County for new septic. Front setback dimension questioned. No significant issues noted with this proposal. This is a lot Type II Minor SEQRA action as determined by the Planning Board. The applicant was notified of his right to waive the pre-conference and move to a formal application. Applicant waives the pre-conference. A motion was made, seconded and approved to amend the agenda from a pre-conference to a formal. A motion was made, seconded to approve application contingent upon verification of the front setback dimension by the OIO.

SP 03-04 Special Use Permit renewal, Alternative energy system, Yuri Odeuchuk, 4355 Holley Byron Rd. Fee paid, inspection complete, no complaints on file. Motion made and seconded to approve renewal

Regular Meeting September 8, 2015

SD 15-10 Pre Conference for One (1) Lot Sub-division 17113 LaDue Road tax id# 121.-1-53, Applicant Eris Oleksyn, Owner Robert & Susan Saucke. The Board determines that this is a Type II action for SEQRA purposes. Chairman Griggs informs the board that on the advice of TOC Assessor, Cindy Davis, he has verified with Dawn Allen, Orleans County Real Property director, that the proposed corner connection of parcels was acceptable. The Board agrees that the corner connection as proposed (25 foot) needs to be revised to a 30 foot dimension to comply with TOC Sub-division requirement. No other issues were noted with this proposal. Chairman Griggs informs the board a letter is on file from the applicant asking to waive the pre-conference and move to a formal application if there are no issues. A motion was made, seconded, and approved to move to a formal application. A motion was made, seconded and approved to approve the application contingent upon receipt of revised survey maps correcting the 25 foot dimension to the required 30 feet, creation of a deed merging parcel #121-1-53 and # 121-1-52 together and submission of the Deed and the revised survey map to the county.

HISTORIAN/HISTORICAL SOCIETY REPORT –

Historian / CHS President Melissa Ierlan reported that on October 3rd there will be a ghost walk at the Hillside Cemetery. Students in the History Club from Genesee Community College will play the role of prominent town characters that are buried in the cemetery; Students have been working at the museum site over the summer. Supervisor Moy has checked with the insurance company and says the town is 'good to go'. This is being done in conjunction with the Genesee-Monroe-Orleans County Museum Crawl. Bill Latin will have a talk in the chapel from 4 to 5PM.

Brigden Memorial has donated a stone for Lillian Bentham, the Titanic survivor buried at Hillside; there is a story on the stone. Roy Bubb has purchased a stone for Phoebe Sprague, woman doctor from Holley. The ghost walk will be from 7 to 9 PM. Lions Club will cook hots on the corner. The Society is looking for civil war re-enactors for that day. The CHS museum was open on Sunday. Pam Toman came in and finished the inventory. Betsy Kennedy has compiled a spread sheet from the inventory sheets showing items at the museum site.

CORRESPONDENCE

NYSDEC has sent a copy of the mining permit issued to Keeler Construction for the gravel pit on Chugg Road. NYS Department of Public Service has sent a schedule for a series of regional information sessions and public statement hearings regarding two proceedings currently before the Commission; an examination of low income programs offered by major electric and gas utilities in New York State and a joint petition submitted by Time Warner Cable and Charter Communications seeking approval to merge. Orleans County Self Insurance has sent notice of 2016 compensation insurance premiums; Clarendon's will be \$34,379 (a decrease of 1.4%). The Rochester Area Community Foundation has sent \$20,000 in grant funding for historical preservation of Hillside Chapel.

OLD BUSINESS

It was reported that construction of the WIBA #11 watermain is on Chugg Road now. The only road left to lay pipe is Holley Byron Road (NYS Rte 237). Then the contractor will do clean-up. The Town Board authorized Supervisor Moy to sign a legal services agreement with Bond, Schoeneck & King (Attorney Essler) for Water District No. 9 extension project and a SEQR Resolution was adopted for the same. A Public Hearing for WD #9 ext. was held on Friday, September 18th. Chatfield Engineers presented a map of the project area (Holley Byron Road from Powerline Road approximately 1700 linear feet southwesterly) and an explanation of computation of estimated first year cost to typical property and typical one or two family home. Debt service charge for these homes to be included on the tax bill was presented at \$474.62. The Town Board accepted part 3 of the environmental assessment and determined a negative declaration under SEQR for the project. The Board established extension no. 1 to Clarendon Water District No. 9 subject to permissive referendum.

General discussion was held regarding Solar Power; Board members not comfortable with the matter yet and will wait to see it successfully working elsewhere prior to consideration. Other in-house steps possible were discussed; LED lighting, improvements at highway building; the roof and furnaces, etc. The Board adopted the proposed Zoning Ordinance Amendments; Section 636 – Trailer, Travel / Camper / Recreational Vehicle (a copy is available at the Clerk's Office for review) and resignation from the Zoning Board of Appeals was accepted from Mark Flint; he has moved to Tennessee.

The Board held a workshop meeting to review proposed budget items for the 2016 town budget. The Tentative Budget for 2016 was presented to the Board Members by the Town Clerk at a Special Meeting on September 29th.

HILLSIDE HERITAGE EVENTS ANNOUNCED

The Clarendon Historical Society and the Genesee Community College History Club will be presenting "Hillside Heritage Events" in October and November to benefit the restoration of the Hillside Cemetery chapel. Designed by Rochester architect Addison Forbes, the Medina sandstone chapel was built in the Gothic Revival style in 1894. Hillside Cemetery and the chapel are listed on the National Register of Historic Places and have been recognized by the Landmark Society of Western New York as one of the "Five to Revive" properties for 2104. Hillside Heritage Events will include a series of evening lectures, sans technology, inside the chapel itself at Hillside Cemetery, outside the village of Holley. Lectures begin at 7:00 PM and are free, though donations to the restoration fund are gladly accepted. **Oct. 26th** – GCC Associate Dean of the Orleans County Campus Centers and Historian Jim Simon will present "The Philosophy of History: What Does it Matter?" **Nov. 2nd** – GCC Associate Professor Derek Maxfield will present "Victorian death and the Civil War." On **Sat., Oct. 3rd**, Hillside Heritage events will include a full day of programs intended to spotlight the chapel and cemetery culminating in an evening "Ghost Walk."

GCC students will serve as guides and ghosts in Hillside Cemetery's first "Ghost Walk." The walk will include a tour of the old cemetery, with stops at eight stations associated with the graves of significant local people. The "ghosts" will portray the folks buried in the cemetery and will relate their life stories. One of the "ghosts" will be a surprise local celebrity. Admission to the "Ghost Walk" will be \$10.00 per person to benefit the chapel restoration fund. Advance tickets are available at the Clarendon Town Hall and the Village of Holley Offices. Any remaining tickets may be purchased at the door. All tours will start at the chapel in Hillside Cemetery. The Clarendon Lion's Club Concession Stand will be onsite. These events are part of an on-going fund raising campaign by the Clarendon Historical Society with the goal of restoring the chapel to once again make it available for public use with anticipated uses to be lectures, art exhibits, concerts and historical displays. The Town of Clarendon recently received a grant of \$20,000 from the Rochester Area Community Foundation. Rochester Area Community Foundation works to improve the quality of life in the greater Rochester region by evaluating and addressing community issues, promoting responsible philanthropy, and connecting donors to the critical needs of the community. to host talk on History of Apple Production**

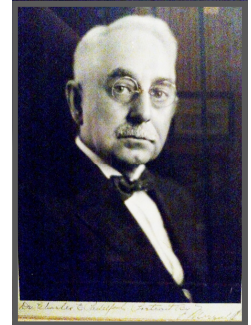

Dr. Charles E. Padelford (Sept. 21, 1869- Dec. 6, 1943) was a resident of the Town of Murray and had a practice in the Village of Holley.

He was one of two doctors in the village at the time, the other was Dr. Ogden. Dr. Padelford was located in the square near the church for many years.



His name appears as attending physician in some of the old birth and death records at the Clarendon Town Hall. His headstone is very unique as it is shaped like an urn which symbolizes the soul, other headstones may have a small



urn adorning the top of an obelisk but this large urn is the actual marker. A road is named after him in the Town of Murray.

COMMANDMENTS
-Of-
FIREARM SAFETY**



1. **WATCH THAT MUZZLE!**
Keep it pointed in a safe direction at all times.
2. **TREAT EVERY FIREARM WITH THE RESPECT DUE A LOADED GUN.**
It might be loaded, even if you think it isn't.
3. **BE SURE OF YOUR TARGET AND WHAT IS IN FRONT OF AND BEYOND IT.**
Know the identifying features of the game you hunt. Make sure you have an adequate backstop - Don't shoot at a flat, hard surface of water.
4. **KEEP YOUR FINGER OUTSIDE THE TRIGGER GUARD UNTIL READY TO SHOOT.**
This is the best way to prevent an accidental discharge.
5. **CHECK YOUR BARREL & AMMUNITION.**
Make sure the barrel and action are clear of obstructions, and carry only the proper ammunition for your firearm.
6. **UNLOAD FIREARMS WHEN NOT IN USE.**
Leave actions open and carry firearms in cases and unloaded to and from the shooting area.
7. **POINT A FIREARM ONLY AT SOMETHING YOU INTEND TO SHOOT.**
Avoid all horseplay with a gun.
8. **DON'T RUN, JUMP OR CLIMB WITH A LOADED FIREARM.**
Unload a firearm before you climb a fence or tree, or jump a ditch. Pull a firearm toward you by the butt, not the muzzle.
