## NOTICE OF ADOPTION OF BOND RESOLUTION SUBJECT TO PERMISSIVE REFERENDUM

PLEASE TAKE NOTICE that the Town Board of the Town of Clarendon, Orleans County, New York (the "Town"), at a meeting held on August 18, 2015, adopted a bond resolution, which is subject to a permissive referendum, that authorizes the issuance of \$230,000 serial bonds of the Town to finance the purchase of machinery and apparatus to be used for constructing, reconstructing, repairing or maintaining Town improvements, including a plow truck to be used by the Highway Department (the "Project") the cost of which is \$30,000 or more. The period of probable usefulness is fifteen (15) years and the bonds are payable from amounts to be annually levied on all the taxable real property in the Town. Pursuant to the New York State Environmental Quality Review Act and the regulations promulgated thereunder ("SEQRA"), the Town has determined that the project is a Type II Action requiring no further action under SEQRA.

#### **LEGAL NOTICE**

BE ADVISED that the Town of Clarendon hereby authorizes the appropriation of \$1,600.00 for purpose of engaging Chatfield Engineers, P.C. to prepare a general map, plan and report for such proposed Extension No. 1 of Town of Clarendon Water District No. 9 as required by Town Law § 209-b, which such map, plan and report shall comply with Town Law § 209-c; and that, pursuant to Town Law § 209-b, this Resolution is subject to permissive referendum pursuant to the terms of Article 7 of the Town Law, and shall not become effective until either the time for filing a petition for a permissive referendum has expired without such petition having been filed or until this Resolution has been approved by permissive referendum if such a petition is timely filed. ALSO BE ADVISED that the Town of Clarendon has received an Engineering Report from Chatfield Engineers, P.C. regarding the establishment of a new water supply district within the Town of Clarendon designated therein as Extension No. 1 to Town of Clarendon Water District No. 9; and WHEREAS, such Engineering Report generally sets the boundaries of the proposed Extension No. 1 to Water District No. 9 as extending approximately 1700 linear feet southwesterly along Holley-Byron Road from the intersection of Holley Byron Road and Power Line Road and encompassing all or portions of the following tax parcels: 87.-4-34; 87.-4-38.21; 87.-4-36; 87.-4-37.1; 87.-4-51; 87.-3-22; 87.-3-65; 87.-3-21; 87.-3-20; and 87.-3-19.114, all as more fully described in the Engineering Report; and (Continued on Page 4)

## **CLARENDON TOWN BOARD—Meeting Highlights August 2015**

The Town Board held its annual August meeting at the Historical Society Museum Barn. Brick provided music and the Historical Society served hot dogs and drinks from 5 to 7pm. The meeting began at 7:00.

#### **OPEN END**

Pat Giglio reported that the American Legion Ladies Auxiliary will hold its annual Pasta Dinner on September 19<sup>th</sup> from 4:30 to 7:30 PM. Jim Moore, Historical Society Vice-President thanked the town for again hosting this evening's event. This is a very nice thing to do; a small community coming together to relax.

#### HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Swanger submitted a written report; as follows: The second roadside mowing is complete. The Highway Crew has worked on Taylor and Bennetts Corners Roads preparing for paving. Taylor Road from Bennetts Corners Road to the County Line has been paved and the Bennetts Corners Road from Route 31A to the Taylor Road has been paved. Orleans County and other towns' highway crews helped with the paving and Clarendon helped other towns and the county to pave and seal. Two water taps were installed for new homes and one grave was dug this past month.

#### PLANNING BOARD REPORT

Chairman David Griggs submitted the following written report:

Regular Meeting July 28, 2015

SD 15-06 Pre Conference for 1 lot subdivision tax id# 120.-1-37 Sara Bartholomew-Burton, 5528 Holley Byron Road. The applicant provided a sketch from the surveyor of the property to be conveyed. No significant issues noted with this proposal. This is a one lot Type II Minor subdivision as determined by the Planning Board. The applicant was notified of her right to waive the pre-conference and move to a formal application. She waives the pre-conference. A motion was made, seconded and approved to amend the agenda from a pre-conference to a formal. A motion was made, seconded to approve application contingent upon receipt and review by the OIO and Planning Board Chairman of stamped survey map showing pins set and receipt of filing with the county of property merger.

SD 15-07 Pre Conference for 1 lot subdivision tax id# 97.-1 -53.1 George Mathes East Lee Road. A pictometry map has been provided to show the lot and locations of existing buildings. The county is reviewing Ag districts and may be combining the three county districts into one. Some discussion about removing the parcel from the Ag district at that time to avoid lateral restrictions etc. To be determined. Additional information is needed to finalize application. This application will be carried on the next agenda and remain in a pre-conference stage until more information and a licensed survey map is provided.

Regular Meeting August 11, 2015

Cancelled due to lack of sufficient agenda items.

#### CORRESPONDENCE

Orleans County Board of Elections sent notice of election dates. (See notice on front page of this Gazette). Membership dues for 2016 New York State Association of Towns is \$999. NYS Office of Real Property has sent notice of Town's Final Equalization Rate for 2015 Assessment Roll at 100%. Partial payments have been received for the cemetery vandalism restitution and court loss restitution. Hindsburg Road resident Eric Bradshaw has submitted a letter of application for the Planning Board. The Town has received \$800 in revenues from the Traffic Diversion Program for April through June 2015.

#### **OLD BUSINESS**

Supervisor reported that when the Water Improvement Benefit Area No. 11 main is installed on Glidden, Hinds and South Holley Road, the contractor will install the taps there; Glidden has been tested and approved. The Town Board authorized Chatfield Engineers to prepare a map, plan and report for proposed Water District No. 9 extension at a cost of \$1600, subject to permissive referendum (to replace private line on Route 237) and adopted an order to hold a public hearing for formation of WD #9 extension on September 18<sup>th</sup> at 7pm providing no petition is filed regarding the engineering report expense.

Supervisor spoke with an engineer at the Orleans County Fair regarding solar power. Laws have changed since the first presentation to the town regarding solar and the town can now put in any size system desired, not just sufficient enough to handle government electric needs (for citizens too). Supervisor will research this more in depth for next month's meeting.

The Board adopted a SEQR Resolution declaring the proposed zoning text amendments will not have significant adverse environmental impacts. The proposed amendments will go to the County Planning Board for review.

#### **NEW BUSINESS**

The Board adopted a SEQRA Resolution and a Bond Resolution (subject to permissive referendum) relating to the town's purchase of a truck with plow/sanding equipment.

Workshop meetings for the 2016 Budget were scheduled; September 21<sup>st</sup> at 9AM and if needed, September 22<sup>nd</sup> at 9AM.

Hillside Cemetery Rules and Regulations were amended to require bodies left in the vault during the winter to be removed and interred or cremated by May 15<sup>th</sup>.



## Rural Community in Western New York Hosts Growing Canadian Cluster of Businesses BUFFALO NIAGARA ENTERPRISE Access US—August 2015

Canadian companies are setting their sights on Buffalo and Niagara Falls to create U.S.-based locations that are close in proximity to their home operations. Canadian businesses expanding into surrounding New York counties are proving to be interested in more rural communities such as **Orleans County**, **New York**; this is due to an abundance of prime land and affordable building inventory, an industrious workforce and convenient access to the entire Northeast corridor.

One of those that came and stayed is **Hinspergers Poly Industries Ltd.**, a Canadian manufacturer of seasonal and solar pool covers, opened in 2002 in Medina, New York and has remained a consistent supporter of Orleans County. General Manager, Greg Budd, notes that the company's 83,000 square-foot warehouse manufacturing facility has expanded twice since coming to the area and annual product sales have increased up to 8 times as much since the year the company moved to Medina. Currently, Hinspergers employs over 60 people and Budd says rural Orleans County suits their company, "It's about two hours door-to-door from our head office and close enough for Owner, Peter Hinspergers, or our Vice President of Finance to come down for a visit. Our Canadian sales reps meet here, which is also close to our existing and growing customer base," he says. When looking for a place to establish U.S. operations, Budd said that many cities were considered, "I would say that this region was settled on because of the proximity to our head-office and customer base," he notes.

Additional Canadian companies with operations in Orleans County include **Associated Brands**, **Bomet Recycling**, **FreezeDry Foods** of Oakville, Ontario, as well as Niagara Falls, Ontario-based **Brunner Inc**. Brunner is a 10-minute drive from the Hinspergers plant and makes drive axles, brake shoes and S-cams, which force brake shoes apart and against brake drums; the company recently completed a \$15 million expansion at its Medina plant, which employs more than 400 and is located in a former foundry, built in 1951. Brunner Inc. Vice President, Bradley MacDonald, notes that the community is strong and has resources available to large companies such as low-cost hydropower to support manufacturing initiatives and growth, "We had more confidence in the strength of the talent base in Orleans County and Western NY," he said. "The Orleans EDA, local and state officials all collaborated and reinforced that the full scope of our expansion could be more effectively achieved in Orleans County versus other parts of the country."

Orleans County is 45-minutes from both the urban centers of Buffalo and Rochester, New York and offers a commute that is 25% shorter than the national average. Along with the surrounding counties of Erie, Niagara, Monroe and Genesee, Orleans County is part of the 3rd best performing economy and the 15th strongest job market in the United States. The region is also recognized for having some of the best real estate values in the nation and is one of America's #1 arts destinations.



## Hillside Sketches

Hillside has two grave markers in the form of tree stumps. Nationwide, you can find thousands of such markers in almost as many

variations. The tree stump symbolizes a life cut short and was a funerary art contrivance mimicking the natural surroundings of the park like cemeteries. Generally they were most popular from 1885 to 1905. One of Hillside's is unusual because it comes well after that period. Many such stones are associated with the members of the Woodsmen of the World, a fraternal benefit society based in Omaha Nebraska that operates a large privately held insurance company for its members. Once again,

Hillside's are a bit different, as they do not seem to be connected to WOW.

Ida Hayworth Clark, the wife of Charles Clark, died at the tender age of 24 in 1892. Her grave marker includes a prominent calla lily which represents beauty. A truncated branch is engraved with the words "At Home With Jesus."





Mary P. Lemke Arendt died in 1940. Her marker includes an anchor which symbolizes hope and a cross to represent Christianity.

### **Hillside Chapel Awarded Another Grant**

The Town of Clarendon received some great news recently. The Rochester Area Community Fund has awarded the town a grant of \$20,000 towards the restoration of the chapel in Hillside Cemetery. This money is to be used towards the roof replacement project, the most expensive project in the plan.

The chapel was built in 1894 of Medina Sandstone in the Gothic Revival style. Both Hillside Cemetery and the chapel are listed on the National Register of Historic Places. Due to age related deterioration, the chapel has not seen much use in recent decades. It is only used for the storage of caskets when winter weather makes burial impossible. However, it is a beautiful building with great potential as a community asset. Future uses include concerts, art exhibits, lectures and historical displays. First, however, more than 120 years of wear and tear has to be corrected. If the building is not made weather tight in the near future, we will be at risk of losing this fine example of Victorian architecture.

This is the second time we have received funds through the Rochester Area Community Foundation. This spring an anonymous donor gave \$10,000 to the chapel restoration through the Foundation. We have also received a grant from the Elizabeth Curtis Dye Foundation which recently funded the re-pointing of the exterior stone work. Altogether, \$34,500 has been raised through grants. Each of these grant proposals were written by volunteers from the Clarendon Historical Society at no cost to the Town.

The community has also shown local support through tax-deductible donations made to the Clarendon Historical Society Chapel Fund. To date, about \$9,800 has been donated. This includes some donations made in memory of loved ones, a donation from the Holley National Junior Honor Society and the proceeds from the sale of geraniums by the Holley Elementary Student Council which is also adopting the chapel restoration as their civic project for this coming school year.
