



# **CLARENDON TOWN BOARD—Meeting Highlights August 2016**

The Clarendon Town Board held its monthly meeting in August on the 16<sup>th</sup>, 2016 at the Clarendon Historical Society Museum Barn, Fourth Section Road in Clarendon, NY. Free hotdogs, drinks and music by the Brick Band was held from 5 to 7 pm. Supervisor Moy called the meeting to order at 7:06 PM. With the Pledge to the Flag.

**JENA BUCKWELL**, Powerline Road resident gave a presentation: 'UnBottle Orleans'. Ms. Buckwell informed that she is a member of AmeriCorp and currently serving with Orleans County Soil & Water working to reduce the negative impacts of bottled water in Orleans County. A summary of her presentation is included on page 9 of this Gazette.

#### HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Larry Swanger reported the second roadside mowing is complete. Glidden and Hinds roads, between Route 237 and South Holley Road have been sealed. All nine taps are in on Water District No. 9 ext. water main; four residents have been hooked up. A water service for a new house has been installed on South Manning Road. Superintendent referenced the repair done on the South Manning Road leak and pointed out the MCWA bill this month was \$5,000 lower than last; that savings was within the eight days the leak was found/repaired and the meter was read. There were no signs of a leak there, but for poor water pressure at the residence. If the residents didn't call about it, the leak would have gone unnoticed. Superintendent reported that Randy Robishaw had a plumber look at his property on Fourth Section Road and thinks the culvert east of his house is plugged, causing the surface water there.

#### PLANNING BOARD REPORT

Chairman Dave Griggs submitted the following written report:

July 26, 2016 Regular Meeting -

The Planning Board held a pre-conference for a site plan review, SD16-04, Keith Brask, 16010 Brown Schoolhouse Road tax id# 108.-2-75.12 to construct a 30' x 60' Pole Barn. After review no issues were noted with this proposal. There is a letter asking to waive the pre-conference if there are no issues. A motion was made, seconded, and approved to amend the agenda from a pre-conference to a formal application for SD 16-04. A motion was made, seconded and approved to approve application SD 16-04 Keith Brask16010 Brown Schoolhouse Road tax id# 108.-2-75.12 to construct a 30' x 60' Pole Barn. The Planning Board held a pre-conference for a site plan review for a one (1) lot subdivision SD 16-05, Robert & Anthony Christopher, 4348 Hulberton Road tax id# 87.-3-40. Review of the application determined that a survey map will be needed in order to proceed with this subdivision proposal. A motion was made, seconded and approved to table this item pending receipt of a survey map. Seasonal Permit renewal, S97.-2-10, Richard Moy East lee Road. Fee paid, no complaints, inspected by the OIO. A motion was made seconded and approved for renewal. July 9, 2016 Regular Meeting - Cancelled due to lack of sufficient agenda items.



#### HISTORIAN/HISTORICAL SOCIETY REPORT

Historian and Society President Melissa lerlan submitted the following written report: Winding down the season at the Clarendon Historical Society, tomorrow night we have a talk on the quarries. If you are available, please join us. I am ramping up with work on Benjamin Downey's Eagle Scout Project. Larry Swanger met us in the cemetery to decide where to situate the fencing Ben is putting in. If anyone would like to donate, please see myself or Ben. We have received the historical marker awarded to us from the Pomeroy Foundation for Herbert Taylor and it will be installed soon. We will have a ceremony in October to unveil it along with Tim Archer and any of his seventh graders who assisted in writing the grant application. The Orleans County Tourism Facebook page has been very supportive of all kinds of activities this summer. Our meetings and events as well as the County Historian's events have been advertised. It is another tool we have to get the word out.

#### SUPERVISOR REPORT

Supervisor Dick Moy reported time spent with Ben Downey, Boy Scout of Troop 59. He a very nice guy and has already put a lot of time into this Eagle Project. The approximate amount Ben needs to raise for the project is \$3449. He has been attending local community organizations requesting donations. Supervisor Moy commended him.

#### CORRESPONDENCE

New York State Real Property has sent Certification of STAR Exemptions for 2016-2017 school levy; Enhanced STAR exempt assessed value \$70,150; Basic STAR \$32,230.

NYS Real Property has sent Certificate of the Final State Equalization Rate for 2016; 100%.

Supervisor Moy acknowledged a thank you note with \$100 donaton to Historian Ierlan from the VFW Post 1483; she will use the money to buy paint to 'face lift' more historical markers in the county. Supervisor informed that Melissa has been using her own money to fix up and paint the historical markers around Orleans County.

#### **OLD BUSINESS**

Supervisor reviewed discussion from the water workshop meeting held Monday, the 15<sup>th</sup>. A resolution establishing new water district fees was adopted, effective with the next water billing; new fees are included on page 5 of this Gazette.

#### NEW BUSINESS

The Town Board authorized Supervisor Moy to sign a Memorandum of Understanding between Orleans County and the Town of Clarendon Highway Department in regard to interagency communication, interoperability and cooperation.

Supervisor informed board members that he cleans almost a full bag of trash from the Town Park every week; empty pop cans, pizza boxes, etc. Supervisor expressed concern that if a receptacle was provided, it would overflow with trash. Councilmen were asked to give this problem consideration for fixing it.





# Híllsíde Sketches


John Downs (1846-1901) was born in Clarendon and was educated in the local schools. His father, William Downs, was born in Ireland, moved to Clarendon in 1830, and became a

farmer and livestock dealer.

Young John followed in his father's footsteps, becoming a success in the livestock and wool business. It wasn't long before he be-

came one of the largest shippers of livestock in the country. In one winter, he shipped from the Detroit area 200 carloads to New York City.


Mr. Downs later moved his headquarters to Holley. He bought an interest in the local bank, engaged in real estate extensively and bought his own stone quarry. The sandstone from the quarry was used to build his new hotel, Downs Hotel (currently



the Holley Hotel), on the Public Square which replaced the old Mansion House. The Temperance folks were elated when he announced there would be no alcoholic beverages sold in his hotel.

When John was thirty nine in 1885, he married Eva Glidden from Clarendon. They had four children – John Jr., Nancy, Hattie and Gladys. The Downs home is located at the traffic light in Holley. John Downs died in 1901 at the age of fifty-five, being a wealthy gentleman.

Roy Bubb's latest book, <u>The Family Scrapbook; An Era in Holley's</u> <u>History</u> will cover more detail. Anticipated publishing date is Spring 2017.

Aside from having difficulty in finding jobs outside of the mines and factories, the immigrants were basically excluded from most community organizations and activities. It was during this time that the northern states saw a resurgence of the KKK to deal with the large influx of immigrants. Using town and county records, newspaper articles and photographs, the speech will track the rise and fall of the KKK in our area and will illustrate the power of the Klan and what actions it took to deal with what it saw as the "immigration problem".

Mr. Cianfrini is a lifelong resident of the Village of Oakfield and a graduate of the Oakfield-Alabama Central School, the State University of Albany, and the University of Buffalo Law School. He served in the US Army from 1968 to 1970. He has conducted a private practice of law in Oakfield for the past 44 years. He served as Mayor of the Village of Oakfield for 7 years from 2000 to 2007 and is currently in his 9th year as a County Legislator for the Towns of Oakfield and Alabama and his 3rd year as the Chairman of the Genesee County Legislature.
