## CLARENDON TOWN BOARD - Meeting Highlights January

The Town Board held two public hearings prior to the regular meeting in January for proposed Local Law No. 1 of 2018 A Local Law Rescinding All Existing Dog Control Laws of the

Town of Clarendon (Supervisor explained that the county has a dog law that will encompass the entire county therefore the Town is rescinding its own laws) and proposed Local Law No. 2 of 2018 A Local Law to Amend Local Law No. 4 of 2008 to Continue to Provide a Real Property Tax Exemption to Cold War Veterans Without Regard to the Ten-Year Limitation. No comments were given at either of the hearings. The Board did adopt both proposed laws, copies of which are available at the Clerk's Office.

Bill Fox, resident of 5673 Upper Holley Road spoke to the board about proposed WIBA 12. Mr. Fox introduced himself and read a brief statement informing that the majority both in assessed value and number of votes do not want the water going down Upper Holley Road. Mr. Fox requested that the petition for water improvement benefit area 12 be recalled and have Upper Holley Road removed from consideration. Mr. Fox indicated there are other roads also against the public water that have also signed a petition for their roads to be removed from consideration of the water benefit. There are a few people who signed for the water and then signed against it after they felt they were given misinformation. Supervisor Moy asked for an example of the misinformation given; Mr. Fox didn't know and wanted those residents to speak for themselves. They were not present. Supervisor asked those present if anyone felt they'd been misinformed; no one responded. Mr. Fox will submit his petitions to the Town next week. Supervisor Moy confirmed that petitions in favor of the public water have been submitted to the Town and will be forwarded to the Attorney for his review. If the petitions are correct and meet the legal requirements, the board will have another public hearing before the district is formed.

### HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Swanger reported a lot of plowing this past month. On Friday, they had a few minor breakdowns with equipment. Paperwork for the March 'Stella' storm has been submitted and Superintendent estimated \$17,000 coming to the town through FEMA. Half the fourth quarter water readings have been done. The Town Board authorized the purchase of a John Deere Z930M Commercial ZTrak zero turn mower for use in Hillside Cemetery; at \$9765.91. Superintendent Swanger suggested the old mower either go to auction or be put out for bid to dispose of it.

### HILLSIDE CHAPEL RESTORATION PROJECT

Erin Anheier and Russ Bosch reported on the Hillside Cemetery Chapel Project bids received for window restoration and masonry repair. Estimation for window work was at \$56,900; actual low bid came in at \$43,400. Estimation for masonry work was at \$3500; actual low bid came in at \$10,000 interior and \$12,000 exterior. The overall project is still under budget. The Board accepted bids from Northwood Historic Restoration for the windows and from TSW Masonry for the masonry repair. At board member questioning, it was confirmed that the State resisted having any kind of protective screen in front of the glass due to moisture; Plexiglas would turn yellow. Mr. Bosch informed that they are ordering enough extra glass to replace the windows if need be.

### SUPERVISOR REPORT

Supervisor Moy reported notice of Self-Insurance Quarterly Meeting on January 22, 2018 in the County Office Building. Orleans County Soil & Water Conservation District has sent invitation to its 73<sup>rd</sup> Annual Meeting on February 7, 2018 at the Village Inn in Gaines. Monroe County Water Authority has sent notice of water rates increase from \$2.22 to \$2.43; effective January 2018. This item will be on February agenda to match the increase for the Town customers; it will take effect with the billing due in April. Supervisor read aloud a letter received from Brent Chapman, Byron resident at 5891 Upper Holley Road, indicating his interest in public water if the district is established. Supervisor Moy referenced water usage for the year prepared by Superintendent Swanger; numbers appear to be consistent. Supervisor Moy recognized Superintendent Swanger for his service to the town saying that people don't realize all he does. Supervisor mentioned the planning that goes into snow plowing the roads; Superintendent Swanger was filling in for a sick employee, plowing for the week. In the middle of the night Superintendent has responded to water problems; a resident had a water break in his house and in zero degree weather, Superintendent had to find the box and shut of the water to the residence. Supervisor Moy expressed much appreciation for Superintendent Swanger.

### CORRESPONDENCE

Notice has been received from the New York State Unified Court System of the town board requirement to audit town court records; it is scheduled for January 22, 2018. Revenue has been received from the NYSDOT PAVE NY 2017 in the amount of \$24,173.63, from NYSDOT CHIPS Extreme Winter Recovery Program in the amount of \$20,219.33 and a check in the amount of \$1838.64 received from the New York Municipal Insurance Reciprocal.

### OLD BUSINESS

The Board adopted a SEQR Resolution for Water Improvement Benefit Area 12 declaring a Negative Declaration.

### NEW BUSINESS

The Board adopted a Resolution Accepting Affirmation of the Highway Equipment Audit done by Councilman Robinson and Councilman Major.

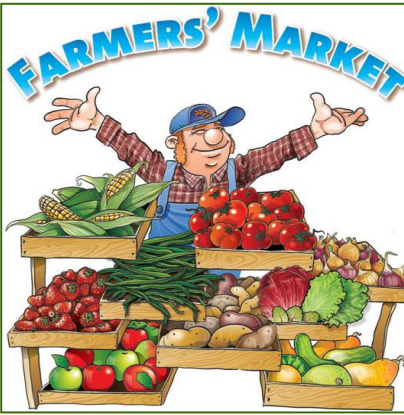

Public markets are almost as old as history. All around the world there are flourishing marketplaces which are centuries old and vestiges of former ways of doing business. In the United States, these markets began to decline after World War II with the advent of the supermarket and convenience shopping. The **Four Chaplains**, also sometimes referred to as the "Immortal Chaplains" or the "Dorchester Chaplains", were four United States Army chaplains who gave their lives to save other civilian and military personnel as the troop ship *SS Dorchester* sank on February 3, 1943, during World War II. They helped other soldiers board lifeboats and gave up their own life jackets when the supply ran out. The chaplains joined arms, said prayers, and sang hymns as they went down with the ship. Those chaplains were Lt. George L. Fox, Methodist; Lt. Alexander D. Goode, Jewish; Lt. John P. Washington, Roman Catholic; and Lt. Clark V. Poling, Dutch Reformed.

## *Just for Laughs .....*

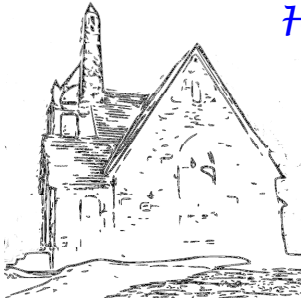
