

Tickets for our Wine Tasting & Farmer's Market Gala go on sale in the library on Monday, April 2nd. Tickets are \$15 each advance sale for the event, Friday, April 27th, from 7-9 PM.

Highway employees addressed the board regarding health insurance. Currently the Town allows accumulation of 180 days sick time unused; 160 days maximum can be used toward time in the NYS Retirement system. Consideration from the Board was requested for the option of using some of the unused sick days toward paying health insurance upon retirement; health insurance coverage for the employee between the ages of 62 and 65. Cost and savings for the town were reviewed if this option was approved. It was confirmed that four other towns in the county, the Village of Holley, the Holley School and Orleans County employees have this option. The board will address it at the March meeting.

HIGHWAY/WATER DEPARTMENT REPORT- Superintendent Larry Swanger reported plowing, salting and repair work done. Murray had a couple of water breaks that lowered our water tank level. The Board approved the purchase of a new M5-111HDC12 Kubota mowing tractor from Bentley Brothers in Albion, NY at a cost of \$52,896.35 and authorized surplus equipment be taken to auction in May; 2004 Chevy Pick-up; 2009 Zero Turn; 1993 Ford (Ambulance); 1988 Ford Tractor; 1996 Stone Trash Pump; 2001 Garden Way Wheel Trimmer.

PLANNING BOARD REPORT - Chairman Dave Griggs submitted the following written report: **01-23-2017 (Regular Meeting)** Meeting cancelled due to lack of sufficient agenda items. **02-13-2018 (Regular Meeting)** The Planning Board conducted a review of changes to part 360 of the New York State Solid Waste management Regulations to ascertain their ramifications to the Town of Clarendon's existing Zoning Regulations. These changes were effective in November of 2017. These regulations govern the management of excavated materials and surplus construction materials from generating source to offsite storage areas. While no issues were noted by the Planning Board requiring modification to the zoning section most closely regulating such activity, Article III - Permits and Procedures, Section 306 - Application procedures for Land Reclamation (fill) permits, it was noted that Municipal operations routinely stockpile material removed from public work projects. These activities are required to conform to the new regulations. It was the consensus recommendation of the Planning Board that the Town Board initiate a review of any stockpiling activities by the Highway Department to assure the town is in compliance with these new regulations. Chairman Griggs reported that the Planning Board did review the impact of the new regulated waste and recommends that the Highway Department be reviewed in storing waste from projects. Superintendent Swanger reported that NYS DEC is going to be checking spoil piles. Brush is the only thing that individuals are allowed to dump at the garage; the County or State may dump ditch waste.

HISTORIAN REPORT - Historian Melissa Ierlan submitted the following written report: Attended a meeting hosted by our county historian last week. It was fairly well attended. Everyone has projects going on; in particular the Town of Barre will be celebrating their Bicentennial this year. I have offered to help as I have pictures that they can use of residents who moved to Clarendon from Barre in the 1900's. Adrienne Daniels, the Barre Historian, provided me with a copy of the 1865 record of military service for Clarendon. Joyce Blank allowed me to scan over 400 slides from her personal collection; many are from the old GLF and associated family members. I have two students from GCC doing their service hours with me, helping sort newspaper articles and inventory our collection of yearbooks. Is it Spring yet??

SUPERVISOR REPORT - Supervisor Dick Moy reported that the street lights will be converted to LEDs shortly. They will be brighter and use less energy.

CORRESPONDENCE - Albion Agencies, the Town's insurance agent has merged with Seaway Insurance Associates in Gasport. They have common ownership but each agency is operated independently. This will give more

access to different insurance companies. The Town has received \$1,333.33 in revenues from the Traffic Diversion program for the period of October through December 2017. The Orleans County Legislature has approved apportionment of 2018 sales tax to towns and villages. Clarendon's share will be \$116,260.89. Ridgeway is the only town with a higher apportionment. Kim DeFrank, the Orleans County Treasurer, has sent an abstract of all payments made to Clarendon by the County in 2017. The Orleans County Planning Board has sent its annual reminder letter to send complete applications for review to their Planning Board. The Orleans County Board of Elections has sent notice of date the elections will be held this year; this information will be available upon request.

OLD BUSINESS - The Town Board held public hearings for proposed Water Improvement Benefit Area 12 and Water District 13. At meetings following the public hearings the board adopted resolutions establishing the WIBA and District and scheduled a special election for each to be held on April 25, 2018; noon to 8:00 PM at the Town Hall. Voting rights for property owners were reviewed. Individual notices will be mailed to property owners in addition to the legal notice publications. The majority vote of those who physically cast a ballot will decide the future of that district. Pursuant to Monroe County Water Authority's 21 cent increase in usage rates, the Board increased Clarendon Water Rates to the Customer with Monroe County Water Authority supplier to \$3.75 per thousand gallons; Effective with the first quarter billing of 2018. Pursuant to the Village of Holley's 18 cent increase in usage rates, the board increased Clarendon Water Rates to the Customer with the Village of Holley as Supplier to \$5.40 per thousand gallons; Effective first quarter billing of 2018. The Town Board waived requirements of project bids on the masonry bids for Hillside Chapel Restoration Project in regard to not submitting performance or payment bonds as required and the insurance certificates do not provide all the coverage required in the contract; As the contracts are small, risks to the town are minimal and/or since the contractor is sole proprietor the board will waive said requirements.

NEW BUSINESS - The Board accepted proposals for mowing from A&K Lawn and Garden \$2450.00/Season to mow the Historical Cemeteries on Hibbard Rd., Munger Rd. and two on Holley Byron Road. Kingdollar Lawn Care to mow the Town Park, Holley Byron Road \$40/mow; Town Hall Lawn, 16385 Church Street \$40/mow; Triangle Lot, Upper Holley Road \$20/mow; Water Tower Lawn, East Lee Road \$25/mow. The Board accepted the proposal from Beth Skehan for Town Hall Garden Maintenance at \$525.00. The Board adopted a "Think Differently" Resolution in support of a welcoming and supportive environment for residents with Special needs. The Board authorized the expenditure of \$355,312.80 in highway money for General Repairs and \$170,000.00 in highway money for Permanent Improvements. The Board held an executive session with the Assessor; no action was taken.


Jazz a Chinese Crested age 14 and retired agility with highest level received, master in jumpers.








Hillside Sketches

John Westcott

At the time of his death in 1905 John Westcott was the oldest male resident of the village of Holley. Born August 10, 1810 in Bow, Devonshire, England. In 1834 he boarded the ship Ebenezer for New York. After a six week voyage he



traveled to Albany. He worked and moved to LeRoy then Stafford and finally to Oak Orchard. John Westcott married Mary Cook on February 4, 1838.

After a visit home to England in 1850, John purchased several acres in the Brown School House district in Clarendon. Mr.

Westcott walked two miles to work each day in Clarendon. He was a partner in a shoe and boot business with David Wetherbee.

In 1871 John moved to Holley and went into business with his son and worked until 1886. His children were William, Thomas and Emeline. Both of his sons served during the Civil War. Thomas enlisted at the outbreak and was at the battle of Bull Run. He returned after 90 days. In 1862 both Thomas and William enlisted in the 8th New York Heavy Artillery. They were at Cold Harbor where their regiment lost 700 men.
