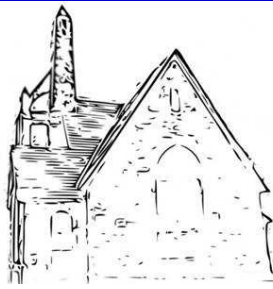

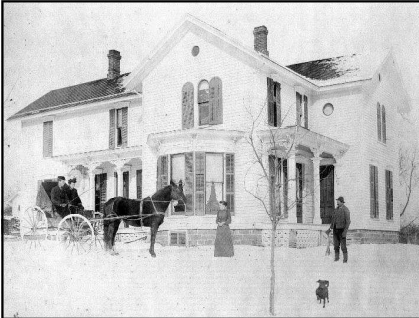


Hillside Cemetery

William H.H. Goff 1843-1934

Mr. Goff lived in Clarendon and in 1880, 1881, 1887 & 1888 he served as town supervisor. Mr. Goff also served in the county legislature in 1892. He was a farmer by trade and well respected in the community.

He built a fine house in Clarendon around 1893 on Rt. 237. A picture of this house was found recently in what used to be the home of his daughter Mrs. Daniel Daum in Clarendon.

Mr. Goff served as a director of the Orleans County Farmer's Mutual Insurance Company. Later in life Mr. Goff moved to the village of Holley and eventually sold that home and lived with his daughter until his death.

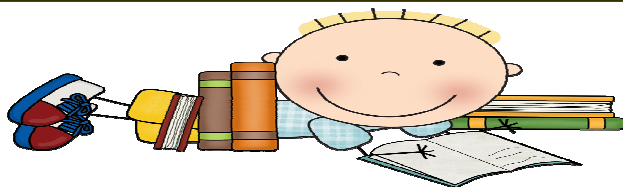

My Special Friend *Melissa Ierlan, Town Historian*

When I started working for the town of Clarendon back in 2006 one person I remember meeting was Cecil Moore. He came in to the town hall on occasion and knew I was interested in history so he always had a story or two to share.

He told me about growing up in Clarendon and how many brothers and sisters he had. He talked about his childhood and some of the mischief he got in to. Some stories are fit to print and others are not! He talked about his mother Jessie and what a hard working woman she was. He was proud that she was nearing her 100th year and that her children were all still here.

One time Cecil came in with a picture of his old softball team. He also donated the trophy they had won for the 1955 Eastern Orleans County Softball Championship. The names engraved on it are: G. Ferguson, W. Raley, P. Keith, C. Moore, R. Moore, W. Potter, W. Baker, G. Novak, W. Crawford, L. Webster, T. Baker. Cecil used to tell me about the old violin maker in Clarendon, DeZetter. He said he had an old violin made by him out of a cigar box. "Someday I'll give it to you" he said, "But I'm not ready yet". I told him about the violin we had in our collection as well as a photograph of Mr. DeZetter in his shop surrounded by violins and parts and tools. Cecil told me about the men who would drink and play music together. He said they were all very talented. I saw my friend a week before he passed away and he told me that I had to come up and see him because he had some things he wanted to give me. Unfortunately I did not get to visit him and it makes me sad but I have some wonderful memories and for that I am grateful.

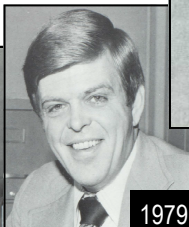

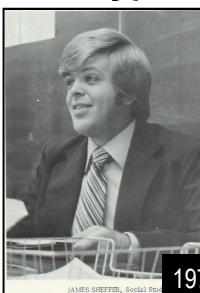

- Mark in pen or pencil.
- To vote for a candidate whose name is printed on this ballot, make a single cross X mark or a single check ✓ mark in the voting square above the name of the candidate.
- To vote for a person whose name is not printed on this ballot, write or stamp his or her name in the space that appears at the bottom of the column containing the title of the office.
- Any other mark or writing, or any erasure made on this ballot outside the voting squares or blank spaces provided for voting will void this entire ballot.
- Do not overvote. If you select a greater number of candidates than there are vacancies to be filled, your ballot will be void for that public office or party position.
- If you tear, or deface, or wrongly mark this ballot, call the Board of Elections at (585) 589-3274, 3222, 3133, 3270 for instructions on how to obtain a new ballot. Do not attempt to correct mistakes on the ballot by making erasures or cross outs. Erasures or cross outs may invalidate all or part of your ballot. Prior to submitting your ballot, if you make a mistake in completing the ballot or wish to change your ballot choices, you may obtain and complete a new ballot. You have a right to a replacement ballot upon return of the original ballot.
- To be counted, absentee ballots returned by mail must be postmarked no later than the day before election day and be received by the Orleans Board of Elections no later than 7 days after election day.

HOW TO RETURN ABSENTEE BALLOT

- After marking the ballot, fold such ballot and enclose it in the envelope bearing the voter's statement, and seal the envelope.
- Fill in properly the blanks in the statement and sign your name.
- Enclose the sealed envelope bearing the statement in the envelope addressed to the Orleans Board of Elections and mail promptly.

HOW TO RETURN AFFIDAVIT BALLOT

- After marking the ballot, fold such ballot and enclose it in the envelope bearing the voter's statement, and seal the envelope.
- Fill in properly the blanks in the statement and sign your name.
- Return the sealed envelope to the election inspector.

HOW TO RETURN MILITARY BALLOT

- After marking the ballot, fold such ballot and enclose it in the envelope bearing the voter's statement, and seal the envelope.
- Fill in properly the blanks in the statement and sign your name.
- Enclose the sealed envelope bearing the Statement in the envelope addressed to the Board of Elections and mail promptly.
- The ballot of the military voter must be postmarked not later than the day before election and received by the Board of Elections not later than 7 days following the day of election to be cast and counted.

CLARENDON TOWN BOARD - Meeting Highlights August 2018

The Town Board held a Public Hearing to consider amendments to the Town Zoning Ordinance prior to the regular meeting. No comments were given/heard. At the meeting, the Board did adopt a SEQR Resolution declaring the zoning action will not result in significant adverse environmental impacts. Application has been sent to the County Planning Board for review.

CLARENDON FIRE COMPANY - Bob Freida, President and Karl Biedlingmaier, Treasurer represented the Clarendon Fire Company and presented its budget for the proposed five year agreement for providing fire protection in the Town from 2019 through 2023. The vehicle account shows an increase of \$10,000 due to price increases and state requirements/mandates. Vehicle maintenance budget has been supplemented by fundraising and rec hall funds. The Fire Company is trying to replace trucks that are getting older and before any new mandates. The operating budget is down 1.2% from 2018. Supervisor suggested the Fire Company supply Fire Police with gas; the Fire Company has not factored that in with the fuel budget. In the past, Fire Police have been paid for gas if they're out for long periods of time; that money would come from fundraising if it were to be done. Bob and Karl stressed the fact that the fire company is very careful with the spending of tax dollars. The budget includes \$500 for specialty training which is supplemented as needed with donations. Most training is done at the county.

OPEN END - Highway employees asked the Board why they are considering dropping sick days for new employees from 15 to 5/year, reasoning that if someone needs surgery, they will need more than a week; that all other towns in the County give one day/month. Councilman Major stated that most companies offer five days; that after that short-term disability would kick in with full pay.

HIGHWAY/WATER DEPARTMENT REPORT - Superintendent Swanger reported paving finished on Munger Road and portions of Merrill Road. Shoulder work is done on Munger Road. Chugg Road, Hall Road, Lake Road, Route 237 and Wood Road were sealed. Clarendon helped the Village of Holley with sealing and the Town of Murray with paving. Town highway crews helped the State grind Route 31 in Albion and received four loads of the millings; one that had to be delivered to the State DOT. Roadside mowing is being done and two graves have been dug in the past month. Water readings are complete and second quarter billings have gone out. Discussion was held regarding Saturday funerals at Hillside Cemetery; town employee is paid for four hours (over-time) to be there to cover the grave. If the funeral doesn't start until 3:00 PM, it's very inconvenient and late for employee to be there. Supervisor suggested Saturday burials be amended in the rules and regulations.

A motion was made, seconded and approved to grant building lot approval. **SD 18-11, Pre-conference for site plan review for a private solar array, tax id# 108.-2-79.1. 16173 Glidden Road, Michael Restivo.** No issues noted. Notice was received that the 2019 dues for the Town's membership in the Association of Towns remains at \$999. The Orleans County Department of Personnel and Self Insurance has sent a copy of the approved 2019 self- insurance plan apportionment of assessment; 2019 premium for the Town is \$25,075, for the Fire Company \$196. New York State has sent \$4243.44 for the adjusted payment for snow & ice removal.

OLD BUSINESS - The Board authorized Supervisor Moy to sign a renewal Emergency Water Agreement with the Town of Barre. There has been no call-back to the Supervisor regarding the town's request to T/Murray for monetary help to paint the water tower. No response has been received regarding town's request to supply entire town with internet from Charter Communications. MCWA was to send a new proposed retail lease a couple of weeks ago after the meeting Supervisor and Superintendent had with them; they haven't yet. *Continued on page 9*

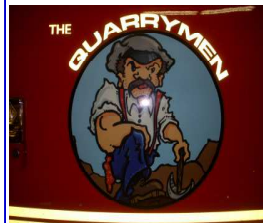
