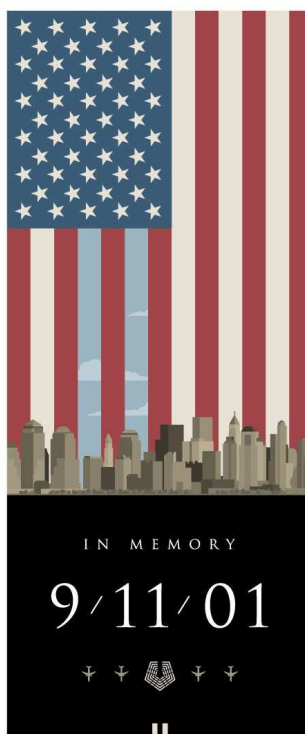

## CLARENDON TOWN BOARD - Meeting Highlights August 2019

The Town Board held well attended workshop meetings to consider employee handbook review and solar farms. Items were agreed upon for action at the regular meeting to amend the handbook allowing 12 sick days/year and adding mandated harassment training. Board members were in agreement to proceed with a draft ordinance allowing solar farms in Clarendon. The Solar Law from the Town of Stafford will be used as a template, amending language according to Clarendon's needs. Supervisor Moy will meet with NYSERDA, who provides solar companies with grant funding. Items were agreed on for inclusion in the draft; Zoning Districts that this would be an allowable use: Residential Agricultural (RA) and Industrial (I) Districts. Setbacks: Front from Center of the Road – 200 feet; Side & Rear from Lot Lines – 200 feet; From any Residence – 500 feet; From a Zoning District Boundary – 100 feet. An Escrow Account is to be maintained for engineering and legal fees, Bonds will be required for Decommissioning and Site Restoration, to cover any non-payment of Pilot Agreement and for road repair necessary from building and decommissioning of project. Maximum Solar Farms allowed: 2% of the acreage included in the RA and I Districts. A variance is the open option if the town's maximum is met and another wants to build. Planning Chairman Griggs informed that typically only 50% of the lot can be used for a project. Six to eight acres is needed per megawatt. The two projects being proposed are at 20 megawatts each. Screening: Chain-link security fence at a minimum height of 7 feet; Minimum of double row, staggered 10 foot pine trees; Berm where needed; to be determined by Planning Board in review process. Emergency Service Access Required.

### **SATURN POWER CORP./EMPIRE COMMUNITY SOLAR LLC**

Supervisor Moy introduced Bogdan Dinu, Project Developer at Saturn Power and Julia Kossowski, P.Eng. Director of Project Development. Ms. Kossowski stated that Saturn Power is in Baden, Ontario Canada with offices in Calgary, Alberta, Washington DC and Ankara Turkey; is a small privately owned business that was founded by two people living in a farming community. Ms. Kossowski informed that they specialize in mid-sized utility scale solar, wind and energy storage. Saturn staff is involved in their projects every step of the process; they're looking to establish a farm in Clarendon and would be here for a few decades. Saturn has 200mw projects in the USA in New York, Oregon, Colorado, Pennsylvania, and Illinois. The project being presented for South Holley Road is not an energy storage facility. The project was said to be 19.99 MW AC Solar PV Facility located at corner of South Holley Road and Hinds Road; Single Axis Tracker System - panels would face north/south and tilt east/west; 79,968 Solar PV Modules and 400 inverters on 136.33 acres. New York International Organization for Standardization (ISO) will review the project and will help determine if it's feasible. The ISO develops international standards for businesses and technologies.

Supervisor Moy informed that he met with Bogdan and Julia earlier this afternoon; that they have come to the town way ahead of the usual time in the process. Saturn has not done the financial studies and hasn't applied to New York State Energy Research and Development Authority (NYSERDA) for funding, therefore don't know if this project will be feasible yet. Bid in price for this project to NYSERDA is the next step. Town Benefits were said to possibly be a partnership on the taxation side with a PILOT agreement. Short term benefit – project will create some jobs for local contractors, need to purchase gas and food. Long term benefits include operations and maintenance of the site. Life expectancy of the panels-25 year warranty, but projects worldwide see 30 to 35 year life. Panels are recycled at the end; modules have an aluminum frame and copper wiring; is 95% recyclable. Energy will be feeding into National Grid power lines and will have no effect on the town rates. Power would go to sub-stations first. Renewable Energy Credits (REC) will be sold

to National Grid at wholesale rates; NYSERDA will buy REC's at the lowest rate. Saturn would be paying for the equipment up-front. It was stated that visual impact will depend on natural screening and/or what is put in according to Town requirements. Closest module will depend on a shading study. Mandated setbacks usually are put in place from a residence, not lot line; visual screening is effective. Ground testing will be done and SEQR review; trenches will be opened and aluminum jacketed cables will be laid. Soil used will stay within the confines of the project. Modules convert the power from DC to AC. There is no noise and no fluids. Saturn is responding to state goals and mandates. The Governor expects the state to be 70% reformed energy by 2030. Funding provided by NYSERDA last year totaled 1.3 billion dollars; a project of this size will cost \$1 million to hook into the grid. Saturn will stabilize the ground with a silt fence, filters and seeds stapled in to take root to help stabilize the ground from rain/run off. Distance between panels will be maybe ten feet. An environmental review will be done. When asked how Saturn chose Clarendon, Mr. Dinu explained that a junior developer was doing a sighting and thought it would be a good place for the project; has a main trunk and wide open area. Cable will be underground. It was stated that solar panels still produce 30 to 40% in cloud cover.

### **OPEN END**

Supervisor Moy opened the floor for resident questions. A resident questioned natural screening and snow. It was said that there is a wooded area around one side and the modules have sensors on them and can dump the snow off. This company has been in business for twelve years, operating seven years in Ontario. Their risk management plan will be done with in-house staff, consultants and a finance team. Resident concerns included change in water run-off and resident sump pumps; heavy truck traffic on side roads and change in wildlife habitat. Mr. Dinu stated that there is a project development phase where they look at all these things to see if the project is feasible. The size of the project is determined by the size of previous projects; that NYS says to stay with the same size as developed in the past. At resident questioning it was stated that panels are hot to the touch but do not radiate heat. The project proposes 400 inverters for 79,000 modules (not electromagnetic). There are three kinds of inverters; Central, Smaller (this project) and Micro. Supervisor informed that a bond to maintain road damage is one of the items proposed in the draft ordinance. Mr. Dinu stated they will use local labor/contractors for the project. Saturn does all the decommissioning with money set aside for that purpose with a bond to allow for inflation. Other resident concerns included constant, heavy traffic ruins roads; that the noise from traffic and dust will be a bother and wildlife survival concerns. New York State has mandated renewable energy at 70% by 2030; NYSERDA requests projects of certain sizes; minimum project is 7MW. NYSERDA will buy a number of credits every year for an established number of years.

### **HIGHWAY/WATER DEPARTMENT**

Superintendent Larry Swanger reported that the seconded mowing is almost complete. The back of the Hillside Cemetery has been mowed; the sumac has been removed. It looks very good. Work was done to clean up the park around the falls and the creek. Road work has been done as follows: Brown Schoolhouse Road has been sealed between Upper Holley and Route 237; Hibbard Road has been sealed. Shoulder work was done on Mansfield and Brown Schoolhouse Road. The Towns of Barre and Gaines helped with the paving and Clarendon helped them. The highway crew helped the Town of Murray to repave the bus garage road at the Holley School. Four hundred hydrants

#### PLANNING BOARD REPORT

Chairman David Griggs submitted the following written report: **07-23-2019 (Regular Meeting)** - Meeting Canceled due to insufficient agenda items. **08-13-2019 (Regular Meeting)** - **SD 19-09**-The Planning Board held a pre-conference for a one (1) lot subdivision, tax id#'s 87.-4-55 and 88.-3-19, Peter Dreher, Taylor Road. No issues were noted with the proposal, Applicant requests waiver of pre-conference. A motion was made, seconded, and approved to amend the agenda from a pre-conference to a formal application. A motion was made, seconded and approved to move to a formal application. A motion was made, seconded and approved to declare this exempt for SEQRA purposes. A motion was made, seconded and approved to approve Subdivision contingent on OIO receipt of survey maps for signature, creation of deed and verification of merger of the two parcels. **SP 19-11**, Pre-conference for a Special Use Permit for the addition of an auto repair shop to an existing multiple use occupancy, Twins Mart, (convenience store, fuel dispensing facility), tax#98.-9-1-22.1, Holly Byron Road. Numerous items were discussed but no significant issues were noted. Applicant requested to move to formal application. A motion was made, seconded, and approved to amend the agenda from a pre-conference to a formal application. Permit conditions were discussed. It was noted that while a SEQRA is on file for the original business a new one should be performed. Chairman Griggs will do the SEQRA. A motion was made, seconded and approved to schedule a public hearing prior to our next Planning Board meeting (08-27-10). Item carried to next meeting.

#### SUPERVISOR REPORT

Supervisor Richard Moy thanked Melissa Ierlan for cooking the hotdogs today before the meeting at the CHS Museum Site. Supervisor addressed the flier that was handed out around town regarding information on solar farms. He stated that the flier has incorrect information on it and is upsetting a lot of people. He asked that only correct information be circulated.

#### CORRESPONDENCE

The Orleans County Board of Elections has sent information regarding 2020 elections. There will be three elections; voting hours will be from 6AM to 9PM for all elections; there will be early voting ten (10) days prior to each election. Orleans County has sent a check in the amount of \$933.33 for town's share of revenues from the Traffic Diversion Program – April through June, 2019. Williamson Law has sent notice of 2% increase in its annual support fee in 2020. Orleans County Treasurer has sent \$1,039.50 for administration fees collected in 2019 for Solid Waste/ Recycling.

#### OLD BUSINESS

The Town Board adopted Resolutions adopting Local Law No. 1, 2, 3 & 4 of 2019 pertaining to zoning and subdivision regulations. Robert A. Criddle was appointed as Assessor for the Town of Clarendon effective April 1, 2020 to fill the remainder of Cynthia Boheen Davis' term upon her March 31, 2020 Retirement. Amendments were made to the employee handbook adding language on Discrimination, Harassment and Sexual Harassment, Workplace Violence Prevention and employee vacation time. The Construction Contract for Water Improvement Benefit Area No. 12 was awarded to Keeler Construction Co., Inc. at 13519 West Lee Road, Albion, NY 14411 for a total price of nine hundred fifty-five thousand five hundred eighty dollars and no/100 (\$955,580.00).

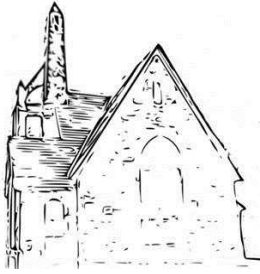

## Hillside Cemetery

**SIDNEY GODLEY**  
(1822 - 15 Feb 1889)

"Out of money, out of work, and sick," were the reasons Sidney GODLEY of Indianapolis, formerly well-known resident of this village, gave for coming back to Holley last week and shooting himself; printed in the Holley Standard Feb 21, 1889. In a letter to his good friend Henry J. Buell, he stated the following: "As a friend I write you; Henry, I am out of business, out of money, and sick. Don't know of anything only to be buried in Holley beside my wife. It is my lot and paid for. Mr. GODLEY was 66 years of age, and was a resident of this county many years. He was in the hardware business first at Lyndonville and afterwards in this village. Subsequently he traveled for a number of years for Bussey, McLeod & Co., the stove manufacturers. His first wife (Content HURD) died here in 1876. She was a very estimable lady, and was highly regarded, as were also her daughters. Several years after the death of his first wife Mr. GODLEY married a lady in Ohio, but they separated after a year or two and she procured a divorce. His third wife, who survives him, he married a little over a year ago. They lived in Indianapolis until November last, when Mrs. GODLEY came to Rochester to stay with her daughter there.

Mr. GODLEY had been out of employment for a large portion of the time during the past six months and was obliged to pawn his watch to obtain money to come to Holley from Cleveland. But the "last straw," as he stated in memoranda left in a note book in his pocket, was the publication of scandalous story concerning him in a disreputable Sunday paper in Cleveland. He claimed the story was to a large extent a fabrication for the purpose of

blackmail, and that \$25 had been demanded to secure its suppression, which he was unable to pay even if he had been willing to do so.



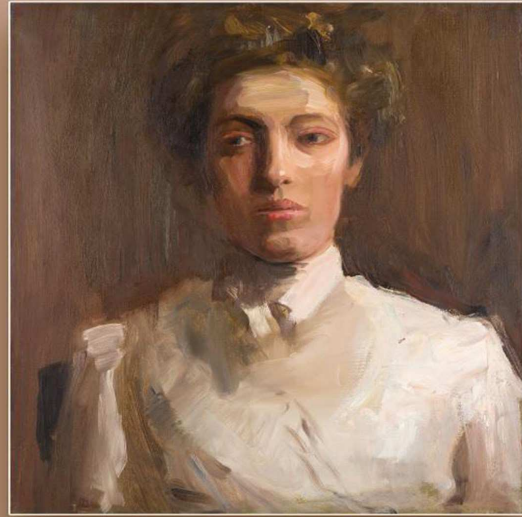
Mr. Sidney Godley was laid to rest with his first wife Content Hurd Godley and daughter Mary.
