CLARENDON TOWN BOARD - Meeting Highlights December 2019

OPEN END - Bob Barrett, Mill Road resident presented the Town Board with a wood carving of the Old Stone Store. He informed that he started it in the spring and has just finished it. This is the second carving Bob and his wife Linda have donated to the town, the first one being of the Old Mill. Thank you Bob and Linda. It's beautiful. Both carvings are on display in the board meeting room.

HIGHWAY/WATER DEPARTMENT REPORT - Superintendent Larry Swanger reported that the highway crew has been busy with the winter weather; the freeze and ice. Purchase of salt this year has taken the cost over budget. The highway men have been helping the county crew cut down trees on the South Holley Road in the swamp area (south of Glidden Road).

PLANNING BOARD REPORT - Planning Board Chairman David Griggs submitted the following written report: 11-26-2019 (Regular meeting) • SP 19-18, Pre-conference for a site plan review to construct a 40' x 40' pole barn, 5026 Merrill Road, Tammy Beaney tax id# 109.-2-43.1. The Planning Board reviewed the application, no issues were noted. The applicant requested to wave the pre-conference. A motion was made, seconded and approved to amend the agenda to a formal application. A motion was made, seconded and approved to approve SD 19-18 as submitted. • SP 19-19, Pre-conference for a site plan review to modify existing special use permit SP05-03, American Tower, dba Verizon wireless, 16640 Munger Road tax id# 120.-1-54.21. Applicant wishes to add an additional antennae to the existing tower as well as a generator located within the confines of the existing fenced area. A letter detailing a structural analysis was provided verifying that any additions to the tower would not diminish its structural integrity. No issues noted with the modification proposed. The applicant requested to wave the pre-conference. A motion was made, seconded and approved to amend the agenda to a formal application. A motion was made, seconded and approved to approve the proposed modifications to SP 05-03 as submitted. • SP 01-001, Nick Penna, 4064 Holley Byron Road, renewal of Special Use Permit. Fee paid, inspected, no outstanding complaints. A motion was made, seconded and approved to approve renewal of SP 01-001. 12-10-2019 (Regular Meeting) • By unanimous consent the Planning Board members approved the following appointment recommendations be submitted to the Town Board for their consideration and approval. David R. Griggs, Planning Board Member, Five (5) year term to expire 12-31-2025 David R. Griggs, Planning Board Chairman, one (1) year term to expire 12-31-2020, Kevin Johnson, Planning Board Deputy Chairman, one (1) year term to expire 12-31-2020 The regularly scheduled Planning Board meeting for December 24th has been cancelled. The next scheduled Planning Board meeting is at 7:00 PM, January 14, 2020 at the Clarendon Town Hall, 16385 Church Street.

HISTORIAN/HISTORICAL SOCIETY REPORT - Historian and CHS President submitted the following report: In 2019, the Historical Society provided seven educational programs open to the public. The subjects were English Barns, The Building Legacy of J.T. Wells, The History of the Grange Movement, Temperance Camp Meetings in Copeland's Grove, The Cook Family of Clarendon, The Time Capsule in Your Back Yard, and the Three Erie Canals.

An eagle scout project in Hillside Cemetery was done by Jeremy Crandall of LaDue Road. This decorative cinder block wall with medina sandstone topper was designed and built by Jeremy with donated materials. Local resident Jeff McPhee donated the piece of granite for the

inscription and Brigden Memorials donated the engraving on the sign. We once again volunteered our grounds to be used for a Farmer's Market on Thursday's during the growing season. The Boy Scouts used our property for some of their outdoor activities. The August Town Meeting was held at our site.

An eagle scout project by Cody Tanis of Fourth Section Road was done at the Museum. His project included scraping and repainting the school house and shutters. The building also got some minor repairs of rotted siding. The scaffolding was donated for use by Larry Swanger and this made the job so much easier.

We received and installed the new cemetery signs at four of the historical cemeteries this summer. The chapel at Hillside had the windows finished up before the weather changed and the remaining piece of the project has 3 bids being submitted for review. Our paperwork was submitted to the state and returned with dozens of post it notes with missing info, missing paperwork or clarification. Joanne Major helped me for 2 days to organize and gather all the missing information and it was resubmitted for reimbursement again. Another eagle scout project is in the works by AJ Dreschel of Hulberton and hopefully once it is reviewed by the council he can begin. It involves sprucing up the museum displays. AJ is very excited about this. I have continued to submit Hillside sketches for the monthly gazette and have had good feedback on them. Larry Swanger had some items at the highway building which I asked for. Jamie, Pete and Eric delivered them to the museum and we will incorporate them into our displays. On a separate occasion Larry also delivered a very large item that was donated to the museum. Larry sent help to Brockport to get the piece of Medina sandstone for Jeremy Crandall's eagle project. I have to say that over my last 13 years of employment Larry has always been a huge supporter of our history. This summer I was asked back to the summer school at Holley to speak about local history. I find that showing them what used to be here and what is currently in the same place is very eye opening. They really enjoyed the stories that went along with the photos. I have and will again participate in Holley's 4th grade pioneer days. We have secured a roster of speakers for 2020 at the historical society and are very excited to be able to offer this monthly from April through October. We have great turn outs each time with an average of 40 people up to 80 at times. As always, I have done research for people either in person or phone or email and have had some very happy people who often leave with much more information and even photos than they were hoping for. I am involved with the Orleans County Historical Society as a trustee and help with the heritage festival when they need me. Every 2nd and 4th Friday I host a genealogy group at the town hall. We gather to help each other with research and offer help to anyone. We use ancestry.com and other websites to do research as well as our local records. County Historian Matt Ballard has attended many of these and shares information when requested, he is very thorough. I enjoy being the town historian and love our town and county history.

SUPERVISOR REPORT - Supervisor Moy reported that Water Improvement Benefit Area 12 is done except for hooking in the Upper Holley, Mansfield, Brown Schoolhouse and New Guinea Roads. The contractors are ahead of schedule; cleaning up properties will be when the weather allows. Water District No. 13 will go out to bid January 16, 2020.

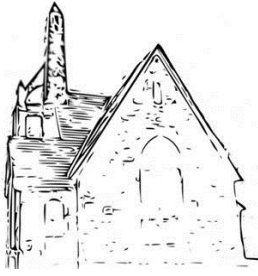

Floyd M. Gillis

was born September 2, 1877 and died June 11, 1944 in Clarendon, NY. He was the son of Edgar and Ida Gillis. On January 25, 1900 he married Nellie Hackett. They had no children.

Floyd was very active in his community. He was a trustee of the Universalist Church in Clarendon and a member of the Murray Lodge #38 of Free and Accepted Masons. He owned and operated Gillis General Store in the hamlet for over 35 years.



He was also the town clerk for 30 years and to date the only person to serve longer than that is our own Susan Colby who has been in office since 1989!

The Town has signed a one year agreement with the Village of Holley to maintain the Clarendon Water System. Superintendent Swanger will meet with Matt Campbell of the Village Public Works Department this week. Supervisor is drafting a written procedure for overdue water bills. Supervisor Moy thanked Larry Swanger for all he has done during his service with the town; that it has been a pleasure to work with him. Supervisor Moy also thanked Bill Campbell, Councilman, for all his hard work on the town board; that it was a pleasure to work with him.

CORRESPONDENCE - The Orleans County Health Department has completed its inspection of the Clarendon Water System. The Town of Sweden has sent a copy of proposed amendments to its Telecommunication Facilities in its town code. Environmental Design & Research has sent a letter of request for viewpoints to be considered regarding the town of Barre Heritage Wind Project. The New York State Real Property has sent a letter regarding future communication between NYS ORPTS and the Town of Clarendon being electronic. Guardian Dental policy renewal has been received. The Orleans County Legislature has sent notice of Mortgage Tax Receipts between 4/1/2019 thru 9/30/2019; Clarendon's share is \$21,618.65. Traffic Diversion proceeds revenue from July thru September, 2019 is \$933.33.

NEW BUSINESS - The Town Board accepted a resignation from Karen Bradshaw from the Planning Board and appointed William Fox to the unexpired term; to expire 12/31/2021. David R. Griggs was reappointed to a five year term on the Planning Board; to expire 12/31/2025. Payment of year-end bills was authorized on Abstract No. 13. The 2020 Organizational Meeting was scheduled for January 2, 2020 at 6:00 PM at the Town Hall. Evelyn Pangrizeo was appointed Assessor Clerk. The Board accepted resignation from the Zoning Board from Bruce Hovey pursuant to his election as councilman and appointed Crystal Gurney of South Holley Road to fill the remainder of Mr. Hovey's term; to expire 12/31/2021.



The Town of Clarendon has received another one of a kind treasure from long time residents Bob and Linda Barrett. Over the years Bob has done some beautiful wood working projects and donated them to the town. He has donated a custom framed map of Clarendon from 1913, an old newspaper ad for the 1960 sesquicentennial celebration of Clarendon and a hand carved version of a photograph of the old Clarendon Mill which was once situated in the current location of our town park. In December, Bob once again donated a hand carved version of a photograph of the Copeland's Stone Store which was built in 1836 and still stands on the corner of Rt. 237 and 31A in the hamlet.



Bob has also done other projects such as a hand made box which held the ashes of a beloved Clarendon resident who passed away and was buried in Hillside Cemetery and a complete restoration of the desk and chair which was used in the Gaines Basin cobblestone school house over a hundred years ago.

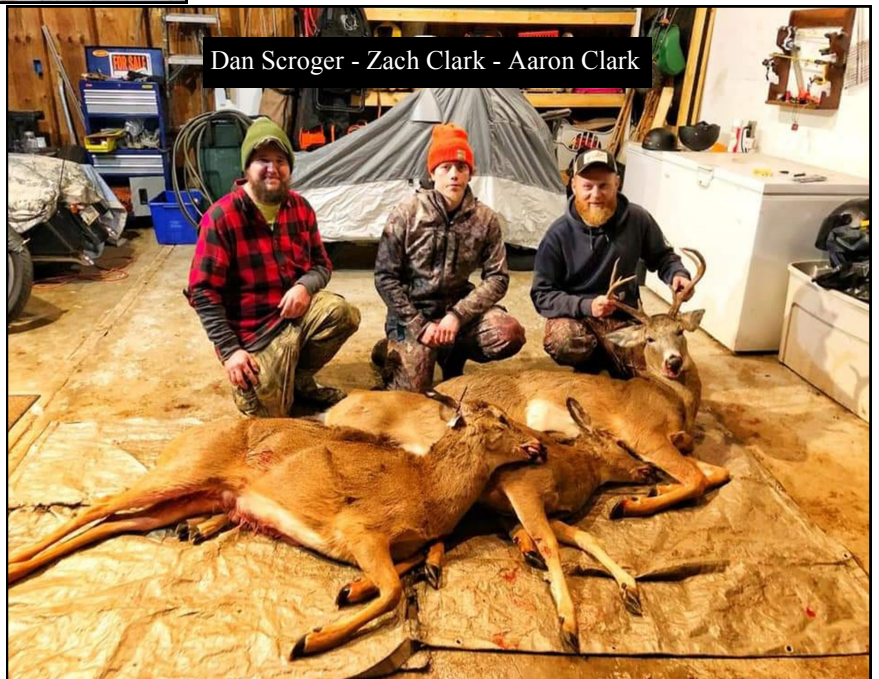
