CLARENDON TOWN BOARD Meeting Highlights - April 2020

The Clarendon Town Board held its April meeting via ZOOM.

HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Tracy Chalker reported that the highway department has been operating with 50% of its crew; Katie Harvey at Orleans County Personnel /Civil Service has informed that it can now run with 100%. All employees will be working at the same time effective on Monday. Dirt roads have been graded; New Guinea Road, Acton Road and Wood Road. The pioneer cemeteries are being readied for mowing. The Glidden Road Cemetery has a tree that keeps losing branches. He'll look at removing the tree. Two large trees came down in the last wind storm. They were removed from the road. The crew has been cleaning the trucks; getting them ready for summer work; prepping and painting the plows. The crew has been repairing vard damage done from plowing and some brush clean up on the Upper Holley Road extension hill has been done to improve visibility. Mowing has begun at the town hall and the Hillside cemetery. Sign repair was done at NYS Route 237 and Powerline Road. Wood chips are now available to the residents. There is a pile in front of the highway garage; first come first serve. That pile will be replenished from a large pile out back. Two legs of Water District 13 are open for hook-up; South Holley Road and Munger Road. A tentative restoration plan for Water Improvement Benefit Area 12 has been submitted. Weather permitting it will be done May 7 through 22nd.

Superintendent Chalker reported a phone meeting with Supervisor Moy and accountant Tim Hungerford about the budget with regard to the COVID 19 virus situation. \$60,000 needs to be trimmed from the highway spending. CHIPS monies received will be cut by 20%. Some of the planned road work will need to be cut; CHIPS money will be used first so as not to lose it.

PLANNING BOARD REPORT

Chairman Dave Griggs reported that in addition to the solar initiative for the zoning, the Planning Board is also working on some minor changes in the ordinance. The proposed changes in the fee schedule better reflect the cost associated with services rendered; for the three types of permits issued by the town, cost will be the same for each. The following written report was submitted: 03-24-2020 (Regular meeting) Meeting cancelled due to insufficient agenda items. 04-14-2020 (Regular Meeting) SD 20-02, Preconference Robert Arnold, New Guinea Road, tax id# 119.-2-55.2, for a building lot approval. No issues noted, a motion was made, seconded and approved to waive the pre-conference and move to formal application. A motion was made, seconded and approved to approve building lot. SD 20-04, Pre-conference, Peter Spence 4219 Lake Road, Tax id#87.-3-19.116, for a site plan review for construction of a 24' x 32' pole barn. No issues noted, at the request of the applicant a motion was made, seconded and approved to waive the pre-conference and move to formal application. A motion was made, seconded and approved to approve site plan. SD 20-07, Pre-conference, Germeo/Gaurdino Hall Road, tax id# 99.-2-37.4, Two (2) lot subdivision. No significant issues noted, at the request of the applicants a motion was made, seconded and approved to waive the pre-conference and move to formal application. A motion was made, seconded and approved to declare this a minor subdivision for SEQRA purpose. A motion was made, seconded and approved to approve this application subject to pins being set, creation of deeds and filing with the county. SD 20-07, Preconference, Germeo/Gaurdino Hall Road, tax id# 99.-2-37.4, Special use permit for a farm market/retail store (G&G Farm Market). Multiple issues discussed and resolved (lighting, parking, septic,

hours of operation, curb cut, etc.). At the request of the applicants a motion was made, seconded and approved to waive the preconference and move to a formal application. A public hearing was set for April 28th at 7:00 with a regular Planning Board meeting to immediately follow. **SP 96-02**, Thomas Estates West, Manufactured Housing Community, LLC. Special Permit Renewal, Fee paid, Inspected, No outstanding complaints. A motion was made, seconded and approved to approve renewal of Special Permit.

HISTORIAN/HISTORICAL SOCIETY REPORT

Historian Melissa Ierlan reported working with students from Genesee Community College doing community service. She's been sending them documents to translate for genealogy projects; some of the writing is hard to read. The next two monthly meetings of the Historical Society have been cancelled due to the virus social distancing.

SUPERVISOR REPORT

Supervisor Dick Moy informed of his presence on Zoom for the Saturday morning updates with the County due to the COVID 19 virus. Thirteen additional cases of the virus have been reported in Orleans County – these being in Albion. Clarendon still has zero cases reported. Supervisor reported that chlorine feed to the water system has been being done manually. An automatic chlorination system has been ordered; cost \$5792. Once installed it will monitor and operate the automatic chlorination feeding twice/day.

Discussion was held regarding the 2020 town budget. Supervisor reported that it's been estimated that with the cuts in revenue because of the virus, the general fund will fall \$70,000 short. There is \$35,000 in the contingency fund that can be used, leaving \$35,000 needing to be cut. Supervisor suggested that instead of paying employees not working because of the virus, the town could give them half pay or let them draw unemployment. This would affect the court clerk, assessor clerk and deputy clerk when not working. Supervisor estimated five more weeks in virus mode estimating the total savings would be \$2000. Supervisor Moy stated that revenue cuts would include sales tax, mortgage tax and court revenue; that no spending should be done unless absolutely necessary from anyone's contractual account. Discussion was held and councilmen were not in favor of cutting payroll to employees.

Supervisor Moy reported that the interest rate on the Water District 13 BAN came in at 2.69% from Greene Bank in Catskill.

Supervisor Moy, Planning Chairman Griggs and a NYSERDA representative held a phone conference regarding the Article 23 that was adopted by the state. Projects of 20 Mega Watts or more have a choice; they can work with the town or the state. Oriden has told Supervisor Moy they would like to deal with the town if possible; if not too restrictive. The Board will discuss it at the May 6th 6PM Zoom workshop meeting.

DA Joe Cardone is in charge of setting up Wi-Fi hot-spots in the County due to the COVID 19 situation. One will be installed at the highway garage; citizens will be able to access the internet at that site free of charge.

HEARING OF ASSESSMENT COMPLAINTS

The Board of Assessment Review is scheduled to meet on Tuesday, June 9th via telephone conference between hours of 3:00 P.M. and 5:00 P.M. and 6:00 P.M to 8:00 P.M., to hear and examine all formal complaints in relation to assessments upon the application of any person believing that they have been aggrieved. Since in-person hearings will not be held while social distancing protocols are in effect, it is imperative that a fully completed RP-524 complaint form with all supporting documentation be submitted via mail, email, fax, or Town Clerk Mail Drop Box to the Assessor's Office before June 9th if possible, to afford sufficient time to adequately prepare for the hearings. Once a properly completed complaint form is received, a complainant will be contacted to schedule an appointment for their telephone conference hearing with the Board of Assessment Review. While complaints may be filed until 8:00 P.M. on June 9th, the Board will not hear them until a future date and time. Complainants will be contacted to schedule this appointment. Persons who file a complaint have the option to have the Board review their complaint form without having a telephone conference. The Board will inform them in writing of its decision. Complainants will have opportunity to choose this option when contacted to schedule an appointment. Complaint forms can be filed after May 1st. The complaint form and the publication "Contesting Your Assessment in New York State" are available online at NYS Tax & Finance at www.tax.ny.gov or the Assessor's Home Page at www.townofclarendon.org. Since this is a public meeting that the public is allowed to listen to, dial-in instructions for a telephone connection to the meeting will be made available on the town's website or by contacting the Assessor's Office. OLD BUSINESS

Supervisor Moy reported his discussion with Nick Penna regarding no burning or storing of junk materials on the leased town property. Mr. Penna is good with that being added to the agreement. The Board accepted the amended five-year lease for farming.

Supervisor Moy informed that Cindi Davis has agreed to chair the committee for the Comprehensive Plan Review. No action will take place until the state of emergency has been lifted. Regarding solar projects, companies can submit application for funding in May. If granted, they would apply for project construction in June. The Board adopted a Resolution authorizing Supervisor Moy to sign an agreement between the Town of Clarendon and the County of Orleans related to the construction and maintenance of a Communications Tower in the Town of Clarendon providing the Legislature signs the same at their 4/22/20 meeting. The Town Board adopted a Resolution for Implementation of a Policy for Cancellation of Meetings during the State Disaster Emergency. The Board authorized extending its contract for fiscal services with Municipal Solutions, Inc. for both WIBA 12 and WD 13. The fee schedule was amended as proposed, making Permit Issuance for Special, Zoning or Operating Permits a \$150 fee plus \$.20 per sq ft or \$50 per acre, whichever is greater: Permit renewals at \$50 per year: Permit transfers for the same is \$50 non-refundable fee for transfer.

Supervisor Moy asked Councilmen to look over the budget; expenses need to be cut by \$35,000.

All meetings will be held via ZOOM until further notice.



The New York State Department of Environmental Conservation (DEC) today announced that a new online hunter education course will be available on April 15, for first-time hunters who want to hunt during New York's turkey hunting season. Turkey hunting season runs from May 1-31, and youth turkey hunting season for New Yorkers 12 to 15 years old is April 25-26. DEC's Hunter Education Program (HEP) is partnering with Kalkomey Enterprises, a company that specializes in hunter education, to create this online course that can be completed in six to eight hours. The course is available to individuals 11 and older. Students can complete the course from a computer, tablet, or smart phone at any time. Visit https://www.hunter-ed.com/newyork/ to learn more or to sign up. The curriculum for the online course is identical to what is taught in the traditional classroom course. Topics such as firearm safety, tree stand safety, hunting ethics, wildlife conservation, and New York State hunting laws and regulations are all covered. Students who successfully complete the online course and pass the final exam will receive a hunter education certificate and can purchase a hunting license from a DEC license issuing agent such as a town clerk, hardware stores and large retailers. The cost of the course is \$19.95. The online course will be available through June 30, 2020, at https://www.hunter-ed.com/newyork/. Traditional, classroom-based courses will resume at a future date. Cemetery

Someone asked me how I choose the person I'd like to highlight each month in Hillside Sketches. I have no answer and there is no

method. I was at a friend's house one day and saw an old family photo album. It appeared to be from the late 1890's so I picked it up and began looking at the photos. The name "Cragbon" was familiar to me and when my friend told me they were family, I remarked "They are buried in Hillside"! My friend knows that I am the historian and that I work in the cemetery so this sudden statement was normal to hear. This is how I chose Clara Cragbon for my topic.



Clara Dawes Cragbon was born on April 30, 1861 in Michigan. She married Arthur Cragbon of Holley on January 21, 1886. Arthur purchased the grocery business of Harmon Cole in 1893. They were members of the Baptist church in Holley and sang in the choir. The Cragbon's owned a cottage at Beechwood Park in Troutburg. Clara and Arthur had 3 children, Lois, M. Dayle and Gladys. Lois died when she was just 17 years old and is also buried in Hillside.

Clara was a local artist and painted hundreds of small water color paintings in her lifetime. She was self-taught

and her paintings featured many local landscapes. Years ago, the Cobblestone Museum in Childs featured an exhibit of her work.



As a result of the stay at home order we have been asked to observe if we are non essential, and schools and colleges being closed down, Ron Jewell is here today and on the road to

recovery. His son and grand daughter were home this particular day and when he wasn't feeling well, things went bad guickly. Ron's heart had stopped and because of the quick actions of his family, 911 was called and CPR was started. As is the case in our small town and county, people showed up quickly and in numbers to provide help. An AED (automated external defibrillator) was used on him 4 times between his house, Strong West and Strong Memorial Hospital. He was stabilized and spent some time in the hospital but was home very soon. I received a phone call from Ron on April 24th and he told me the story, I made sure he knew that he still had 5 lives left but he need not be in a hurry to use any of them. Ron talked about what happened and how grateful he was for the people who helped him. He was especially proud of his son Ron and his grand daughter Annie and credits them for saving his life. When I made him laugh he told me that he had a broken rib from Annie! I told him that was a good sign that she had done her job. I hope this brings a smile to your face and gives you hope. I along with many others in this community are very proud of all the folks who made this a happy ending to what could have been something very tragic. Melissa
