LEGAL NOTICE The Clarendon Town Board held a Public Hearing on June 16, 2020 at 6:00 PM to hear comments on proposed amendments to the town zoning ordinance via Zoom Group Meeting On-Line. *This hearing has been recessed and will continue in person on July 21, 2020 at the Town Hall, 16385 Church Street in Clarendon, NY.* Anyone wishing to comment on the proposed amendments can do so at this hearing. Proposed changes to the Clarendon Town Zoning Ordinance are summarized as follows: Article II – Word Terms & Definitions has new and revised definitions; Article V, Section 530-5 Minimum Specifications in the Business Commercial Zoning District, Minimum Lot Size Non-Dwelling and Minimum Lot Frontage Non-Dwelling has been revised; Article VI, Regulations Applicable to All Zoning Districts Section 601 Permitted Uses/Permitted Accessory Uses has been revised. NEW Article VI, Section 666, Battery energy Storage Systems (BESS) has been added to the Ordinance and NEW Article VII, Section 730, Alternative Energy System (Solar Powered) Utility Scale has been added to the Ordinance. 

CLARENDON TOWN BOARD

Meeting Highlights - June 2020 via ZOOM on-line

HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Tracy Chalker reported roadside mowing half done. The crew has been patching potholes on LaDue Road and will also work on Merrill Road. Stone has been hauled for Bennetts Corners Road north and LaDue Road. The roads will be chip/sealed to try and protect what we have until funds are more available. The backside hills at Hillside Cemetery have been mowed and look very nice. Supervisor Moy has been helping with the mowing at the Town Hall and Park; it is appreciated. The crew has been working with Albion and Barre through the shared services program and the Village of Holley loaned two men to help on LaDue Road. Funding has been approved for CHIPS at \$105,963.77, Pave NY at \$24,187.29 and Winter Recovery at \$20,219.34. Superintendent Chalker informed that the Town is still at risk of losing 20% of the CHIPS funding. Suit Coat has offered to hold bills until the town receives the state funding if Clarendon continues to use their services, even into next year if need be, with no interest. Superintendent Chalker reported meeting with Paul Chatfield about ways to spend the extra water funding from WIBA 12. Discussion was held regarding a GIS System for water. Price estimates at \$79,000 but with funding, cost would estimate at \$35,000. At Superintendent's suggestion, town board members in agreement with hiring a part-time employee at minimum wage to paint the fire hydrants in town. Dave Nenni from Holley will spray vegetation around all hydrants at no cost to the town. Superintendent Chalker will submit a revised Form 284 regarding road work planned for the year. The major construction planned for LaDue Road has been reconsidered and roads will be chip/sealed to try and protect what we have until funds are more available.

PLANNING BOARD REPORT

Chairman Dave Griggs submitted the following written report: **05-26 - 2020 (Regular meeting)** - Cancelled due to lack of sufficient agenda items. **06-09-2020 (Regular Meeting) Via Zoom Conference - SD 20-12**, Ryan Jenks, 15930 Brown Schoolhouse Road, Pre-Conference for site plan review for construction of a 24' x 32' pole barn. A sketch showing placement and setback measurements was provided. No issues have been identified. Applicant requested to waive pre-conference. A motion was made, seconded and approved to waive the pre-conference and move to formal application. A motion was made, seconded and approved to approve SD 20- 12 for construction of a 24 x 32' pole barn. **SP 20-01**, Gary Germeo/Tony Guardino, Special Use permit for farm market, Hall Road. The Planning Board reviewed the recommendations received from the County Planning Board. A motion was made, seconded and approved to accept the County Planning Boards recommendations.

HISTORIAN/HISTORICAL SOCIETY REPORT

Historian Melissa Ierlan reported working with a man named Bernie Roberts from Farmington Hills, Michigan. He is writing a book on Chauncey Robinson a former resident of Clarendon in the 1840's. Chauncey Robinson's son Tracy was very instrumental in the completion of the Panama Canal. The family was also related to the Pettengills of Clarendon who invented along with a business partner Alexander Miller the 24 hour distillation process for vinegar. Chauncey Robinson was very political and was a huge supporter of the Abolitionist Movement. He wrote many articles that were published on this topic. It is said that he was a stop on the Underground Railroad, possibly in Clarendon but definitely in Holley where he moved his family to in 1850.

SUPERVISOR REPORT

Supervisor Dick Moy reported that the Town Hall opened to the public on June 8th for regular office hours. MVP Health Care has sent notice of a proposed 3.61% increase in rates for next year. No grievances were filed with the Board of Assessment Review. A note of appreciation was received from the Holley School thanking the Town for the use of the town hall parking lot as a food distribution center. Supervisor Moy reviewed that communications with the State changes every day and no one is completely sure where the COVID regulations stand. Supervisor and Town Clerk signed on to a webinar hosted by the town's bond counsel firm with regard to municipalities. They informed that Town halls were never legally closed and that we could open. The Saturday ZOOM meeting with the County said not until July. The BAN closing for WIBA #12 will be on June 24, 2020. Supervisor will deliver the closing documents to the Rural Development Office in Batavia on June 22nd.

C O R R E S P O N D E N C E

Because of the COVID 19 social distancing and regulations, the Joint Youth Recreation program sponsored by Clarendon, Murray, Holley and the Holley School, has cancelled the 2020 summer recreation program. Clarendon's annual share of the funding, \$3700.00, has been returned to the Town. The Town has received a mortgage tax payment in the amount of \$17,405.56 from the County Treasurer. The Orleans County Board of Elections has sent notice and instructions regarding the June 23, 2020 elections. Voting hours will be from 6AM to 9PM. All Town Offices will be closed. The Town of Sweden has sent SEQR documents for Clarendon's review of its proposed solar park energy 12 solar farm subdivision, site plan and special use permit on West Sweden Road. The documents are available at the Town Clerk's Office if anyone is interested in reviewing them. The Town has received a Snow & Ice payment of \$16,114.33 from the New York State Department of Transportation.

OLD BUSINESS

The Town Board adopted a Resolution regarding the proposed amendments to the town zoning ordinance determining a negative declaration under the SEQRA after an environmental review.

NEW BUSINESS

The Town adopted a Resolution authorizing any fee associated with installing a 1" water service tap at 4552 Holley Byron Road be waived. The 1995 Location Map for construction and waterline installation was marked by the property owner at that time, showing approval of the proposed location of its 1" water service as indicated on said map prepared by Chatfield Engineers. It should have been installed at time of water line construction but was not.

The Town Board held a Public Hearing regarding proposed amendments to the zoning ordinance. This hearing was recessed and will continue on July 21, 2020 at 6:00 PM in person at the Town Hall.




Lemuel Whitley Diggs

Medical pioneer, leader in sickle cell research and co-founder of St. Jude Children's Research Hospital, a native of Hampton, Virginia, Diggs received his undergraduate and master's degrees from Randolph-Macon College. His medical degree was from Johns Hopkins University. Through the efforts of Dr. Diggs, the first blood bank in the southern United States was established in 1938. In 1942, with a nation at war and preparing for civil defense, he urged hospitals throughout the nation to collect, store, and dispense whole blood and plasma. After Diggs arrived in Memphis in 1948, he began to research sickle cell disease cases. Little was known about this disease that was found mostly in African Americans. His study of the topic was instrumental in teaching and making the world aware of rare blood diseases. Diggs also aided in helping singer-actor Danny Thomas create St. Jude Children's Research Hospital in Memphis. Diggs was the only doctor in Memphis involved in the study of sickle cell disease and leukemia. It was Diggs who suggested that St. Jude Hospital be devoted to the study of childhood diseases. He also authored a book called "Morphology of Human Blood Cells," a text book that is still used by medical students today. Diggs spent more than six decades researching blood diseases. He died of organ failure at his home in Memphis at the age of 95.

Beatrice Fenn Moshier Diggs was a native of Rochester but had family ties to Clarendon. Her mother was Agnes Pettengill Moshier and her grandmother was Vesta Jane Miller. In 1921, Beatrice became the first Eagle Girl Scout in Rochester. She was a camping and archery counselor at Northway Lodge, Algonquin Park Canada. She got her BA degree at Wellesley College. She did Pernicious anemia research at the University of Rochester and Strong Memorial Hospital. Beatrice was named in Who's Who in American Women 2002 and Who's Who in Science and Engineering 2004.



The Miller and Pettengill families owned and operated this mill before moving to Holley and locating their operations for fruit processing and vinegar distillation to what we know as the Duffy Mott Company. The grand daughter of Agnes now owns the painting and her name is Peggy Diggs Simons of Honesdale PA.
