## CLARENDON TOWN BOARD

### Meeting Highlights - July 2020

The Town Board reconvened the June Public Hearing regarding proposed zoning amendments prior to the regular meeting. Six concerned citizens were present and gave comments/suggestions for changes. Items of concern regarding utility scale solar powered systems included setbacks, screening, protection of open and natural character of the land on private and public properties and protection of farming.

**PLANNING BOARD REPORT** Chairman Dave Griggs submitted the following written report: **06-23-2020 (Regular meeting)** Cancelled due to lack of sufficient agenda items. **07-14-2020 (Regular Meeting) - SD 20-13**, Peter Dreher, 17209 Taylor Road, tax id# 88.-3-19.11, Pre-Conference for site plan for a one (1) lot subdivision. A survey map showing new property lines and setback measurements for existing duplex was provided. No issues have been identified. Applicant requested to waive pre-conference. A motion was made, seconded and approved to declare this a minor subdivision for SEQRA purposes. A motion was made, seconded and approved to waive the pre-conference and move to formal application. A motion was made, seconded and approved to approve SD 20-13 contingent upon verification by OIO of pins being set, creation of deeds and filing with the county.

#### **SUPERVISOR REPORT**

The Town Board cancelled the annual August music and hot dog event at the Historical Society due to the COVID pandemic. Supervisor Dick Moy reported approval of a GIS Map System and a utility truck for water; cost paid in full from left over funding for the WIBA 12 capital project. A window at the stone store was broken. Joe Fertitta had a guarantee on the windows when he put them in prior to town ownership and was able to get a replacement for it; Joe then installed it for free. Supervisor Moy will send a letter of thanks. Supervisor reported receiving many calls from residents about things he doesn't control. Years ago, he and Cindi Davis put together a presentation on the jobs and procedures of the local government and one person attended. Supervisor informed that the internet hot spot was installed at the Town Hall because the signal wasn't strong enough at the highway garage. This gives free access to the internet. Many favorable comments have been received on how nice the Hillside Cemetery looks. Superintendent Chalker acknowledged Jamie is doing a good job; that she's even there working in the pouring rain. Jamie's a good worker as are all the highway employees.

#### **HIGHWAY/WATER DEPARTMENT REPORT**

Superintendent Tracy Chalker reported the first roadside mowing is complete. Brown Schoolhouse Road down the hill has been re-ditched, moved back and filled with 6" Gambian Stone; it kept washing out with hard rains. It has held up since the work has been done. The hoist on one of the trucks has been replaced. Superintendent Chalker reported that the Sterling truck is very rusted underneath and was leaking fuel when hauling stone; the fuel pump is rusting off. The Town needs to look into replacing that truck. Supervisor estimated a 15 year time-frame on replacing equipment in the past. The crew has been hauling stone for shoulder work on LaDue and Bennetts Corners Roads. This past month there have been three water leaks, one push and multiple WD 13 installs. The south/back side of Hillside Cemetery has been bush hogged. Restoration has begun where the water leaks were found. The highway crew has been patching roads; Brown Schoolhouse, Jackson and Merrill; and also the parking lot at the fire hall and highway garage.

#### **CORRESPONDENCE**

NYS Tax & Finance Department has sent Clarendon's Certificate of Final Telecommunications Ceiling for the 2020 assessment roll showing the maximum taxable assessed value of private mass telecommunications property. Entities include MCI Communications, Verizon New York, Frontier Tel of Rochester and Intellifiber Networks. Also received is Clarendon's Certificate of Final Special Franchise Full Values for the 2020 assessment stating assessments shall in no case exceed full value. Entities include Niagara Mohawk dba National Grid, Verizon New York, Frontier Tel of Rochester and Time Warner of Rochester. NYS Department of Transportation has sent notice of a maintenance resurfacing project on Route 237 within the Village of Holley; to start in the spring of 2021 and be completed by fall of 2021. This project schedule will be coordinated to follow the village's sidewalk reconstruction and waterline improvements project that is anticipated to be substantially complete in 2020. Orleans County has sent a check in the amount of \$93,325.98 for payment of the first roadside mowing in 2020 and 2019-2020 sanding & plowing payment. A second check was received for \$3123.88 for payment of the second roadside mowing in 2020. The Orleans County Legislature has adopted a resolution in relation to the disposition of Orleans County sales and use tax revenues; the quarterly payment of sales tax revenue made to the towns and villages to be paid on or about July 1, 2020 shall be delayed until further notice. Supervisor Moy contacted Jack Welch, the county's chief administrative officer, regarding estimated revenues to the town for budgeting purposes. He had no answers. NYS Agriculture & Markets sent its annual inspection reports for the Municipal Shelter and Dog Control Officer. DCO inspection is rated Satisfactory. The Shelter services report noted satisfactory for most, citing two door frames of kennels are rusted and need to be a disinfectable surface and food needs to be stored off the concrete floor. Supervisor informed of his intent to discuss revenues at the upcoming Municipal Association Meeting. It was reported that sales tax on internet orders stays in the county of order delivery. E-Bay collects taxes and pays the state.


#### **OLD BUSINESS**

Supervisor Moy spoke with Cindi Davis; she will start working on the comprehensive plan committee. A workshop meeting was scheduled for August 18, 2020 at 6:00 PM at the Town Hall regarding the proposed zoning amendments to consider comments from the July public hearing. The regular monthly meeting will immediately follow the workshop. A budget workshop was scheduled to be held September 10, 2020 at 6:00 PM at the Town Hall. The tentative budget needs to be given to the Town Clerk by September 20; then presented to the Town Board at a meeting by September 30. The Board adopted a Resolution authorizing final payment for WD 13 capital construction and designating Matt Campbell as licensed operator. Supervisor referenced the proposed Town of Sweden Local Law concerning Vacant Building Registry and suggested the Planning Board review the law and give its opinion; that every town has the same issues with this matter. Councilman Major reported his review of said law and found it very detailed and thorough. Town Board in agreement to have the Planning Board review it for consideration in Clarendon. The Town Board authorized Amendment to the MRB Group WIBA 12 Project relative to a Clarendon Water System GIS Mapping; total compensation \$74,900.00 paid for with grant funding.





## Hillside Cemetery

**John Church** was born in Herkimer County in 1803. He came to Clarendon in the 1830's and purchased a large parcel near a creek and was a successful farmer. He served the Town of Clarendon as a school inspector, teacher, constable and town clerk for several years. John married his wife Louisa and they had several children. Sadly, their son Darwin died at the age of 7. His other children were Horace, Albert, Almyra, George, Adelaide, John, and Anna.

David Sturges Copeland, author of the History of Clarendon 1810-1889 wrote the following:

When Chauncey Ford passed out for the last time, one Daniel Stedman had a log-house when the country was new. He was much troubled by the wife of Allen Blanchard coming over to his home from her cabin, to the east, at the hour of midnight, and telling her tale of woe, resulting from a drunken husband abusing her deaf and dumb son. John Church, Samuel L. and Merrick Stevens, Orson Tousley and Horace Peck, after blackening their faces in a brush-fire, proceeded through the darkness to Blanchard's cabin. They rapped at the door, and Blanchard hesitated about opening, but his wife finally persuaded him, and in the lads rushed, seized him in his shirt, marched him over bull thistles up to his waist, back of Chauncey Robinson's house, and, after making him promise that he would in the future act soberly toward his family, left, him to shift for himself.

Apparently, John Church and some others took it upon themselves to protect their neighbors!

John Church died February 26, 1873 and was laid to rest in the north section of Hillside cemetery with a beautiful family monument.





### REFLECTIONS OF RURAL AMERICA (Reprinted from 2006)

Arlene Campbell Bowen was born on December 29, 1935 in Ogdensburg, NY to Alfred & Irene Campbell. When Arlene was three years old, her family moved to Western New York and in 1943, moved to the Housel Homestead Farm in Clarendon, New York where the Campbells raised dairy cows and cash crops. Arlene, one of nine children, had a close family that worked hard and enjoyed a good life. Sundays were a day of rest and going to church. As Arlene says in one of her poems, “The best things in life are free, The sun shinning on your family, Helping a kitten down from a tree, Writing a poem or singing a song, Or just helping someone along.” Arlene attributes her creative writing ability to her family upbringing. “As a teenager I loved to draw and write stories and poems, but I never saved them” says Arlene. Married in 1953, Arlene and Lewis Bowen raised their three children in Clarendon and at age 44, Arlene again, took time to write poetry for family and friends. “A few years ago, I started putting my poems in the Clarendon Gazette and I received so many compliments, that I decided to keep them all in a book.” Encouragement from the Town Clerk sent Arlene to the Genesee-Orleans Regional Arts Council in Batavia for grant funding to publish her book of 100 poems. With sponsorship from the Holley Community Library, Arlene was awarded a partial grant toward the publishing of her book, Reflections of Rural America. The Clarendon Historical Society will host a Book Signing and Reception for Arlene’s new book on October 1<sup>st</sup>, 2006 from 1:00 – 5:00 PM in the Museum Barn at the corner of Church Street and Fourth Section Road in Clarendon. The Holley Community Library will host the same on Friday, October 20<sup>th</sup> from 6:30 – 8:00 PM. Books will be available at both events for \$10 each. *Arlene passed away July 27, 2020.*
