TAKE NOTICE that the Clarendon Town Board has introduced proposed Local Law No. 5 of the Year 2020, A Local Law Adding Chapter 169 to the Clarendon Town Code Concerning Vacant Building Registry, and has scheduled a Public Hearing to consider said law on October 20, 2020 at the Town Hall, 16385 Church Street, Clarendon, NY at 6:00 PM. Anyone wishing to be heard for or in opposition to the proposed local law will be heard at this time. The Town finds that vacant buildings are unsightly, unsafe and have a negative effect on the community, many that once vacant, remain that way for years. Purpose and intent of said law is to establish rules for identifying and registering vacant buildings, to set forth various responsibilities of vacant building title holders and to enhance the rehabilitation of said vacant buildings by way of inspections and when necessary, penalties for offenses. A complete copy of proposed Local Law No. 5 of the Year 2020 is available upon request at the Town Clerk's Office during regular business hours, by email to townclerk@townofclarendon.org or on the Town Website at townofclarendon.org on the zoning ordinance page.

TAKE NOTICE that the Clarendon Town Board has scheduled a Public Hearing to consider the Preliminary Town Budget for the Year 2021; to be held October 20, 2020 at the Town Hall, 16385 Church Street, Clarendon, NY. Said hearing will begin immediately following the Public Hearing scheduled for 6:00 PM regarding Vacant Buildings. Salaries for Elected Officials are proposed as follows: Supervisor \$12,240; Councilmen \$15,500 (4); Town Clerk \$41,442; Superintendent of Highways \$56,100. Anyone wishing to be heard for or in opposition to the proposed Preliminary Budget will be heard at this time. **ALSO BE ADVISED**, that the Regular Monthly Meeting for October will begin immediately following said public hearing for the Preliminary Budget.



CLARENDON TOWN BOARD

Meeting Highlights - September 2020

HIGHWAY/WATER DEPARTMENT

Superintendent Tracy Chalker reported that the roadside mowing is complete. The crew chip-sealed Bennetts Corners Road from NYS Route 31A north to the railroad tracks. Shortly after, there was vandalism done that tore up the intersection; it cost the town \$1500 to repair the damage. Shoulder work has been done on LaDue Road, Bennetts Corners Road and Merrill Road where needed. The highway department continues to mow town properties and has done some tree clean-up at the cemeteries and on Powerline Road. Site repair has been done due to vandalism in the town. Superintendent Chalker went to Albion at 2AM to collect Clarendon road signs for Mansfield and South Manning that were taken down. Buffalo Water has cancelled all 2020 classes for operator schooling. Superintendent Chalker intends to register in Morrisville for water class in February. This will require staying overnight so the rest of the crew will not be going due to the time of year. Superintendent Chalker requested limiting Brown Schoolhouse Road – between Upper Holley and NYS Route 237 – to 6 ton weight; local delivery only. Town Clerk informed that Local Law No. 3 of the year 1988 already restricts the use of town highways by commercial vehicles with a gross vehicle weight in excess of six tons. Superintendent Chalker has posted signs to limit access. There is a lot of dump truck traffic and Superintendent informed the road base won't handle it when the wet season begins. Discussion was held regarding purchase of a new plow truck. Superintendent has spoken with his crew and other highway superintendents regarding a 6 wheeler vs 10 wheeler and they've agreed with the 10 wheeler. Superintendent reasoned that a 10 wheeler is needed for the deep drifts and that with a 6 wheeler, the driver will need to make multiple trips to the garage to reload with salt wasting time. Councilman Major in agreement with a 10 wheeler; that all equipment should be kept the same. Superintendent Chalker wants to also purchase the extended warranty for seven years or 250,000 miles. Councilman Hovey informed that other towns (Sweden and Ogden) use 6 wheelers and feels it is enough. Highway employee Eric Collyer stated that the 6 wheeler truck is used in the village of Brockport and in Ogden for housing tracks; State highways need to be done with a 10 wheeler. Superintendent Chalker agreed about the state highways and added that there is a lot of blowing and drifting on other routes, leaving treacherous conditions. Price difference between the two trucks is approximately \$100,000. Councilmen Robinson and Nicosia agree with the 10 wheeler. Superintendent informed that from order to delivery will be one to one and a half years and would like to have it before winter of 2021. It was confirmed that this will be an automatic transmission, as not all highway department employees can drive a standard transmission plow truck. Supervisor requested this item be put on the October agenda for further discussion.

PLANNING BOARD REPORT

Chairman Dave Griggs submitted a written report indicating that both the 8/25/2020 and 9/8/2020 meetings of the Planning Board were cancelled due to lack of sufficient agenda items.

HISTORIAN/HISTORICAL SOCIETY REPORT

Historian/CHS President Melissa Ierlan submitted the following written report: Bob Barrett has donated another beautiful carving to the town. Also, he constructed beautiful stands for all the carvings he has made. What a very special talent he has. I am so grateful for his generosity.

The Disciples United Methodist Church has long-term-loaned the town historian two display cases that were once housed in the church. They contain items that once belonged to the Hulberton ME Church as well as the Holley ME and Clarendon ME Churches. Eagle project graffiti: Jeremy Crandall's Eagle project at Hillside Cemetery was vandalized over the weekend with spray paint. Fortunately it was not ruined and Jamie Steffen cleaned off the paint on Monday. We held off on installing the granite plaque due to all the events going on with people protesting first responders and this happened. Eagle Project at the Clarendon Historical Society: A.J. Dreschel has worked at the museum twice now and has rearranged the layout of the southeast corner of the barn. It is really coming along nicely. Some items will be stored in the school basement to allow more room for people to walk through when it is complete. We have received permission from the new homeowner in the Village of Holley to put in the historical marker that was purchased last year by the Orleans County Historian, Roy Bubb and Jim Robinson for the underground railroad and Brainerd House.

CORRESPONDENCE

The town has received its refund for fees paid for Water Operator Certification courses enrolled in that were scheduled for 2020; all courses have been cancelled due to COVID. The County has forwarded payment for the third roadside mowing in the amount of \$3123.88. NYS Agriculture & Markets has performed a facility inspection at the Orleans County Animal Shelter on 7/31/2020. The dog shelter services were rated satisfactory. Association of Towns and New York Planning Federation will sponsor a 2020 Planning & Zoning School webinar. Discussion will include Planning & Zoning Basics and the Citing of Major Solar, Wind & Alternative Energy Generation: New Legislation to be held on September 25 from noon to 2:00 PM. NYS Department of Taxation & Finance has sent Aid in the amount of \$5179.62 for the 2019 assessment update. Orleans County has given the town its annual balance of sales tax in the amount of \$81,803.02.

OLD BUSINESS


Supervisor Moy reporting hearing nothing yet from Cindi Davis regarding the Comprehensive Plan Review. The Board adopted a Resolution accepting the amended zoning documents and directing them be sent to the County Planning Department for review. At Supervisor Moy's questioning, Councilman Robinson is concerned about the farmland classifications of land in a project (prime or unique farmland, or farmland of state or local importance); that it should be included in the zoning. Supervisor Moy stated that that is part of review that New York State Energy and Research Development Authority (NYSERDA) covers; that they will handle it, not the town. Supervisor intends to write a letter to NYSERDA mentioning that land in one of the proposed projects is in one of the farmland classifications that they recommend staying away from. Councilman Robinson accepted that NYSERDA will include that in their review. The Board adopted a Resolution Introducing Local Law No. 5 of 2020 entitled 'A Local Law Adding Chapter 169 to the Clarendon Town Code Concerning Vacant Building Registry' and calling for a public hearing (*See notice of public hearing on front page*).

NEW BUSINESS

Board members reviewed proposals obtained for boiler maintenance of the town hall units and accepted a proposal from Frontier Heating & AC Service from Albion, NY quoted a pre-paid maintenance year plan at \$264.95 for each boiler, which includes unlimited service calls 24 hours/day. The Town Board adopted the Tentative Budget for the Year 2021 as presented by the Town Clerk; which, upon adoption, becomes the Preliminary Budget (*See notice of public hearing on front page*).

MAIL REGISTRATION

Applications must be postmarked no later than **October 9, 2020** and received by the Board of Elections no later than **October 14, 2020** to be eligible to vote in the General Election.

IN PERSON REGISTRATION

You may register at your local board of elections (Orleans County Board of Elections, 14016 Route 31W, Albion, NY 14411, 585-589-3274) no later than **October 9, 2020**. If honorably discharged from the US Military or have become a naturalized US Citizen after **October 9, 2020** you may register in person at the Board of Elections up until **October 24, 2020**

CHANGE OF ADDRESS

Notices of change of address from registered voters received by **October 14, 2020** by a county board of elections must be processed and entered in the records in time for the General Election

ABSENTEE BALLOT DEADLINES

October 27, 2020 - Last day to apply online, by email, fax or to postmark an application or letter of application by mail for an absentee ballot. (Please be warned that despite this deadline, the Post Office has advised they cannot guarantee timely delivery of ballots applied for less than 15 days before an election.)

November 2, 2020 - Last day to apply IN-PERSON for absentee ballot.

November 3, 2020 - Last day to postmark ballot. Must be received by the local board of elections no later than Nov. 10, 2020. Military Voter Ballots must be received no later than Nov. 16, 2020




Michael Pozzanghera, is an 80 year old gentleman from Hamlin, NY. Mike grew up riding motorcycles, and has loved them ever since. On June 3rd 1957, Mike was a 17 year old, getting ready to join the Navy. While he was riding down Kings Highway in the Town of Irondequoit, he lost control of his bike. Mike suffered a fractured skull, and the accident severed his optical nerve leaving him blind for the rest of his life. Mike is also wheelchair bound. Recently Mike and his wife Barbara were leaving a restaurant in the Town of Greece, when Mike heard someone on a motorcycle pulling into the parking lot. Mike's wife Barbara wheeled him over to the motorcycle. He told the biker about his love for motorcycles, and was wondering if he could touch his bike. Unfortunately, the biker was less than cordial, and told Mike to get away from his bike and leave. It should be noted that this biker was not a member or affiliated with the Punishers LEMC. However, when the Punishers Law Enforcement Motorcycle club heard about this, the Club was shocked at the rude, and callus attitude a biker would display to someone. Our International President John Boyan, reached out to Mike's family to express sadness of such treatment. On September 12, 2020, a group of Punishers



rode out to Hamlin Park to meet Mike, and his family. This visit was arranged within 24 hours of hearing about the way Mike was treated. Punishers from Utica, Binghamton, Syracuse, Rochester, and parts in between rode to meet Mike, his wife, and extended family. Many of the Chapters represented, gave Mike mementos from the club (challenge coins, key chains, tee shirts). The Members of the Punishers LEMC lifted Mike onto the back of a motorcycle, so he could take a little ride. He was yelling "WooHoo" as he rode off. Despite a horrendous encounter with a motorcyclist, the Punishers LEMC Members were able to turn Mike's experience around. Mike's desire to touch, feel, and ride a motorcycle came true today, with the caring hearts of men who have devoted their lives to protecting others. These Men made Mike's wish come true. DEC Announces Youth Pheasant Hunting Weekend for Western New York

Youth-Only Pheasant Hunt Weekend on October 10-11


A special youth-only pheasant hunting weekend will be held in Western New York on Oct. 10 - 11, the New York State Department of Environmental Conservation (DEC) announced today. The hunt will occur one week prior to the regular pheasant hunting season and enables junior hunters (ages 12-15 years old) to hunt pheasants with a licensed adult companion. The 2020-2021 regular pheasant season opens Oct. 17.

"The youth-only pheasant hunting weekend provides an excellent opportunity for junior hunters to become acclimated to upland game bird hunting when fewer hunters are afield, and to learn safe hunting values and skills from experienced hunters," said DEC Region 9 Director Abby Snyder.


Junior hunters must be accompanied by a licensed adult hunter during the youth pheasant hunt. Accompanying adults will not be allowed to possess a firearm or take a pheasant during this special season. During the two-day youth hunt, junior hunters will be allowed to take two birds per day, as allowed during the regular season. 
A state department of Fish and Wildlife is advising hikers, hunters, fishermen, golfers and birdwatchers to take extra precautions and be on the alert for bears while in the Dillon, Breckenridge and Keystone area in Colorado. They advise people to wear noise producing devices, such as little bells on their clothing to alert, but not startle bears unexpectedly. They also advise you to carry pepper spray in case of an encounter with a bear. It is also a good idea to watch for signs of bear activity. Hillside Cemetery

Luther Dean Hurd was born in Newport, N. H., August 13, 1819, a son of Parmenas and Sophia Hurd. In 1824 the family moved to Elizabethtown, N. Y., and

four years later to Proctorville, Vt.

Luther D. learned the trade of a carriage trimmer (the equivalent of an upholsterer) until about 1839 when he settled in Holley, Orleans county.

Luther went to work for William Seward, a produce and grain dealer in Rochester. Mr. Hurd was his representative in Holley, and bought large quantities of grain and produce. He operated the stone grist mill in Holley for a time, and with Henry Hurd, his brother, owned a mill in Dexter, N. Y. Later, Mr. Hurd operated in the west, dealing extensively in western grain until the time of the Chicago fire (1871). Luther also had large real estate interests in Illinois. In 1871 Mr. Hurd purchased of George W. Stoddard his interest in the banking business of Bowman & Stoddard, continuing a partner until September 1, 1882, when he sold his interest to Downs & Eddy, and purchased a lime kiln in Rochester. In 1875 the Orleans Republican reported that Luther Hurd was finishing off the first brick house ever erected here. This was known as the Hurd Mansion and was three stories high. In 1930 the Shell Eastern Petroleum Products Company purchased the property and demolished it to build a gas station.

Luther's first wife was Sara Hurd. Aurilla Elizabeth Sprague was his second wife with whom he had two children. A daughter Gertrude and son Dean Aleijah. Luther's third wife was Jeanette Morgan Hurd who was 30 years younger than him, they had one daughter Cora Hurd Beachem.



In December of 1888, Luther was elected as a trustee of the Holley Cemetery Association which ran Hillside Cemetery at that time. Mr. Hurd died March 29, 1891. In 1908 the First Presbyterian Church of Holley dedicated its new building and on the north side was a memorial stained-glass window for Luther Hurd, Robert Mc Cargo and Lewis Ferry.


