TAKE NOTICE that the Clarendon Town Board has scheduled a public hearing for November 17, 2020 at 6:00 PM at the Town Hall, 16385 Church Street, Clarendon, NY to consider Local Law No. 6 of 2019 entitled A Local Law to Override the Tax Levy Limit Established in General Municipal Law 3-c. Anyone wishing to be heard in favor of or in opposition to said proposed law will be heard at this hearing. It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Clarendon pursuant to General Municipal Law Section 3-c, and to allow the Town of Clarendon to adopt a budget for the fiscal year 2021 that requires a real property tax levy in excess of the 'tax levy limit' as defined by general Municipal Law Section 3-c. A copy of the proposed law is available on the town website on the Legal Notice page. **Also be advised** that the November monthly meeting of the Clarendon Town Board will commence upon close of said Public Hearing.

CLARENDON TOWN BOARD

Meeting Highlights - October 2020

HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Tracy Chalker reported that the department has been busy. Work is being done on pothole repair and the third roadside mowing has begun. The crew has been working the shared serves program with the Town of Barre, Village of Holley and Town of Murray. The county assisted with damaged trees on Glidden Rd. and also with a tree in Glidden Rd Cemetery. A tree on Jackson Rd came down with the high winds. 11 trees total. Meter reads for the 3rd quarter water billing have been finished. There have been many dead deer on the roadsides; the State and County are responsible for their roads in Clarendon but the town will remove the road kill if it's in front of a residence even if on a County road or State highway. Equipment is being worked on. Cheyan Palmer is done with temporary work for the highway department for the year. All fire hydrants are painted with primer and six need a final coat. Superintendent Chalker is still looking into salt options/inserts for the new truck. An insert would help the life of the truck; this item will be on November agenda. A water leak on South Holley Road has been corrected; a hydrant was used and wasn't closed tight. The new water truck has been ordered. Delivery is anticipated after the first of the 2021 year; paid for with WIBA 12 grant funding. Discussion was held regarding the 21 signatures on a petition submitted requesting the speed limit on Pumping Station Road be lowered; Town Board in agreement to recommend it be 25 mph. Town Clerk will check on procedure. Superintendent Chalker informed that the Local Law regulating a six ton weight limit on town roads does not include Brown Schoolhouse Road and requested the Local Law be amended to include that road from NYS Route 237 to Upper Holley Road.

HISTORIAN REPORT

Historian Melissa Ierlan reported that a Clarendon resident donated many old clocks from his family homestead, where since 1818, that family has continuously occupied the home!

CORRESPONDENCE

The Orleans County Planning Board reviewed and approved the proposed amendments to the town zoning; the town adopted said amendments. The Town received proceeds for the 2nd quarter in 2020 from the traffic diversion program in the amount of \$1080. The Orleans County Legislature has sent notice of community college expenses being allocated to the towns. The County has capped their support for the colleges at \$2,050,000; expenses above the cap will be allocated to towns according to where the students are from.

OLD BUSINESS

Due to the COVID pandemic, the town's comprehensive plan review will begin in the spring of 2021. Local Law No. 5 of 2020 was adopted adding a Vacant Building Registry to the town code and the fee schedule was amended to include fees for the local law. The budget will be on the November agenda with the addition of monies for community college expenses.

NEW BUSINESS

The Board renewed its agreement for Joint Youth Recreation with the Town of Murray, Village of Holley and the Holley School District. This agreement will be for two years at half the current annual contribution. The fee schedule was amended and Rules and Regulations adopted pertaining to the New Veterans Section of the Hillside Cemetery. The Board signed a Supplemental Agreement No. 1 with New York State for Snow & Ice Season 2020/2021 Winter.

We had our meeting on Wednesday, October 14th, with a brown bag dinner at 6:30 PM, followed by our meeting at 7:00 PM, at the Clarendon Methodist Church. We held the meeting in the church's basement conference room, all being at least 6 foot apart (social distance). We will be having a fund raiser by selling a pick-up lunch bag, containing a red hot, chips and a pop, on Saturday, November 7th and 14th, at the Clarendon Town Park, Falls Pavilion, from 9:00 AM to 6:00 P.M. In addition, we are planning this year to again sponsor the children's "Breakfast with Santa" Christmas Party on Saturday, December 12, 2020. Although this year, in order to follow the county's Health Department requirements, the party will need to be limited to three 50-person party's (9:00 to 9:45 A.M., 10:00 to 10:45 AM, and 11:00 to 11:45 AM). Reservations will need to be made by contacting the Eastern Orleans Community Center (585-638-6395) in Holley. Again, with great food and activities, and Santa Claus visiting, delighting all. Our next meeting will be held on Wednesday, November 11, with a brown bag dinner at 6:30 PM, meeting at 7:00 PM, followed by good fellowship. Our 911 Sign Fund Raiser, a blue metal sign, with white reflective numbers, indicating your house number, which can be installed at the entrance to your driveway, making it easy for emergency services to locate your residence. Our "Little Free Pantry" located at the east end of the Town of Clarendon Office parking lot, on Church Street, is for those in need of short-term food help. Especially now, we need your continued support, to replenish the pantry with non-perishable foods, such as boxed items (cereal, crackers, pasta, etc.), diapers, laundry soap and other non-perishable items. I have been the Town Clerk for the Town of Clarendon, Orleans County, New York since September of 1989. Our Town has grown over the years, but remains a small community. Since I've been in service of the Clarendon Community, one organization has and continues to go above and beyond in caring for the people in our Community through its volunteers. That is the Clarendon Lions Club, currently 21 members strong. These residents volunteer their time to the community by holding fund raisers throughout the year so they can fund scholarships and different needs in the community. The Clarendon Lions hamburger/sausage stand and annual Geranium sale are most popular to the residents. The Clarendon Lions Club has set up a "Little Free Pantry" at the Town Hall for residents in immediate need. Community folks have been very responsive to donating non-perishable foods and products to be placed in the box. Kevin Johnson, President of the Clarendon Lions Club, says "sometimes folks just need a little something to get them by when times are tough. The Little Free Pantry is a way for folks from the community to help each other. If the box is empty; it is because someone needed it... if it is full; it is because someone donated." The Lions newest project, 911 Signs, is an Orleans County Area Fund Raiser. The cost to purchase a house number sign is a donation that will be returned to the community through projects and support. These signs help emergency services locate a residence. These dedicated volunteers spend much time setting up, working and tearing down for each fundraiser, giving to their community. Annually, the Clarendon Lions Club offers three \$250.00 scholarships to area high school seniors. Criteria includes being accepted to a college and plan to have a career in the health/medical/public service field. The student submits a letter explaining their goals and why they should receive the scholarship. Over the past five years, Clarendon Lions have donated \$4,250.00 toward scholarships. The Lions also helps to fund a 'Christmas Shop' at the school where children are allowed to shop for inexpensive items for family gifts. Other funding given includes the following: Community Center – to families for Christmas, funding for Easter and Halloween parties, and general operations. ARC of Orleans, Blind Student Activities, Camp Abilities, Camp Badger, Canine Helpers, Challenger Miracle Field of Rochester, Genesee Ministry of Concern, Guiding Eyes for the Blind, Community Library, Hospice of Orleans, Mercy Flight, NYS & Bermuda Foundation, Orleans Adult Learning Services, Project New Hope, United Disciples Church, VA Bingo, West Side Challenger Tennis, Brady Buggy Wagon, Holley Community Garden and VA-WNY Rec (health care). Donations over the past five year period total \$22,750.00. The Clarendon Community is blessed with the volunteers of its Lions Club. Such dedicated volunteers are hard to find today. These citizens are worth their weight in gold and so appreciated by the Clarendon Community. The Lions Club has recently received recognition with a Small Town America Civic Volunteer Award.

Archie Ventress

Archie Ventress was born October 24, 1866 in Canada. He came to Clarendon in 1888. Archie met and married Julia Crossett of Clarendon in 1891. Together, they had 8 children, 5 daughters and 3 sons. A son born in 1893 sadly died at 5 months of heart failure. Shirley born in 1894, Clayton in 1896, Bertha in 1901, Hazel in 1902, Harold in 1904, Mildred in 1906 and Alma in 1908. Archie began a partnership with R.J. Cole and together they ran the flour mill in Clarendon until they dissolved their partnership in 1912. Archie worked for the Barge Canal office at Holley for two years before resigning in 1914 to take a job with the Highway Commission staking out roads. He was a masonry inspection officer for the state. Archie was a farmer and an active member of the Clarendon Universalist Church and the Clarendon Grange. Archie participated in the Centennial celebration of the Town of Clarendon in 1910 by providing a float in the parade. He was also on

the advertising committee. Thousands of people turned out for the celebration in August of 1910. The newspapers said that as many as 18,000 people attended the event which lasted several days.

Whoever holds the champion medal for rat catching in this county may hand it to Archie Ventress, who caught seventeen rats in as many minutes last Thursday. Archie found that there were rats in his corn house and he nailed up every rat hole in the building but one; over this he placed a bag, and going inside he made a charge on the vermin and they took refuge in the bag. Any one passing by can see them, as they are nailed to the side of the corn house. Next.
