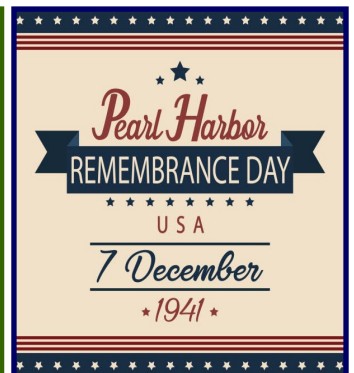

Meeting Highlights - NOVEMBER 2021

HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Tracy Chalker reported that the highway crew has been busy doing needed and preventative maintenance on the trucks and readying trucks and plows for snow season. We've been helping surrounding towns in the shared work program. Potholes have been patched on Boots Road, Merrill Road, South Holley Road, North Manning Road and Lake Road. There have been a lot of road-kill deer pickups. There are many vacations being taken.

PLANNING BOARD REPORT

Chairman David R. Griggs submitted the following written report: 10-26-2021 (Regular meeting) - Open end - Aaron Kelly addressed the board regarding looking at provisions in the zoning to allow more than two (2) campers on a private lot on an occasional basis. Chairman Griggs directed him to the Town Board with his request. SD 21-10, John Cape 17245 Jackson Road tax id# 110.-1-14.14. Pre conference for a 30' x 40' pole barn. Chairman Griggs reviews the application with the board. No housing of animals, setback met, sketch map provided, request to waive pre conference from applicant. No issues noted. Motion made and seconded to move from a pre-conference to a formal. Motion made, seconded and approved to approve SD 21-10. Planning Board members were apprised of the resignation of alternate member Gary Thompson. The Town Clerk will advertise the opening. 11-09-2021 (Regular meeting) - Planning Board members - reviewed Planning Board appointment recommendations to the Town Board for 2022. Chairman Griggs to submit a list to the town board for their consideration and approval. Planning Board members - approved a meeting calendar for 2022. SP 06-001 renewal, Best Rentals 5375 Upper Holley Road. Fee paid, inspected, no outstanding complaints. A motion was made, seconded and approved for renewal. SP 07-001 renewal, Autumn View Apartments 5395 Upper Holley Road. Fee paid, inspected, no outstanding complaints. A motion was made, seconded and approved for renewal. SP 17-01 renewal, GMC Industries 5278 Holley Byron Road. Fee paid, inspected, no outstanding complaints. A motion was made, seconded and approved for renewal. Planning Board members - reviewed a draft of proposed zoning language regarding a temporary permit for campers/travel trailers. No issues noted. Chairman Griggs will submit a draft to the town Board for their consideration and approval. The next regularly scheduled Planning Board meeting is 7:00 PM, November 23, 2021 at the Clarendon Town Hall, 16385 Church Street.



SUPERVISOR REPORT

Supervisor Richard Moy reported that the water bill payment due date for this past billing was November 12; there is still \$15,000 due. Shut-off Notices will be sent on November 26 and Red Tags will go out on January 6, 2022. Also reported was that one town hall employee has a positive COVID test and is in quarantine; one unvaccinated employee has also been quarantined. Both can return after the Thanksgiving Holiday. Supervisor reported on ARPA funding uses allowed. Anything doing with water is approved; the building at the water tower, meters, even fixing a road after a water repair. Nothing at the highway garage or air-packs for the Fire Company.

CORRESPONDENCE

The town planning board has submitted its meeting schedule/calendar for the year 2022. The Town has received its revenue from the Traffic Diversion Program for the second and third quarters 2021 in the amount of \$3929.98. Orleans County Self-Insurance has sent notice of our 2022 assessment; the town is \$110,328 and the Fire Company is \$7776 = total due \$118,104. Court Clerk Joanne Major has completed her ten years of service in our justice court and has completed her continuing court clerk education for 2021.

OLD BUSINESS

The Board adopted the final budget for the year 2022. A copy of which is available at the Clerk's Office or on the website; Supervisor and/or Town Board page.

NEW BUSINESS

William Fox was reappointed to the Clarendon Planning Board for a five year term; to expire 12/31/2026. General discussion was held regarding the proposed zoning amendment allowing for a temporary permit to occupy a trailer, travel/camper/recreational vehicle on a private lot. The Planning Board submitted a draft of new language pursuant to town board request. Supervisor Moy suggested that the number of vehicles/campers allowed be left up to the discretion of the Code Enforcement Officer according to the size of the property. Discussion was held regarding a \$40 fee for the permit/inspection. Comments ranged from no permit, no fee, to a fee only for vacant land or if there is a call or complaint making the CEO inspect; 2 weeks maximum stay or language that vehicles need to move out prior to getting another permit. No action was taken; will be on the December agenda. The Board authorized signs be placed at the Hillside Cemetery regulating parking/no parking at the Superintendent's discretion. The Board adopted the Orleans County Hazard Mitigation Plan as this jurisdiction's Natural Hazard Mitigation Plan.

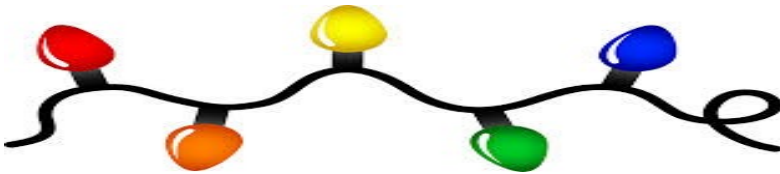

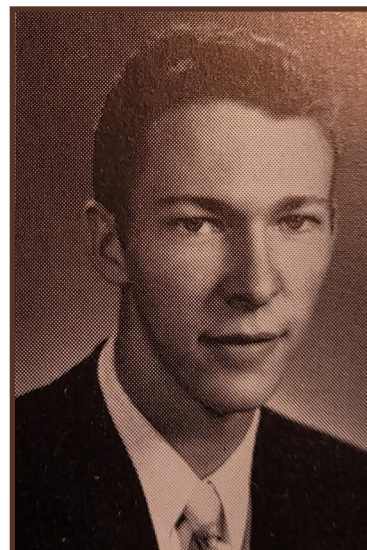

An Open Letter to the Residents of Clarendon From your Highway Superintendent

For your safety and well being during inclement weather, you should reduce your speed and drive according to the highway conditions. Winter driving conditions with icy and snow-covered roads require more driving care. If your vehicle becomes stranded, contact the Orleans County Sheriff's department at 589-5527 and they will notify the appropriate highway department. **SNOW REMOVAL** – The law regarding the depositing of snow on highways, shoulders or ditches is as follows: "Section 1219 of the Vehicle & Traffic Law and Section 214 of the Highway Law of New York State specifically prohibits the placing or leaving of snow, ice or other substance upon any highway" (this includes pavement, shoulders and ditches). As a result should these practices occur, police agencies will be notified of such occurrence(s) with the intent that summonses will be issued to the responsible person or persons. **MAILBOXES** – During and after significant snow storm, highway departments in the course of plowing, receive phone calls regarding damage to mailboxes either from snow plows directly or from the force of snow being thrown by the plows. If such damage is indeed caused by snow removal, it is not done intentionally but is an unfortunate consequence of snow removal. It must be pointed out that there is no statutory or legal authority which grants a property owner or resident along a public highway any right to place a mailbox in a highway right-of-way; the mailbox is on town or county right of way as a courtesy to the postal service. Thus, the necessity of keeping the highway open conflicts with the individuals' reception of the mail, the latter must stand aside. The owner may even be asked to remove the box under Highway Law #319. From past experience, we have found that plastic mail boxes do not withstand the abuse of snow from the plows and are not recommended. *As a courtesy, the Clarendon Highway Department will place a temporary box so that residents can receive mail if their box is damaged by the plow but we will not replace any fancy mailbox or post.* Mailbox posts with fancy supports are not recommended as they stick down under the box and give the wing plow something to get hold of. A box mounted directly on top of a treated 4 X 4 is best. **Posts should be placed fifteen (15) feet from the centerline of the road.** Please note illustrations.
