# CLARENDON TOWN BOARD

## Meeting Highlights - JANUARY 2021

Sandra Shaw, Director at the Holley Community Free Library, informed that the two year construction project at the library has been finished. It has received over \$100,000 in grants, some of which has been used to purchase two new computers. This is the library's 75<sup>th</sup> year anniversary; Ms. Shaw asked for celebration ideas and suggestions.

### **HIGHWAY/WATER DEPARTMENT REPORT**

Superintendent Tracy Chalker reported that the crew has been busy plowing and salting the roads. Work has been done on the salt shed. Water meters have been read for 4<sup>th</sup> quarter usage 2021 and red tags have been hung for those who still owed payment from the prior billing. Three water services have been turned off for non-payment and three more are still in question. The crew has been working on brush clean-up and there were two burials at Hillside this past month. Clarendon helped the Village of Holley with water leaks on New Year's Eve and New Year's Day. Superintendent Chalker shared estimates received from Direct Security Systems, Action Security and Communications and Amherst Alarm to install security cameras at the highway garage. Amherst Alarm currently monitors the alarm system and would also monitor the camera system. Superintendent favors the system from Direct with 8G cameras and 16 channels; 7 outside and 1 inside. A router for internet will be needed for the system. The 14 year old hot water pressure washer needs to be replaced. Kepner Equipment has offered a demo unit for \$6795.00. Superintendent Chalker will do more research before purchase.

### **PLANNING BOARD REPORT**

Planning Chairman Dave Griggs submitted the following written report: **12/28/2021 (Regular Meeting)** – Cancelled due to insufficient agenda items. **01-11-2022 (Regular Meeting)** – **SD 21-11, follow up action**, Pre-conference for a one (1) lot subdivision from Tax ID #99.-2-32.11 for merger with Dennis Ladd 4629 Hall Road Tax ID #99.-2-31.1. Motion made, seconded and approved to declare this a minor subdivision for SEQRA purposes. **SD 21-12, follow up action**, Pre-conference for a two (2) lot subdivision, Lisa Fiorito Tax ID #99-1-47.11. Motion made, seconded and approved to declare this a minor subdivision for SEQRA purposes. **SP 22-01**, Pre-conference, Automotive repair shop, All American Diesel, Erich Hoak, 5267 County Line Road Tax ID #99.-2-5.1. Planning Board Members reviewed the proposal. Parking, hours of operation, waste removal, buffering, lighting, signage, etc. were discussed. No significant issues noted with the proposal. Applicant requested a waiver. Motion was made, seconded and approved to waive the pre-conference and move to formal application. A motion was made, seconded and approved to schedule a public hearing at 7:00 pm on January 25, 2022 with the regularly schedule Planning Board Meeting to immediately follow. **SP 00-001**, Renewal, Old Paths Bible Baptist Church, 4782 Hall Road Inspected, fee paid, no outstanding complaints. Motion made, seconded and approved to approve renewal of Special Use Permit.

### **HISTORIAN/HISTORICAL SOCIETY REPORT**

Historian Melissa Ierlan gave a report regarding the Hillside Cemetery Chapel restoration project. Before we even applied for grant monies, the Clarendon Historical Society pledged to raise 30k in order to offset the town share of the matching grant. The CHS actually contributed 44k which included some smaller local grants that were applied for and received. The methods used to raise monies by the CHS were ticket sales for cemetery walks, basket raffles, Holley Central School Student Council

fundraising efforts, a "Save the Chapel" flier that was distributed locally and in the Christopher Mitchell Funeral Home. To date we have completed the replacement of the slate roof and repair and replacement of the stained-glass windows. Also, the repointing of the sandstone inside and outside has been done. Other grant monies/donations that we have obtained totaling a little under 40k were from Orleans County Community Foundation, Elizabeth Dye Curtis and the CHS. It is estimated when all is said and done, the actual "out of pocket" monies from the town will be less than \$50,000. What this means is that a \$252,000 historical restoration project for the chapel cost taxpayers less than 1/5<sup>th</sup> the total.

### **SUPERVISOR REPORT**

Supervisor Richard Moy reported attending a seminar on ARPA funding and allowances for use of the money. He has sent questions to confirm items and will discuss this after confirmation is received.

Ag & Markets has sent another report of inspection of the county dog shelter; it is rated satisfactory.

### **CORRESPONDENCE**

CHIPS revenue in the amount of \$157,641.11 has been received from New York State. Bennett, Difilippo, Kurtzhaltz Law Office has sent solicitation for legal representation at \$200/hour. The Town has used this firm in the past regarding real property tax litigation. Fourth quarter traffic diversion program revenue has been received from the county in the amount of \$960.00. Orleans County Board of Elections has sent notice of the 2022 elections; Primary Election will be on June 28 and General Election will be on November 8. Voting hours for all elections are 6:00 AM until 9:00 PM. NYS Unified Court System has sent a reminder that audit and report of the Court Records is due by March 1, 2022. Supervisor Moy and Deputy Supervisor Robinson perform this audit every year. The county has sent an abstract of payments made to the town in the year 2021.

### **OLD BUSINESS**

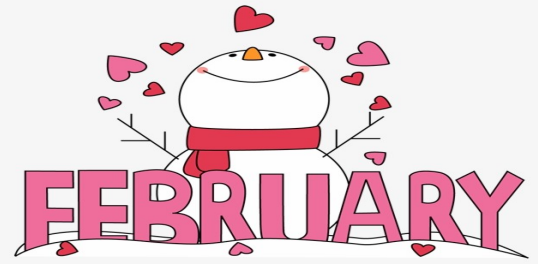
Town board members unanimously voiced strong opposition to consolidation of justice courts and the Justice Court Reform establishing a District Court System. General discussion was held regarding the proposed zoning ordinance amendment regarding Trailer, Travel/Camper/Recreational Vehicles. This will be on February agenda with changes to the draft. The Town Board accepted the water maintenance agreement with the Village of Holley at an annual rate of \$11,000. Holley water superintendent will send letter to the health department regarding status of Superintendent Chalker's license mandates completed.

### **NEW BUSINESS**

Crystal Gurney was reappointed to a five-year seat on the Zoning Board of Appeals; term to expire 12/31/2026. The Town Board accepted an estimate from AED Custom Remodeling for purchase and installation of new front doors at the town hall; to include accessible auto opener and closer at a cost of \$10,700; to be paid for by ARPA funding. The Board adopted a SEQR and Bond Resolution to finance the new plow truck. Monroe County Water Authority has sent notice of its water rate changes for 2022; the charge per day for the meter has increased but the rate per 1,000 gallons has been decreased. Town Board in agreement not to change its water rates to residents. The Orleans County Legislature is requesting for towns and fire companies to select a representative to serve on the Task Force established to assess the issues that are impacting emergency medical service responses in the county. Supervisor Moy will represent the town and Councilman Marc Major, Chief for the Clarendon Fire Company will select representation from the Fire Company.

## An Open Letter to the Residents of Clarendon From your Highway Superintendent

For your safety and well being during inclement weather, you should reduce your speed and drive according to the highway conditions. Winter driving conditions with icy and snow-covered roads require more driving care. If your vehicle becomes stranded, contact the Orleans County Sheriff's department at 589-5527 and they will notify the appropriate highway department.

**SNOW REMOVAL** – The law regarding the depositing of snow on highways, shoulders or ditches is as follows: “Section 1219 of the Vehicle & Traffic Law and Section 214 of the Highway Law of New York State specifically prohibits the placing or leaving of snow, ice or other substance upon any highway” (this includes pavement, shoulders and ditches). As a result should these practices occur, police agencies will be notified of such occurrence(s) with the intent that summonses will be issued to the responsible person or persons. **MAILBOXES** – During and after significant snow storm, highway departments in the course of plowing, receive phone calls regarding damage to mailboxes either from snow plows directly or from the force of snow being thrown by the plows. If such damage is indeed caused by snow removal, it is not done intentionally but is an unfortunate consequence of snow removal. It must be pointed out that there is no statutory or legal authority which grants a property owner or resident along a public highway any right to place a mailbox in a highway right-of-way; the mailbox is on town or county right of way as a courtesy to the postal service. Thus, the necessity of keeping the highway open conflicts with the individuals' reception of the mail, the latter must stand aside. The owner might even be compelled to remove the box under Highway Law #319. From past experience, we have found that plastic mail boxes do not withstand the abuse of snow from the plows and are not recommended. *As a courtesy, the Clarendon Highway Department will place a temporary box so that residents can receive mail if their box is damaged by the plow but we will not replace any fancy mailbox or post.* Mailbox posts with fancy supports are not recommended as they stick down under the box and give the wing plow something to get hold of. A box mounted directly on top of a treated 4 X 4 is best. **Posts should be placed fifteen (15) feet from the centerline of the road.** Please note illustrations. 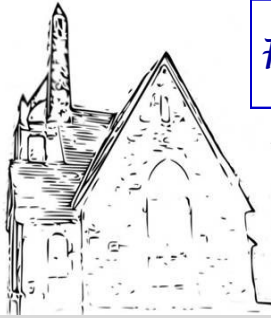

## Hillside Cemetery

**Daniel P. Albert** was born in the Town of Murray on July 6, 1834. The son of Aaron and Sarah Albert. He had 2 brothers Peter and Storm. When he was in his early twenties, Daniel purchased land in the town of Clarendon. He owned several parcels between 1860 and 1898.

Daniel married Amelia Glidden the daughter of William and Lucinda who lived in Clarendon on Glidden Road. Daniel and Amelia had 4 children, a daughter Hattie born 1858, William born in 1861, Daniel born in 1867 and Bert born in 1876. On the 1870 Federal Census Daniel was recorded as a farmer in Clarendon. The census showed that he had 8 horses, 2 milk cows, 7 beef cows, 41 sheep and 1 pig. It also recorded that his farm produced 220 bushels of winter wheat, 100 bushels of barley and 100 bushels of Indian corn. Daniel sold 90 acres of land located on Hindsburg Road in 1883 for \$5,00. (Equivalent to \$155,00 in today's money) The Holley Standard reported on February 4, 1886 that a portable saw mill on his farm was rapidly filling up with saw logs and a very large supply of wood. A notice was published in several newspapers on June 6, 1859 that stated:

The early settlers of Orleans County, and all others who feel an interest in our early history, are requested to meet at the Court House in Albion, on Saturday, the twenty-fifth of June, at two o'clock pm, for the purpose of forming a Pioneer Association for Orleans County. Daniel was a member of this organization. The Holley Standard in 1899 published the yearly list from the Pioneer Association of members who had died. Around 20 people from Clarendon alone were on that list. Daniel was only 64 years old when he died. The obituary for Daniel told of his death from heart disease. It said he had been invalid for a year but confined to his bed for only a short time. It also stated that during his last hours he suffered intensely. This was the first death in the family. The funeral was held at the Universalist Church in Clarendon.
