CLARENDON TOWN BOARD Meeting Highlights - MARCH 2022

HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Tracy Chalker reported that the plows made 32 runs in the 28 days of February 2022. The brush pile behind the highway garage was burned prior to the burn ban; pot holes have been paved and trees removed with the help of the county. The new truck was in on March 11th. Fifty-four red tags were hung regarding unpaid water bills and the crew has still been doing tree clean-up from the wind storms.

PLANNING BOARD REPORT

Chairman Dave Griggs submitted the following written report: March 02-22-2022 - Regular Meeting was canceled due to insufficient agenda items. 03-08-2022 (Regular Meeting) - SD 22-02, Pre-conference for a site plan review for a one (1) lot subdivision and building lot approval for a single-family home. Kate Crist, Transit Road, tax id# 108.-1-54.11. Chairman Griggs reviewed the subdivision survey map with the board. No significant issues noted. Applicant requested a waiver of pre-conference. A motion was made, seconded and approved to waive the preconference and move to formal. A motion was made, seconded and approved to approve subdivision contingent upon verification by the OIO that pins had been set, creation of deed and filing of map with Orleans County clerk. Lot is currently in Ag district and subject to lateral restrictions, a well would be required. A motion was made, seconded and approved to grant building lot approval. SD 22-03, Pre-conference for a site plan review regarding the transfer of a previously issued certificate of Non-conformance (Harling's Auto Repair Shop) to a new owner, Kevin Manna, 16179 E. Lee Rd. In addition to continuing to operate a motor vehicle repair shop the applicant requested to add motor vehicle sales. Applicant was informed that no motor vehicles are allowed to be offered for sale on the premises. Additional items were discussed and agreed to as conditions of renewal. A motion was made, seconded and approved to submit the findings of the site plan review by the Planning Board to the Town Board for their review and consideration regarding their approval of the transfer of the Certificate of Non-conformance. SD 22-05, Preconference for a site plan review for building lot approval for a single-family home, Natalie Bornemann, 16379 Munger Road, tax id# 120.-1-62. Chairman Griggs reviewed the application with the board. Perc test approved by the Orleans County Health department. Clarification of front setback is required. Motion made. seconded and approved to table for further information. SP 96-005, Nancy Curtis Caswell, Pet's Galore Grooming, 4880 S. Holley Road. Inspected, fee paid, no outstanding complaints. A motion was made, seconded, and approved to renew the Special Use Permit. SP 22-01, Automotive repair shop, All American Diesel, Erich Hoak, 5267 County Line Road, tax id# 99.-2-5.1. County Planning Board review found no issues with this proposal. A motion was made, seconded and approved to approve Special Use Permit.

HISTORIAN REPORT

Historian Melissa Ierlan submitted the following written report: It's been a quiet month so far. I've done some research on a house in Clarendon for information on first owners and providing old maps etc. Another research project on a family who lived near Pumping Station Road in the early 1900's. I provided images of old historical documents to the person opening up the business in Holley at the old bank. Invoices and other documents dealing with hops. Hops were grown in Clarendon for many years and an old drying house was once located on Upper Holley Road. I attended the Byron Historical Society Meeting and received some slides from their 1970 parade which contained two pictures of the Clarendon Fire Company. The Clarendon Historical Society was asked to help sponsor an Easter Egg Hunt being held in April. We will donate some candy and plastic eggs to hide. I also designed the flyer for the event. A local scout came up with the idea and Disciples First United Methodist Church will hold the event.

SUPERVISOR REPORT

Supervisor Richard Moy thanked Superintendent Chalker and the highway crew; it is the first time that each water district has an excess of revenues collected from bills being paid It was reported that New York State has a low-income household water assistance program. Information is available at the Town Clerk's Office. Congressman Chris Jacobs will be the guest speaker at the Orleans County Association of Municipalities this month to be held at the White Birch in Lyndonville.

CORRESPONDENCE

The town received \$78.00 for its share of capital paid to NYMIR insurance. The NYS Office of Temporary and Disability Assistance has sent notice of Assistance available with past-due water bills. Orleans County will host emergency management training at the Carlton Recreation Hall on April 2, 2022.

OLD BUSINESS

The Town board held a public hearing to consider proposed zoning amendments prior to the regular meeting. No comments were given/heard. The Town Board approved the proposed zoning amendments be sent to the county planning department for review.

NEW BUSINESS

The Town Board authorized an increase in town mileage rate from \$.50 per mile to \$.58 per mile pursuant to gas price increases. (The state rate is 58.5 cents per mile). Discussion was held regarding consideration of the transfer of Certificate of Non-Conformance to the new owner of 16179 East Lee Road for a Motor vehicle repair shop. NYSDEC has no record that the gas tanks at that property were removed from 1985 to 1989. DEC recommended the town receive proof the tanks are not still buried and/or have the soil tested for contamination. It was confirmed that New York State will not issue a license for repair until the town issues the special permit. OIO mentioned that GPR (ground penetrating radar) can be used to locate the tanks. Supervisor Moy read aloud the Planning Board's list of proposed conditions resulting from its site plan review. A majority of board members in agreement that confirmation of the tanks having been removed be obtained prior to any town board approval.

Hillside Cemetery

Jesse B. Mower was born in the town of Hartland, Niagara County in 1865. His parents were Levi and Sarah Mower. Jesse came to Clarendon with his parents at the age of five which is listed on the 1870 US Federal Census. His siblings were Adelbert, Alice and Eddie.

When Jesse left home his profession was farming. The Holley Standard had several articles in which farmers were listed as news when they moved from farm to farm each year. Jesse was in Clarendon, Holley, Albion, and Manning on different farms in his early adulthood.

Jesse attended church in Clarendon and was a member of the Epworth League. The Epworth League was authorized by the General Conference of the Methodist Episcopal Church and its purpose was to develop young church members in their religious life and provide training in churchmanship.

In 1897 Jesse left Clarendon to take a job in sales for an oil company in Brooklyn, NY. In a letter home he stated that making \$40 per month was a good wage considering the times.



By 1899 Jesse was back in Clarendon and it was reported in the Holley Standard that on January 13, 1899 there would be a "box social" at his house for the benefit of the singing school.

During the late 1890's and early 1900's "box socials" were popular community events that were used to raise money for schools and churches. It involved young women preparing a picnic style meal that would include sandwiches, fruit and a dessert.

Jesse married Hattie Bell Gates of Clarendon in 1890. Jesse and Hattie had two children, Clifford born in 1900 and Mildred born in 1903. An article in the Batavia Newspaper October 21, 1905 reported that Jesse Mower a Clarendon farmer, bought the Stannard Building on Gates Street in Bergen, erected in the summer of 1898, and containing a saw and planning mill as well as a sash and blind factory. It also said that Mr. Mower would be operating in a week or two but would not move to Bergen until the spring. The same newspaper in April 1906 reported that Jesse Mower, his wife and two children became residents of the village of Bergen occupying the Church house on Gibson Street.
