BE ADVISED that the Clarendon Town Board will hold a Public Hearing on November 1, 2022 to consider proposed Local Law No. 1 of 2022 entitled A Local Law Providing for Written Notification of Defects and Obstructions on Town Highways, Bridges, Streets, Sidewalks, Crosswalks and Culverts in the Town of Clarendon (a copy of the local law is available at the Clerk's Office or on the town website on the legal notice page). ALSO BE ADVISED that the Town Board will hold a Special Meeting immediately following the afore mentioned Public Hearing to authorize unpaid balances for zoning violation, mowing services and water charges in arrears be added to the January 2023 town/county tax bills with an additional \$100 penalty and to introduce proposed Local Law No. 2 of 2022 entitled A Local Law Increasing the Maximum Income Eligibility Level for the Senior Citizen Tax Exemption Under Section 467 of the Real Property Tax Law and Allowing the Disabled and Limited Income Exemption Under Sect. 459 of the Real Property Tax Law.

If the customer previously purchased a DMP thru the instant lottery ( Aug 1-Oct 1) they will not be charged for their First Come First Served (FCFS) application. If the customer did not purchase a DMP in the instant lottery, they will be charged \$10 for the FCFS applications.

# **CLARENDON TOWN BOARD Meeting Highlights - October 2022**

The Town Board held a Public Hearing to consider the 2023 budget for the town on October 17, 2022 and interested taxpayers were given opportunity to file or register any objections to said proposed budget.

The Town Board held a workshop meeting to discuss purchases with American Rescue Plan Act (ARPA) funds prior to the regular meeting. Supervisor referenced a spreadsheet showing all ARPA funded purchases to date and the balance of funding. Total received is \$355,998.93. Items paid include digital water meters & equipment, two new boilers at town hall, new town hall front doors, new mower for Hillside Cemetery, a new shredder for town hall and a water back-up laptop computer – these purchases totaling \$110,709.48. \$100,000.00 has been marked toward establishment of Water District No. 14 -\$18,872.60 having been spent to date on engineering services, leaving \$81,127.40 for WD #14. Discussion was held on additional possible purchases/projects; including Records storage on the second floor of the Stone Store; Councilman Major to visit the building and assess fire proofing that would be needed. Fire Company is discussing need for new Self Contained Breathing Apparatus' (SCBA's) - a pack with two bottles. Nineteen was estimated at a cost of \$75-80,000. Comprehensive Plan needs funds to mail survey \$3,000.00; Metal is needed on the building by the water tower \$10,000.00. Supervisor suggested other items be put on hold until the stone store is thoroughly investigated for records storage.

#### **OPEN END**

Supervisor Moy asked Legislator Eick about consideration of increased revenue to towns from sales tax revenue; that the 20% that goes to the towns was set many years ago when Marcia Tuohey was on the Legislature. Legislator Eick informed that 3 or 4 years ago it was discussed, but nothing came from it.

#### HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Tracy Chalker reported that the Highway crew replaced shoulder material on Hulberton, Jackson, Mansfield and Transit Roads. We've helped the county with paving and surrounding towns finish up with road work. Clarendon is done with roadwork for the year. Trucks are being set up for winter; plow frames on, boxes cleaned out, salters and spinners on. Continuing to mow town properties and deer pick-ups have increased. There were three burials at Hillside Cemetery this month. The third quarterly water meter readings are done. It went well with all new meters installed: it took less than one day, saving manpower and time. Superintendent Chalker attended the Highway Fall Conference; it was very educational. The CHIPS, State of NY, Extreme Winter Recovery forms have been submitted and approved. The town should have a check after December 15, 2022. Working on completion of third roadside mowing. Superintendent took a town truck to the first annual Family Fall Festival hosted by All-American Diesel Service on County Line Road. It was a successful event; the Fire Company was there with a truck also.

#### SUPERVISOR REPORT

Supervisor Dick Moy informed of a call received from a resident that a homeless man was sleeping in the town park under the big pine tree. The resident was very uneasy. Supervisor cautioned not to approach the man; that the police had been notified. Supervisor went by the park after last night's public hearing and he was gone. Highway Superintendent agreed to trim the low branches on that pine tree for better vision from a distance.

#### CORRESPONDENCE

The Town received notice of New York State's Health Law regarding tobacco and cannabis use in parks. It is available to anyone who wants to review it. The Orleans County Board of Elections has sent notice of the November 8, 2022 general election. Polls will be open from 6:00 AM to 9:00 PM. That office was going to draft a letter to the state regarding early voting. Turn-out in this county is very low; last early voting cost every taxpayer \$120/vote! The Town received notice from the Kendall Fire Department that it will no longer offer a transporting ambulance service as of 12/31/2022. As of 1/1/2023 the Kendall Fire Department will operate as a BLS first response agency and continue to serve people of the Kendall Fire District and surrounding communities. Monroe Ambulance will be the transporting agency as of 1/1/2023. Notice was received of Land Use Training for Local Officials; Planning Board Deputy Chairman Kevin Johnson will attend.

#### **OLD BUSINESS**

Planning Board Chairman informed that the Planning Board will prepare a draft of Short-Term Rentals for the zoning ordinance after conference attendance. Supervisor reported receiving a breakdown of vacant land acreage from the assessor's office of lots over 15 acres within 1 ½ miles of the powerline; in regard to solar farms. Supervisor will contact Laura Kingdollar with the information.

The Town Board approved the 2023 Preliminary Budget; upon approval the preliminary becomes the final budget for 2023; it will be on the November agenda for adoption. A copy of the accepted 2023 Preliminary Budget is made part of the Permanent Record of these minutes.

#### **NEW BUSINESS**

The Town Board introduced Proposed Local Law No. 1 of 2022 entitled A Local Law Providing for Written Notification of Defects and Obstructions on Town Highways, Bridges, Streets, Sidewalks, Crosswalks and Culverts in the Town of Clarendon and Calling for a Public Hearing on November 1, 2022 at 6:30 PM at the Town Hall with a special meeting to commence immediately following the public hearing. Orleans County Real Property has sent notice of its intent to increase the income limits allowed for Senior Aged and Disability Exemptions. Clarendon currently allows for the Senior Aged exemption and will need to adopt a local law in order to increase the limits allowed. A local law will be prepared for consideration at the November 1, 2022 special meeting, to include disability exemptions. Designating relevied water and mowing charges filed with the Town Board has been delayed to the special meeting on November 1, 2022; the Board will authorize that the unpaid balance for zoning violation, mowing services and water charges in arrears from the July 5, 2022 billing and/or prior billings unpaid on November 1, 2022 be added to the January 2023 town/county tax bills with an additional \$100 penalty.



# Híllsíde Sketches

George N. Bowman was born on Sept. 12, 1824, in Herkimer County, NY. At the age of five he and

his parents moved to the Town of Yates. George's parents died when he was quite young, and he lived with Dr. Nicholson in Sandy Creek. George spent a number of years working for Mr. Calvin Church who was the proprietor of the LaFayette Hotel in Sandy Creek. George married the daughter of Calvin Church in 1850. They had no children. In 1857 George worked in the mercantile business with Birdsall Perrigo and continued that work until 1867. He then moved to Holley and along with C.W. Gibson established the Exchange Bank of Holley. He was the president and cashier at the bank for more than 30 years and worked up until the year before his death from heart disease on September 17, 1898.



From the time of its organization, George was the treasurer and vestryman of St. Paul's Church in Holley. George served as the treasurer and director of the Electric Light Company. He was also the treasurer of the village, the Union School and various business and social organizations. He served two terms as the supervisor of the Town of Murray.

On November 25, 1940, the Exchange Bank of Holley became a branch of the Marine Trust Company of Buffalo, NY. The bank was the oldest business organization in Holley, in operation for more than seventy years. The bank had \$960,000 when it changed hands. The bank had always been owned and operated by local residents and practically all of its stock was held in the immediate vicinity. In 1931 when many banks throughout the country had failed, it was threat-

ened by a run which may have proved disastrous not only to the institution but to the entire community; it was saved by prompt action on the part of local residents. A bank examiner that was present called this the finest example of cooperation he had ever seen. (Kind of reminds me of the storyline in the movie "It's a Wonderful Life"




#### A MESSAGE FROM THE HIGHWAY SUPERINTENDENT .....

Now is a good time to take a look at the condition of your mailbox and post. Winter will soon be here and the plows will be out in full force. When we get a call that the plows have taken out your mailbox the majority of them are knocked over by the weight of the snow. If the post is in poor condition it is more likely to be knocked over. Please take the time to inspect your post and make sure it is not starting to rot or get rusty. Also check and make sure the post is securely seated in the ground. If your mailbox and post are secure they are less likely to be knocked over.

## An Open Letter to the Residents of Clarendon From your Highway Superintendent

For your safety and well being during inclement weather, you should reduce your speed and drive according to the highway conditions. Winter driving conditions with icy and snow-covered roads require more driving care. If your vehicle becomes stranded, contact the Orleans County Sheriff's department at 589-5527 and they will notify the appropriate highway department. **SNOW REMOVAL** – The law regarding the depositing of snow on highways, shoulders or ditches is as follows: "Section 1219 of the Vehicle & Traffic Law and Section 214 of the Highway Law of New York State specifically prohibits the placing or leaving of snow, ice or other substance upon any highway" (this includes pavement, shoulders and ditches). As a result should these practices occur, police agencies will be notified of such occurrence(s) with the intent that summonses will be issued to the responsible person or persons. MAILBOXES During and after significant snow storm, highway departments in the course of plowing, receive phone calls regarding damage to mailboxes either from snow plows directly or from the force of snow being thrown by the plows. If such damage is indeed caused by snow removal, it is not don intentionally but is an unfortunate consequence of snow removal. It must be pointed out that there is no statutory or legal authority which grants a property owner or resident along a public highway any right to place a mailbox in a highway right-of-way; the mailbox is on town or county right of way as a courtesy to the postal service. Thus, the necessity of keeping the highway open conflicts with the individuals' reception of the mail, the latter must stand aside. The owner may even be asked to remove the box under Highway Law #319. From past experience, we have found that plastic mail boxes do not withstand the abuse of snow from the plows and are not recommended. As a courtesy, the Clarendon Highway Department will place a temporary box so that residents can receive mail if their box is damaged by the plow but we will not replace any fancy mailbox or post. Mailbox posts with fancy supports are not recommended as they stick down under the box and give the wing plow something to get hold of. A box mounted directly on top of a treated 4 X 4 is best. Posts should be placed fifteen (15) feet from the centerline of the road. Please note illustrations. For further information, contact me at (585) 734-1302 or (585) 638-8547. Thank you.
