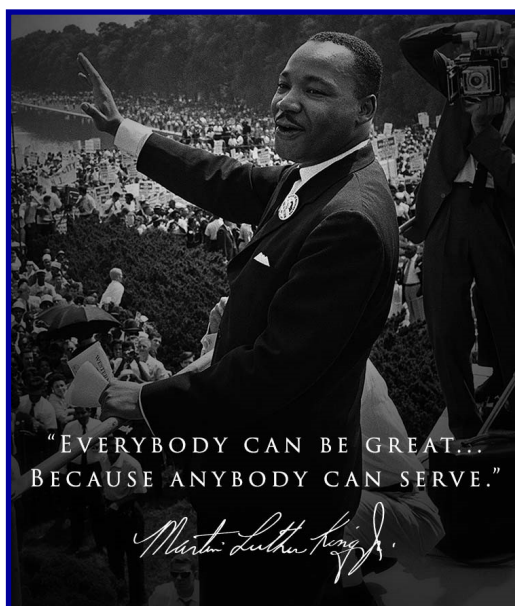

CLARENDON RESIDENTS BE ADVISED that the Clarendon Town Board will hold its regular monthly meetings for the year 2023 on the third Tuesday of every month at 7:00 PM at the Town Hall, 16385 Church Street in Clarendon, NY. Additional meetings and public hearings will be published when set. The official bank for the Town in 2023 is Five Star Bank and legal notices will be published in the Westside/Suburban News.

CLARENDON TOWN BOARD Meeting Highlights - November 2022

HIGHWAY/WATER DEPARTMENT REPORT –

Superintendent Tracy Chalker reported that the crew has been busy plowing and salting the roads and cleaned up eight downed trees from the roadway. Mowers and tractors have been prepared for winter storage. Two driveway culvert pipes were replaced; one on LaDue and one on Mansfield Road. Small tools have been cleaned up. Christmas decorations were hung and a decorated town truck was in the Christmas parade. Truck maintenance has been done and water samples taken. Superintendent reported his intention to place an ad for two part-time seasonal/summer employees; for the cemetery and to paint fire hydrants. At Councilman Robinson's request, Superintendent Chalker reported a lot of trees could come down on the roads or powerlines that are outside of our right of ways that residents need to address; possibly hundreds of trees could come down in heavy winds. If a tree is dangerous looking, the town can do easements to properties for removal.

Motion made, seconded and approved to approve renewal. Special Permit renewal SP 17-01, GMS Industries, 5278 Holley Byron Road. Inspected, fee paid, no outstanding complaints. Motion made, seconded and approved to approve renewal. Special Permit renewal SP 07-001, Autumn View Apartments, 5395 Upper Holley Road. Inspected, fee paid, no outstanding complaints. Motion made, seconded and approved to approve renewal. Chairman Griggs presented the latest revised preliminary draft for Short Term Rentals for further review. Changes were discussed and agreed on. Chairman Griggs will incorporate them into a revised preliminary Draft for continuing review at our next meeting. 12-13-2022 Regular Meeting: Chairman Griggs provided the latest update of the preliminary Draft for Short Term Rental (STR) for further review. Changes were discussed and agreed on. Chairman Griggs will incorporate them into a final revised preliminary Draft and submit it to the Town Board for their consideration and approval at the next Town Board Meeting. The next regularly scheduled Planning Board meeting is at 7:00 PM on December 27, 2022 at the Clarendon Town Hall, 16385 Church Street.

HISTORIAN/HISTORICAL SOCIETY REPORT –

Historian Melissa Ierlan reported that the second annual Christmas Parade was a well-attended success; that the 'Grinch' (Superintendent Tracy Chalker) handing out onions was a big hit! Melissa thanked all for their participation and help in the event. Melissa was acknowledged for the hard work in making the event a great celebration.

SUPERVISOR REPORT –

Supervisor Dick Moy reported that Court Clerk Joanne Major has completed her NYS continuing clerk education requirements. Supervisor Moy was given a tour of the quarry and was present for a blast. The Town requested stone for use in the town park parking lot; Hanson not only supplied the stone, but installed it for us.

CORRESPONDENCE -

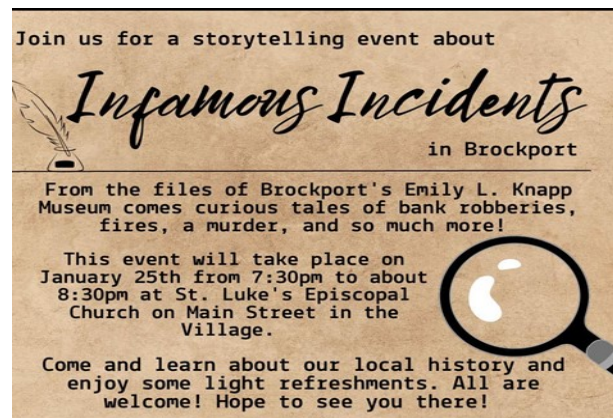
The Town Board received a resignation from Amy DiFante from the Board of Assessment Review; her term expired in September and Amy does not wish reappointment. The County has sent notice of approved amounts for towns' mortgage tax revenue share; a check for \$76,265.31 for Clarendon's mortgage tax revenue from April 1 to September 30, 2022 has been received from the Orleans County Treasurer. National Grid has sent notice they will be completing routine maintenance/upgrade work on existing utility poles in the area; scheduled to begin in February 2023 and will continue in our area for several days. Notice of the town's Self-Insurance cost for 2023 has been received; town \$110,666.00, fire company \$7898.00. 2022 STOP DWI convictions revenue has been received from Orleans County in the amount of \$250.00. The County Legislature has approved the 2023 Solid Waste/Recycling Program Fees at \$216.00 per parcel; Clarendon will collect \$236,196.00

Appreciation was expressed for Michelle Chalker and her son Zeke for decorating the town hall for Christmas and to Cherrie Brooks for decorating the stone store windows.

OLD BUSINESS -

Supervisor Moy reported that the Town of Kendall has decided not to contract with Monroe Ambulance. Therefore the agreement was amended to exclude the Town of Kendall. The Board authorized a new contract to include municipalities of Albion, Barre, Carlton, Clarendon, Gaines and Murray. Supervisor Moy acknowledged that a public hearing will be needed for input on the proposed Short Term Rental zoning amendment. Board members in agreement to put the item on the January agenda. Planning Chairman Griggs explained that this will give the town control as could pose problems with trash, noise, parking, etc... Lake Placid regulations were used as a model. The Town Board authorized payment of Year-end bills on Abstract 13. Proposed Local Law No. 1 of 2023, entitled a Local Law to Change the Grievance Day for Assessments in the Town of Clarendon, was introduced and a public hearing set (see page 1 of this Gazette). The Town Board held its organizational meeting on January 3, 2023. Annual appointments and designations were authorized.
