

#### CLARENDON TOWN BOARD Meeting Highlights - November 2022

The town board held a public hearing regarding Local Law No. 1 of 2023, changing the day for grievance of assessments in the Town of Clarendon. Supervisor Moy explained that pursuant to real property law, when an assessor handles more than one town, grievance day can be changed to accommodate a second town. The assessor has since retired from his employment with the other town and handles Clarendon alone, therefore by law, grievance day needs to be held on the fourth Tuesday in May. No comments were heard at the hearing; the Town Board did adopt the local law at the regular meeting.

#### HIGHWAY/WATER DEPARTENT REPORT

Superintendent Tracy Chalker reported that the crew has been plowing and salting the roads.

He has been working on FEMA paperwork for the storm at Christmas; cost to the town for snow removal that weekend during that storm is figured at \$21,603.08; average cost for labor, fuel and salt per plow run is \$2432.08. Fourth quarter meter readings have been complete and routine water details are being done; flushing hydrants and taking water samples. Fourteen trees came down during the storm that highway crew took care of alone to make the roads passable. Clean-up is being done when time allows.

A Soffit and gutter came off the highway garage during the heavy winds. Two new water services were installed; one on Bennetts Corners Road and one on County Line. We had one burial at Hillside and the Christmas decorations were taken down.

#### PLANNING DEPARTMENT REPORT

Chairman Dave Griggs submitted the following written report: 12 -13-2022 (Regular Meeting) Chairman Griggs provided the latest status update of the preliminary draft for Short Term Rental (STR). Bed & Breakfast (B&B) language will be included. Chairman Griggs will incorporate language for them into a final revised preliminary Draft and submit it to the Town Board for their consideration and approval at their next town meeting. 01-10-2023 (Regular Meeting) Special permit renewal SP 21-07, Showdowns Ranch, 16213 East Lake Road, Inspected, fee paid, no outstanding complaints. Motion made, seconded, and approved to approve renewal. Orleans County Representative Kevin Johnson updated the Planning Board members regarding the status of the proposed Short Term Rental (STR) zoning draft in Kendall that was rejected by the County Planning Board. Board members were given copies of Kendall's draft for review. The general consensus was that it was rejected because its provisions were either too restrictive or too vague. The Planning Board will continue to monitor this situation as it plays out.

#### SUPERVISOR REPORT

Supervisor Dick Moy reported final estimated revenues for last year's \$800,000 budget were only off by \$1100; a difficult job well done!

#### CORRESPONDENCE

The Town received a check from the NYS Dot for CHIPS. PAVENY, POP, WIRP in the amount of \$237,507; NYS Court System sent notice of continuing education completion for Justice Thomas DiFante; The Orleans County Health Department has sent their water system field compliance inspection report; Orleans County Board of Elections has sent notice of 2023 elections -Town Clerk sent notice of elected official positions to be on the November ballot. Correspondence was received requesting local input to update the FCC broadband map; allocation of federal funds for broadband deployment will be calculated based on the map. NYSDEC sent notice regarding the new Green Purchasing Communities Program making it easy for local governments to purchase products that have a lower environmental impact. Association of Towns has sent information regarding its Annual Training School and Business Meeting held February 19-22, 2023 in New York City.

#### **OLD BUSINESS**

The Board scheduled a public hearing regarding a zoning amendment to include short term rentals (see notice on front page).

#### **NEW BUSINESS**

Supervisor Moy referenced the cost of propane for users living in the Heron Falls Mobile Home Community. When the park was built, town agreement regulation determined that the fuel tank had to be in the ground which then determined that residents could only purchase fuel from the company owning the tanks. The new park owner wants the residents to be able to choose their fuel providers and is requesting approval for the town to amend its original agreement for the park from needing the tanks buried to allowing two tanks placed near the homes. The Town Board agreed to the amendment from underground tanks to two 100 lb tanks next to their home. President Bob Frieda requested town approval to amend the Fire Company's Certificate of Incorporation. Supervisor requested a copy of the original Certificate to clarify changes being made; President Frieda will submit a copy to the Clerk. This will be on the February agenda. Monroe County Water Authority has increased its purchase rate per 1000 gallons to the town from \$2.47 to \$2.55. The Town Board adopted a new rate to Clarendon residents with MCWA as the supplier at \$4.25 per 1000 gallons.



#### An Open Letter to the Residents of Clarendon From your Highway Superintendent

For your safety and well being during inclement weather, you should reduce your speed and drive according to the highway conditions. Winter driving conditions with icy and snow-covered roads require more driving care. If your vehicle becomes stranded, contact the Orleans County Sheriffs department at 589-5527 and they will notify the appropriate highway department.

SNOW REMOVAL – The law regarding the depositing of snow on highways, shoulders or ditches is as follows: "Section 1219 of the Vehicle & Traffic Law and Section 214 of the Highway Law of New York State specifically prohibits the placing or leaving of snow, ice or other substance upon any highway" (this includes pavement, shoulders and ditches). As a result should these practices occur, police agencies will be notified of such occurrence(s) with the intent that summonses will be issued to the responsible person or persons. MAILBOXES – During and after significant snow storm, highway departments in the course of plowing, receive phone calls regarding damage to mailboxes either from snow plows directly or from the force of snow being thrown by the plows. If such damage is indeed caused by snow removal, it is not done intentionally but is an unfortunate consequence of snow removal. It must be pointed out that there is no statutory or legal authority which grants a property owner or resident along a public highway any right to place a mailbox in a highway right-of-way; the mailbox is on town or county right of way as a courtesy to the postal service. Thus, the necessity of keeping the highway open conflicts with the individuals' reception of the mail, the latter must stand aside. The owner might even be compelled to remove the box under Highway Law #319. From past experience, we have found that plastic mail boxes do not withstand the abuse of snow from the plows and are not recommended. As a courtesy, the Clarendon Highway Department will place a temporary box so that residents can receive mail if their box is damaged by the plow but we will not replace any fancy mailbox or post. Mailbox posts with fancy supports are not recommended as they stick down under the box and give the wing plow something to get hold of. A box mounted directly on top of a treated 4 X 4 is best. Posts should be placed fifteen (15) feet from the centerline of the road. Please note illustrations. For further information, contact me at (585) 734


