CLARENDON TOWN BOARD

Meeting Highlights - February 2023

The Town Board held a public hearing regarding proposed zoning ordinance amendments to allow Short Term Rental (STR) units as a benefit to the town, its residents and the general public. Discussion was held regarding parking; Supervisor Moy referenced the off-street parking provided for in the proposal. Discussion also included not allowing campers, trailers and motor homes parked at the STR.

HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Tracy Chalker reported some plowing but mostly salting this last month. The crew has been cleaning up downed trees and doing maintenance clean-up of trees most likely to come down. A culvert was replaced on Acton Road and drainage ditches in the town are being surveyed in preparation of their clean-out. 125 Red Tags were hung for non-payment of water. Six services were shut-off, two turned back on and four services remain shut-off – residence is empty. The new Mack truck was taken in for warranty work and a recall notice. The new cutting edge is on the 403. Routine water sample testing and flushing hydrants continue. Spill containment for the pump-house chlorine tanks is in. General maintenance on truck wear items is being done. Superintendent Chalker will have the 284-agreement form complete for next month showing the roads that will be worked on this year; pricing comes out March 17th. Superintendent Chalker will attend CHIPS Advocacy Day in March. At Supervisor's questioning, Superintendent confirmed there was basically no fluoride in our water.

PLANNING BOARD REPORT

Chairman Dave Griggs submitted the following written report: 01-10-2023 (Regular Meeting) SP 91-016 Aggregate Placement Inc., Keith Diehl New Guinea Road tax id# 119.-2-53. Special permit renewal. Inspected, fee paid, no outstanding complaints. Motion made, seconded, and approved to approve renewal. SP 20-19 Horvath Communications cell tower, Holley Byron Road tax id# 98.-1-11.1. Special permit renewal. Inspection has been done, fee is paid and there are no complaints. Chairman Griggs reported that at the last town board meeting, Heron Falls formerly called Thomas Estates Manufactured Mobile Home Park requested a change to allow above ground propane tanks to be permitted. Their proposal would be for two 120-gal upright propane tanks that would be located against each mobile home. Suburban Propane owns the current underground tanks and will not turn them over to the individual mobile home owners. They will remain in the ground and the responsibility of Suburban Propane until such time as they remove them. The Town Board approved this request. All appropriate safety guidelines will be followed to ensure the safety of the people and homes. Chairman Griggs points out that modifications will need to be made to Article VII Sect. 708 item O and item T. Planning Board members reviewed a survey from Genesee Finger Lakes Regional Planning regarding a short online survey regarding "Site Plan For Multimodal Transportation". Chairman Griggs submitted a response. Auto Sales lot dimensions. Chairman Griggs would like the board to take a look at the current dimensions required for auto sales and possibly reduce the setbacks and lot size to be consistent with other municipalities and points to the Villages of Holley and Albion as having auto sales lots on smaller parcels. 02-14-2023 (Regular Meeting) Meeting canceled due to insufficient agenda items.

SUPERVISOR REPORT

Supervisor Richard Moy reported included in the state budget by 2025 residential housing needs to increase by 1% or else NYS can eminent domain property and build housing; without adhering to town zoning. Copies of the state budget proposal are available at the town hall.

CORRESPONDENCE

Claudia Tenney sent a letter to Supervisor, offering support to our local volunteer fire department and on issues of priority to the town. Congresswoman Tenney had a meet and greet in Medina; Supervisor couldn't attend but exchanged emails with the Congresswoman. Orleans County Youth Bureau is calling for nominations for recognition awards. Awards will be presented at the annual banquet; nominations are due by March 31, 2023. NYS has sent \$154.00 refund due to the court. The Town received revenues of the 4th quarter 2022 traffic diversion program in the amount of \$1,860.00. The Orleans County treasurer has sent an abstract of payments made to the town in the year 2022. NYS has sent the first payment for 2022-2023 snow & ice agreement in the amount of \$67,823.64. Albion Agencies has sent reimbursement of \$192.50 due to an insurance policy change; removing the 2007 Sterling.

OLD BUSINESS

The Town Board scheduled a public hearing to consider zoning amendments to allow a maximum of two (2) 120 gallon above ground vertical propane tanks to be held March 21, 2023 at 6:30 PM with the regular meeting to follow. County Planning Board review is required prior to adopting zoning amendments; the board will send both the propane tanks amendment and the Short Term Rentals amendment together for county review in March. Supervisor Moy reported Attorney Sansone's review of the Fire Company request for approval of certificate of amendment to the certificate of incorporation found it in order. On Supervisor's behalf, Attorney Sansone sent a letter requesting language be added that any donations received by the fire company will be used toward purchase of equipment or in furtherance of fire prevention; President Bob Freida was fine with that statement. Supervisor read aloud uses allowed pursuant to corporate purposes and the board felt it would allow donation monies to be used for the recreation hall, not just the fire hall. Board members in agreement to explore the separation of the fire hall and the recreation hall prior to this amendment; that the use of donations would then not be in question. The Board accepted application from Beth Skehan to again care for the town hall garden for the 2023 season and from Laura Kingdollar to fill the open seat on the Board of Assessment Review. The Board adopted Resolutions authorizing the Snow & Ice Agreement for 2022/2023 season, in Support of Assembly bill regarding legal notice on-line newspaper publications and accepting the affirmation of the town justice court audit.

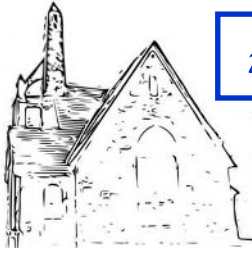

'Till all men learn to live as brothers.

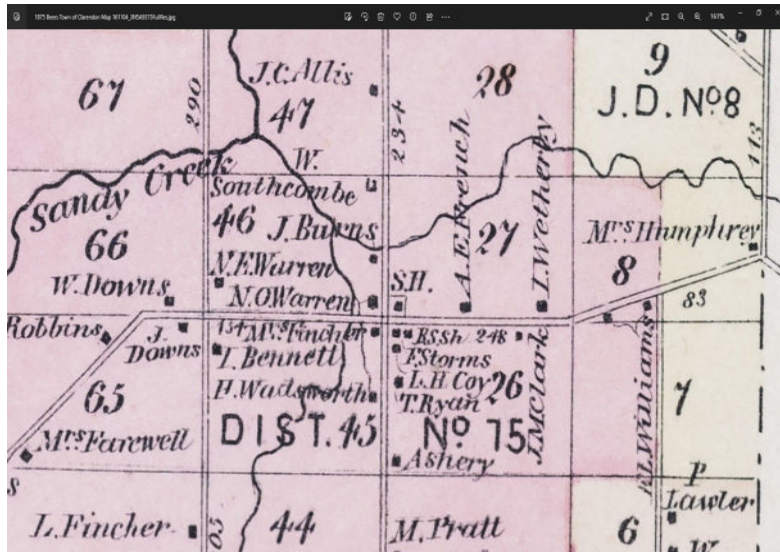

Harmon Wadsworth was born in July 1811, the son of Silas and Judith. He lived in the Town of Sweden and at age 14, moved to Clarendon with his family. Harmon eventually took over the family farm and married his first wife Hannah Wilder. They had 5 children, Sarah b. 1832, Luana b. 1836, Hiram b. 1840, Electra b. 1843 and Adelbert b. 1848.

David Sturges Copeland wrote in his book "The History of Clarendon 1810-1889" that Harmon erected some of the finest buildings to be found in any portion of Clarendon, and his farm is one that the owner and all citizens have reason to be proud of.
