





Open burning of brush, limbs and branches is prohibited. Backyard fire pits, small cooking fires, and small campfires are still okay, but these can never be left unattended.



# **CLARENDON TOWN BOARD** Meeting Highlights - March, 2025

#### OPEN END

Bob Freida, Chief and Craig Hadden, President of the Clarendon Fire Company attended the meeting with their guarterly report. It was confirmed that the Fire Company's fiscal year begins April 1st so they are finishing up the 2024-2025 budget with 105% spent; fund raisers will fund remaining month's business. In 2024, 459 calls were answered; 286 of which were patient care reports; 990 training hours were completed and 3211 man-hours were logged in. Already in 2025, 124 calls were answered; 60 of which were patient care reports; 1900 man-hours logged. One person has completed exterior basic training and two more are currently taking the training; Three firefighters are waiting to take the interior training portion of the class. The Fire Company will be hosting a bus rescue next month; 40 people have signed up to attend. Chief Freida reviewed that the Town Board had a meeting last month with Mercy Ambulance in attendance and no one from the Clarendon Fire Company was present; that he read the minutes in the Gazette and it sounds like all is running fine and well. Chief Freida reported having a lot of issues with Mercy so far; equipment failures, delays in response time, ambulance break downs once or twice a week and medics who don't know how to use their equipment. Chief Freida said they have some great medics and he's sure this will workout in the long run but requested the Fire Company be part of any future discussion that concerns them. The contract with Mercy is for two ambulances and 1 fly car; there is a paramedic on the ambulance but the fly car has an advanced EMT; it is not advanced life-support. A lot of the ambulances are coming from Genesee County; Mercy won't tell Clarendon anything more specific and many come from East Pembroke, when there are ambulances much closer in Brockport. According to the minutes summary in the Gazette last month, Supervisor Moy said that Mercy should use the Clarendon Fire Company building; Chief Freida reviewed that cannot happen; they are a private company and can't have Mercy use the building. Mercy is housed right now in the middle of the Battalion, which is the best spot for it to be to benefit Clarendon Murray and Kendall. Clarendon Fire Company is making notes of the issues that need work; Mercy is a good company but the transition is not as smooth as it's been made out to be. Specific problematic instances were given. Deputy Supervisor Robinson said that looking at their report, Mercy seems to have good response times. Chief Freida asked if it is the fly car time being there or the ambulance at the scene. It was reported that it takes Mercy ambulance thirty minutes plus for a majority of the calls to get there. Legislator Bill Eick said that this has been a disturbing issue with Orleans County; that the County EMS Director was never involved in discussions, and should have been. Anyone other than Supervisors of the towns involved were kicked out of meetings regarding the contract negotiations. On the west end of the county everything is fine; on the east end there are problems and without the proper people involved they can't be resolved. Councilman Caufield stated that there used to be a taskforce that met every couple of months, that included representatives from all sides of the issue fire and municipalities; that a county-run ambulance service was to be considered. Then this ended up being just supervisors to determine the contract and bring it back to the boards for a vote. Councilman Caufield stated being in favor of a county ambulance service. It was reported that Orleans County was given a free ambulance; that the EMS director was working on budget issues; that it would still require Mercy or Monroe but that the county would be the third ambulance going out.

Amanda Anderson, Director of the Holley Community Free Library reported that the annual wine tasting will be held this year on Friday, May 2<sup>nd</sup> from 7:00 – 9:00 PM. There are 8 vendors, that will be revealed over the next month on Facebook and the library website. Tickets go on sale April 1<sup>st</sup> in person at the library or on-line; all funds raised go to the summer reading program.


#### **HIGHWAY/WATER DEPARTMENT**

Superintendent Tracy Chalker reported that since the last board meeting, the highway crew had eleven plow runs and spent a lot of time pushing snow banks back. Multiple trees have been cleaned up and nine deer have been picked up from the roadsides. Maintenance has been done in the Hillside Cemetery. Repairs and maintenance have been done on the trucks. Waterline repairs have been done on South Holley Road and on Taylor Road. Hydraulic leaks have been repaired on the loader and backhoe. Some mailboxes have been repaired even though it's not the town's responsibility; it's done out of courtesy.

Superintendent Chalker reported he attended and spoke at a press conference for Advocacy Day in Albany; he then went to Albany with 750 other Highway Superintendents to rally for CHIPS funding increase, which looks promising. There was one burial at Hillside Cemetery. Lance Babcock is going to again work in the cemetery for the summer. He worked very well last year. The F-550 has been stripped down for other uses; ditching, water work and tree clean-up. There are four possible water pushes coming up to do. Routine water maintenance and testing continues. Superintendent Chalker referred to the 'salt issue' as a nightmare! An order was put in with American Rock Salt on January 9th and on the 17th it still wasn't delivered; an emergency load was received from OGS at a higher price and we're still waiting for cost reimbursement of the difference from American Rock Salt. We have 400 ton more on order; unsure what will happen with that. It was reported that use of salt normally at 200 lbs per lane mile was reduced to approximately 130 per lane mile by keeping main roads clear and salting just the intersections and curves on the back roads. New price bids for next year are due in on May 1st.

#### PLANNING BOARD REPORT

Chairman Dave Griggs submitted the following written report: 01-25-2025 (regular meeting) Meeting canceled due to insufficient agenda items. 03-11-2025 (regular meeting) SP 96-005, Special use renewal, Pets Galore, 4880 S. Holley Road. Inspected, fee paid, no outstanding complaints. A motion was made, seconded and approved to grant renewal. SP 05-03, Special use renewal, American Tower, dba Verizon, Munger Road. Inspected, fee paid, no outstanding complaints. A motion was made, seconded and approved to grant renewal. SD 25-01, Pre conference for building lot approval, Mike Koberg, tax id # 87.-3-65, Powerline Road. The property consists of 42.49 acres with frontage on three (3) roads, Lake, Powerline, and Holley Byron Roads. The Planning Board reviewed the site plan checklist, verified public water availability, setbacks & drainage plan. No issues were noted. Applicant requested a waiver from pre-conference to formal. A motion was made, seconded and approved to waive pre-conference. A motion was made, seconded and approved to grant building lot approval contingent upon Orleans County approval of septic design and connection to public water approved by the Town of Clarendon Water Supervisor. SP 24-01, Pre conference, Greenhouse/nursery operation, 17209 Taylor Road. Tabled for further information.

There they focus on education and physical fitness, and the children are also provided with clothing and shoes.

## Town Board Meeting Highlights Continued from Page 4

#### DEPUTY SUPERVISOR REPORT

Deputy Supervisor Allen Robinson reported that the Orleans County Association of Municipalities monthly meeting will be on March 25, 2025 at 6:30 PM at the Tavern on the Ridge in Gaines. Four Planning Board members intend to attend. The NYCLASS Investment is paying 4.19% interest and Steven Hawley, Assemblyman, has sent a letter in support of Clarendon's request for a traffic study to lower the speed limit on Upper Holley, Brown Schoolhouse and Glidden Roads.

#### CORRESPONDENCE

An invitation was received to attend the Orleans County Bicentennial Ceremony to be held on April 15, 2025 at the Orleans County Courthouse in Albion. It is scheduled to begin at 11:45 AM. The Village of Albion has sent notice of a public hearing to be held regarding the elimination of fluoridation of its water supply. Clarendon receives its water from Monroe County Water Authority; therefore it doesn't apply to Clarendon. Revenue has been received from New York State for Snow & Ice in the amounts of \$4545.49 and \$70,397.74; CHIPS revenue was received in the amount of \$10,906.72. Confirmation of the 3/31/2025 appointment scheduled for the town hall boiler inspection was received.

#### **OLD BUSINESS**

The Town is still waiting for a response from the State DOT regarding the speed limit change request for Brown Schoolhouse Road, Upper Holley Road and Glidden Road. The Board accepted the proposal for bond counsel services from Bond, Schoeneck & King for Water Improvement Benefit Area No. 14 and the proposed zoning amendments have been forwarded for review by the County Planning Board at its March 27, 2025 meeting.

#### **NEW BUSINESS**

The Town Board adopted a resolution in support of the Harriet Tubman Underground Railroad Byway to establish a 550-mile byway highlighting historical sites with connections to the Underground Railroad from New York City to Niagara Falls; including municipalities in Orleans County. The Board accepted a \$750.00 quote from CHPC to migrate our website from .org to .gov as per recently passed legislation. Bill Downey will handle the email account changeovers. The Town Board adopted a Resolution accepting affirmation of the 2025 highway equipment audit done on February 4, 2025.

Híllsíðe Sketches

2025 is the bicentennial year of the formation of Orleans County, NY. I selected one of Clarendon's pioneers for this month's Hillside Sketch.

# Horace Peck

came to Clarendon in 1816 as a fourteen -year-old with his father Linus Peck. That same year, Horace drove a mixed herd of cattle, sheep and horses to Batavia and then to Buffalo. He was paid \$4 for this work. Horace labored 15 days toward building a corduroy road near Col. Schubael Lewis' house (this very home is still standing. It is located on Rt. 237 and has a historical marker in





front of it). As a young man, Horace taught in a log school house on Wyman Rd. (the school was replaced with a cobblestone building and is now gone, it once housed the Clarendon Fire Company) Horace was paid \$13 a month and there were 30 students.

In the late 1820's Horace married Anna White. They

had 2 children, a daughson Warren

ter Emily and a son Warren. Warren fought in the Civil War with Company F, 13<sup>th</sup> Infantry. His wife Anna died in 1834. Horace married a second time to Adeline and had 2 more children, Lewis and Emily.

In 1834, Horace helped to start the Universalist Church in Clarendon. (The church was located on East Lee Road and was demolished in 2006 as it was dilapidated and beyond repair).

In 1859 Horace and his father

Linus were among the men who founded the Orleans County Pioneer Association. Horace Peck died on March 12, 1887 at age 85.
