# CLARENDON TOWN BOARD Meeting Highlights - April, 2025

In the absence of Supervisor Moy and Deputy-Supervisor Robinson, Councilman Major conducted the board meeting.

### HIGHWAY/WATER DEPARTMENT REPORT

Superintendent Tracy Chalker reported that the crew rebuilt the small trailer for lawn mowers with completely new wiring front to back, new lights and a new deck. The old deck was rotting. Wafers on the three-point hitch broom were changed. Trucks to Beam Mack for repairs: The 405 had a leak in the DEF system plus electrical issues with turbo and the 403 had warranty work and recall notice work done. Superintendent submitted the agreement for expenditure of highway moneys and informed it was subject to change pending the Federal budget. A water push and tap were installed on Lake Road. The same was attempted on NYS Route 31A but due to rock, the push will have to be hired out. Ash trees are still coming down every time the wind blows; the crew has been cleaning them up. Highway employees attended a two-day training for safe excavation and sexual harassment, trench safety and confined spaces, traffic control and work place violence. The crew is working on lawn repairs needed from plowing. The first quarter water reads have been completed and some meters have been changed-out. Routine water maintenance continues. The light at the town hall has been changed-out with the help of the Village of Holley. There has been one plow and salt run since last meeting and salt has been mixed with Millenium Roads product. New Guinea has been graded with assistance from the Town of Barre. Superintendent reported he will be attending water school next month and will not be at the May board meeting; this training is required to maintained his license. Superintendent asked about applying for a general credit card for the Highway Department with a \$1500 limit to be used for purchasing items on-line. Superintendent Chalker informed there are wood chips in front of the highway garage available for residents.

#### PLANNING BOARD REPORT

Chairman Griggs submitted the following written report: 03-25-2025 (regular meeting) Meeting canceled, attended training session, at the Orleans County Association of Municipalities Monthly Meeting. 04-08-2025 (regular meeting) Meeting canceled due to insufficient agenda items.

### SUPERVISOR REPORT

Councilman Marc Major reported that Councilman Hovey and himself attended the Bicentennial Ceremony at the Orleans County Courthouse and were impressed with the amount of history there is in the county. He thanked Clarendon Historian Ierlan for serving on the Bicentennial Committee. Councilman Major showed the program with upcoming events listed and a tourism book in celebration of the Bicentennial.

#### CORRESPONDENCE

NYS Agriculture & Markets has sent its report of the 3/27/2025 municipal shelter inspection. The Orleans County Treasurer has sent sales tax revenue in the amount of \$47,365.52. The NYS Department of State has sent notice of completed CEO in-service training for 2024 and Rochester Portable Toilets sent a proposal for services in 2025. The board accepted the proposal from Best Rentals for the 2025 season for delivery, set up and weekly service of portable toilets at the park and cemetery.

#### **OLD BUSINESS**

There is still no word on the speed limit change request for Brown Schoolhouse, Upper Holley and Glidden Roads. MRB Engineering is requesting appropriations on behalf of the town for additional funding for Water Improvement Benefit Area 14 from Senator Schumer, Senator Gillibrand and Congresswoman Tenney. The Town Board adopted the proposed zoning ordinance amendments after County Review and approval.

### **NEW BUSINESS**

Planning board member attendance at Association of Municipalities meetings and Water District Rules/Regulations Policy for Hardships and Active/Inactive water accounts were moved to the May meeting. The board accepted the agreement for the expenditure of highway moneys as submitted by Superintendent Chalker; including general repairs on 43.11 miles of town roads; permanent improvements on Munger Road, Boots Road, Hulberton Road, Mill Road, Upper Holley Road Extension, Elizabeth Drive, Hibbard Road, Glidden Road and Chugg Road.

Councilman Caufield reported that the County's Drug Take-Back will be held April 26, 2025 at the Public Safety Building/Sheriff's Office. This will be the last event of this kind; there will be no funds to continue it.

## Hillside Sketches

William H. Westcott was born in 1839 in Erie County, New York. His parents John Westcott and Mary Cook were both natives of England and came to the U.S. in 1834. Soon after William's birth, the family moved to

Hindsburg Rd. William spent his childhood in Clarendon. He went to school at the Albion Academy and Albion Normal School. In 1862 William and his brother Thomas enlisted in the 8th N.Y. Heavy Artillery, Colonel Porter's famous regiment. The brothers were at the Battle of Cold Harbor where Thomas received wounds from which he never fully recovered. Both brothers attained the rank of Lieutenant. William entered the service as a Corporal. In September 1863 he was appointed Quartermaster Sergeant. On December 2, 1864 he made Second Lieutenant. In June of 1865, William was transferred to Company C 4th N.Y. Heavy Artillery and mustered out in Washington D.C. on September 28, 1865.



In the spring of 1866, he engaged in the hardware business in Clarendon and worked for eight years. He served as Post Master and Town Clerk as well. William married Adelaide L. Peggs of Clarendon. In 1874 William's brother Thomas died and at that time, William took his brothers place as partner with his father in the shoe business in the Village of Holley. William was a staunch Republican and for many years was an active and influential factor in town and county politics.

In 1912 an article in the Holley Standard stated that for a number of years the observance of Memorial Day had been sadly neglected in Holley. The article further stated that the original purpose of the day had been lost sight of and if there has been any celebration at all it has been in the way of sport and amusement. Memorial Day is a US Federal holiday observed on the last Monday of May to honor and mourn the members of the U.S. military who have died while serving in the Armed Forces. It's a day to remember the sacrifice and lives of those who have died in service to the coun-

try. Originally called Decoration Day, Memorial Day began as a way to honor soldiers who died in the Civil War, and it evolved to commemorate all American military personnel who died in service, according to the National Archives. It's a time for reflection, remembrance, and honoring the fallen.

# Clarendon Personality ..... DANNY CAMPBELL by Jim Bowen

If you don't know me, I'm Danny's first cousin, Jim. My mother and Danny's father were brother and sister. I've known Danny my whole life. We were born 7 months apart and have always been like brothers. I could tell you a lot of stories about Danny. So, if he's reading this he's probably thinking, "Oh, crap." We have hunted, fished, played sports, worked together, partied to all hours, and, of course, been part of the fire company. We were the best man in each other's weddings. Recently, Danny was recognized for 50 years of dedication to the Clarendon Fire Company but, I know that Danny's been involved for many more years than that. Uncle Everett and Aunt Letha, Danny's Mom and Dad, were heavily involved in the fire company. At birthday parties, graduation parties, anniversaries, picnics, Christmas parties, and any other gathering that you can think of, Uncle Everett and Aunt Letha would bring along their monitor, in case the tones went off. That was back when we had those big blue monitors that plugged into the wall. When they had battery operated monitors, they even took it with them fishing. Aunt Letha was a devout bingo player and made it every week. Bingo started at the original fire hall. Most everything started there. Bingo, wedding receptions, anniversary parties, graduation parties, training classes, CPR classes, meetings, and just about anything that fireman, family, or townspeople needed, happened at the fire hall. Boy Scouts, paper drives, fire police putting reflectors on bicycles, auto extrication drills.... And, Danny grew up there. This has been a part of him. He believes in helping others. He loves this fire company. When we were kids, the fire company held the Clarendon Carnival right where the Recreation Hall is now. The parade started at the Clarendon Park. came through the center of town and ended at the carnival grounds. Everyone in town was at the carnival at least one night and some of us every night. And anyone who wanted to help would be given something to do. I remember serving pop, French fries, and hamburgers. Danny was always there someplace. As he got



older, I think he may have wandered into the beer tent a time or two. Probably because the steamed clams were in the same tent. This Fire Company has been involved in parades, fund drives, spaghetti dinners, turkey raffles, steak dinners, carnivals, fire drills, disaster drills, training exercises, and a host of other things. And Danny was always there. This Fire Company showed up for fallen brothers whether fire company or police department. Near and far. Stood guard for the fallen. And Danny was always there. Danny was so involved; I'm sure Diana would roll her eyes every time the tones went off. That's just who Danny is. When Danny turned 18 years old, he couldn't wait to join the Fire Company. It was one of the proudest moments of his life. Over the years, I think Danny has held just about every office that the fire company had to offer. I'd like to share a couple of memories that you may or may not know about. Several years ago, the Clarendon Fire Company played the Town of Clarendon in a softball game. We played in Shenck's field just up the road here. Now, to be fair, we kind had the deck stacked in our favor but, the town tried really hard to put together a team that could take us down. I think they even brought in some ringers. Dick Moy pitched for the town. Bill Quill was catcher, George Turner played first base. Billy Ennis was in center field. Geary Shenck was Town Supervisor, and he umpired the game. I have many memories of that game. I played second base. I won't forget Kevin Novak playing 3rd base and stretching out for a throw over a runner sliding into base. The ball whizzed by the runner's ear, Kevin made the catch and tagged him out. I won't forget Terry Novak playing Center Field Rover and shagging a ball, throwing to the cutoff man to make a play on a runner going to home plate. And I'll never forget Earl Jenks playing short stop and making a diving catch that put him flat out and parallel to the ground. Paul Wagner overran first base, rolled, and broke his collarbone. There were many highlights in that game but, my fondest memory was of Danny. Danny's first two at-bats were home runs over the left field fence. His third time at bat was a little short of the fence so, he ran the bases for an in the park home run. Someone said he missed 3rd base. They threw the ball to third base and Geary Schenck called him out. Danny knew he didn't miss third. Everyone on our team was upset. But not Danny. He just waited for his next at-bat, switched to batting left-handed, pointed to the right field fence, and hit a home run over the fence. Nobody else on that field could do that. Danny might not look like an athlete now but, I've seen him do some things. He could run and field. He could base run faster than most people and turn what should have been a double into a home run. As a fielder I've seen him catch balls on a dead run over his shoulder. Well, you guessed it, we won that game. Cannot tell you the score but, we won. Another memory was a little more sobering. We had an MVA on Beatle's curve. I don't know if you guys still call it Beatle's curve, but we did. A bend in the road on route 237, headed to Holley. A car swerved to miss a deer and went sideways into a brick pillar marking the edge of a driveway. The car hit just behind the driver's door. The two guys sitting in the front seat were fine but the 17-year-old girl in the back seat wasn't so lucky. Danny was Chief and I was Emergency Squad Captain. We both arrived on the scene first and that girl was struggling to stay alive. We asked the homeowner for a turkey baster to use for suction until the ambulance arrived. Well, many medics and fire fighters that day tried to keep that girl alive. We transported to Brockport, and on to Strong. They kept her alive on life support way into the early morning until they pronounced her dead and harvested her organs. We were all sad. Anytime that happens we take it hard. It's personal. Danny had us all meet back at the fire hall for debriefing. It was hard on firemen, medics, and fire police. Well, the next day I got a call from Danny. He said, "Take a ride with me.". I jumped in his truck, and we drove to that same house. Danny had gone to the store and bought the best turkey baster they had with his own money. We knocked on the door and gave it to them. Then Danny asked them if they were alright. That's the kind of man he is. He never leaves anyone out. As a fire fighter, medic, person, humanitarian you'll never find a truer example. On a call he'll drive truck, man a hose, or lead a scene. At the hall he'll clean trucks, fold hose, or resupply a truck. At events he'll be the Master of Ceremony, sweep the floors, sell raffle tickets, or help clean the kitchen. He'll organize training drills or buy supplies. He'll learn or he'll teach. I don't think we'll ever see a more dedicated hero. He was born to help, and he'll do it until he can't. That's who he is and that's who he'll always be. Whenever I was at a scene, I took great comfort when I realized Danny was there. I knew if I saw Danny everything was going to be alright. Over his 50 years serving the Town of Clarendon, I know many of you have had the opportunity to know Danny. He has been a great asset to the town. I'm sure Uncle Everett and Aunt Letha planted the seed and now Danny and Diana's son Matt has joined his father with 30 years of service and Matt and Courtney's first-born son, Gage is hopeful to soon be joining the ranks to make it four generations of Campbells in the Clarendon Fire Company. I know that Danny's mom and dad are looking down and thinking, "We sure are proud of that boy." Please, join me in thanking Danny for everything he's done over the years and congratulating him on 50 plus years of service. Thank you, Danny!
